MONDAY, June 15, 2015

The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Mike Stack) in the Chair.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator McGarrigle.

Senator McGARRIGLE. Mr. President, my amendment will merely strike two words, "increased to." First, it is not clear to what these words actually refer, if they refer to an increase in PRI surcharges from 12 to 23 over the prior version of House Bill No. 911. The words, I submit, are confusing and unnecessary because Amendment A2053 specifically deleted any lan-

guage in House Bill No. 911 referring to 12 surcharges. Under my amendment, the revised, and I submit improved, language is simply subscriber's assessments shall be 23 surcharges per digital transmission link.

I respectfully ask for the support of my colleagues for my proposed amendment.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Vulakovich.

Senator VULAKOVICH. Mr. President, I rise today to respectfully ask for a "no" vote on the amendment. The current language in the bill has already been agreed to by multiple key stakeholders, including the County Commissioners Association and the telecommunication providers. This amendment would disrupt that agreement. PRI lines are currently collected at one fee for every 23 channels, one of which is administrative. The language in this bill reflects that change in a way PRI lines are charged, effective as of July 1, 2015. Now, we have CCAP, the County Commissioners Association, in support of this, and so are the telecommunication providers.

I would like to remark that this bill, nor the section, in any way is meant to weigh into any lawsuits in this Commonwealth regarding the past collection on 911 fees by telecommunication providers. Rather, this bill is meant to establish, moving forward, how the 911 fee is to be collected. I ask for a "no" vote on this amendment. Thank you.

#### LEGISLATIVE LEAVE CANCELLED

The PRESIDENT. Senator Sabatina has returned, and his temporary Capitol leave is cancelled.

And the question recurring, Will the Senate agree to the amendment?

The PRESIDENT. The Chair recognizes the gentleman from Delaware, McGarrigle, for the second time.

Senator McGARRIGLE. Mr. President, I, once again, ask my colleagues for their support on this. We were not sent here by the telecoms, so the support of the telecoms means nothing to me at all. We are here to look out for the taxpayers of this Commonwealth. I ask you for your support on this amendment. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Mensch.

Senator MENSCH. Mr. President, I, too, rise in opposition to this amendment. Let me talk about it a little bit from the industry perspective, in which I lived for 35 years. We are caught up in a definition that does not apply to every vendor that provides access for 911 services. A PRI is unique to someone who implements T1 service, which is 1.544 megabits of data. PRI is unique to one vendor in their terminology for their implementation of the service. If you are a broadband carrier and you implement your access for 911 across broadband, you do not use the terminology PRI. Therefore, it is not applicable to that vendor. So this is vendor-specific, to one vendor, it singles out that one vendor, and it increases the costs for 911 behind that arrangement significantly.

Let me give you an example, Mr. President. If I am a company that subscribes to broadband access for my business, and I

have 1,000 stations behind that, I will have 23 fees, as proposed in this amendment. If I am a business and I subscribe to Verizon, who implements it differently, and I have 1,000 stations, I am going to have 1,000 fees. On one hand, I have 23 fees, and on another, I have 1,000. This is not an equitable situation that we are creating. We are disadvantaging one vendor for the purposes of a lawsuit. That is not the purpose of legislation. That is not my understanding of what a government should be doing. We need a level playing field. We use that term so often it becomes trite here, but in this case we need a level playing field so that every vendor is going to be asked to provide the same fees for 911 service.

So, Mr. President, with that description, I really do ask Members for a negative vote on this amendment. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Vulakovich, for the second time.

Senator VULAKOVICH. Mr. President, I just wanted to make sure that everyone understands that I am asking for a "no" vote on this amendment.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Kitchen.

Senator KITCHEN. Mr. President, we have heard the saying "time is precious." Time is precious is a slogan that is as true today as it was in 1865. So, imagine how precious it was 150 years ago when news finally reached Galveston, Texas, that Congress had, 2 1/2 years earlier, signed the Emancipation Proclamation to formally and historically end slavery. The Emancipation Proclamation was signed into law on January 1, 1863, but that important piece of news did not reach African Americans who were fighting for freedom until June 19, 1865, when Major General Gordon Granger arrived in Galveston and declared that all slaves were free.

June 19, 1865, is Independence Day for a lot of African Americans. We call it "Juneteenth National Freedom Day," but Juneteenth National Freedom Day is for everyone. The final end of slavery is for everyone to celebrate, observe, and remember it so it never happens again. More than 11 million Africans came to America against their will. They endured horrid travel conditions and lived with the fear of whips and chains for whatever their owners decided was bad behavior. But we must all strive for universal freedom and liberty, Mr. President. Juneteenth celebrates freedom and marks a very important time in American history. Everyone can join in the celebration of Juneteenth. In fact, there are many communities across the city of Philadelphia who celebrate this important day in many ways. One organization, in particular, is using this holiday of independence, human rights, and African American culture to reenergize and reunify a community that has been plagued with crime and hopelessness. Juneteenth represents hope, survival, and freedom for everyone.

Time is precious, that is true, Mr. President, and I ask the Senate to waste no time adopting my resolution making June 19, 2015, Juneteenth National Freedom Day.

Thank you, Mr. President.

The PRESIDENT. The Chair thanks Senator Kitchen for standing up for hope and justice in America.

The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, I join Senator Kitchen in asking that this resolution be adopted. When we understand what slavery was all about, when we understand the joy that people experienced when they were free, we liberate all of ourselves. Black and white people in this nation have been tied into a knot of misunderstanding, and the way you untie the knot, the way you create racial relations that are worthy, that are good, that are sincere, that are real, is to understand the history. To untie the knot that has tied us together in misunderstanding, and Juneteenth and the celebration of this holiday, of this festive occasion, allows us to do just that. So, it is my privilege to join Senator Kitchen.

Also, as Senator Kitchen said, there are still problems today that we have to recognize. The problem, for example, of human slavery continues across the world, in terms of the millions--we estimate it to be about 15 million to 16 million--human beings who are enslaved either in terms of sexual exploitation or in terms of labor. It occurs in our country. That is why this legislature passed Senator Greenleaf's bill to end human trafficking. We will soon have another version of that bill to take care of a vote that we did not take care of the last time. It is time for us to have a true celebration of Juneteenth by ending slavery, including human trafficking in all places in the world, including the United States of America, because human trafficking, which is slavery,

continues today, and then we can stand on the floor and then we can say that Juneteenth is real and takes care of everyone, not just in the United States, but in the world as a whole.

So it is a privilege to join Senator Kitchen in passing this resolution with the hope that someday we can all join hands together and say that slavery in this world is no more.

The PRESIDENT. The Chair thanks Senator Vogel, and you can count on the Chair attending on June 23 for a milkshake. Pennsylvania's milk is the best in the world. Thanks for the dairy farmers and thank you, Senator Vogel.

The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, I join my colleague and friend, Senator Vogel, who is the true dairy farmer here in the Pennsylvania State Senate, and join with him in celebrating Dairy Month here in Pennsylvania. Some interesting facts about Pennsylvania's dairy industry. Mr. President, we are the fifth-largest milk producer in the United States. We have the second-largest number of dairy farms in the United States. We are home to over 7,400 dairy farms and more than a half-million cows, Mr. President, here in Pennsylvania. Dairy is the largest segment of Pennsylvania's agriculture economy, which means it

is quite important to us. It represents 40 percent of the ag revenue in Pennsylvania. It provides nearly \$5 billion in economic revenue and supports nearly 60,000 jobs across the Commonwealth. Senator BLAKE. Mr. President, I am delighted to join my friend and colleague, Senator Vulakovich, and others here on behalf of Senator Costa, as well as on behalf of Senator Baker, to acknowledge our veterans homes and to join in my support of this resolution. As a young professional coming out of college, I worked for the Lackawanna County Redevelopment Authority and there was a gentleman who was chairman of that board with me for about 10 years, and his name was Gino Merli. He was a Congressional Medal of Honor recipient. Mr. Merli was one of the most humble and most remarkable men I have ever met. #### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Fontana.

Senator FONTANA. Mr. President, I am proud to take part in the 10 days for \$10.10 program, and would like to thank my colleague, Senator Tartaglione, for her leadership on this important issue. Mr. President, the time has come to make Pennsylvania's minimum wage a living wage. It is about human decency. It is about giving low-income workers a fighting chance. It is about injecting spending dollars into our economy. Most importantly, it is about doing the right thing for our citizens.

Mr. President, I can stand here and list statistics about how the wage gap has widened and how the American middle class is disappearing before our eyes, or I can explain how other States and cities that increased their minimum wage have seen eco-

nomic growth, especially compared to States and cities that have not. I can tell you how price comparisons reveal that minimum wage increases do not significantly lead to increased consumer costs. In my view, all of these supporting points do not really touch on the overriding issue, and that is one of fairness. Mr. President, it is nearly impossible to survive on \$7.25 an hour. For anyone who may argue otherwise, I challenge them to try it. In my America and our Pennsylvania, working people should not be living in poverty, it is as simple as that. Mr. President, do you know that a full-time minimum wage worker typically falls below the poverty line?

Contrary to stereotype, a typical minimum wage worker is not some suburban teenager earning pocket change. Based on Census Bureau data, 88 percent of minimum wage earners are adults, and more than half are women. In my previous life, Mr. President, as a realtor, I know firsthand that for these workers, decent housing is out of reach. In fact, they would need to work nearly three full-time minimum wage jobs just to simply rent a two-bedroom apartment at a rate of less than 30 percent of their income. Where do these struggling workers go to make ends meet, Mr. President? Government services. It is, too often, the only option they have. In this system, is this the best we can do? Are we really going to continue ignoring the plight of these struggling families? Are we really going to stand by watching the rich get richer while our hardworking men and women fall behind? Pennsylvania's minimum wage is outdated, senseless, and harsh. It stifles our economy and drains crucial safety net and welfare programs. Embarrassingly, inaction on this issue symbolizes this legislature's indifference toward hardworking people and emotional intolerance for poverty.

Mr. President, more than 75 percent of Americans favor a minimum wage hike. Mr. President, it is time to act. Thank you very much.
