The Department of Environmental Protection (DEP) is pleased to present to you its Annual Low-Level Radioactive Waste Program Report to the General Assembly and the Appalachian Compact Commission. This report covers calendar years 2012 and 2013.

The report provides a summary of the current activities of the Appalachian States Low-Level Waste Compact (compact), a list of all low-level radioactive waste (LLRW) generators in the compact, and the amounts of LLRW disposed by volume. It also contains a discussion of LLRW generation trends, LLRW in storage, waste minimization and financial statistics relating to all aspects of the compact.

The Pennsylvania Low-Level Radioactive Waste Disposal Act (Act 1988-12) requires that this report be prepared each year. The enclosed report is based on data from the U.S. Department of Energy's Manifest Information Management System (MIMS). MIMS is a national database that contains the actual volume and radioactivity of LLRW disposed of at three existing LLRW disposal facilities in the country. The information on waste in storage was obtained directly from the LLRW generators.

As we did with the previous year's report, DEP once again is distributing the report electronically and providing a link for accessing the report online. The report can be found in the DEP eLibrary at [www.dep.state.pa.us](http://www.dep.state.pa.us). Select tools; eLibrary; Publications; Radiation Protection; Low-Level Radioactive Waste Program Annual Reports. ### POINT OF ORDER

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, I rise to request a ruling of the Chair pursuant to Senate Rule 20(c)(2). On November 3, I

was elected judge of the Court of Common Pleas of Delaware County. Am I permitted to vote on House Bill No. 89?

The PRESIDENT. First, Senator, congratulations on your election.

Senator PILEGGI. Thank you, Mr. President.

The PRESIDENT. We will miss you in the Pennsylvania Senate. The Chair thanks you for your inquiry about a conflict of interest in the factual situation just given. The Chair rules that in the situation just described, there is no conflict, and that in accordance with Senate Rule 20, Senator Pileggi, you must vote on this bill. Under the rules, anything which would excuse you from voting on this bill would have to afford you a benefit which would be particular in nature and personal to you alone. Although you in the near future will be a member of a class of judges who may be impacted by this legislation, this bill addresses the whole class, not just you, Senator Pileggi. The Chair does not find that any votes you may cast would be particularly personal to you or privately affect you alone. Therefore, it would be the ruling of the Chair that in the important duty of representing your constituents, you are indeed required to vote on the legislation under our Senate rules. And perhaps next time I will give you a shorter ruling.

Senator PILEGGI. Mr. President, thank you.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Mr. President, I might be the only "no" vote here, but I believe in a representative democracy. We run every 4 years and we have to face our electorate. It is sort of interesting, every 10 years reapportionment shifts our districts around, but we have to face opponents and constantly get criticized for the \$83,000 and some change that our rank-and-file Members make. We are here to make a constitutional amendment to take our judges from 70-year maximum age to 75. They run for one election in which they will have opposition. After that, they run once every 10 years for retention. For just one exception that I remember, and it was over a pay raise issue, nobody, to my knowledge, has ever lost a retention vote. They

have a 4-percent multiplier, which means every year they are in office, it is 4 percent of that year, so after 25 years of office, they receive 100 percent of their salary. That salary presently is \$180,000 a year for a common pleas county judge. I think 70 years of age is plenty of time to make a millionaire out of individuals. Let us give somebody else an opportunity to sit on the benches.

I read the letters to editors about State Senators and State Representatives having these life careers, I guess I am no exception to that rule, I have been around a long time, but it only takes one election and a retention and a half to give these common pleas judges 100 percent of their salary. Let us let the taxpayers have an opportunity to put some different philosophies on that bench and some opportunities for some young lawyers to have an opportunity to put that black robe on and be a judge. Perhaps 70 is the new 50 in this day's world, and at 75, you are probably still accurate and bright. But I will tell you what, I think in the confusion of life, let us make 70 years of age the standard where we maintain and not to exceed that. That is 5 years shy of 80. I have nothing against senior citizens, but these are people who are sitting on the bench dispensing something that sometimes is intangible. You cannot touch it, you cannot taste it, and you cannot see it, and it is called justice. I know it is a constitutional amendment, let us let the citizens decide, but for me, I say 70 is plenty and let us keep it that way. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Williams.

Senator WILLIAMS. Mr. President, I am speaking because the last time this came before us I voted in the affirmative for this particular bill. I want my constituents and those who are watching, and certainly the Members on this floor, to understand why I am changing my position. Unfortunately, not too long ago, certain information came to me regarding members of the Supreme Court. The consequence of that information is still rolling out to the general public, and the ugliness of that is rolling out to the general public. Some of these folks who are on the Supreme Court currently would be positively affected when it comes to this.

My intention is to remove anyone who is involved in the current set of circumstances regarding the scandalous, repugnant, racist, misogynistic emails from the Supreme Court. They should not serve a day longer, but they sure as heck should not receive the opportunity to serve 5 additional years. So for those reasons, I am voting against this particular bill. I see the merit and wisdom on many and frequent occasions of experienced individuals continuing on their service, but in this set of circumstances, these people do not represent the best of Pennsylvania, and so if they are gone, I will be more than happy to consider this particular bill at a future date. Today, as the court is currently constructed, I think it works against not just the court, but against all Pennsylvanians. So I ask for a negative vote, Mr. President. Thank you.

This interchange designation will help honor the duty and sacrifice that he made to do what firefighters do, which is to help keep our communities safe.

Lieutenant Eslary was a well-respected and committed law enforcement officer who established his department's K9 unit in 2000, and provided K9 training assistance to other departments across the State. He was instrumental and a very important part of the Westmoreland County Drug Task Force, through which he provided drug resistance education to local schoolchildren and civic organizations. This bridge designation will help honor the life, work, and sacrifice of Lieutenant Eslary. Thank you.

(1) A. Louis "Lou" De Lancey was born March 8, 1936, in Newport to Sherman and Dorothy Adams De Lancey.

(2) In June 1954, De Lancey joined the Navy and served aboard the USS Midway and the USS Hanson during the Korean War era.

(3) While aboard the USS Midway, Petty Officer De Lancey assisted in the evacuation of more than 18,000 civilians and 15,000 of Chiang Kai-shek's Nationalist troops to Formosa, now known as Taiwan, as they fled from the Communist People's Liberation Army advancing on the Dachen (Tachen) Islands.

(4) In recognition of his service, Petty Officer De Lancey received the China Service Medal, the Good Conduct Medal and the National Defense Service Medal.

(5) Petty Officer De Lancey was a lifelong member and Post Commander of William H. Saylor VFW #34, Newport American Legion Post #177, Commander of the Perry Council VFW, cofounder and President of the Perry County Sailors Association, a member of the USS Midway Veterans Association, a member of the Navy Club of the USA and was inducted to the Chapel of the Four Chaplains Legion of Honor in 2003 for his work with the Korean War Veterans Recognition Ceremony.

(6) In addition to his military service, Petty Officer De Lancey was a member of the Loyal Order of Moose Lodge #925 and the Plumbers and Pipefitters Local Union #520.

(7) After a courageous battle with cancer, Petty Officer De Lancey passed away on February 23, 2014, at 77 years of age.

(b) Designation.--The section of Pennsylvania Route 849 in Newport, Perry County, is hereby designated as the United States Navy Petty Officer 1st Class A. Louis De Lancey Memorial Highway.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the highway to traffic in both directions on the highway.

Section 3. Edward W. Helfrick Resource Management Center.

(1) Edward W. Helfrick served as Senator from the 27th Senatorial District from 1981 to 2003.

(2) Officer J. Horace Callaghan.

(iii) Officer Callaghan was survived by his wife and three children.
