§ 5701. Definitions.

The following words and phrases when used in this chapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Child." An individual who is under 21 years of age and meets

one of the following:

(1) The county agency is conducting an assessment of the need for services.

(2) The county agency is conducting an investigation of suspected child abuse of the child under Chapter 63 (relating to child protective services).

(3) The county agency is providing services to the child County agency. As defined in section 6303 (relating to definitions).

"Department." The Department of Human Services of the Commonwealth.

"Law enforcement." The law enforcement agency which is responsible for investigating cases of missing children under 18

Pa.C.S. \$ 2908 (relating to missing children).

"Sex trafficking victim." As defined under section 475 of the Social Security Act (49 State).

§ 5702. County responsibilities.

(a) Report of possible sex trafficking victims.--A county agency shall report to law enforcement as soon as practicable, but in no case later than 24 hours after receiving information about a child who:

(1) the county agency has reasonable cause to suspect of

being at risk of being a sex trafficking victim: or

(2) the county agency identifies as being a sex trafficking victim.

(b) Child missing from residence or abducted.--A county agency shall report to law enforcement and to the National Center for Missng and Exploited Children as soon as practicable but no later than 24 hours after receiving information about a child who is missing from the child's residence or is abducted.

(c) Report to department .-- The county agency shall report annually to the department the total number of children who are sex trafficking victims. The report shall be submitted in the form and by the deadline prescribed by the department

§ 5703. Law enforcement responsibilities.

When law enforcement receives information from a county agency about a child who is missing from the child's residence or is abducted under section 5702(b) (relating to county responsibilities), law enforcement shall enter the information into the National Crime Information Center database.

§ 6302. Definitions.

The following words and phrases when used in this chapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

'Age-appropriate or developmentally appropriate." The following:

(1) activities or items that are generally accepted as suitable for children of the same chronological age or level of maturity or that are determined to be developmentally appropriate for a child based on the development of cognitive, emotional, physical and behavioral capacities that are typical for an age or age group; and

2) in the case of a specific child, activities or items that are suitable for the child based on the developmental stages attained by the child with respect to the cognitive, emotional, physical and be-

havioral capacities of the child.

"Caregiver." A person with whom the child is placed in an outof-home placement, including a resource family or an individual designated by a county agency or private agency. The resource family is the caregiver for any child placed with them.

"Out-of-home placement." A setting that provides 24-hour substitute care for a child away from the child's parents or guardians and for whom the county agency has placement care and responsibility. The term includes resource family homes and supervised settings in which a child is living and, for a child who has attained 18 years of age, a supervised setting in which the individual is living independently. The term does not include secure facilities, facilities operated primarily for the detention of children who have been adjudicated delinguent, accredited psychiatric residential treatment facilities or

"Private agency." An entity that provides out-of-home placement services to children under a contract with a county agency.

"Reasonable and prudent parent standard." The standard, char-

acterized by careful and sensible parental decisions that maintain the health, safety and best interests of a child while encouraging the emotional and developmental growth of the child, that a caregiver must use when determining whether to allow a child in an out-ofhome placement under the responsibility of the county agency to par-

ticipate in extracurricular, enrichment, cultural and social activities.

"Resource family." As defined under section 3 of the act of November 22, 2005 (P.L.404, No.73), known as the Resource Family

Care Act.

Section 30. Section 6351(e)(1), (f)(8) and (f.1)(5) of Title 42 are amended and subsection (f) is amended by adding a paragraph to

§ 6351. Disposition of dependent child.

(e) Permanency hearings .--

- (1) The court shall conduct a permanency hearing for the purpose of determining or reviewing the permanency plan of the child, the date by which the goal of permanency for the child might be achieved and whether placement continues to be best suited to the safety, protection and physical, mental and moral welfare of the child. In any permanency hearing held with respect to the child, the court shall consult with the child regarding the child's permanency plan, including the child's desired permanency goal, in a manner appropriate to the child's age and maturity. If the court does not consult personally with the child, the court shall ensure that the views of the child regarding the permanency plan have been ascertained to the fullest extent possible and communicated to the court by the guardian ad litem under section 6311 (relating to guardian ad litem for child in court proceedings) or, as appropriate to the circumstances of the case by the child's counsel, the court-appointed special advocate or other person as designated by the court.
- (f) Matters to be determined at permanency hearing.--At each permanency hearing, a court shall determine all of the following:
- (8) The services needed to assist a child who is [16] 14 years of age or older to make the transition to [independent living] successful adulthood.
- (12) If the child has been placed with a caregiver, whether the child is being provided with regular, ongoing opportunities to participate in age-appropriate or developmentally appropriate activities. In order to make the determination under this paragraph, the county agency shall document the steps it has taken to ensure that:

(i) the caregiver is following the reasonable and prudent

parent standard; and

(ii) the child has regular, ongoing opportunities to engage in age-appropriate or developmentally appropriate activities. The county agency shall consult with the child regarding opportunities to engage in such activities.

(f.1) Additional determination .-- Based upon the determinations made under subsection (f) and all relevant evidence presented at the

hearing, the court shall determine one of the following:

(5) If and when the child will be placed in another planned permanent living arrangement [intended to be permanent in nature] which is approved by the court [in cases where the county agency has documented a compelling reason that it would not be best suited to the safety, protection and physical, mental and moral welfare of the child to be returned to the child's parent, guardian or custodian, to be placed for adoption, to be placed with a legal custodian or to be placed with a fit and willing relative.], the following shall apply:

(i) The child must be 16 years of age or older.
(ii) The county agency shall identify at least one significant connection with a supportive adult willing to be involved in the child's life as the child transitions to adulthood, or document that efforts have been made to identify a supportive adult.

(iii) The county agency shall document:

(A) A compelling reason that it would not be best suited to the safety, protection and physical, mental and moral welfare of the child to be returned to the child's parent, guardian or custodian, to be placed for adoption, to be placed with a legal custodian or to be placed with a fit and willing relative.

(B) Its intensive, ongoing and, as of the date of the hearing, unsuccessful efforts to return the child to the child's parent. guardian or custodian or to be placed for adoption, to be placed with a legal custodian or to be placed with a fit and willing relative.

(C) Its efforts to utilize search technology to find biological

family members for the child.

(iv) The court shall:
(A) Ask the child about the desired permanency goal for the

child. (B) Make a judicial determination explaining why, as of the date of the hearing, another planned permanent living arrangement is the best permanency plan for the child.

(C) Provide compelling reasons why it continues not to be in the best interests of the child to return to the child's parent, guardian or custodian, be placed for adoption, be placed with a legal custodian or be placed with a fit and willing relative.

(D) Make findings that the significant connection is identified in the permanency plan or that efforts have been made to iden-tify a supportive adult, if no one is currently identified.

Section 31. The Department of Human Services of the Commonwealth shall conduct a study to analyze and make recommendations on the permanency goal of another planned permanent living arrangement for children 16 years of age or older. The following apply:

(1) The study shall include recommendations on all of the following:

(i) Strategies to reduce the use of or eliminate the use of the permanency goal of another planned permanent living arrangement.

(ii) Other permanency goal options for children.

(iii) Expected outcomes for children by the reduction of or the elimination of another planned permanent living arrangement as a permanency goal.

(iv) A timeline to achieve the strategies set forth under sub-

paragraph (i).

- (iii) The chairperson and minority chairperson of the Judiciary Committee of the House of Representatives.
- (iv) The chairperson and minority chairperson of the Children and Youth Committee of the House of Representatives.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, before we proceed to a vote on this matter, I ask the Chair for a ruling relative to my son, who is a prosecutor in the Attorney General's Office, and given that the resolution clearly deals with the office, but more importantly potentially deals with the authority that flows from the Attorney General to other prosecutors, including my son, whether or not it is appropriate for me to vote on this matter.

The PRESIDENT. Thank you, Senator Costa. The inquiry you made refers to Rule 20 of our Senate Rules, and from the facts that you have indicated in this Chamber, your son is a member of a class of employees who may or may not have a direct involvement in this case. There is, however, no direct benefit to you. Therefore, not only are you permitted to vote, you must vote on this particular piece of legislation.

Senator COSTA. Mr. President, thank you.

#### POINT OF ORDER

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Mr. President, I ask for a ruling from you under Rule 20 of the Pennsylvania Senate Rules. Even though this is a procedural resolution, I feel it is incumbent upon me to get a ruling from the Chair. I am a declared candidate for the Office of Attorney General, along with several other individuals, and I want to know whether or not I may vote on this resolution.

Thank you, Mr. President.

The PRESIDENT. On the issue that you have posed, Senator Rafferty, the Chair rules that in the situation just described, there is no specific conflict of interest, and that in accordance with Senate Rule 20, you must vote on the resolution. Under our rules, anything which would excuse you from voting on the resolution would have to afford you a benefit which would be particularly personal to you. You are a member of a class of individuals who are running. There are other folks running in Pennsylvania for that office. The Chair does not find that any votes you may cast would be particularly personal to you or privately affect you alone. Therefore, it would be the ruling of the Chair that in the important duty of representing your constituents, you are indeed required to vote on the resolution under our Senate Rules.

Senator RAFFERTY. Mr. President, thank you.

And the question recurring, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I rise to raise some issues and some concerns that I have in regard to whether I believe that the committee has the right to do what they are doing. The Constitution provides for that, and I think they have done an excellent job in obtaining evidence and obtaining the law and that sort of thing. I think it would be better, though, if before we proceeded with this, that we let the matter unfold and play out in regard to some of the charges that have been filed against the Attorney General and see what happens with those matters. If they are adverse to the Attorney General, then that is a different story, but if they are not, then it is another story. So, I would think that we would take our time with this and make sure that we are taking advantage of waiting until the whole process unfolds.

In addition, much of the talk has been about not having a license to practice law, but, in fact, the Attorney General has not been disbarred. There are two actions that you take, a number of actions that you take in the disciplinary board. One of them is a disbarment. At that point, they are not a member of the bar. Under suspension, I understand that they are. They are still subject to the rules of the court. Their right to practice law is suspended, but that is not a basis for removal. Removal would be other facts developed that have been charged here. So, I think it is important for us to — all the statutes refer to that. She has been admitted to the bar. She is a member of the bar. She still continues to be a member of the bar.

So I think it is important to explore this. I think it is important for us to get all of the evidence, and so I rise today and ask if we are going to proceed with this, that the committee spend some time looking at that particular issue, the fact that she is still a member of the bar and does the statute, the Constitution, and the Commonwealth Attorneys Act apply to just those individuals who are members of the bar who are suspended, and whether we would have enough to take action here in this body. I think that is the crucial question here. I ask the committee if they are going to proceed with this to make sure that we are on firm ground. I know the chairman and other Members are well-meaning, fine people, and excellent attorneys, and I am sure it would be well for us to look at that issue before we go too far down the road here. Thank you.

The PRESIDENT. If I understand the gentleman correctly, you are offering input with regard to how the Senate should proceed. You are not asking to amend the resolution or to table it in any way, but I am sure the Senate appreciates your input.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes my friend from the city of Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, I appreciate the cooperation of both sides of the aisle with respect to utilizing this moment for something that is traditionally saved for the end of our legislative Session, the window for us to speak to our Commonwealth, to the State, and, in fact, to the world, since we are online, about our various issues or concerns or ideas that we want to discuss and consequently make them part of the record of the Commonwealth. Again, I thank the body for allowing me this moment.

America is something very special, Mr. President. From the Appalachian region to the Grand Canyon to the great State of Texas, from the beautiful shores of California to the bustling city of Philadelphia, our favorite home, to the city of champions, home of the Steelers, and many more places, America is a great place. But the greatness of America does not lie in the Mississippi River or the Susquehanna River. It does not lie on the banks of the Potomac. The greatness of America does not lie solely in the richness that exists in the Napa Valley or the Silicon Valley, which is the leading entity for technology, not just in this nation, but in the world. The greatness of America does not lie in every acre in every county in the Commonwealth of Pennsylvania. More importantly than anything, Mr. President, the greatness of America lies in its idea of what it is supposed to be and

what it can be. The idea of America, where we all come together and at some point realize our equality and realize our rights and realize our opportunity and that we all see each other equally and respect each other's ideas but also respect each other's differences, respect each other's preferences, respect each other's religions, respect each other so that in this common sense, commonwealth, if you will, of respect, that we all figure out a way to move this nation forward, move our families forward, move our communities forward, and, in fact, given our position in the world, move this nation forward in that context and concept of mutual respect for one another.

That idea is a very delicate one, Mr. President. It has been challenged for over three centuries. That idea is researched, studied, analyzed in schools, in grade schools, in high schools, and colleges. And you, Mr. President, a distinguished member of the bar, and as many of our colleagues are, in fact, also distinguished members of the bar, you spend time as a law student studying the idea of this nation. It is rooted in your basic knowledge and your basic concepts of how you practice law. It is rooted in how we conduct our business here in this Chamber. It is rooted in the fact that in every day and every Session day we have an opportunity to speak our mind without rebuke.

Unfortunately, Mr. President, that idea of America is being challenged right now in a very ugly, demeaning, and terrifying way. The idea of a nation that brings everyone together and works through the rough and tumble of our differences, but allows us to seek that respect and move forward, is being challenged in a very ugly way, in a way that can, in fact, tear this nation apart.

The gentleman who is seeking the highest office in the land, the highest office in our nation, maybe the most powerful position in the world, he has attacked just about every group in this nation. He has attacked the disabled. In fact, during a rally on November 26, the gentleman, whose name is Trump, waved this arms in a way that imitated Serge Kovaleski, a New York Times reporter who has a chronic disability that limits the movement of his arms. Trump was criticizing an article that Kovaleski wrote at that time. Many of us have seen that video. Many of us have witnessed that atrocity. The gentleman, Mr. Trump, claimed that Muslim Americans cheered after the 9/11 attacks during an appearance on "ABC This Week" on Sunday, November 22. He also said on Twitter on Monday, November 9, that the U.S. should block all Muslims from entering the United States. In fact, he also said that they should all be rounded up. That is not America, Mr. President. That is not America to attack the disabled. That is not America to claim that they want to prevent anyone, a particular group, because they practice a faith that happens to be the second-largest in the world, that they should be blocked from this nation, from entering this country. That is not America.

Mr. Trump retweeted a graphic on Twitter on November 22 that falsely implied that African Americans are responsible for more murders of any race than any other group, which contained inaccurate statistics and cited a nonexistent agency as a source. The graphic was later traced to a white supremacist Twitter account. That is not America, Mr. President. That is not who we are. That is not the best of us, and it certainly does not represent the idea of America.

During his announcement speech on June 16, 2015, Mr. Trump said the following about Latino immigrants: "When Mex-

ico sends its people, they're not sending their best. They're sending people that have lots of problems, and they're bringing those problems with them. They're bringing drugs. They're bringing crime. They're rapists." In fact, Mr. President, Trump has said that Latinos should be rounded up in this nation and sent back. Eleven million is the number that should be sent back. Mr. President, that is not America. That is not who we are.

Trump said that women should be judged by their looks: "We could say, politically correct, that look doesn't matter, but the look obviously matters." Trump said to a female reporter in a clip featured on "Last Week Tonight" on September 21, "Like you wouldn't have your job if you weren't beautiful." Numerous times, and we have all witnessed this, Mr. President, Mr. Trump has represented the lowest of the low in his characterization of women, minorities, disabled, and just about every sector of the American population. Megyn Kelly asked why Trump has called women fat pigs, dogs, slobs, and disgusting animals on social media. He said to reporters they are dishonest, generally speaking, in the world of politics. He said about American leaders, "And the Mexican government is much smarter, much sharper, much more cunning. And they send the bad ones over because they don't want to pay for them. They don't want to take care of them. Why should they when the stupid leaders of the United States will do it for them? And that's what is happening whether you like it or not."

He said of the former First Lady of the United States, the former United States Senator, the former Secretary of State for this nation, "I'll tell you what, with Hillary Clinton. She came to my wedding, you know why? She had no choice, because I gave to a foundation that frankly that foundation is supposed to be good. I didn't know her money would be used on private jets going all over the world." He has criticized just about everybody. He has put us all in a position to have to be very conscious about this idea of America and protecting it. This idea where we could all figure out a way to work together. We would all respect each other's differences, but within that respect of each other's differences, figure out a way where we could work together to try to be the best of ourselves, not the worst. Mr. Trump criticized President Obama for praising Muslim American athletes as role models. Mr. Trump also called for a national database to track Muslims in the United States. Mr. Trump has said that U.S. mosques should be under surveillance, regardless of if there was any suspicion of terrorist activity. He represents the worst of us, Mr. President. He represents that which should not be allowed to hold public office, but most importantly, that which we should be on the regular business of denouncing, on a daily basis, every opportunity we can.

You see, Mr. President, when we sit idly by and are quiet and allow for that kind of hate-filled conversation to spread across the national airwaves, to infect the national conversation, to rile up people to take arms, if you will, when you allow that and do not step to it, do not denounce it, do not say something against it, then before you know it, it becomes the will of the land. Before you know it, Mr. President, that hate conversation becomes practiced. This idea of America is very delicate. It should be protected, it should be nurtured, it should be embraced, and it should be defended. It is very imperfect, but in its imperfection there is a sense of beauty and joy about it that allows it to be massaged and worked on, on a daily basis. Although Mr. Trump is an American citizen and is allowed to speak his mind and to

say what is on his heart, which he clearly is doing, we have a responsibility to say, in no uncertain terms, that what he represents is the worst of us, Mr. President. What he represents is something that we cannot work with, tolerate, and we certainly cannot ignore. We are at a very precious and special moment in the history of this nation, and we must always, at all times, express tolerance for anyone, no matter what their differences are, and at the same time, Mr. President, when someone seeks to strike out at those of us who are part of a disabled community or a smaller minority in this nation, that, in fact, we must step to that hatred, call it for what it is, and demand that it be put back in its place and not be allowed to be the public conversation that ripples across this land.

Mr. President, I rise not so much to speak against Mr. Trump. I rise to defend this idea of America. It is special, it is precious, even in its imperfections that we have to work on, on a daily basis; it cannot be allowed to be torn asunder by the likes of a Mr. Donald Trump. We owe it to ourselves and to this institution that we swore on a holy book to defend and protect, to speak loudly and clearly against the comments and the conversation of a Mr. Donald Trump.

### BILL REPORTED FROM COMMITTEE AND REREFERRED

Senator McILHINNEY, from the Committee on Law and Justice, reported the following bill:

HB 1690 (Pr. No. 2653) (Amended) (Rereported)

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, as follows: in preliminary provisions, further providing for definitions. In Pennsylvania Liquor Control Board, further providing for general powers of board. In Pennsylvania Liquor Stores, further providing for when sales may be made at Pennsylvania Liquor Stores and for sales by Pennsylvania Liquor Stores. In licenses and regulations, liquor, alcohol and malt and brewed beverages, further providing for license districts, periods and hearings, for issuance, transfer or extension of hotel, restaurant and club liquor licenses, for sales by liquor licensees and restrictions, for special occasion permits, for wine option permits, for liquor importers' licenses, fees, privileges and restrictions and for interlocking business prohibited; providing for wine expanded permits and for casino liquor licenses; further providing for malt and brewed beverages manufacturers', distributors' and importing distributors' licenses, for malt and brewed beverages retail licenses, for application for distributors', importing distributors' and retail dispensers' licenses, for distributors' and importing distributors' restrictions on sales, storage, etc., for retail dispensers' restrictions on purchases and sales, for interlocking business prohibited and for breweries; establishing the Pennsylvania Malt and Brewed Beverages Industry Promotion Board; further providing for limiting number of retail licenses to be issued in each county, for incorporated units of national veterans' organizations, for licenses not assignable and transfers and for renewal of licenses and temporary provisions for licensees in armed services; providing for license auction; further providing for responsible alcohol management, for local option, for public record, for surrender of restaurant, eating place retail dispenser, hotel, importing distributor and distributor license for benefit of licensee and for shipment of wine into Commonwealth; providing for Pennsylvania Wine Marketing and Research Board; and further providing for unlawful acts relative to liquor, alcohol and liquor licensees, for unlawful acts relative to liquor, malt and brewed beverages and licensees and for identification cards, licensees and State Liquor Store Employees saved from prosecution. In distilleries, wineries, bonded warehouses, bailees for hire and transporters

for hire, further providing for limited wineries and for distilleries. Establishing a wine and spirits wholesale and retail privatization commission.

Upon motion of Senator CORMAN, and agreed to by voice vote, the bill was rereferred to the Committee on Appropriations.
