Senator WOZNIAK. Mr. President, on March 7, 2016, a very good friend of mine and a former Senator, Bill Stewart, passed away of a heart attack while on business in Cleveland. He served in the House of Representatives from 1977 to 1987, when he replaced Mark Singel here in the Senate in 1987, and served until 1996, when I was elected. He worked at Bethlehem Steel as an electrician. He was a small businessman, an ally of labor, he loved his children, and especially his wife, Kitty. His son, last May, died of a heart attack also, at age 40. He is survived by Kitty, his wife; his son, Chris, who is a trainer for the Penguins; and two grandchildren.

He enjoyed his office. He was one of the wittiest people I ever knew. It is interesting, we live in a very difficult political climate, he could read through the political rhetoric and read those tea leaves. He will be sadly missed. He was very energetic for us in Johnstown dealing with the 911 system, the community college without walls, which is now our community college, and also dealing with a lot of issues while in the Senate dealing with brownfields. So his legacy will live on with his good works. I want to spend a moment of time and have a moment of silence in respect for a former colleague and a friend, Senator Bill Stewart.

The PRESIDENT. A moment of silence will now be honored in memory and in thoughts to our former colleague, Senator Stewart, on behalf of Senator Wozniak.

(Whereupon, the Senate en bloc stood in a moment of silence in solemn respect to the memory of the Honorable WILLIAM J. STEWART.)

The PRESIDENT. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, before we move on to the next order of business, if I could make a couple of remarks. I did not get the opportunity to serve with Senator Stewart, but I did know him fairly well. I worked in Harrisburg as a staff person for United States Senator Rick Santorum at the time and I spent some time here at the Capitol. Senator Stewart, who did not need to give me any time of day, was always very courteous in his time with me and was very kind. He was a gentleman to work with. We have a fraternity--maybe that would be incorrect with gender--sorority or fraternity here in the Senate that when you serve in this body, it is a special place to serve. When one of us passes, it affects all of us. From our side of the aisle I want to say what a nice man he was. He was always very courteous to everyone who came to his office, whether they were important or not. He always extended the olive branch to people.

So, we will miss him here as well, but as all Members of the Senate are, they are here for public service, and that was what Senator Stewart was here for. I know Senator Wozniak filled his shoes very well, but he left a mark in his district, in Johnstown in particular, and he will be missed.

Section 2. Definitions.

The following words and phrases when used in this act shall have

the meanings given to them in this section unless the context clearly indicates otherwise:

"Account." The Plant Pest Management Account established in section 9

"Agricultural pilot program." The program under section 3 to research the growth, cultivation, marketing and sale of industrial hemp to ensure that institutions of higher education, and sites and persons utilized by the institutions of higher education, grow or cultivate industrial hemp as authorized under this act.

"Department." The Department of Agriculture of the Commonwealth.

"Industrial hemp." The plant cannabis sativa l. and any part of the plant, whether growing or not, with a delta-9 tetrahydrocannabinol concentration of not more than 0.3% on a dry weight basis.

"Institution of higher education." An institution which:

- (1) meets the definition set forth in section 101 of the Higher Education Act of 1965 (Public Law 89-329, 20 U.S.C. § 1001); and
 - (2) is located in this Commonwealth.

"Secretary." The Secretary of Agriculture of the Commonwealth. Section 3. Industrial hemp.

- (a) Authority.--Notwithstanding any other law to the contrary, the department may implement the agricultural pilot program to research industrial hemp consistent with this act and Federal law.
- (b) Permits.--An institution of higher education, or a person that supplies services to the institution of higher education to implement or operate the agricultural pilot program, may apply to the department for a permit under section 4(3).
- (c) Oilseed.--Industrial hemp shall be recognized as an oilseed in this Commonwealth.
- (d) Prohibition.--A person may not grow, cultivate, market or sell industrial hemp unless all of the following apply:
- (1) The person is part of the agricultural pilot program pursuant to a contract with an institution of higher education.
- (2) The person has a permit under section 4(3).

Section 4. Department.

The department has the following powers and duties:

- (1) To develop and implement the agricultural pilot program in this Commonwealth.
 - (2) To promulgate regulations under section 5.
- (3) Subject to the Controlled Substances Act (Public Law 91-513, 84 Stat. 1236), the Safe and Drug-Free Schools and Communities Act (Public Law 107-110, 20 U.S.C. § 7101 et seq.), 41 U.S.C. Ch. 81 (relating to drug-free workplace) and notwithstanding the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, and 18 Pa.C.S. § 7508(a)(1) (relating to drug trafficking sentencing and penalties), to issue, renew, deny, revoke, suspend or refuse to renew a permit as follows:
- (i) For an institution of higher education to conduct research relating to the cultivation or marketing of industrial hemp.
- (ii) For a person that contracts with the department or an institution of higher education as necessary to implement the agricultural pilot program.
- (4) To establish requirements for the use or reuse of seeds, crops or products produced as the end result of the agricultural pilot program.
- (5) To adopt and publish permit fees, which do not exceed the actual cost of administering this act.
- (6) To create and maintain a database of institutions of higher education and persons that have permits under paragraph (3).
- (7) To inspect facilities, sites, seeds, plants, individual growers and persons or things utilized as part of the agricultural pilot program to ensure compliance with this act and regulations promulgated under this act.
- (8) To ensure that no industrial hemp is grown, cultivated, marketed or sold except in accordance with this act. Section 5. Regulations.
- (a) Authority.--The department may promulgate regulations to ensure compliance with this act and policies and procedures of the department. Regulations include the following:
 - (1) Research.
- (2) Notwithstanding 3 Pa.C.S. Ch. 71 (relating to seed) and regulations promulgated under that chapter, labeling, packaging and testing of industrial hemp and industrial hemp seeds.
 - (3) Applications and other information required to be submit-

ted to the department.

- (4) Marketing and advertising of industrial hemp.
- (b) Temporary regulations.--
- (1) Within three months of the effective date of this paragraph, in order to facilitate the implementation of this section, the department may promulgate temporary regulations.
- (2) Temporary regulations shall not be subject to any of the following:
- (i) Sections 201, 202, 203, 204 and 205 of the act of July 31, 1968 (P.L.769, No.240), referred to as the Commonwealth Documents Law
- (ii) Sections 204(b) and 301(10) of the act of October 15, 1980 (P.L.950, No.164), known as the Commonwealth Attorneys Act.
- (iii) The act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act.
- (3) Temporary regulations shall expire two years after the effective date of this section.

Section 6. Contracted persons.

An institution of higher education holding a permit to conduct an agricultural pilot program may contract with entities and individual growers to the extent necessary to carry out the agricultural pilot program. The contract terms must incorporate the provisions of the permit. The entity or individual grower shall be subject to the terms and requirements of the permit issued to the institution of higher education and to enforcement by the department for a violation of any of the following:

- (1) This act.
- (2) A regulation issued under this act.
- (3) The permit.

Section 7. Noncriminal offense.

The department may assess a civil penalty of not more than \$5,000 for a violation of this act.

Section 8. Criminal penalties.

- A person that violates section 3(d) commits a summary offense. Section 9. Account.
- (a) Deposit.--Money received from licensing, permitting fees, fines and penalties under this act shall be paid into a special restricted account in the General Fund known as the Plant Pest Management Account. All money deposited in the account is appropriated to the department for the purposes of this act and the act of December 16, 1992 (P.L.1228, No.162), known as the Plant Pest Act, and may not replace money appropriated to the account as provided in subsection (b).
- (b) Supplements.--The account may be supplemented by money received from the following sources:
- (1) State money appropriated to the department for purposes of this act.
- (2) Federal money appropriated to the department for purposes of this act.
- (3) Gifts and other contributions from public or private sources for purposes of this act.

Section 10. Expiration.

- (a) Federal action.—If the United States Department of Agriculture is authorized to regulate industrial hemp, the secretary shall transmit notice of the authorization to the Legislative Reference Bureau for publication in the Pennsylvania Bulletin.
- (b) Date.--This act shall expire 60 days after publication of the notice under subsection (a).

Section 11. Effective date.

This act shall take effect as follows:

- (1) The following provisions shall take effect immediately:
- (i) Section 3(a).
- (ii) Section 4(1) and (2).
- (iii) Section 5.
- (iv) Section 10.
- (v) This section.
- (2) The remainder of this act shall take effect in 60 days.

recognized as Rare Disease Awareness Day, and since we were not in Session on that day, I did not want to let the occasion pass without recognizing the important day and, more importantly, the Pennsylvania families who are loving and supporting someone with a rare disease. For many families, their lives have been changed forever by the diagnosis of a rare disease. These diseases are conditions that affect fewer than 200,000 Americans at any given time. Many of these conditions have genetic origin, and more than 50 percent of them are diagnosed in our children. Today, Mr. President, my request for recognition of Rare Disease Awareness Day is on their behalf.

Many of these rare diseases are seldom discussed, but that needs to change. The more we raise awareness of these diseases like Pompe disease or Krabbe disease, maybe the sooner we will find a cure. Families like the Brackbills and their daughter, Tori, from right here in Harrisburg, and the Krabbe Foundation are fighting every day toward a cure on behalf of those children. These are just a few of the examples, Mr. President. These families need our support and they need our help raising awareness as they work with medical teams to find effective treatments that hopefully and ultimately lead to a cure. I am asking that you, Mr. President, and my colleagues join me today and every year on the last day of February doing the same.

Will the Senate adopt the resolution?

The PRESIDENT. The Chair, with trepidation, notices green ties out there. He is already jealous of his colleagues who are about to offer a very special resolution. Who shall go first? In a good, kind Irish gesture, Senator Blake has deferred to his colleague, friend, and fellow Irishman, the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Mr. President, faith and begorrah. It is an honor to be here this afternoon with my friend and colleague, Senator Blake. This is something that I have done since I was a Member of the Senate with you, Mr. President, when you were a Member of the rank and file here in the Senate, and it is a nice tradition to continue.

We celebrate our Irish ancestry this month. It is a time for us to reflect in many ways on a joyous occasion, but also a very solemn and religious occasion. Our ancestors fled Ireland due to famine, political persecution, and religious persecution and came to the United States of America for a better life for themselves and for their families. We know the Irish American history throughout the Commonwealth of Pennsylvania. Many of them were miners, many of them built the railroads, many of them worked in industry throughout the Commonwealth, and, of course, the Irish are known for staffing the religious orders of priesthood, for the police officers, and for government officials.

Mr. President, as we celebrate this month, we need to take time to reflect on the Irish American involvement in the founding of this country and for the endurance to make sure this country lasted through strife, from the colonel who led the Pennsylvania Longrifles, who was an Irishman, to Gettysburg, where the Irish Brigade certainly stood at the forefront in protecting the Union and turning back the Confederate tide. General Meade, who, himself, was of Irish ancestry, headed the Union forces that day, and for the many who have served this country in a noble way, and continue to serve this country in a noble way.

Each of us, we hope, in our actions for the Commonwealth of Pennsylvania, reflect the great St. Patrick, the apostle of Ireland, who was kidnaped and taken prisoner to Ireland, fell in love with the country and the people, and took a pagan country and made it a bastion of Christianity. It is that same selfless service and living faith in our actions that really is characteristic of Irish Americans. I am proud to stand here today with Senator Blake to ask for unanimous support on this resolution for the month of March 2016 to honor Irish Americans here in the Commonwealth of Pennsylvania.

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Blake.

Senator BLAKE. Mr. President, I am honored to stand with my colleague, Senator Rafferty, and ask for unanimous support of this resolution to celebrate Irish heritage. As Senator Rafferty said, the fortitude, the grace, the faith, and the perseverance of the Irish is woven into our own country here in the United States of America and certainly woven into our own State of Pennsylvania. In 1964, Robert F. Kennedy, in his first public speech after the assassination of his brother, the President, came to Scranton to the 22nd Senatorial District and delivered what is, indeed, a most remarkable and impassioned speech. He talked about life not always being so good for the Irish, in the old country or here in the U.S. He called attention to that black day in February of 1847 when it was announced in the House of Commons that 15,000 Irish were dying of starvation every day. The Irish have suffered subjugation in their own land and discrimination here, but perseverance and faith achieved independence for the Irish Republic. The Good Friday Agreement, which was facilitated in part by George Mitchell, a former U.S. Senator, has created an economic and social cooperation between the UK, Northern Ireland, and the Republic of Ireland that lasts until this

No one who knows the story of the Irish would say it was easy here, but it is worth noting that all of the wealth of our legacy stems from an island in the far Atlantic that has a population one-fourth that of Pennsylvania. This past Saturday, Senator Rafferty and I were able to enjoy a big Irish celebration in Scranton with the second-largest St. Patrick's Day parade in the nation. It was a gorgeous day, 10 deep, and the crowds were so proud in celebrating their Irish heritage. Again, perseverance and

faith, the two hallmarks of the Irish heritage that have put such a mark on us here in Pennsylvania.

I tell you also, Mr. President, to close up my remarks, this past week I had a chance to listen to a wonderful speech by the Irish ambassador to the United Nations, David Donoghue, who was at the University of Scranton. He talked about how Ireland is such a trusted broker in the United Nations. They are a trusted broker because of the history and legacy that they have had. The Irish troops can go and stand on the wall between Syria and Israel, but because they are not a member of NATO, it does not upset our Russian friends. The point is they are very, very special and they are trusted. The most recent unanimous consent strategy in the United Nations going to 2030 was brokered in part by the Irish ambassador to the UN. So the prominence to which Ireland has risen is really worldwide.

I am delighted to be with my friend and colleague, Senator Rafferty, to ask for unanimous support to acknowledge this month for Irish heritage, and in the Gaelic language I can say to the Irish in Gaelic: Go raibh maith agat. Thank you very much.

The PRESIDENT. I could not have said it better myself. I apologize, once again, for not having my green tie on, Senator Rafferty, but I will every day the rest of this week and the week after.

Senator VULAKOVICH. Mr. President, I rise today to ask my colleagues to support this resolution designating March as "American Red Cross Month" in Pennsylvania. The American Red Cross was founded by Clara Barton in 1881, and since then it has been at the forefront of helping Americans prevent, prepare for, and respond to large and small disasters. Today's Red Cross is focused on providing compassionate care in five critical areas: people affected by disasters, support for members of the military and their families, blood collection processing and distribution, health and safety education and training, and international relief and development.

The resolution that Senator Baker, Senator Costa, and I are introducing recognizes the important role that the American Red Cross plays in communities across Pennsylvania. In fact, the Red Cross responded to 2,479 disasters in 2015 and provides assistance to families impacted by disaster in all 67 counties. As every one of us is aware, this represents a year-round effort, since disasters do not take a holiday or vacation. While the disaster response efforts are in some ways the most visible part of the Red Cross mission, we should not forget the important role that the organization plays in providing a number of training courses in our communities. More than 225,000 Pennsylvanians have received training through first aid, CPR, water safety, and other programs. This year's focus is on "No More Fire Deaths" with the American Red Cross partnering with the local fire departments to insure that anyone that needs a working smoke alarm can get one.

I personally want to thank the 7,252 Pennsylvanians who served as volunteers for the American Red Cross in 2015. Their efforts truly are appreciated, and it is with them in mind that I offer this resolution. Mr. President, I conclude by asking my colleagues to join me in saluting the American Red Cross and its 44 member chapters with an affirmative vote on this resolution. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, Shada Mahone, 26 years old; Jerry Shelton, 35 years old; Tina Shelton, 37 years old; Chanetta Powell, 25 years old, along with her unborn child; and Brittany Powell, 27 years old - each of these individuals was tragically gunned down in the community of Wilkinsburg in Allegheny County last Wednesday evening. Mr. President, each name quickly becomes a statistic in our environment and our communities. These are the faces of the victims of the growing violence in each of our communities. Last Wednesday it was in Wilkinsburg, the mass shooting that I referenced, and earlier today or last evening it was in Homestead, where a murder-suicide occurred. Three people were shot and two were murdered. And if we think it cannot happen in each of our own little small towns, this is evidence that it can.

We all share, Mr. President, in my view, the responsibility to help our communities heal, and recently I participated in community meetings this weekend to try to do that. While it was refreshing to be able to participate and help folks grieve in the community and be a part of that grieving, we all need to recognize, both in our communities and here, that we need to come together and work together before tragedy strikes. Collectively, we need to build our communities and support families who are living in those communities, and one may ask what it is that we could do here in Harrisburg that allows for the ability to help folks in our communities address some of these issues, like gun violence that I just referenced, and the horrible situation that occurred last Wednesday evening, or how it is that we can deal with the drug epidemic that has taken over our counties. Allegheny County, Westmoreland, you name it, each of our counties across Pennsylvania is suffering along those lines as well.

Mr. President, in my view, there is a lot we can do. First and foremost, as elected representatives of the people in those communities who have been impacted, those today and those who will ultimately be impacted at some later point in time and those folks who are struggling with many of the things that they need to try to do, to try to find a job, to be able to try to find a solution to a particular problem that they are dealing with, whether it be an addiction to a drug, whether it is addiction to alcohol, or whether it is simply not having the ability to be prepared to find

an appropriate job to support a family, there are things that we can do first and foremost in our communities to serve as facilitators to be able to connect folks who need these types of services to those services.

There are also things we can do here in Harrisburg, Mr. President, and that is where I would like to take the conversation today. While our hearts grieve for the men and women across this Commonwealth and across this country who lose their lives to gun violence and the other things I mentioned, there are things that we can do as a Commonwealth to be able to work to try to make sure that we assist as many folks as possible to help them. Finding a job requires a couple of things. It requires the level of investment in education that I think is going to allow for folks to be able to attain the education that they need, most importantly starting with our young kids, our young children. Early learning programs and preschool programs. Early learning programs, which I have said on this floor countless times are, to me, the best investment we can make, because if we do not work with folks to build the appropriate foundation, we will not allow folks to build upon that foundation to allow folks to grow and flourish.

Even K through 12 needs to make certain that the schools they attend are schools that are significant and they make a difference and that they mean well in terms of the education that they are providing. This particular community of Wilkinsburg that I reference has been suffering for a number of years with respect to, in my view, a lack of investment in education, ultimately culminating this fall with the closing of their high school. Fortunately, we have been able to work with the community, myself and Representative Gainey and Representative Wheatley, along with the city of Pittsburgh School District and Dr. Linda Lane, to be able to transition students from that school into the city of Pittsburgh School District, which I think will provide them with opportunities and hope, the ability to be able to get a first-class education and then continue to grow and flourish. It goes beyond that. It goes to higher education and providing opportunities in today's world where you need some type of a degree or certificate that reflects your ability to have a higher degree of learning beyond high school, or experience or training. Those resources need to be there and support needs to come from this Commonwealth along those lines.

Probably, Mr. President, the area where I think we are lacking the most in a number of these communities relates to the areas of what I refer to as human service programs. The major changes that have taken place over the years with respect to human service programs, not having community programs, whether it be drug and alcohol programs that were an integral part of the community that provided the wrap-around services and identified folks who had issues that needed to be dealt with, those are the types of programs that we have lost focus on and we have not been able to fund properly over the past several years. We continue to fight to want to make those investments, to be able to have pride for the programs, the social service agencies, and the wrap-around services to men and women and teens, in particular, in our communities to allow them the opportunity to have a place to go when they have issues that they are dealing with, whether it be drug or alcohol related.

Mr. President, with respect to mental illness, we have seen what has happened throughout this country with individuals who have had access to weapons who are suffering from mental illness. I know our former colleague who worked with many of us

here in this Senate, Congressman Tim Murphy, has been at the forefront of that conversation in Washington, D.C. We certainly hope that he is able to get other folks to listen and understand what he is trying to say, because it is an important conversation that has to take place. Again, Mr. President, it is something that, here in this General Assembly in Pennsylvania, we have not provided adequate resources for the past several years, and those programs, those community programs, those community networks, the conversations that need to take place in the community with providers and people who are working the streets understand and know that those programs are there, but yet, there is nobody there to be able to reach out to the folks who need our help. They need the help of government, and that is where government comes in.

Finally, Mr. President, in the area of jobs, if we want to work with folks to be able to help them build themselves up and bring themselves up, help them not resort to a life of crime, we have to be able to provide jobs and we have to have an understanding about what that means when we want to be able to provide jobs. That means we invest in our communities and neighborhoods, we invest in the rehabilitation of our neighborhoods, but more importantly, we let folks know that there is a path for men and women who want to be able to be part of the workforce, that there is a way in which we can do that. There are a variety of ways to achieve that. Investments in higher education, I referenced earlier, but more specifically into our community colleges in programs through the workforce programs that provide resources to help grab folks off the streets, get them the appropriate level of training, get them to understand what it means to be a solid and good employee, to be able to go to work, have a family, own a home, and be part of a community. That is what is lacking in many of these communities that we are dealing with. It is our responsibility to look at all of those issues and to make certain that we make the appropriate level of investments, that we have the appropriate level of commitment to work with individual organizations and men and women who are leaders in those communities.

Mr. President, at the services I attended over the weekend, I saw countless men and women who came to the podium and talked about the programs that they have participated in, how it is that they have worked day in and day out trying to get kids off the streets, trying to get young men and women in the right direction, trying to work with them to find out what it is that makes folks angry and why they go down the path that they go down. I learned a lot over the course of this weekend with respect to this, that there are so many people who want to do the right thing, but we need to assist them and supplement what it is that they are doing. They are doing the day-to-day grunt work, we have the ability to provide the resources to a community like Homestead or Wilkinsburg or any other community throughout the region and Commonwealth to be able to work with them. In my view, those are the ways in which we can diminish and beat back some of this violent crime that we see taking place in our communities across Pennsylvania.

So I appreciate my colleagues allowing me the opportunity to talk a little bit about a horrific incident that took place in the Pittsburgh region over the weekend, but more importantly, extend my sympathies certainly to the family members, and, quite frankly, this was a situation where there were many family members who lost their lives. At the end of the day, Mr. President, we

have to figure out a way to stop this violence and we have to figure out a way to work with organizations and provide resources to programs that allow us to be able to get our hands into the middle of what is going on and be able to work with folks and help them down an appropriate path as we go forward. So, on behalf of myself and my family, and my colleagues here, we extend our deepest, deepest sympathies to the Mahone, Shelton, and Powell families for their horrific loss and pray to God that as we go forward, we will figure out a way to make this all work.

Thank you, Mr. President.

The PRESIDENT. The Chair acknowledges that we must find a solution. The Chair joins you, Senator Costa, in sending out our deepest sympathies and prayers to the Mahone, Shelton, and Powell families, to the greater Wilkinsburg, Homestead, and Pittsburgh area.
