TUESDAY, March 15, 2016

The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Mike Stack) in the Chair.

#### **PRAYER**

#### BILLS REPORTED FROM COMMITTEES

Senator VOGEL, from the Committee on Agriculture and Rural Affairs, reported the following bills:

SB 1123 (Pr. No. 1544)

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, in weights and measures, further providing for standards for automotive fuel.

HB 806 (Pr. No. 2948) (Amended)

An Act amending the act of December 19, 1974 (P.L.973, No.319), known as the Pennsylvania Farmland and Forest Land Assessment Act of 1974, further providing for land devoted to agricultural use, agricultural reserve, and/or forest reserve, for responsibilities of department and for responsibilities of county assessor in establishing use values.

Senator TOMLINSON, from the Committee on Consumer Protection and Professional Licensure, reported the following bills:

#### SB 881 (Pr. No. 1604) (Amended)

An Act amending Title 66 (Public Utilities) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for the definition of public utility.

#### HB 1326 (Pr. No. 2396)

An Act amending Title 66 (Public Utilities) of the Pennsylvania Consolidated Statutes, in rates and distribution systems, providing for valuation of acquired water and wastewater systems for ratemaking purposes.

Senator SMUCKER, from the Committee on Education, reported the following bills:

#### SB 1122 (Pr. No. 1536)

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in community colleges, further providing for election or appointment and term and organization of board of trustees.

#### SB 1159 (Pr. No. 1595)

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in preliminary provisions, providing for review of the State plan required under the Every Student Succeeds Act.

#### HB 423 (Pr. No. 458)

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school health services, providing for administration of epinephrine auto-injectors by school bus drivers.

#### HB 1734 (Pr. No. 2598)

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in certification of teachers, further providing for continuing professional development, for program of continuing professional education and for charter schools.

Senator GREENLEAF, from the Committee on Judiciary, reported the following bills:

#### SB 579 (Pr. No. 1605) (Amended)

An Act amending Titles 18 (Crimes and Offenses), 22 (Detectives and Private Police), 23 (Domestic Relations), 42 (Judiciary and Judicial Procedure), 44 (Law and Justice) and 61 (Prisons and Parole) of the Pennsylvania Consolidated Statutes, in general provisions, providing for short title of title; codifying provisions relating to the Pennsylvania

Commission on Crime and Delinquency, to sheriffs and to crimes victims; and making editorial changes and related repeals.

#### **SB 1031 (Pr. No. 1606)** (Amended)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, providing for conflicts of interest; and repealing and adding provisions relating to independent counsel.

#### HB 665 (Pr. No. 1187)

An Act amending Titles 20 (Decedents, Estates and Fiduciaries) and 57 (Notaries Public) of the Pennsylvania Consolidated Statutes, in powers of attorney, further providing for general provisions; and, in Revised Uniform Law on Notarial Acts, further providing for short form certificates, for implementation of power of attorney and for durable powers of attorney.

Senator VULAKOVICH. Mr. President, I rise in support of Senate Bill No. 1013. I thank Senator Hughes for working with me and the Committee on Veterans Affairs and Emergency Preparedness on advancing this important piece of legislation. While Pennsylvania local governments have had veterans preference for a number of years, without this legislation, private sector businesses are not able to set up similar policies for recruitment and retention of those who have served in the military. Twenty-seven States, including Washington, which was the first State, have passed laws to recruit and retain veterans within the private sector.

We all owe a debt of gratitude to those veterans who served the nation in times of peril, and hiring a veteran is not just a noble idea, but it is important to note that a veteran is likely to possess courage, consistency, habits of obedience, and fidelity, qualities that are important in any field of work. Again, I thank Senator Hughes for championing this legislation. I look forward to moving this bill through the House.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, briefly, let me also say thank you to the Members of the committee, and thank you to Senator Vulakovich for helping and working with us to move this legislation forward. It allows for private employers to adopt and apply a veterans hiring preference. It covers veterans, their spouses, disabled veterans, surviving spouses of a veteran, and it is completely voluntary for the private employer.

I will not prolong the conversation, but this is a good piece of legislation to help deal with those men and women who have put their lives on the line to allow us to be in this Chamber to do what it is that we do, which is to speak to democracy and all of the good values that come from it.

Senator HUTCHINSON. Mr. President, I rise today to ask my colleagues for an affirmative vote on this resolution recognizing

the week of March 20 through 26, 2016, as "Maple Producers Week" here in Pennsylvania. The maple syrup industry has a rich and long history in Pennsylvania. Native American tribes in North America were the first to have produced maple syrup and maple sugar. When the Europeans came to America, they learned from the Native Americans how to farm the syrup from the trees and they began to harvest it themselves. Over the next 250 years, this harvesting grew into the industry that we have today.

Today, the northeast region of the United States is one of the top maple syrup producing regions in the world, and Pennsylvania contributes significantly to this production. As a Commonwealth, we produce more than 160,000 gallons of maple syrup from over 600,000 taps. The sap that is tapped from these trees is then used in Pennsylvania to make numerous different food products, most importantly, maple syrup. Mr. President, adoption of this resolution raises awareness and knowledge of this crucial industry in Pennsylvania, which in turn helps us to grow and strengthen the industry's presence in our State. I ask my colleagues for their support.

The PRESIDENT. The Chair recognizes the gentleman from Erie, Senator Wiley.

Senator WILEY. Mr. President, today I rise to ask unanimous support for this resolution designating the week of March 13, 2016, as "Poison Prevention Week" in the Commonwealth. I offer this resolution to not only help raise awareness of the staggering frequency of accidental poisonings, but also to recognize the important work of poison control centers across the Commonwealth and the nation, work that is currently in jeopardy due to the suspension of funding during this budget impasse.

Ninety-four percent of accidental poisonings occur in the home, with a majority of exposures being unintentional. Half of the nearly 2 million calls to poison control centers each year are for exposure and ingestion among children age 5 or under. The leading causes of non-medication exposure calls to poison control centers for children age 5 and under are cosmetics, personal care products, household cleaning substances, pesticides, and plants. Additionally, a tremendous number of children are seen in an emergency department setting for accidental medication exposures, with many children requiring further hospitalization. The American Association of Poison Control Centers supports

the nation's 55 poison centers, as well as providing information, advocacy, education, and research. Poison control centers are staffed 24 hours a day with trained personnel who provide lifesaving instructions and resources to callers.

According to Safe Kids Worldwide, a global organization dedicated to preventing injuries to children, each dollar spent at a poison control center saves approximately \$7 to \$15 in unnecessary healthcare expenses. In the 49th Senatorial District, in which I serve, Safe Kids Erie plays an important role in poison prevention in the greater Erie community. Under the direction of long-term coordinator Patty Puline, Safe Kids Erie has been working with local parents and families to raise awareness of injury prevention since 1991 with over 200 member agencies. I am proud and honored to be one of the founding members of Safe Kids Erie and to continue to support the great work that is done to protect the children and families in the 49th Senatorial District.

Mr. President, the prevention of accidental poisoning can be accomplished in a few simple steps, and I ask that my colleagues not only join me in supporting this resolution, but also further support organizations and movements like Safe Kids in their own districts. Thank you.
