The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Mike Stack) in the Chair.

#### **BILL AMENDED**

**SB 180 (Pr. No. 1678)** -- The Senate proceeded to consideration of the bill, entitled:

An Act amending Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes, in anatomical gifts, further providing for definitions, for persons who may execute anatomical gift, for persons who may become donees and purposes for which anatomical gifts may be made, for manner of executing anatomical gifts, for amendment or revocation of gift, for rights and duties at death, for requests for anatomical gifts, for use of driver's license or identification card to indicate organ or tissue donation, for the Governor Robert P. Casey Memorial Organ and Tissue Donation Awareness Trust Fund contributions, for the Governor Robert P. Casey Memorial Organ and Tissue Donation Awareness Trust Fund, for confidentiality requirement and for prohibited activities; providing for promotion of organ and tissue donation; establishing the Donate Life PA Registry; providing for facilitation of anatomical gift from decedent whose death is under investigation, for collaboration among departments and organ procurement organizations, for information relative to organ and tissue donation, for requirements for physician and nurse training relative to organ and tissue donation and recovery, for uniformity of application and construction and for relation to Electronic Signatures in Global and National Commerce Act; and repealing provisions relating to corneal transplants.

On the question,

Will the Senate agree to the bill on third consideration? Senator BROOKS offered the following amendment No. A7232: Amend Bill, page 8, by inserting between lines 15 and 16:

(b.2) Minors.--Notwithstanding subsection (b), if the decedent is a minor, only the following persons, in the absence of known objections by the decedent, in order of priority stated, may give all or any part of the decedent's body for any purpose specified in section 8612:

(1) Either parent.

(2) A guardian of the person of the minor decedent at the time of the minor's death.

(3) An adult sibling with an established relationship with the minor decedent.

(4) A grandparent with an established relationship with the minor decedent.

On the question,

Will the Senate agree to the amendment?

The PRESIDENT. The Chair recognizes the gentlewoman from Mercer, Senator Brooks.

Senator BROOKS. Mr. President, this conversation of organ donation is abundant with emotions of tragedy, heartache, and, yet, of hope. For one family, it is one of great heartache as they will say goodbye to a lost loved one. Yet for another family, it is one of great hope that their loved one will have a renewed opportunity of life. This amendment supports organ donation, but it gives a clearer direction in respecting the parents' wishes for their minor child with whom they are saying goodbye.

Mr. President, I ask for an affirmative vote on this very important amendment. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, as the gentlewoman from Mercer mentioned, this legislation has been around for a couple of years. We have been negotiating and working with it and it is a very emotional conversation to have, particularly in light of the subject matter, of course. With respect to the particular amendment that is being offered. I ask for a negative vote. As we know, there have been significant negotiations that have taken place along these lines which we believe resulted in an omnibus comprehensive amendment that was introduced, I believe with the work of Senator Greenleaf and others. We believe that needs to be the final word as we move this process forward because this has been a piece of legislation that has been around for a number of years and we need to move the process forward.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Mercer, Senator Brooks, for the second time.

Senator BROOKS. Mr. President, without this amendment, if a minor child is tragically killed, then the decision would lie on someone to make regarding what happens with the organs and the body of that child. What this amendment does is it lists that a parent, a guardian, an adult sibling with an established relationship with a minor decedent, or a grandparent with an established relationship with a minor decedent would have the right to make that decision for the minor child.

If this amendment does not go into this legislation, if you look on page 7 of the bill, "(9) a person with an established relationship with, and who exhibited special care and concern for, the decedent..." could make this decision for a minor child. A neighbor, a seventh cousin, or someone whom they are not even close to could make the decision to donate your minor child's organs.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa, for the second time.

Senator COSTA. Mr. President, again, I certainly understand the gentlewoman's concern about decisionmaking in what was described as a horrible situation, but, I think as was described by the gentlewoman, the items that are enumerated in the amendment coincide, except for just a couple, with page 7 of the legislation. Let us be clear that the situation of the hypothetical proposed where you have a decedent minor would be as with any decedent, the folks who would make a decision relative to the organs of that particular decedent would continue to, first and foremost, be: a parent of the decedent, then an adult sibling of the decedent, a guardian of the decedent, an adult grandchild of the decedent, or a grandparent of the decedent. Only then do we get to that what I would call fifth category out of those nine where that provision would apply.

So, clearly, I think this conversation about the amendment was contemplated as a default position as it related to this particular section that we talked about on page 7 of Senate Bill No. 180. So, I want to be clear and have Members understand that.

Mr. President, cystic fibrosis, which is commonly referred to as CF, is a genetic disease affecting about 30,000 children and adults in the United States, and about 1,460 of them live in our Commonwealth. The disease causes the body to produce an abnormally thick sticky mucus that clogs the lungs. These secretions result in life-threatening lung infections and obstruct the pancreas, preventing digestive enzymes from reaching the intestines to help break down and absorb food.

More than 10 million Americans are symptomless carriers. They do not know that they have the defective CF gene. With advances in the treatment of CF, the median age of survival has risen to 41 years of age. I ask the Senate to join me in supporting this resolution.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, I rise today, along with my colleague, Senator Teplitz, to offer this resolution designating May 2016 as "Amyotrophic Lateral Sclerosis Awareness Month" in Pennsylvania. ALS, also known as Lou Gehrig's Disease, is a progressive neurodegenerative disease that affects nerve cells in the brain and the spinal cord. The initial symptoms of ALS can vary from person to person. One person may have trouble grasping a pen or lifting a coffee cup, while another may experience a change in vocal pitch when speaking. Unfortunately, in virtually every case, those affected by ALS are unable to live a normal life. As ALS takes over, muscles weaken, leading to impaired use of the arms and legs. Eventually, the disease takes away the ability to walk, dress, write, speak, swallow, and even breathe. Incredibly, since ALS only attacks only motor neurons, the senses of sight, touch, hearing, taste, and smell are not affected.

In addition to the physical suffering, there could be significant costs for medical care, equipment, and home health caregiving later in the disease. At any given time, there are as many as 30,000 Americans living with ALS. It is estimated there are 1,000 Pennsylvanians currently battling the disease. For unknown reasons, Mr. President, military veterans are approximately twice as likely to be diagnosed with the disease than the normal general public, making ALS a service-connected disease. Most diagnoses occur between people 40 and 70 years of age, but cases of the disease do occur in persons in their 20s and 30s.

Lou Gehrig, one of the greatest baseball players of all time, died from ALS when he was only 38 years old. In the past few years, ALS researchers have made significant progress in identifying new genes and biomarkers to understand the progression of the disease and to get us closer to finding a cure. In Pennsylvania, the ALS Association supports ALS families through multiple treatment centers providing wheelchairs, ramping, speech devices, and offering in-home care programs, as well as educating people with ALS and their care groups.

The funding the General Assembly has appropriated to ALS patient care in this Commonwealth goes a long way under the guidance of these organizations to improve the quality of life of those living with the disease. I hope with our recognition today we will advocate for more research and give patients living with ALS and their families much needed support in their search for a cure.

Thank you, Mr. President.

Senator TEPLITZ. Mr. President, I rise to join Senator Farnese in urging our Senate colleagues to designate the month of May 2016 as ALS Awareness Month in Pennsylvania. ALS awareness holds a personal meaning for me. My grandfather died of complications of ALS, and there was nothing my family or any doctors could do to stop the progression of the disease. So I thank the advocates for joining us in the Capitol this week to raise awareness about this terrible disease and to share their sto-

ries. It is our hope that we can continue to support patients and researchers so that one day we can find a cure for ALS.

So I ask my colleagues to join Senator Farnese and me in declaring the month of May 2016 as ALS Awareness Month in Pennsylvania.

Senator BARTOLOTTA. Mr. President, lung cancer is the number one cancer killer of women, killing almost twice as many females as any another cancer. On average, less than half of all women diagnosed with lung cancer will be alive 1 year after diagnosis. Although smoking is the leading cause of lung cancer, exposure to radon and air pollution is a second-leading cause among women. Many people also do not know that every 5 minutes a woman in the United States is told she has lung cancer, and the lung cancer death rate in women has more than doubled over the past 35 years.

Mr. President, I have personally lost a number of close family members to various forms of cancer. I lost both of my grand-mothers to lung cancer. My maternal grandmother chain-smoked for nearly 60 years, but my paternal grandmother never smoked a day in her life. So it can affect anyone, and together we can increase awareness and advocacy efforts which will result in better treatment and more options, particularly for women. Ultimately, our goal is to help save lives. I ask my colleagues to join me in recognizing this week as "Women's Lung Health Week" in Pennsylvania and vote in the affirmative on this resolution. Thank you.

The PRESIDENT. The Chair thanks the gentlewoman on a very enlightening resolution.

An estimated 3 in every 1,000 children between the ages of 6 and 17 in the United States are diagnosed with Tourette syndrome, a neurobiological, genetic condition which has no cure. Tourette syndrome is a lifelong developmental disability that begins before a child reaches 18 years of age and affects children and adults of all races and ethnicities. Individuals with Tourette syndrome are affected by tics and involuntary rapid, sudden movements or vocalizations that occur repeatedly. Individuals with Tourette's face periodic changes in the nature and severity of their tics, as their symptoms wax and wane and change without forewarning.

With this resolution, we will recognize the needs of these individuals with neurological impairment and urge all citizens to support education and awareness of Tourette syndrome and to assist those individuals and families who deal with this neurobiological disorder every day of their lives.
