#### BILLS REPORTED FROM COMMITTEE

Senator FOLMER, from the Committee on State Government, reported the following bills:

SB 495 (Pr. No. 449)

An Act amending the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, in party organization, further providing for definition of political parties and political bodies; and, in nomination of candidates, further providing for nominations by minor political parties and for nominations by political bodies.

#### SB 1157 (Pr. No. 1620)

An Act amending the act of March 4, 1970 (P.L.128, No.49), entitled "An act granting to the Governor of the Commonwealth the sole authority for regulating the display of the flag of the United States from

any public ground or building and from any ground or building of certain other institutions," further providing for the display of the official POW/MIA flag on Commonwealth grounds or buildings.

# HB 1934 (Pr. No. 3076)

An Act authorizing the Department of General Services, with the approval of West Chester University of Pennsylvania of the State System of Higher Education and the Governor, to grant and convey to Aqua Pennsylvania, Inc., or its assigns, an existing water tower and permanent utility easement from lands of the Commonwealth at West Chester University of Pennsylvania, situate in the Borough of West Chester, Chester County, for the purpose of public water distribution.

# HB 1990 (Pr. No. 3365)

An Act authorizing the Department of General Services, with the approval of the Pennsylvania Historical and Museum Commission and the Governor, to grant and convey to Associate Members of Old Mill Village Museum, Inc., certain lands situate in New Milford Township, Susquehanna County.

# HB 2003 (Pr. No. 3211)

An Act authorizing the Department of General Services, with the approval of the Pennsylvania Historical and Museum Commission and the Governor, to grant and convey to the Southern Lancaster County Historical Society certain lands situate in Fulton Township, Lancaster County.

# HB 2014 (Pr. No. 3220)

An Act authorizing the Department of General Services, with the approval of the Department of Transportation and the Governor, to grant and convey, at a price to be determined through a competitive bid process, certain lands, buildings and improvements situate in Lawrence Township, Clearfield County.

# GUESTS OF SENATOR DAYLIN LEACH PRESENTED TO THE SENATE

The PRESIDENT. For the purpose of recognizing some very special guests, almost better than the Beatles, the Chair recognizes the gentleman from Montgomery, Senator Leach.

Senator LEACH. Mr. President, as the Senator representing the school at issue today, I am so proud to recognize and introduce to the Senate the National NCAA Division 1 Basketball Champions, Villanova University.

(Applause.)

It is hard to overstate what an achievement this is. I am led to understand there are 351 Division 1 schools, is that right? That is an awful lot of schools. Many of them are much larger and have a much larger student population than Villanova University, but Villanova beat them all and became the national champions. I am proud to have some history with Villanova. I am not an alum but I have alums with me today, and a couple of them will say some words. I actually went to Temple University, but I spent a lot of time at Villanova as an undergraduate because by the time I was a sophomore, all of the girls knew me at Temple, and I had to go other places in order to socialize. Then, when I went to the University of Houston Law School, I remember cheering on Villanova as if I were an alum when they won their first national championship under Rollie Massimino. That was another amazing upset and come-from-behind victory.

I must say even now, Villanova is a godsend to me. I have a 13-year-old son. Now, when I was 13, every Philadelphia sports team lost every year. Every year we were in last place. Sometimes--some of the older people will remember this--the Phillies and the Expos would battle it out for fifth place in the division, but we were always in last place, and when you are 13, that is sort of the sweet spot for sports in your life. It is all you really care about, and it was devastating to me. We went through some good years, but then my son hit that spot, and we are right back where we were when I was a kid. It is heartbreaking to watch him watch Philadelphia professional sports sometimes. To show you how bad it got, he started rooting for arena football in order to find a team that won sometimes. So when Villanova came along and they started moving through the tournament, this was the greatest thing that ever happened in his life, and when they shot the winning basket in the last second, I have never seen him happier. So, I cannot tell you how personally grateful I am for the amount of money you saved me in future therapy for my son, as someone is finally giving him something to root for.

I must admit that Villanova was not in my bracket. I do not know enough about all of the teams to intelligently make a bracket, so I just make my bracket alphabetically, which I am told is not necessarily the best way to do that, but I am happy that the Arizona vs. Yale final did not occur, and that Villanova finally got their victory.

We have a citation from the Senate recognizing your amazing accomplishments. We are hopeful that we will be back here next year doing this again. Thank you for all you have done for your community, for your city, for your State, and for really all the inspiration you gave to people all across the country. This is something you can be proud of the rest of your life. We are so thrilled that you are with us today. So, thank you very much. I would like to introduce the three Villanova alums in the Senate behind me to say a few words. I introduce Senator Boscola.

Senator BOSCOLA. Mr. President, I had Villanova in my bracket to win all the way. People thought I was crazy at first, but I won a lot of money, and by the way, you cannot do those brackets because they are illegal. I am trying to change that.

Anyway, let us give them a standing "Novation." (Applause.)

They are led by a cool cat, Jay Wright. I will tell you what, when I saw you, when I was watching that game and Jenkins made that shot, you were like, "Bang, we win." I am like, holy crap is he cool. So, Daniel Ochefu, for mopping up the floor, the attitude award; Ryan Arcidiacono--I love him, God, I love him, I wish he was here. Jenkins, oh my gosh - Arch, Arch, Arch, give me the ball, and you just sink the shot, and it is just awesome. After the shot that happened with North Carolina, when Marcus Paige shot, and I said, what kind of shot is that? And then we got the best shot ever. Awesome. One more year, Phil Booth. Jalen Brunson, rookie of the year, well, Big 5 Rookie of the Year. Mikal Bridges, another freshman, dancing on the stage. Oh, my God, you guys are just the best. I love you. And of course, Josh Hart, awesome guy.

I am a proud alumnus, Father Pete is one of the best people we have. I know he thinks I am really crazy when it comes to Villanova basketball. I yell at refs, I do all that stuff and he goes, will you calm down? But I cannot. Anyway, congratulations, you made me proud, always, continuously, I will be at all of those games, I always am. I wore my T-shirt for 2 days in a row when

you guys were playing, and I got the smackdown by a lot of the Members saying, how can she wear that T-shirt, it is not what you can do here, and I said, ah, but I am an alumnus, I can do whatever I want. So anyway, congratulations, love you guys, and thank you for being here.

(Applause.)

Senator BLAKE. Mr. President, briefly, I could not be more proud, Nova Nation. Coach, I told you privately what a special thing it is for you to get across that line with your national championship and your leadership telling this team to work as a team, unselfish, unbelievable gentlemen, comporting themselves as you would give example to them on and off the court. I could not be more proud of Villanova University, I could not be more proud of your program, and could not be more proud of these gentlemen. Those six games were, boy, I will tell you, something else, Coach, something else. Nova Nation is really proud of you, and we are glad to have you here in the Senate. Congratulations.

Senator LEACH. Coach Wright, I will present this to you now. Along with the citation comes a brand new Buick LeSabre for each of your players, while supplies last, and that is out front. Anyway, thank you so much.

(Applause.)

Senator CORMAN. Mr. President, I am from central Pennsylvania and I am not an alumnus of Villanova, but I am very proud. Pennsylvania is a Commonwealth and we are very excited about all of our teams' successes. Villanova, certainly with a lot of class and a lot of heart, showed a lot of Pennsylvanians a great run. So, we were very excited to see it and we want to offer our congratulations as well. You brought a lot of excitement and a lot of joy to a lot of people.

I do want to make a comment to my colleague from Montgomery County. I understand his grief. When I was 13 in the 1970s, I remember the one year the Steelers did not win the Superbowl, it was very upsetting. If he wants his son to really have some good times, tell him to look west and you will see another championship tomorrow night.

The PRESIDENT. Point well-taken.

The Chair will exercise my prerogative as a Villanova Law alumnus. We are so delighted to have Coach Wright and the team here. I said this before, that final game was so suspenseful, it was almost as suspenseful as the issue of whether I would graduate from Villanova Law School. We are delighted to have you all here. You guys have been a tremendous example of the right way to do it. We are so proud of you and continued success in all things you do, and I think you can be assured all of us here in the Pennsylvania Senate and in our State government are your friends and want to help you in all of your endeavors.

Coach, thank you so much for being here.

The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I want to echo Senator Corman's comments about a wonderful opportunity tomorrow night for the Pittsburgh Penguins, and as we have supported Villanova, in Pittsburgh, we have to bring it home tomorrow night. Thank you.

# BILL LAID ON THE TABLE
