An Act amending the act of October 27, 1955 (P.L.744, No.222), known as the Pennsylvania Human Relations Act, further providing for the title of the act, for findings and declaration of policy, for right to freedom from discrimination in employment, housing and public accommodation, for definitions, for unlawful discriminatory practices and for prohibition of certain real estate practices; providing for protection of religious exercise; and further providing for powers and duties of commission, for educational program and for construction and exclusiveness of remedy.

Which was committed to the Committee on STATE GOV-ERNMENT, April 25, 2017.

# SB 434 (Pr. No. 473)

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in limitation of time, providing for ten year limitation, for mesne profits and for reimbursement and further providing for twenty-one year limitation.

# SB 461 (Pr. No. 454)

An Act amending Title 44 (Law and Justice) of the Pennsylvania Consolidated Statutes, in DNA data and testing, further providing for policy, for definitions, for powers and duties of State Police, for State DNA Data Base, for State DNA Data Bank, for State Police recommendation of additional offenses, for procedural compatibility with FBI and for DNA sample required upon conviction, delinquency adjudication and certain ARD cases, providing for collection from persons accepted from other jurisdictions and further providing for procedures for withdrawal, collection and transmission of DNA samples, for procedures for conduct, disposition and use of DNA analysis, for DNA data base exchange and for expungement.

#### SB 496 (Pr. No. 496)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in burglary and other criminal intrusion, further providing for the offense of criminal trespass.

### SB 510 (Pr. No. 505)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, providing for the offense of threat against law enforcement officer or sheriff.

### SB 577 (Pr. No. 646)

An Act amending Title 12 (Commerce and Trade) of the Pennsylvania Consolidated Statutes, prohibiting the sale of shark fins; and imposing a penalty.

# SB 200 (Pr. No. 254)

An Act amending the act of December 19, 1990 (P.L.1372, No.212), known as the Early Intervention Services System Act, further providing for the title of the act; in general provisions, further providing for definitions, for State interagency agreement, for other duties of State agencies and for council; and, in Statewide system for provision of early intervention services, further providing for requirements, for program regulations and standards, for administration by Department of Public Welfare, for administration by Department of Education and for child identification, assessment and tracking system.

Merrill is part owner of WBCB 1490 radio in Levittown and serves as vice president and general manager. Merrill is an avid golfer who competes in numerous charity events and is also an avid tennis player. There is no greater thrill--Merrill and I have played in many charity outings, special olympics, and different outings to raise money for charities in Bucks County--nothing is more thrilling than to listen to Merrill Reese describe the outstanding drive that you have just made. It almost sounds like you are on television when Merrill plays golf with you. He is a great community member and a great champion for great causes. He resides in Blue Bell with his wife, Cindy. His son, Nolan, is a film editor in Hollywood, California, and daughter, Ida, is a graphic designer. The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I rise in favor of this legislation. Last Session, this Chamber and the legislature passed a bill to provide additional penalties for people involved in trafficking of children, and provided significant penalties for those offenses. In addition, it also began the process of stopping the treatment of the victim as a criminal and the criminal as a victim. In these cases, when a child has been trafficked, all too often they were treated as a criminal and nothing was done to the pimp. They are not really pimps, that is even too good of a word for them. They are people who are habitual, violent sexual predators, but they manipulate these children and use them for trafficking purposes.

This bill establishes a general rule that children under the age of 18 who are victims of human trafficking will be provided specialized services instead of facing charges in the juvenile justice system. In addition, it provides training for law enforcement officers so they know how to treat the victim and rehabilitate them. There is also some criminal immunity for minor charges that could have been filed against them. We should not file charges against them. That makes them even more victimized when we do that. We are going to use dependency in lieu of delinquency in our approach to them and not put them through the juvenile justice system but provide them help and assistance from the Department of Human Services.

There also is a provision here for -- all too often, what the pimp does is put tattoos on their victim, and they are acting as their father and a person who cares about them, but they do not care about them at all. They are just using them, and so far they

have gotten away with it in our society. That is ending, and this is the last part of that provision. What we are doing is finally treating them as victims, not as criminals. We have a program we can use to rehabilitate them and put them back on the path that they were involved in before their capture by the sexual predator. This bill would allow for paying for the removal of those tattoos from their body. This may be a symbolic thing, but it is an important thing because it is a first step in their rehabilitation, taking them away from the domination and manipulation of the predator who has been using them for trafficking.

So, I ask for an affirmative vote on the legislation.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, this is an important bill that Senator Greenleaf took the lead in putting together. It deals with human trafficking. It deals with young people, and I hope that all Members here support this bill. It is another one of the steps. We have done two previous bills to deal with the serious issue of human trafficking that is occurring in our communities.

Patients and families who are affected by this condition face numerous obstacles in completing tasks that many of us take for granted, and these challenges often lead to feelings of fear, isolation, and helplessness. Recognizing World HIE Awareness Month is the first step in insuring these families not only be connected to the resources that they need, but also find a connection to other families who are fighting the same battle. Each person who is affected by HIE has a unique set of circumstances that led to their condition, and every patient differs in onset and severity of symptoms. All patients and families who suffer from this condition have a common goal of promoting awareness, better treatments, and new ways to overcome the challenges that HIE creates. Although the condition is rare, this resolution will remind every patient suffering from this disease, and their families, that they are not alone.

Therefore, Mr. President, I stand today to recognize Brain Tumor Awareness Month as an opportunity for us to come together as

a community to celebrate the lives of people impacted by this condition and who are fighting this type of cancer with determination, dignity, and strength.

# SPECIAL ORDER OF BUSINESS SUPPLEMENTAL CALENDAR No. 1

### BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

**SB 5 (Pr. No. 758)** -- The Senate proceeded to consideration of the bill, entitled:

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in general provisions, providing for findings regarding firearms and ammunition; and, in preemptions, providing for regulation of firearms and ammunition.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Langerholc.

Senator LANGERHOLC. Mr. President, I rise today to ask for support for Senate Bill No. 5. Senate Bill No. 5 reaffirms State law by allowing a person who is adversely affected to file suit against a municipality that has enacted an overly restrictive firearms ordinance. "No county, municipality or township may in any manner regulate the lawful ownership, possession, transfer or transportation of firearms, ammunition or ammunition components when carried or transported for purposes not prohibited by the laws of this Commonwealth," according to Chapter 6, Section 6120, of the Pennsylvania Crimes Code. "The right of the citizens to bear arms...shall not be questioned." That is from the Pennsylvania Constitution. "A municipality shall not enact any

ordinance or take any other action dealing with the regulation of the transfer, ownership, transportation or possession of firearms." That is Title 53 of the Pennsylvania Consolidated Statutes, Section 2962.

All of those were enacted by this General Assembly. Unfortunately, somewhere along the way municipalities lost their way. Municipalities passed ordinances and statutes which have directly contradicted existing State law and have purported to do exactly what they are specifically and explicitly prohibited from doing. The lawful residents of our great Commonwealth bear the brunt for that misguided legislation.

Senate Bill No. 5 allows a person adversely affected to file suit against a municipality which enacts an overly restrictive local firearms ordinance, but municipalities must realize that these local ordinances and regulations are in direct contravention with existing State law and severely impact the rights of law-abiding citizens of this Commonwealth. Critics may point to this law in a prior form being struck down by the Pennsylvania Supreme Court. However, the law in its prior form was struck down because it violated the single-subject rule, and that is because the prior law was conjoined with language from a bill dealing with theft of precious metals. That violated the single-subject rule and thereby struck down the bill in its prior form.

Succinctly, Senate Bill No. 5 is about uniformity across the State and insuring that the laws enacted by the General Assembly are taken seriously and followed. With the amendment to Senate Bill No. 5, there will be a 30-day period in which the Attorney General shall notify all municipalities of the passing of this legislation, and the law will go into effect within 60 days, thereby giving municipalities ample time to address any existing ordinances and not be adversely impacted by the same.

Mr. President, I ask for an affirmative vote on Senate Bill No. 5. Thank you.

### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, I speak this afternoon on the House Republican budget plan, House Bill No. 218. I particularly want to talk about its impact on children, the elderly, and individuals with disabilities. As Minority chair of the Committee on Health and Human Services, I watch these things quite carefully. How this budget will end up by the time we get to July is of great concern to me. So, I have studied this and have some thoughts to offer today.

The House Republican budget proposal slashes Department of Health and Human Services funding by \$341 million. Funding for operations is cut an additional 6.5 percent from the Governor's bare-bones proposal, which may result in at least 500 furloughs. These cuts threaten timely access to services for consumers and increase the risk of errors resulting in noncompliance and Federal funding deferrals. There are a number of aspects of this that I would really like to focus on, Mr. President.

First of all, as you know, I was a former county commissioner and I am fully aware of the fact that the State must rely upon the counties to help deliver human services programs. Our counties are already reeling from a 10-percent cut 5 years ago and the impacts of the prolonged budget impasse that we had 2 years ago. Now, as part of the House Republican proposal, they are asking for a \$5-million reduction in community mental health county allocations. Nothing could be worse than cutting our mental health services. We need them desperately in our counties. It reduces the Human Services Development Fund appropriation by 15 percent. Counties use this funding to supplement other county-based human services programs requiring additional resources. If an emergency comes up, or there is a special initiative that a county wants to take, they use these HSDF funds. Cutting them certainly makes no sense if we want the counties to be our partners in delivering these services.

Our hospitals will be negatively impacted because the House Republican budget offers 15-percent cuts to funding for hospital payments. The budget also assumes aggressive changes in programs serving seniors and individuals with physical disabilities in communities. As we have seen, shortened timelines on significant program changes often lead to vulnerable consumers losing services and ending up in expensive institutional care. Just today, Mr. President, I stood with the Home Care Association of Pennsylvania and talked about needed changes in Pennsylvania State law so more individuals with disabilities and seniors can remain in their home, because that is where they want to be. That ends up actually saving us money rather than sending them to a nursing home.

There is no dispute among any of us, I believe, that we are in a drug abuse crisis in Pennsylvania. The House Republican proposal eliminates \$4 million in transitional funding for 1,200 Pennsylvanians seeking treatment for a substance use disorder. Without this funding, many individuals will face up to a 60-day

delay in treatment while they wait to become medical assistance eligible. Many of those people will not make it to that 60-day timeframe. They simply will not.

Children are especially impacted by this budget proposal. Cuts to evidenced-based home visiting programs such as the Nurse Family Partnership are in this budget. Three hundred twenty children may lose services, and Pennsylvania risks noncompliance with Federal funding maintenance of effort provisions. One area that is very dear to my heart is childcare programs which allow parents to work while insuring quality early learning opportunities for their children, but \$63 million in cuts are part of this budget that they have proposed. Mr. President, many years ago when my daughter was young, my daughter was in subsidized childcare. I used those services myself until I was able to be on my feet and get a better paying job so that I could support paying for daycare and making sure that my daughter was in a quality care situation. How can we do this to people who we are asking to get to a self-sufficient state? They absolutely need childcare. This is not only harmful to children but it is harmful to their parents as well.

Mr. President, the many services Pennsylvanians need in regard to healthcare, housing, mental health, and children's services will not go away just because we do not fund them. They simply will not disappear because the legislature refuses to believe that need is there. They will be exacerbated by this poor example of a human services budget. Having reviewed this, I cannot imagine how I and some of my colleagues could possibly support it. I certainly hope as we move forward here in the Senate on the budget proposal that we take a hard look at this and look at what we need to do to make sure that Pennsylvanians are getting the services that they absolutely require.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise to support the comments of my good friend, the gentlewoman from Berks, because I think what we have here is a situation where we have a House version of a budget bill that could be very problematic, as not only Senator Schwank has talked about, but my colleague Senator Hughes and many others as well. Mr. President, today was a pretty busy day here in Harrisburg, as my colleagues know, and we all received visits from a number of organizations and a number of individuals who, I assume, everybody in this room has indicated that they want to work with them to be able to restore as much as possible to some of the lines that could be cut, particularly in those areas that had dramatic and Draconian cuts.

As I think of a couple of areas, Mr. President, I think we can talk about the childcare that Senator Schwank talked about. It would have a significant impact on families, working families, by the way, or working moms in particular, who have to make a choice under this budget of whether or not they are going to continue to work to be able to support their childcare or make a decision of not being gainfully employed because they do not have access to childcare, because the waiting list is going to grow considerably. The Governor has made a very significant proposal that I think is something we need to look at as a Caucus and as a Chamber, and be able to demonstrate our strong support to the other side of the building along those lines.

I also think, Mr. President, about the family centers that Senator Schwank talked about, and what they mean to our communities. Last week, I stood here and introduced a resolution recognizing and honoring the work that they do and how they work with families and individuals to provide them support, in many instances the wraparound services that are so critically important for them to be in the home. That is extremely important.

Mr. President, today I had the chance to participate with my colleagues in an advocacy day centered around the investments in the arts and the arts in education, and as I mentioned, throughout the process, Senate Democrats will continue to talk about some of the challenges that this upcoming budget faces if we would adopt something along the lines of what the House Republican Caucus has sent us. In particular, this budget, as proposed, cuts nearly \$10 million in grants to the arts. These are grants that go into education, these are grants that go to individual artists who make their way into our schools and communities, but they are also grants that provide some level of support for some of the arts agencies and cultural agencies across the Commonwealth. What they are looking for is restoration, just simply the last year's number, to be able to make the investments in the arts that are so critically important, and looking for restoration of \$2 million into the cultural programs. Because what we know, Mr. President, as a fact, as study after study after study has stated and demonstrated, that when we make investments in the arts and cultural activities in this Commonwealth, when our students and kids have access to the arts, and to be able to participate in that process, it has a very, very positive outcome for those individuals, and it ranges from a whole host of different things. The percentage of individuals who indicate to us and to others that their self-esteem is enhanced, and the percentage is like 90 percent of students and teens who participate in some of the programs tell us they have greater confidence in their ability to participate, and more importantly, they have greater confidence and understanding of the position or points of others, which I think is an important conflict resolution process that we need to go through, particularly when we have young teens.

So, Mr. President, I am asking my colleagues, when we met with everybody in the last couple of days, and in particular today, and we promised to work and do some things to support what it is they are supporting and making those reinvestments, that we do not just pay lip service to them, that we be sincere in our conversations with them about what we want to do and need to do as a Commonwealth, and it is going to be tough. We are going to have to make tough decisions, but at some point in time we have to stand up and have the courage to make the investments that need to be made to support the programs we talked about. Many of our colleagues have talked about investment in education. I think that is critically important, but there is a host of other programs and many other people with whom we met and pledged to work along those lines. I am calling on my colleagues as we go forward, hopefully when we come back May 8 through 22, that we have the opportunity to craft language in the budget that allows us the opportunity to fix the problem that was created with regard to the House Republican budget that came over to us.

Again, one area of particular importance to me has been the arts, and I had the privilege of serving as one of the co-chairs, along with Senator Browne and Representative Briggs and Rep-

resentative James, and together we are going to continue to advocate for those investments in the arts and cultural communities, because they have a very positive impact on our communities, but more importantly, a very significant and positive impact on the men and women and kids in our Commonwealth, and we have to demonstrate how important that is.

So, Mr. President, I thank you very much for your time.
