The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Vulakovich.

Senator VULAKOVICH. Mr. President, today I ask for an affirmative vote on Senate Bill No. 251 as amended. As a former municipal police officer, I recognize the important role that local police forces play in our neighborhoods across the Commonwealth. It is pretty amazing that in this technological age, Penn-

sylvania is the only State in the nation that still forces its local police officers to use stopwatches to enforce traffic speed limits. We have sophisticated radar available, and police use stopwatches. That simply does not make sense. I do not question the ability of local officers to use ESP, VASCAR, or AccuTrak, but with those systems, human error is an issue and a minimal hesitation on timing can have a dramatic impact on the fines and penalties imposed.

Based on those variables, more than a few people end up challenging speeding tickets in court, which takes officers off patrol duties and costs taxpayers to prosecute these relatively minor offenses. On the other hand, it is much more difficult to challenge the results of a properly tested and calibrated radar gun when used by a properly trained police officer. And there is a deterrence factor. Local motorists can now figure out where traffic speeds are enforced by looking for white lines across the road. On the other hand, radar is mobile and it only takes one officer to use it, as opposed to multiple officers needed for using VASCAR.

I would like to share with you some national statistics to show where Pennsylvania ranks in road safety from the National Highway Traffic Safety Administration's Traffic Safety Facts for 2015. Pennsylvania has the fourth-highest total of speeding-related deaths behind only Texas, California, and North Carolina. The clear majority, 84 percent of the 540 speed-related fatalities in Pennsylvania in 2015, occurred on roadways other than interstates, which are most often patrolled by local police. We can save lives when it comes to motorists dying from speed-related crashes, and radar is the way to do this.

Getting to this historic vote today would not have been possible without the hard work and dedication of the Radar Coalition led by Jim Nowalk, who is the mayor of Whitehall Borough. Jim has brought together many local government groups to form this coalition, including the F.O.P., Chiefs of Police Association, Pennsylvania Association of Township Supervisors, Pennsylvania Boroughs Association, Pennsylvania Municipal League, Pennsylvania Mayors Association, and Bike Pittsburgh. I thank each and every one of you for your advocacy and hard work.

I also thank Senator Rafferty. This bill is something he and I have spoken about for a long time. His willingness to work with me on this issue is greatly appreciated. It is time for the General Assembly to take action on this issue. I urge the House to take quick action on this. It is well past time we provide our officers with speed-enforcement mechanisms. If you think this bill is going to result in you receiving a ticket, I say to you, slow down. Mr. President, I ask for an affirmative vote.

Each school entity shall determine the manner in which the test shall be administered.

(2) The department shall:

(i) No later than the 2019-2020 school year, post on its publicly accessible Internet website links to the one hundred (100) question civics test used by the United States Citizenship and Immigration Services and any related resources offered by the United States Citizenship and Immigration Services. The department shall post any additional materials and resources that the department deems useful to a school entity in complying with the requirements of this subsection.

(ii) Conduct an electronic survey of each school entity at the conclusion of the 2020-2021 school year and at the conclusion of every other school year thereafter requesting information regarding the civics test required under paragraph (1)(ii). Each school entity shall respond to the survey no later than November 30 following the school year for which the survey is conducted. The survey shall only request the following information regarding the immediately preceding school year:

(A) The total number of students who took the civics test.

(B) The total number of students who attained a passing grade on the civics test by answering at least sixty percent (60%) of the test questions correctly.

(C) The grade level or levels in which the civics test was administered.

(D) The course or courses in which the civics test was administered.

(iii) Make the data collected from the surveys conducted under subparagraph (ii) available on its publicly accessible Internet website.

(iv) Develop a certificate of recognition for students who passed the civics test by answering one hundred percent (100%) of the test questions correctly and make the certificate available on its publicly accessible Internet website for use by school entities.

(3) A student with an individualized education program shall not be required to take the civics test required under paragraph (1)(ii) if the provisions of the student's individualized education program indicate otherwise.

(4) As used in this subsection, the following words and phrases shall have the meanings given to them in this paragraph, unless the context clearly indicates otherwise:

"Department" shall mean the Department of Education of the Commonwealth.

"Individualized education program" shall mean an individualized education program under 22 Pa. Code Ch. 14 (relating to special educa-

tion services and programs).

"School entity" shall mean a school district, area vocational-technical school, intermediate unit, charter school, cyber charter school, regional charter school or nonpublic school.

Section 2. This act shall take effect in 60 days.

Senator VULAKOVICH. Mr. President, I thank Senator Boscola for this resolution. I think it is a very important resolution and something that needs to be addressed. This resolution creates a 17-member task force to examine and analyze the current delivery of healthcare services to women veterans. The task force will study the prominent issues facing women veterans, including post-traumatic stress disorder, traumatic brain injury, military sexual trauma, and alcohol and substance abuse. The task force will provide recommendations to the Governor and the General Assembly in order to insure that our returning female veterans receive proper care following their dedicated military service to our country. It will analyze the laws, procedures, practices, and rules related to the delivery of healthcare services for women veterans at the Federal and State levels and hold public hearings to further examine the current state of affairs. The task force will be comprised of 17 members, and it will be made up of professionals from provider communities with expertise in healthcare, mental healthcare, substance abuse, addiction treatment, and military sexual trauma. There will be Members of the

House and Senate who will be part of the 17-member commission and four female veterans who reside in the Commonwealth.

This legislation is intended to improve the delivery of healthcare services to our nearly 72,000 female veterans, and Pennsylvania ranks as having the seventh highest population of women veterans in the United States following Texas, California, Florida, Virginia, Georgia, and North Carolina. This is a very important piece of legislation, a worthy study to be done to honor and serve those who served us. I ask for a unanimous vote.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, I would also like to thank Senator Vulakovich for his remarks regarding this resolution. This resolution establishes a task force on women's veterans healthcare to address the growing needs of our growing female veteran population here in the Commonwealth. The task force will study prominent issues facing women such as post-traumatic stress disorder, traumatic brain injury, and substance abuse. Its members will then provide recommendations to the Governor and the General Assembly in order to insure that our veterans receive proper care following their dedicated military service to our country. It will be comprised of professionals from provider communities with expertise in healthcare, mental healthcare, substance abuse, addiction treatment, and military sexual trauma. This legislation is intended to improve the delivery of healthcare services to our nearly 71,000 female veterans. Pennsylvania ranks as having the seventh highest population of women veterans in this country, so it is an important issue. I thank the Leaders of the Senate for bringing up this resolution and the support of my colleagues in passing it today.

Senator SCAVELLO. Mr. President, this resolution designates November 2017 as "Epilepsy Awareness Month." One of the world's oldest known medical conditions, epilepsy is also one of the most misunderstood, often leading to fear, discrimination, and isolation. By raising awareness of the realities of this disorder, we can reduce fear and misunderstanding while improving the lives of the millions affected by epilepsy.

A chronic neurological condition, epilepsy is characterized by recurring seizures that are physical reactions to sudden electrical discharges in the brain. While a seizure is often thought to be full-blown convulsions, it can also be brief muscle spasms, or unconscious behaviors that appear to be attention lapses. Over 65 million people worldwide have epilepsy, with more than 2 million in the United States. Epilepsy is the fourth most common neurological disorder in the United States after migraine, stroke, and Alzheimer's disease. About 1 percent of Americans have some form of epilepsy, and nearly 4 percent, 1 in 26, will develop epilepsy at some point in their lives. Unfortunately, the cause of epilepsy is unknown in about 70 percent of cases, and one-third of the people with epilepsy must endure uncomfortable seizures because no available treatments work for them.

Therefore, I ask my colleagues to join me in this effort to raise awareness, educate people about epilepsy, and encourage the support of epilepsy research programs to support those Pennsylvanians living with this condition.

Mr. President, for his years in retirement, he continued to work for the Philadelphia Phillies for short periods of time in spring training as not only a mentor to the pitchers on style and technique, but on mental toughness, which when you read the stories today, was something he wanted to devote himself to in future years working with young pitchers in the Philadelphia Phillies organization. In these past couple years of retirement, he devoted himself entirely to his family. That speaks highly and well of a man who will take that time for his wife and his children to make sure that he had a chance to get to know them, they had a chance to get to know him, and to work together to become better and greater citizens for this United States. He lived in Florida with his family, and we all received the news on a solemn day.

He was that type of individual, Mr. President, who many individuals in this country and this Commonwealth aspire to be like. And, Mr. President, it is with great sadness that we learned of this, and I wanted to take a few moments to share my thoughts on a man I did meet, and I am proud to have called a friend, and a man who meant so much as a hero, as a sports figure, as a father, and as an individual to the city of Philadelphia. Mr. President, may God rest the soul of Roy Halladay, and may his family be strengthened by the warm memories that they had of the years together with Roy. My best wishes to Brandy Halladay, his wife, and his sons, Ryan and Braden, and certainly to the Philadelphia Phillies family. They did a magnificent job at the press conference, David Montgomery and Cole Hamels, and I thank them for their thoughts on that sad day as well. Mr. President, though we mourn the loss of Roy Halladay, let us remember the happiness and joy that he brought to this city and the type of life that he led as a man of outstanding character.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, I want to take a few minutes to bring to everyone's attention an issue that had a hearing a couple of weeks ago, and that is street harassment. Specifically, about 2 weeks ago, I co-hosted a policy roundtable with my colleagues, Senator Boscola and Senator Schwank, and it was attended by Senator Street, to look at the issue of street harassment and get some ideas on a solution from stakeholders.

For those who do not know, street harassment is an unwanted interaction in public spaces between strangers who are motivated by a person's actual or perceived gender, sexual orientation, or gender expression and make the harassee feel annoyed, angry, humiliated, or scared. This type of harassment primarily affects women, but it defies social, geographic, and economic boundaries. I know many of us would be hard-pressed to find a woman in this Commonwealth, in this country, or, for that matter, this world who has not been a victim of street harassment. In fact, in a 2014 study by Stop Street Harassment, a national organization working to end this abuse, reported that 65 percent of women surveyed in the United States have experienced some type of street harassment ranging anywhere from verbal harassment to physically aggressive and even sexually violent assaults. Maybe this does not really come as a surprise, considering that we recently elected a President who openly admitted to sexual assault, yet he still rose to the highest office in the free world, but that does not mean we should sit idly by. This needs to be part of a larger discussion on sexual harassment and rape culture and our society's sickening acceptance of these behaviors.

The fact of the matter is women do not have equal access, Mr. President, to public spaces because of the frequency and acceptance of street harassment. During the roundtable discussion, we heard from women who have literally changed their lives because of this. They assess the way they dress before leaving the house, change the way they traveled to work or school, to their homes, all in an effort to avoid being harassed. They have had to, not because they want to, but because as a society we have not done enough to put a stop to this behavior. This is a quality of life, a social, and an economic issue, and it is time to come up with a solution. In the near future, Mr. President, I will introduce legislation that will study this issue and the solutions that are appropriate for the Commonwealth, but I also will be continuing this discussion statewide. I encourage you and all of my colleagues to join me in bringing this issue to light and working to find its end.
