GUESTS OF SENATOR ANTHONY WILLIAMS PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Williams.

Senator WILLIAMS. Mr. President, I am honored today to have the Bartram High School Football Team with me. Principal Damond Warren, who is here, please stand, if you will; Head Coach Jim Chapman, if he would also stand; and obviously, the team.

(Applause.)

Senator WILLIAMS. So the Bartram folks will understand, we are going to applaud you before you applaud us, so give me a second here, okay? I want to obviously talk about something

they have done this year. They had an extraordinary record. They got to the Class AAAA title game for their conference. They have the best record in their conference. They were 11-1, 5-0 in their conference. They had a shutout in 5 of their 10 games, and their offense often scored 50-plus more in 5 of their games.

I want to tell you what I told them. This school is not in the heart of a community that has a lot of money. This community and these students come from backgrounds that are pretty tough and challenged. These young men could have done anything during the course of their days, but they dedicated themselves, not as individuals, but as a team to have an 11-1 record and go to a championship game. The reason why I asked them to come here is not simply because they are an extraordinary group of athletes, but because what we are missing in America, regardless of where you come from, rural America, urban America, suburban America, whether you are black or white, Democrat or Republican, we wish that our young men would be examples to all of us to be what true Americans are, and that is care about the person next to you. These young men have exemplified the highest and most grateful standard we as Americans hold, and that is care about the other person, support the weakest link, drag along the person who is dragging us behind, and inspire us to greatness. So, in a community that may not have all the money in the world, to a young person who may not have everything they want, they have character, they have fellowship, they have spirit, and most importantly, they hold themselves as true champions.

So, I ask us to rise today to give them our warmest regards and respect as a Commonwealth and as a Senate.

Thank you, Mr. President.

GUESTS OF SENATOR JAY COSTA PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I am again today proud to introduce to our Senate colleagues the Western Pennsylvania School for the Deaf. Mr. President, founded in 1869, the Western Pennsylvania School for the Deaf, WPSD as we know it in Pittsburgh, provides a high-quality academic program for deaf and hard-of-hearing children from birth through grade 12. WPSD offers an inclusive communication/language environment. Individual student needs determine the communication with emphasis on the development of American Sign Language, sign-supported English, and spoken English. Utilizing the newest

technologies, including a 3D printer and laser router, WPSD offers a challenging academic curriculum based on State and national standards, including unique STEM opportunities in computer science and robotics. The WPSD hosts a thriving performing and visual arts program, and all students have the opportunity to participate in afterschool programs, including a variety of clubs and comprehensive sports programs that include soccer, basketball, volleyball, softball, and cheerleading.

Mr. President, we are here to honor--a number of my colleagues have students here today--two WPSD championship teams, a soccer team and a volleyball team, for very, very successful seasons. This fall the varsity soccer team and varsity volleyball team secured their second championship title of the Eastern Schools of the Deaf Athletic Association. The ESDAA is comprised of schools for the deaf from 11 States, regulating interscholastic athletics among its member schools, and it is also the oldest deaf high school athletic association in the United States, founded in 1927. The WPSD varsity soccer team is being honored upon capturing the 2017 Division 1 ESDAA Soccer Championship for 2 consecutive years. They were named the 2017 Team of the Year by Deafdigest Sports, named Team of the Year by the National Deaf Interscholastic Athletic Association for 2 years, and finished the 2017 season with a 16-6 record. The team is led under the expert guidance of head coach Val Woiton, as well as assistant coaches George D'Amore and David Tasselli.

Also here today, Mr. President, is the WPSD varsity volley-ball team, the Lady Lions. The team captured the ESDAA Championship for the second consecutive year and secured the Division 2 "Spike Out" Championship. They were named the 2017 Small School Team of the year by Deafdigest Sports, named Team of the Year by the National Deaf Interscholastic Athletic Association for 2 consecutive years, and this year also finished with a great record of 26 wins and 6 losses. The team is under the expert guidance of head coach Christie Homell, as well as assistant coach Andrea Aquilino.

Mr. President, I ask my colleagues to join our friends from WPSD who are here today to recognize the two championship teams, and I also ask my colleagues to provide remarks in support of those members as well.

Thank you, Mr. President.

The PRESIDENT. Would our guests from WPSD, the Lady Lions volleyball championship team, the soccer team, and all of those accompanying our great young people from WPSD, please rise so that we may welcome you to the Pennsylvania Senate.

working with WPSD. We thank you so much for what you are doing, and what a very special place.

Senator LAUGHLIN. Mr. President, last but certainly not least, right?

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Brewster.

Senator BREWSTER. Mr. President, today I rise to honor and remember the life and service of Officer Brian Shaw. Officer Shaw died Friday, November 17, in the line of duty as a New Kensington police officer. He was 25 years old. The evening started off with a normal traffic stop. It ended when a passenger in the car ran from the car, a foot pursuit ensued, the assailant turned and fired several shots at Officer Shaw, striking him twice. Later that evening, he succumbed to those wounds.

Officer Shaw was a lifelong resident of Lower Burrell, and a 2010 graduate of Burrell High School. He attended Slippery Rock University where he was a place kicker on the football team. He graduated with a bachelor's degree in criminal justice and graduated from the Allegheny County Police Academy. His life dream was to be a police officer. Prior to being hired in June of this year as a full-time officer in New Kensington, he served as a part-time officer in East Deer, Frazier, and Cheswick police departments. He was a member of St. Joseph Roman Catholic Church in New Kensington and the F.O.P. Lodge 39.

I was honored to attend the memorial service for Officer Shaw in Mt. St. Peter Church. The turnout was amazing. Thousands of people stood outside. Tens of thousands lined the streets in the procession. Over 1,000 police departments were represented from as far away as Canada and Colorado. I cannot think of a more meaningful expression of respect and appreciation for Officer Shaw's service and sacrifice. In closing, I want to express my deepest sympathy to Officer Shaw's parents, Lisa and Stephan, his brother, Steffan, who is a police officer for Penn Hills, his fellow police officers, his family, friends, and the communities he served. Mr. President, I ask for a moment of silence for Officer Shaw.

The PRESIDENT. Senators, please now observe a moment of silence for the loss of a hero, Officer Brian Shaw.

(Whereupon, the Senate en bloc stood in a moment of silence in solemn respect to the memory of Officer BRIAN DAVID SHAW.)

Senator COSTA. Mr. President, I rise today to ask my colleagues to support Alina's Law, Senate Bill No. 196, authored by my good friend and colleague, Senator Hughes, and supported by many of us in this Chamber.

Mr. President, earlier this fall, Alina Sheykhet was a student at the University of Pittsburgh where she was studying to become a physical therapist. Alina was beloved by her family, friends, and her classmates. They remember her for her easy smile, outgoing personality, and recall how much fun they had together with her performing in plays and musicals. But a man came into her life and she began dating him and that man became violent, Mr. President. At one point, he broke into her apartment by climbing up a rain gutter into her room. Mr. President, immediately after that Alina went to court and received a Protection From Abuse order. As many people in this room know, it takes a very courageous person in a relationship to have the courage to go to court, confront their attacker, and seek a Protection From Abuse order. Despite the Protection From Abuse order and the promise it provided, her boyfriend violated that Protection From Abuse order, broke into her home again and killed her. She was 20 years old.

Mr. President, in many aspects of this particular case, our justice system failed this young woman. In fact, during the course of the PFA, and the time it was issued, and before the hearing, there were several opportunities to serve the defendant with the Protection From Abuse order, and they failed to do so because of the lack of communication between the agencies across western Pennsylvania. Mr. President, as I mentioned, it failed to protect her. What happened to Alina should not happen to anyone ever again, and that is why I am very, very proud to stand here today and support Senate Bill No. 196 and call it Alina's Law. My hope is that it moves from this Senate over to the House for its immediate consideration and onto the Governor's desk.

Alina's Law will allow our judges to require a defendant of a PFA to wear an electronic monitoring device. I want to be clear, it does not mandate it. It allows the judge to decide and assess the situation and determine whether or not a defendant is an immediate violent threat to the victim. Alina's boyfriend, in this particular case, was an immediate threat to her and the judge, Judge Spurgeon, exercised that discretion and ordered a PFA, but that was all he was able to do. I believe that we need to allow judges to have more tools to protect our victims of domestic violence, especially when it has the risk of becoming a fatal situation.

Under Senate Bill No. 196, Alina's Law, monitors would be alerted if the defendant violates the terms of a PFA. The cost of the monitoring, through this process, would be paid by the defendant, but that cost is minor, Mr. President, when we look to see the hundreds of lives that are lost to domestic violence. Mr. President, according to the Pennsylvania Coalition Against Domestic Violence, there were 102 domestic violence victims killed last

year. In the last 10 years, we have lost more than 1,600 people who have died as a result of domestic violence here in Pennsylvania.

I strongly believe that this bill could have saved Alina's life if it had been enacted at the time. I believe it can certainly save future victims of domestic violence, and I am asking all of my colleagues to join me in voting "yes" on this particular measure, because we need to do these types of things to allow our judges to have the ability to exercise more tools in their toolbox as it relates to domestic violence situations.

Senator RAFFERTY. Mr. President, this is a significant piece of legislation, one supported by the law enforcement community. Many of you remember the Child Protection Task Force formed here in the Commonwealth of Pennsylvania. One of the specific recommendations of that task force was to allow the District Attorney or the Attorney General to issue an administrative subpoena in an ongoing investigation of child sexual exploitation or abuse that utilizes or monitors electronic communications in order to procure subscriber or customer information of the perpetrator.

The information, which can be obtained by an administrative subpoena, was limited to the subscriber's or customer's name, address, telephone, or instrument number, or any other subscriber number or identity, including any temporarily assigned network address. As we all know, perpetrators of child sexual exploitation and abuse frequently utilize the internet to contact a child victim, access or distribute child pornography, or communicate with others for purposes of trafficking children. Investigations, therefore, often start with law enforcement determining where the computer, which is the source of electronic communications and files connected with the crime, is located. Technology permits an internet service provider, or remote computer storage service, to identify the IP address of the originating computer and records of the provider often can identify the person who subscribes to the service through that computer. Prior to the underlying legislation we look to extend today, investigators in the Attorney General's Office and the Internet Crimes Against Children Task Force had to seek a court order or search warrant to get basic, non-content information. This is time-consuming and hampers their ability to efficiently and expeditiously investigate the many cases that are referred from sources such as the National Center for Missing and Exploited Children. By allowing the use of an administrative subpoena, the Attorney General or District Attorney can save time, and perpetrators can be identified more quickly and our children are better protected from predators.

Act 151 of 2014 was a step in the right direction to protect our children by authorizing the use of the administrative subpoena to secure these types of subscriber information of those individuals who are preying on our children. The underlying legislation was given a sunset date at the end of this year, thereby insuring that if the privacy were eroded, the legislation would not need to be overturned but would expire. We have heard of not one instance where an administrative subpoena has circumvented any civil liberties, and thus there is no need to sunset this provision.

Mr. President, it is for these reasons that I stand in support of House Bill No. 561 and encourage my colleagues to join me in an affirmative vote.

HB 1421 (Pr. No. 1785) (Rereported)

An Act amending the act of December 19, 1990 (P.L.1200, No.202), known as the Solicitation of Funds for Charitable Purposes Act, further providing for registration of charitable organizations, financial reports, fees and failure to file, for registration of professional fundraising counsel and contracts and for registration of professional solicitors, contract and disclosure requirements, bonds, records and books.

HB 1902 (Pr. No. 2786) (Rereported)

An Act authorizing the Department of General Services, with the approval of the Department of Military and Veterans Affairs and the Governor, to grant and convey, at a price to be determined through a competitive bid process, certain lands, buildings and improvements situate in the Borough of Kane, McKean County.

It is important to have the support of your family at this difficult time, but it is also important to have the support of your community.

This is one of the reasons why I am a big supporter of the Highmark Caring Place, which specializes in caring for children who have lost a close family member or caretaker. Recently, Mr. President, I had the pleasure of touring a Highmark Caring Place in the city of Pittsburgh. We talked about all of the feelings that go on in a young child's mind after losing a parent. What was amazing was--I was 14 years old when I lost my father unexpectedly. We were talking about all my feelings, and they are no different than the feelings that children have today when they lose a parent. The names are different, but the feelings are the same. I wish I would have had something like this back when I was 14 years old with a sister who was 8 and a brother who was 2. So, I can truly relate to this and can acknowledge the importance of something like the Highmark Caring Place.

I thank you, Mr. President, and ask for an affirmative vote.
