- (a) Findings.--The General Assembly finds and declares as follows:
- (1) Roy J. Gross, Sr., dedicated his life to serving his community with distinction and honor.
- (2) Mr. Gross dedicated more than 50 years of service to Mount Pocono Borough, including 34 years on the council, chairman of the Mount Pocono Municipal Authority and serving on the Police Commission for 23 years.
- (3) Mr. Gross was a life member of the Pocono Mountain Volunteer Fire Company where he was a past assistant chief and served on the carnival committee.
- (4) Mr. Gross was also past President of the Parents Athletic Association of the Pocono Mountain School and was constable and part-time police officer in the Pocono Mountain Regional Police Department
- (5) Mr. Gross received numerous awards for his community service throughout his life, including the 2002 Citizen of the Year award for Mount Pocono Borough.
- (6) In addition to his dedication to community, Mr. Gross was a talented builder and craftsman and worked for the family business, Ervin W. Gross and Sons for more than 50 years. After the business closed, he worked for his brother, Allen Gross, for 10 years until he retired in 2013. Roy was a lifelong resident of Monroe County and loving husband to his wife, Ruth, with whom he shared 62 years of marriage.
- (b) Designation.--The portion of Pennsylvania Route 611 beginning at mile marker 391 and ending at the Pennsylvania Route 940 intersection is designated as the Roy J. Gross, Sr., Memorial Highway.
- (c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the highway to traffic in both directions on the highway.

Senator TARTAGLIONE. Mr. President, I stand here today to urge you to join me in voting for House Bill No. 1778, a measure that would rename the Castor Avenue Bridge over

Frankford Creek, in the 2nd Senate District, in memory of slain Police Officer Gary Skerski.

On the evening of May 8, 2006, Officer Skerski responded to a 911 call for a robbery in progress at Pat's Café, a popular neighborhood tavern in the Northwood/Frankford section of Philadelphia. An armed man with a shotgun had invaded the business and had taken numerous employees and patrons hostage. He demanded their cash and valuables. As Officer Skerski approached the rear entrance of the business, the gunman lay in wait just inside the doorway. When Officer Skerski opened the door, the gunman shot, fatally wounding the officer. Other emergency responders rushed Officer Skerski to a nearby hospital, but the officer passed away later that night. He was 46 years old.

Officer Skerski was a 16-year veteran of the police force, assigned to the 15th Police District. He was a beloved son, brother, husband, and father. He is survived by his wife, Anne, son, Robert, his daughter Nicole, his parents, Chester and Mary, his sister, Jacqueline, his brother, Robert, and he was an equally beloved member in his community.

Although working on an overtime patrol shift at the time of the shooting, Officer Skerski's primary duties were as community relations officer for the 15th Police District. In that capacity, he served a vital role as a face of the Philadelphia Police Department in neighborhoods like Frankford, Mayfair, Tacony, Wissinoming, and Bridesburg. He cultivated relationships with local schools, churches, and civic associations while helping to insure that the community recognized and honored police officers who were doing great work in their neighborhoods. Officer Skerski coordinated many charitable events to support children, seniors, and less fortunate people within the 15th Police District. Officer Skerski showed us every day the many great things that police officers do within communities. He embodied the vision to protect and serve.

In the aftermath of the fatal shooting, patrons who were in Pat's Café that night credited Officer Skerski for protecting them and for literally saving their lives. Likewise, Skerski's efforts on community relations set a shining example that remains relevant today as it was then. These are just some of the reasons that I urge you, my colleagues in the Senate, to support this legislation to rename the Castor Avenue Bridge over Frankford Creek in memory of Police Officer Gary Skerski.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, I, too, rise to urge support for House Bill No. 1778. Officer Skerski served and was killed in the 2nd Senatorial District, neighboring my district, the 3rd Senatorial District. Moreover, Officer Skerski served as a Philadelphia police officer helping both with community relations efforts and efforts to keep our city safe while my father served as the city's chief executive. He was a man who served with distinction. After his untimely demise during the course of his duty, we had the privilege, my father and my family, to meet with Officer Skerski's family and we thanked them for his service. This, too, is a fitting tribute to the important work that not only Officer Skerski did in paying the ultimate sacrifice to protect the people of our community, but also a tribute to many other officers who will not have an opportunity to be remembered with the distinction that he does. For Officer Skerski and all of the officers who serve to protect us every day, and as a reminder to their families, I urge a "yes" vote supporting this bill.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from York, Senator Wagner.

Senator WAGNER. Mr. President, thank you for allowing me to speak. First, I would like to be clear on this bill. This is not about laying people off or not bringing people back to work. This bill-my issue with this bill and opposing this bill has to do with the amount of money that has been spent over a 10-year period and lack of accountability on the part of the Department of Labor and Industry.

A little background, Act 34 of 2013 was signed into law by Governor Corbett on July 2, 2013. The original Act 34 provided 4 years of fund transfers from 2013 to 2016, allowing the following amounts to be transferred to fund the UC call centers from the Service and Infrastructure Improvement Fund, also known as the SIIF Fund. Overall, between 2013 and 2016, the Department of Labor and Industry spent \$178 million, with nothing to show for it. In April of 2017, the legislature approved another \$15 million to fund the UC call centers through calendar year 2017.

House Bill No. 1915, which is the current proposal before the Senate, allows the following SIIF transfers in 2018, \$35 million; 2019, \$32.2 million; 2020, \$32.1 million; and 2021, \$15.9 million, for a total over 4 years from 2018-21 of \$115,200,000. And \$85 million is is going to personnel, \$39 million is going to tech. When Act 34 was signed into law, PA's unemployment rate was 7.1 percent. Today, it is at 4.7 percent. This represents a 66.2 percent decrease in unemployment.

There is also a lawsuit pending, filed by the Department of Labor and Industry against IBM. IBM was paid \$166 million, \$106 million of it was budgeted, \$60 million was over budget, to update the State's UC system back in 2009. The lawsuit was filed in the Dauphin County Court of Common Pleas and it is pending.

During floor discussion on Act 34, my colleague, Senator Scavello, who was serving in the House at that time, Representative Scavello, noted that the fund transfers would provide meaningful upgrades to the department's information management and communication technologies. During the presentation of the audit of the UC call center this year, the Auditor General noted that Act 34 was designed to temporarily supplement the decline in Federal funding that the Department of Labor and Industry uses to administer the unemployment compensation system. I would not constitute 9 years of funding as a temporary solution. It is now a system of dependency requiring reauthorization of the legislature every few years.

Overall, with House Bill No. 1915, the State will have invested close to a half-billion dollars into call centers with no guarantee that long-term solutions will be in place by 2021, which means no accountability. Representative Kauffman, who authorized House Bill No. 1915, noted that the Department of Labor and Industry has showed no willingness and no desire to let us, the legislature, help them run their system more effectively through changes in law. This is being hailed as a long-term solution, House Bill No. 1915. Is this a permanent fix, or will the legislature and the Governor be back at the drawing board in 4 years? This is an accountability issue and a tremendous, breathtaking waste of taxpayer money that is taking place.

Thank you, Mr. President.

#### PERMISSION TO ADDRESS

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise today to say a few words about the Honorable Edward Zemprelli who served in this body for over 20 years. Senator Zemprelli passed away on December 4 and was buried this past Saturday in Jefferson Borough, Allegheny County.

Mr. President, I never had the privilege of serving with Senator Zemprelli, but I got to know him very, very well as many of the folks in this Chamber did. He was an outstanding individual and the person who was one who would not say a few words, and for me to say a few words about Senator Zemprelli would not do him justice, simply because in his time he was a gentleman with immense presence when he served here in this Senate. Plus, Mr. President, as it was mentioned at his funeral this past weekend, he was a man, as I mentioned, who was incapable of few words.

Senator Zemprelli was the former Majority Leader of this body during a time of immense change. He made his mark reforming the State's then antiquated banking laws, he rescued the Unemployment Compensation Trust Fund, a conversation we had today. In working to build the Mon-Fayette Expressway, he

was very proud of his accomplishments while he served here. To many of us and to many folks in this Commonwealth, he was affectionately known as Zemp. He had friends from one end of the State to the other, and he loved this body very much, and in particular the Senators who had the opportunity to serve with him. By all counts, he was a consensus builder and a lawmaker of immense talent and substance.

But, Mr. President, he never forgot his hometown of Clairton, as he referred to DC, downtown Clairton, or the people of the Mon Valley. Senator Zemprelli was a Senator when the steel industry that helped build our nation and served as its arsenal during two world wars was collapsing, but he did his best to try to fight the causes of the collapse and to serve the cities and the citizens who were impacted. He never gave up hope, or his vision that he could use the laws of Pennsylvania to aid those who were impacted.

He served as this body's Majority Leader and was also the Democratic Floor Leader from 1981 to 1988. He ushered in many of the things that we do now today that we take for granted as a Caucus and a Chamber. As a Leader, he invested in technology because he believed in detailed research in order to help the Members better understand the issues and to be able to articulate the issues. He is well remembered by those with whom he served as a tremendous orator who used his legal training to clarify very difficult legal issues. Even after he left the Senate, he was welcomed as a passionate and articulate speaker at various functions and always someone who was welcome to be a part of our conversations and meetings.

He was a colorful and engaging person who enjoyed politics. However, perhaps his greatest character trait was his interest in people. He comforted those in despair, and he celebrated victories both large and small. He was recruited to public service, he said, in his perch as a young attorney with the Clairton Sewer Authority. He was approached by then-Democratic Governor David Lawrence and asked to run for the State House, which he did, and he served in the State House from 1963 to 1968 before moving here to the Senate and then his retirement in 1988.

In the Mon Valley, Mr. President, they named a bridge after Senator Zemprelli, or after Zemp, and at its dedication, he said, and I quote: As I look out from this span, I see small towns, cities, places that I have been to many times where we laughed with friends and worked side by side to make things better, end quote. Indeed, Mr. President, Pennsylvania today is a much better place because of the efforts of Senator Ed Zemprelli.

I ask my colleagues to join me for a moment of silence right now and also to recognize that early next year we will have a memorial service for Senator Zemprelli as well, but I thought it was important today, before we broke for our holiday season, that we take the time to remember an outstanding Member of this Chamber, Senator Ed Zemprelli.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, briefly, I never had the opportunity to serve with Senator Zemprelli but my father did and I know they were friends, despite being on opposite sides of the aisle. They had one thing in common. Senator Zemprelli may have been from the Mon Valley but he was a Penn State guy. He loved Penn State and he carried a lot of the water for Penn State around here for a lot of years. They were very good friends and worked well together. Anyone who served as Majority Leader I

have great respect for because I know the nuances of this job can be taxing at times, but he wore it well and he was a great Leader in this Chamber. It is always important to remember history around here, and he was someone who did a lot of great things and worked here for a lot of years.

The Senator from Allegheny County said it best, Pennsylvania and the Mon Valley are better places because of Ed Zemprelli. I am glad Senator Costa brought it up here today as we get ready to leave for the holidays, and we look forward to bringing his family to talk about him more at length. He was a giant in this building. He was missed when he left this building, and will be missed more now that he has gone on and passed, but he is someone we should give a thought to during this holiday season for what he has done for this Chamber, Pennsylvania, and the Senate as a whole.
