Senator BOSCOLA. Mr. President, it is my pleasure to introduce some special guests here in the Senate. We have two trauma registrars from the Lehigh Valley Health Network, and they are joined by several members of the Pennsylvania Trauma Systems Foundation. This foundation is the accrediting body for trauma programs throughout the Commonwealth. Through their diligent use of technology, they acquire data to enhance and improve outcomes for all injured patients. This data goes to better support clinical research, to provide quality education to hospitals, and educate the public and legislators on the value of this information. The foundation is committed to working with our health systems, like Lehigh Valley Health Network, and to reduce death and disability caused by trauma by providing evidence-based quality healthcare.

Therefore, Mr. President, I recognize our guests in the gallery today. We have Tammy Shaffer, a trauma registrar at Lehigh Valley Hospital, and Robin Schrader, who is the Lehigh Valley Hospital Trauma Registrar Coordinator. They have traveled here from the Lehigh Valley, and they are good friends with my colleague as well, Senator Browne. In the gallery as well are Pennsylvania Trauma Systems Foundation staff, Lyndsey Diehl, manager of trauma data quality unit; Stephanie Radzevick, trauma data analyst; and Gabrielle Wenger, trauma registry auditor.

I will also be introducing a unanimous consent resolution in the future to designate "Trauma Register Day" in the Commonwealth in 2018. I applaud them for their advocacy in getting such a resolution passed in the House as well. I ask the Senate to recognize the vital role they play and give them our usual warm Senate welcome.

John-Henry qualified for the 2014 Winter Olympics, but suffered from the swine flu and was unable to compete. In 2015, John-Henry was the 2015 Overall Men's National Champion.

I am incredibly honored to have such a distinguished guest here in Harrisburg today. Through his many years of training and hard work, John-Henry is an inspiring example of what dedication and passion can achieve. John-Henry, on behalf of a grateful community and country, I congratulate you on your silver medal in the 2018 Olympics and wish you the best of luck in the future.

clearly indicates otherwise:

"Business fee." A fee required to be paid to the Commonwealth or a political subdivision for starting or opening a business within this Commonwealth. The term does not include a fee for maintaining licensure or other requirement for continuing to operate a business.

"Reservist." A member of a United States Armed Forces reserve component or National Guard.

"Reservist-owned small business." A business owned and controlled by a member of a United States Armed Forces reserve component or National Guard.]

§ 9611. Exemption.

(a) Payment.--A veteran-owned [or reservist-owned] small business shall be exempt from the payment of a business fee.

(b) Proof.--A veteran [or reservist] must provide the department or licensing authority of a political subdivision with proof of the veteran's [or reservist's] status using any of the following with any business application:

- (1) A copy of a Federal DD-214 form.
- (2) A copy of a Federal NGB-22 form.
- (3) A valid Federal Veterans' Administration card.
- (4) A valid Department of Defense-issued military identification card.

(c) Status.--The Department of State or licensing authority of a political subdivision, in consultation with other Commonwealth agencies, may determine an applicant's status as a veteran [or reservist] in accordance with this section.

9621. Veteran-owned business logotype.

§ 9621. Veteran-owned business logotype.

(a) Logotype for veteran-owned businesses.--The department or its designee shall design an official Commonwealth logotype to be used by veteran-owned businesses.

(b) Logotype.--The logotype to be designed and issued shall include the Commonwealth Coat of Arms and the words "Pennsylvania Veteran-owned Business."

(c) Verify.--The department, in consultation with the Department of General Services, shall use the verification process under 62 Pa.C.S. § 2202(a) (relating to woman-owned business, minority-owned business or veteran-owned business) to verify the military service status of business owners seeking a veteran-owned business logotype.

(d) Application and issuance.--The department shall issue a logotype when the veteran-owned business is included on the list compiled and maintained by the Department of General Services under 62 Pa.C.S. § 2202(c) for veteran-owned businesses.

(e) Notice.--The department shall post on the department's publicly accessible Internet website a notice that the Commonwealth logotype is available to businesses provided for under this chapter and shall include the criteria necessary to receive the logotype and allow for access to the application and directions on how to submit the application.

(f) Authority.--Upon application of the business, the department shall have the authority to issue, without additional verification, a logotype under this section to a business that is currently approved by the Department of General Services under 62 Pa.C.S. Ch. 22 (relating to diverse and disadvantaged businesses).

(g) Penalty.--A person commits a misdemeanor of the third degree if the person fraudulently holds himself out to be a veteran for the purpose of obtaining a logotype.

National Prescription Drug Take Back Day began in 2010 by the Drug Enforcement Administration as a way to provide safe, convenient, and responsible means of disposing of unused and unwanted prescription drugs while also educating the general public about the potential for abuse of medications. We all know that the heroin and opioid overdose epidemic is the worst public health crisis in Pennsylvania and the nation in a generation. This epidemic has claimed more lives than that of the Vietnam, Iraq, and Afghanistan wars combined. Nationwide, Drug Take Back Day has proven over the years to be a successful event. Since 2010, the DEA and local law enforcement partners have collected more than 9 million pounds of prescription drugs. During last year's Drug Take Back Day events in April and October in Pennsylvania, 2,011 law enforcement agencies collected over 74,000 pounds of prescription drugs. Mr. President, this initiative addresses a vital public safety and public health issue. Unwanted, unused, or expired medications that languish in a home medicine cabinet or medications that are not disposed of properly are highly susceptible to diversion, misuse, and abuse.

Therefore, Mr. President, the resolution I offer today commemorates the 150th anniversary of the Pennsylvania Dental Association and recognizes the organization's long history of serving the residents of Pennsylvania.

Of course, Mr. President, I would be remiss if I did not acknowledge the sudden and tragic death of an active life member of the Pennsylvania Dental Association. Dr. Stephen Grady, a longtime Camp Hill dentist, along with Lancaster County businessman Jim Durkin, were killed last week when the small plane they were flying in crashed in Blair County. As the Pennsylvania Dental Association convenes in celebration of their anniversary, there will be, no doubt, heavy hearts as they mourn the loss of Dr. Grady.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, most of us in this Chamber are very familiar with the disease of cystic fibrosis. It is a genetic disease that affects approximately 30,000 children and adults in the United States, about 1,500 of whom live here in this Commonwealth. It is caused by a defective gene that causes the body to produce an abnormally thick, sticky mucus that clogs the lungs and leads to life-threatening lung infections and obstructions to the pancreas that prevent digestive enzymes from reaching the intestines to help break down food. More than 10 million Americans are actually symptomless carriers of this gene, and it occurs in 1 out of 3,500 births. But what has changed, Mr. President, in the years since we have recognized this, is that people are surviving longer and longer with cystic fibrosis. I recall, Mr. President, having students when I was a teacher who had cystic fibrosis and know now that they are still leading productive lives.

Since approximately 50 percent of the population with CF is at least 18 years of age and they have a variety of symptoms, we know that early diagnosis of CF permits the kind of treatment that makes a difference in people's lives. We can even screen infants at birth to detect those genetic defects so that we can begin the kind of treatment that these children will need to survive. We are fortunate, Mr. President, there are 12 world-class treatment centers in this Commonwealth that specialize in the diagnosis and care of individuals with cystic fibrosis. What is most critical, though, with this month, Mr. President, is for everybody to be aware of it and to recognize that this disease is still there, people are surviving longer, medical miracles are occurring, but we need to continually be aware of this and let the residents of the Commonwealth know that we all have a part to play in ending this disease.

Senator BOSCOLA. Mr. President, I am very impressed with how the Clerk pronounced that. Today, I offer this resolution

designating April 23, 2018, as the official day and awareness in Pennsylvania for a rare disease known as Fibrodysplasia Ossificans Progressiva, which is commonly referred to as FOP—not the same F.O.P. that you usually advocate for, Mr. President, it is a little different. FOP is a rare orphan disease of which only several hundred cases are diagnosed worldwide. Thirteen of those cases are confirmed to be within our Commonwealth by the International FOP Organization. This is a disease whereby if a child were to come across some type of trauma to their muscle, tendon, or ligament, known as a flare-up, instead of it healing like it would in you and me, it hardens and fuses with existing bone. These flare-ups are very painful, extremely painful, and this resolution aims to bring attention, research, and education surrounding FOP.

I first came to know about this disease through the story of the Scoble family of Emmaus, and their 11-year-old son and nephew, Joshua. Joshua's family have set up a really great non-profit organization on behalf of Joshua to increase awareness and offer needed support for other families affected by this disease. The Scobles are working tirelessly to ensure that a cure is within reach. So, therefore, Mr. President, I ask for the Senate's full support in declaring today "Fibrodysplasia Ossificans Progressiva Awareness Day." Thank you.

PETITIONS AND REMONSTRANCES

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise and take a few moments to cover a subject that I think is important for all of us in this Chamber, and certainly I know it is important to the people of Pennsylvania. Mr. President, again, yesterday folks woke up and had the opportunity to review the news to see that there was another tragic shooting that took place with an individual who took the lives of four individuals in Nashville, Tennessee. My recollection is that there was another college campus incident that occurred as well in the past week or so. Mr. President, it seems like every week we come to the Senate floor and we see these types of things occurring across our country. I believe that it is time for us to begin to have a conversation on addressing some of the reasonable and responsible things we can do here in Pennsylvania along those lines as it relates to how we manage the gun control conversation here in Pennsylvania.

Mr. President, let me be clear, I am not looking to take anyone's guns away or violate their Second Amendment right, but I do think there are some things that we can do in this General Assembly that allow us the opportunity to be thoughtful, as I mentioned, responsible, and reasonable in our approach. Earlier today Governor Wolf called upon the legislature to look at addressing the issue of background checks, eliminating the gun show loophole, and things of that nature. I believe that is a really good place to start. I would say, Mr. President, that this Chamber has already started down that path in a very thoughtful way when we passed unanimously, working in a bipartisan way, Senate Bill

No. 501, and I applaud my colleagues on both sides of the aisle and the Leadership on the other side of the aisle for working to advance those measures. Our goal now is, and should be, to move that process forward through the House and, hopefully, the House will take it up when they return next week and we will have the opportunity to get it to the Governor's desk. That supplemented the work that was done on Senate Bill No. 449, Senator Bartolotta's legislation, which was very important as it moved through this process and the whole series of domestic violence bills that we talked about. I believe, Mr. President, that really set the template for what we need to do on this subject matter of how we address weapons in this Commonwealth.

There are a number of things that we can look at that I know Members on both sides of the aisle put forth that we should talk about. Certainly, Mr. President, we need to look at the issue of bump stocks, the horrific mechanism or machinery that was used through the process by the Las Vegas gunman who killed in excess of 50 folks, the most horrific incident that occurred in this country. Mr. President, there are a number of other measures that are reasonable and responsible that we should be looking at. We should be looking at a bill that has been around for quite a while, one gun a month. Look at whether there is a reasonable balance that we can strike along those lines. It may not need to be one gun a month but it could be something that provides limitations on what is taking place to keep weapons out of the hands of those individuals who should not possess them. There are a number of other things, Mr. President. The issue of straw purchasers. I know we tried to address this issue in the past, but we did not go far enough, in my view, and there is more we can do to limit the ability in making certain that those individuals who are purchasing weapons for other individuals that they be incarcerated, or they be punished appropriately through that process, particularly if those weapons are used in some type of incident that results in the death of another.

We should also be looking, Mr. President, as to how we fund our schools. I believe that it is essential, particularly in light of what we saw take place in Parkland, Florida, recently, the need for more mental health counselors in our school districts and making certain they are in schools having conversations with students, not just at the high school level, but at the level before that, at junior high and the like. Legislation I have introduced along those lines to provide for sufficient funding, and I would add, Mr. President, it is an important subject matter that it should rise and fall on its own merits as relates to how we come up with the money. I do not think it is appropriate that we take money from some other agency in order to fund mental health counselors in our school districts.

Similarly, I think we need to look at what steps we can take to put more resources in our schools to allow them to appropriate a level of security in our schools. In addition to the support that would be provided for professionals along those lines, there are other steps that can be taken to make these buildings more secure. We need to look at resources along those lines, and I know my colleague, Senator Brewster, has introduced legislation. Those are important conversations that we need to have. There are certainly others, Mr. President, that we can be looking at. There is certainly something along the lines of mandatory reporting of lost and stolen weapons that is something that I think, again, has been around for a little while but we have not had the courage at this point to address it.

These are some of the responsible, in my view, and reasonable steps that we can take along those lines. And there are more conversations that could take place. To give one example would be the assault weapon ban as well as limitations on the number of bullets in a magazine, how many there would be. I know that stirs up a lot of concern by a lot of people, but other States have addressed and have tackled it. It is my understanding that Connecticut, while it maintains assault weapons in that State, they do so by registering and requiring background checks, and by requiring a review and showing a proficiency of the ability to use that weapon, is my understanding. Maybe that is where we end up here in Pennsylvania, but at the end of the day, the conversation is important to have. These are measures that I think the public wants us to take a look at. I recognize some are controversial, but many are not, and it is those reasonable ones that I think, at a minimum, we should continue to address. Address in the same manner that we dealt with the issue of domestic violence, by working together, having conversations, and putting together a package of bills that allow us to have an impact on things that are taking place in this Commonwealth. There is no question that the young folks in this Commonwealth and this country have stood up and provided multiple opportunities in terms of speaking out and looking to their respective legislatures and looking to Washington, D.C., to take steps to try to help and move and advance measures that protect our students, protect our families, and protect our loved ones. That is what we should be talking about.

So my hope, Mr. President, as we move forward over the next couple of weeks, when we have some down time between now and the election, that when we come back on May 21 that we begin at that point to have serious conversation about advancing some of these reasonable and responsible measures that we could be looking at and, hopefully, stand one day with the Governor signing measures that allow the things that need to be done to take place. So, Mr. President, I am asking my colleagues to join me in looking and pushing our respective Leaders on both sides of the House, and both sides of this General Assembly, looking to make certain that we have the very, very important dialogue and conversation about crafting measures that are fair, that are balanced, that are reasonable and responsible, and address the concerns that many Pennsylvanians have about what needs to be done.
