The PRESIDENT (Lieutenant Governor Mike Stack) in the Chair.

## HB 152 (Pr. No. 3556) (Amended)

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in life insurance, further providing for surplus or safety fund and providing for contact information and for life policy locator service; and, in suitability of annuity transactions, further providing for definitions, for applicability and scope of article andfor duties of insurers and insurance producers, providing for insurance producer training, further providing for mitigation of responsibility and for recordkeeping and providing for regulations. Senator HUTCHINSON, from the Committee on Finance, reported the following bills:

## SB 37 (Pr. No. 18)

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in sales and use tax, excluding from sales and use tax all equipment and devices which prohibit a firearm from being fired without a key or combination.

## SB 1058 (Pr. No. 1513)

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in disposition of abandoned and unclaimed property, further providing for property held by business associations.

## HB 994 (Pr. No. 2909)

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in gross receipts tax, further providing for imposition of tax.

An Act designating a bridge on that portion of Pennsylvania Route 100 over the Schuylkill River in Pottstown Borough, Montgomery County, as the Newstell Marable, Sr., Memorial Bridge; designating the bridge on Stoughstown Road over Interstate 81 in Cumberland County (bridge number 21-3007-0020-0865) as the Private Raymond Lafayette Naugle Memorial Bridge; designating the bridge on Maple Avenue over the Yellow Breeches Creek in Walnut Bottom Township, Cumberland County (bridge number 21-3009-0012-0000), as the Sergeant Kenneth Lee "Buck" Devor Memorial Bridge; designating a bridge on that portion of U.S. Route 219 South, over U.S. Route 22, also known as the Admiral Peary Highway, in Cambria Township, Cambria County, as the PFC Nick Kozorosky Memorial Bridge; designating a portion of Pennsylvania Route 54 in West Mahanoy Township, Schuylkill County, as the Francis V. "Angie" McAndrew Memorial Highway; and designating a portion of State Route 2026, in Upper Moreland Township, Montgomery County, as the Corporal Michael Dennis Cooke Memorial Highway.

## HB 1646 (Pr. No. 3568) (Amended)

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in licensing of drivers, further providing for suspension of operating privilege; in rules of the road in general, further providing for speed timing devices and providing for automated speed enforcement systems; and, in miscellaneous provisions, further providing for careless driving.

## SPECIAL ORDER OF BUSINESS SENATE RESOLUTION ADOPTED

Senators VULAKOVICH, COSTA, BAKER, BARTOLOTTA, BLAKE, BREWSTER, BROOKS, BROWNE, DINNIMAN, EICHELBERGER, FARNESE, FONTANA, GORDNER, GREENLEAF, KILLION, SABATINA, SCHWANK, VOGEL, WAGNER, MENSCH, RAFFERTY, FOLMER, HUTCHINSON, AUMENT, YUDICHAK and HUGHES, by unanimous consent, offered **Senate Resolution 369**, entitled:

A Resolution designating May 23, 2018, as "National Guard Day" in Pennsylvania.

On the question, Will the Senate adopt the resolution? The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Vulakovich.

Senator VULAKOVICH. Mr. President, I offer this resolution designating today as "National Guard Day" in Pennsylvania. On November 25, 1755, the General Assembly passed Pennsylvania's first militia law creating a volunteer militia which laid the foundation for the Pennsylvania National Guard. Today, 263 years later, our Commonwealth has one of the largest and most deployed National Guard forces in the nation comprised of the Army National Guard and the Air National Guard.

Between 1755 and 2018, Pennsylvania's militiamen and subsequent National Guardsmen and women played a large role in every major military action from the French and Indian War through the global war on terror. They were there for the Revolution and they served in the Civil War. Some of the most storied exploits of the 28th, or Keystone Division, came on the European battlefields of World War I and World War II. They fought in Korea, Vietnam, and in the Middle East. Pennsylvania's citizen soldiers continue to serve with honor and distinction today in military and disaster relief roles. Pennsylvania's National Guard force, led by Adjutant General Anthony Carrelli, reaches from the Joint Force Headquarters located at Fort Indiantown Gap, Lebanon County, to almost 90 communities across the Commonwealth. The Pennsylvania National Guard employs about 3,600 in a full-time capacity, while another 16,400 men and women serve in a traditional part-time basis, making the Pennsylvania National Guard one of the Commonwealth's top 10 employers.

Today, on National Guard Day, we remember these citizen soldiers, ordinary people who make extraordinary sacrifices. We owe them our deepest gratitude, and in that spirit, Mr. President, I ask my colleagues to adopt this resolution, and I ask all Pennsylvanians to remember and give thanks for all of the soldiers and airmen from across Pennsylvania who have served or are serving our Commonwealth today.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise to echo the comments of my good friend and colleague from Allegheny County and the chairman of the Committee on Veterans Affairs and Emergency Preparedness, Senator Vulakovich. In talking and speaking about the role that the National Guard has played in this country over the course of our history over the past 263 years, I really want to highlight, though, and I have remarks I will submit for the record, but I really want to highlight the point about men and women who have served and men and women who today serve across this country and abroad, the work that they do, and that they are everyday folks, as he referred to them as ordinary men and women. General Carrelli, when he spoke this morning at the briefing, talked about how these men and women come from every single ZIP Code in our Commonwealth, every single community, and provide services to our country and to our Commonwealth. Whenever the Governor calls upon them to address disasters, they stand there ready and are ready to go to work. When our President calls upon them to defend our country, they stand and are ready to be part of that discussion that needs to take place and be able to provide what needs to be done.

So I am honored to stand here in support of this resolution. I thank the gentleman from Allegheny County for bringing it forward, and I ask all of my colleagues to join all of us today in

recognizing the resolution that we will be voting on momentarily. And I offer remarks for the record, if I could.

The PRESIDENT. Without objection, Senator Costa's remarks will be spread upon the record.

## (The following prepared remarks were made part of the record at the request of the gentleman from Allegheny, Senator COSTA:)

Mr. President, it is my honor to sponsor this year, and every year, a resolution that thanks and recognizes the Pennsylvania National Guard. Our National Guard is one of the largest and oldest divisions in the country with 3,600 full-time members and 16,400 in traditional parttime service who train while they pursue civilian education or careers.

They come from every walk of life and from every part of the State. What brings them together as a team is their love of country, community, and their commitment to all Americans. The history of the Pennsylvania National Guard goes all the way back to 1747, when Benjamin Franklin formed the "Associators," the precursor to the National Guard. And in 1755, the General Assembly enacted its first militia law. In the following 263 years, the National Guard has served Pennsylvania reliably and faithfully whenever called upon.

This unique branch of the military not only serves our State, but the nation as well. Unlike the other branches, Guard soldiers can be deployed by the governors of their resident States to support communities stricken by natural disasters like floods and hurricanes. But Guard soldiers can also be deployed by the President of the United States to defend our country or support our allies overseas. The Pennsylvania National Guard has soldiers currently serving overseas, and many in training for future deployment. Whether they are serving at home or abroad, they are making Pennsylvania proud every time.

Please join me in honoring their service today and every day.

The PRESIDENT. The Chair thanks the National Guard for all they do and for allowing me to serve for 8 years. What a wonderful experience, the best National Guard in the world.

And the question recurring,

Will the Senate adopt the resolution?

A voice vote having been taken, the question was determined in the affirmative.

## GUESTS OF SENATOR RANDY VULAKOVICH PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Vulakovich.

Senator VULAKOVICH. Mr. President, as part of National Guard Day at the Capitol, I am proud to introduce Major General Anthony Carrelli, the 53rd Adjutant General of Pennsylvania.

The PRESIDENT. Let us now welcome Adjutant General Carrelli to address the Pennsylvania Senate.

(Applause.)

Major General CARRELLI. Thank you, everyone. Mr. President, distinguished Members of the Senate of Pennsylvania, thank you so much for having National Guard Day at the Capitol and for passing that resolution honoring the men, the women, the family members of Pennsylvania. We are Pennsylvania. We grew up in Pennsylvania, we live in Pennsylvania, we raise our families here, we go to school here, we do our civilian jobs here. We are Pennsylvania. We are your neighbors, we are part of your family, and we live in your communities. When the Governor or the President calls, whatever time or whatever place, whether it is to serve on an interstate road within Pennsylvania or to serve in a country halfway around the world from here, your Pennsylvania Guardsmen answer that call, put on their uniforms, and selflessly serve wherever they are needed, and that has happened time and time again. This year is no exception.

As I stand here before you, over 850 Pennsylvania Guardsmen are serving globally for Federal purposes, the war on terror across the world. We have had a busy year here at home as well with all of the hurricanes obviously that we had in the fall season. We sent Guardsmen to Texas, to Florida, to the Virgin Islands, and to Puerto Rico. We did snowstorms, we did the Erie snowstorm over Christmas, we did three snowstorms in March. over a thousand Guardsmen just in March alone on the streets of Pennsylvania into our neighborhoods going door to door to make sure that people were okay, the people who lost power, or were stranded on highways, all part of your Pennsylvania National Guard. We thank you so much for your support of our budget and our initiatives to further our National Guard training, programs for our family members, and for our veterans to retain them and to show them that Pennsylvania does care about their service here in the Commonwealth.

This is also a big year for us. It is our 25th anniversary of our State partnership with Lithuania. Of course, just before that partnership began, Lithuania earned its independence from the Soviet Union. I will tell you, I have had the great pleasure of traveling there many times. I know a number of the General Assembly have had trips out there, and I encourage anyone who is able to visit anytime you can. We do not have a better ally in Europe than the people of Lithuania, and, of course, Pennsylvania is home to the biggest population of Lithuanians in the United States. There are a number of Lithuanian communities scattered throughout Pennsylvania. We are honored today to have the Lithuanian defense attache, who drove up from Washington to be here for National Guard Day. I ask Colonel Siuparis to please stand. Colonel Alvydas Siuparis, a Lithuanian Army officer, served alongside of us in Afghanistan in 2009. Thank you so much for attending here today.

(Applause.)

Major General CARRELLI. We also have with us my Deputy Adjutant General for Air, Brigadier General Mike Regan, and our senior enlisted leader, Command Sergeant Major Harry Buchanan. If you guys would please stand as well. Thank you for attending.

(Applause.)

Major General CARRELLI. We also brought three hometown heroes, just a small sample of the Guardsmen that you have across your communities all throughout the Commonwealth. Specialist Patrick Stevens, Myerstown, Pennsylvania, please stand. Patrick is a financial management technician with the 628th, FMSD, and he joined the National Guard in 2015. He works full-time as a Federal technician with the United States Property and Fiscal Office at Fort Indiantown Gap. He deployed to Erbil, Iraq, for Operation Inherent Resolve for nearly a year and returned this past December. Patrick is only 23 years old, has already deployed, and has accomplished so much in the National Guard. Thanks, Patrick, for coming here today.

(Applause.)

Major General CARRELLI. We also have Dana Battersby from Lykens, Pennsylvania. She is a supply specialist with the 721st. She deployed to Afghanistan in support of Operation Enduring Freedom in 2014. She is a full-time active duty soldier with us as a supply specialist. Dana waited until she was 35 years old to enlist in the Pennsylvania Army Guard. You are never too old. She enlisted in 2012. Thank you so much for your service, Dana.

(Applause.)

Major General CARRELLI. Last, I would like to point out technical sergeant Allyson Manner from Titusville, Pennsylvania. Allyson is a photojournalist with the 171st air refueling wing out of Pittsburgh, Pennsylvania. She works full-time in Acutec Precision Machining manufacturing aircraft parts. She recently was deployed to the Horn of Africa, where she offered numerous stories and articles and recorded nearly 5,000 mission images in her photographic work while deployed in Uganda and Djibouti, Africa. She was personally selected to be the photograph support specialist for United States Secretary of State Tillerson for his trip out there. She was also awarded a Joint Service Commendation Medal, which almost never happens at her level, but they were so impressed with her work and her dedication for that entire deployment in Africa. She even offered to extend her duty out there because she knew her duty was so important. She returned from Africa 3 weeks ago. So welcome home, Allyson.

(Applause.)

Major General CARRELLI. We have other Guardsmen up in the balcony. I would like for them all to please stand, and we have some family members here as well. I cannot tell you enough about our family members and the sacrifice that our family members make every single day to support our Guard careers, and the time that we spend away protecting the Commonwealth and country. So to the rest of our Guardsmen and families, thank you so much for coming and sharing the day with us.

(Applause.)

Major General CARRELLI. Once again, it was a great pleasure for me to address the Senate today. I do have the best job in Pennsylvania. I could brag all day about what our Guardsmen and families do. It is so important the work that we do, and I thank each and every one of you for your support for our Guardsmen, their families, and our veterans. Thank you very much.

## GUESTS OF SENATOR THOMAS H. KILLION PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Killion.

Senator KILLION. Mr. President, it is my pleasure this afternoon to introduce the Bayard Rustin High School Boys' Ice Hockey Team, the 2018 Pennsylvania Cup Class A Ice Hockey Champions. This is the Golden Knights' fifth consecutive State championship and the school's sixth championship overall. In addition to their March 2018 State championship victory, they also won their fifth consecutive Eastern Pennsylvania Interscholastic Hockey Association Class A Flyers Cup Championship that same month. It should be noted that in April of 2017, this team traveled to Cleveland, Ohio, where they captured a Class A National Championship title by defeating California Santa Margarita Catholic High School by a score of 4-3.

Bayard Rustin High School is part of West Chester Area School District located in Chester County, and both myself and Senator Dinniman represent these students. The team is led by head coach Nick Russo and assistant coaches Ken Sheriko, Michael Giduck, David Aurillo, and Dustin Doyle, goalie coach Jim Rolston, and team manager Karen Greenberg. I am pleased to recognize these young athletes and coaches, who through their outstanding achievements brought great distinction to themselves, their communities, and our Commonwealth. Senator BAKER. The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I rise to introduce and to review the great experience of our Chaplain for today, Air Force Chaplain and Captain Tony Repic. Captain Repic is a military chaplain with over 12 years of pastoral and military ministry. He is experienced in a variety of counseling issues including crisis, suicide intervention, depression, substance abuse, marriage and family, financial, men's issues, post-traumatic stress, and grief. He is committed to helping people find help and hope through the power of God. He currently serves as a U.S. Air Force Chaplain who serves airmen as well as soldiers in the United States Army. He is married and he and his wife have three children.

His educational background is certainly impressive. He has a Master of Divinity from Liberty Theological Seminary, master of arts from Liberty Theological Seminary, bachelor of the arts in Bible science from Valley Forge Christian College, financial peace certified instructor, Chaplain Officer basic course, Chaplain Captain career course, suicide intervention, and Strong Bond instructor certification. He also has counseling experience in the U.S. Air Force and the U.S. Army and chaplain and assistant college and career pastor at the Calvary Chapel in Philadelphia.

It is our great honor to introduce him and to have him here today with all of his fellow men and women in arms.

The PRESIDENT. Would the guest of Senator Greenleaf, our guest Chaplain Captain Tony Repic, you have risen, please accept our warm welcome from the Pennsylvania Senate and thank you for your prayer, chaplain.

## GUESTS OF SENATOR MARIO M. SCAVELLO PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Monroe, Senator Scavello.

Senator SCAVELLO. Mr. President, I welcome Aidan Bloch, who is serving as my guest Page here in the Capitol today. Aidan is a well-traveled young man. He is an 11-year-old resident of Jackson Township, Monroe County, the youngest of six children, he is in the fifth grade at the Immaculate Conception School in Pen Argyl, Northampton County, and he is an altar server at St. Thomas More Catholic Church in Scranton, Lackawanna County, and he is Boy Scout at Troop 85 in Pocono Township. Senator FONTANA. Mr. President, Senate Bill No. 439 simply requires all childcare facilities in Pennsylvania to install and maintain at least one carbon monoxide detector. Mr. President, unfortunately, according to the Centers for Disease Control and Prevention, Pennsylvania is a national leader in carbon monoxide deaths and poisoning, and that is because, obviously, Mr. President, a lot of buildings in Pennsylvania have fossil-burning heaters and appliances. However, these deaths are entirely preventable. The only safe way to know if carbon monoxide is present in a building is with a working alarm. Although carbon monoxide poisoning can be fatal to anyone, children are particularly vulnerable, and that is why I think it is especially important to have these devices in childcare facilities. Mr. President, these detectors average \$20 to \$50. That is a small price tag to put on an individual's life, especially a child.

I also thank Senator Laughlin for his amendment in identifying other types of carbon monoxide detectors to be included in this bill and working together to obviously improve this bill.

Senator MENSCH. Mr. President, Senate Bill No. 1092 deals with the occurrence of domestic violence in front of children. Specifically, this legislation creates a sentencing enhancement for the offenses of simple and aggravated assault. These offenses are the two most commonly charged for the acts of domestic violence. This legislation is the result of a joint effort by the Pennsylvania District Attorneys Association and Cabrini University Center for Children of Trauma and Domestic Violence Education. In addition, many others have also supported this legislation such as the Pennsylvania Coalition Against Rape, the Pennsylvania Coalition Against Domestic Violence, the Center for Children's Justice, and the Victim Advocate.

Mr. President, although children are less likely to be the direct victims of domestic violence, they are often present when violence occurs. Studies show that 1 in 10 children in the United States are exposed to domestic violence, and the majority of these children are under the age of 6. Regardless of age, Mr. President, children are not immune to this trauma. Consider the content of an educational video produced by the California Attorney General's Office, and I quote: (Reading)

Unlike other organs, the brain is underdeveloped at birth and it is waiting for experiences to shape how it will develop. The amazing thing about the human brain is that the younger you are, the more sponge-like your brain is, which is the reason that children in three years can learn language, can learn to walk, can do all kinds of incredible things, but the very same biological sponginess that allows us to rapidly acquire language is also the same sponginess that makes young children more vulnerable to trauma than older children.

Witnessing family violence is a traumatic experience. Seeing or hearing a family member being threatened or beaten can shatter a young child's sense of safety and security, perhaps forever. The short-term consequences of a child witnessing this violence include increased anxiety, depression, low self-esteem, aggression, difficulty concentrating, social isolation, and the lack of empathy. The long-term consequences are similarly troubling. When these affected children grow up, they are more likely to engage in dangerous behavior. Additionally, they are more likely to be caught up in a vicious cycle of abuse where they too become the abuser or perhaps the abused. Mr. President, the data is clear that when a perpetrator commits an act of violence in front of a child, there is more than one victim. The child suffers many of the same consequences as if he or she had been the direct victim.

My expectation for this legislation is that it will help to end the vicious cycle of domestic violence found in our society. I thank my fellow Senators for their past support of this important legislation, and I ask for their continued support today.

**SB 652 (Pr. No. 1784)** -- Without objection, the bill, which previously went over in its order temporarily, was called up, from page 2 of the Third Consideration Calendar, by Senator CORMAN.

## BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 652 (Pr. No. 1784) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in burglary and other criminal intrusion, further providing for the offense of criminal trespass.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Regan.

Senator REGAN. Mr. President, the bill before us is an important, a very important piece of legislation. Pennsylvania has a vast amount of what are termed critical infrastructure facilities. These include, but are not limited to, natural gas distribution facilities and compressor stations, above-ground pipelines, electrical power generating facilities, water intake structures and treatment facilities, freight transportation facilities, wireless telecommunications infrastructure such as cell towers and telephone poles, and steelmaking facilities using arc furnaces. What Pennsylvania does not have though is a law that differentiates between trespassing on everyday property or buildings and trespassing on critical infrastructure facilities. Senate Bill No. 652 looks to change that by making it a third-degree felony for trespassing on such a facility and a second-degree felony for trespassing with the intent to do damage or impede operations of the facility. It would also be a second-degree felony to willfully defy orders to leave the facility.

Mr. President, I want to be clear that this legislation is not, and I repeat is not, an attempt to impose on anyone's civil liberties and their First Amendment rights. This bill does not make any activity illegal that is not already illegal. Also, this bill is not just about pipelines. We have support from entities like Verizon, Comcast, Norfolk Southern, PA American Water, PA Manufacturers Associations, and many, many more. Businesses that operate critical infrastructure facilities simply want to be able to do so without the the interference from trespassers. But in the event that someone does trespass, despite signage or fences, they want Pennsylvania law to have the teeth in order to hold those individuals accountable. Current law is a slap on the wrist. The types of facilities that we are talking about warrant more stringent punishment if someone willfully trespasses, and more so if they do damage or hinder operations.

The residents of Pennsylvania rely on many of these facilities for electricity, telephone service, clean water, natural gas, and the delivery of goods. Halting operations not only affects the business but the people of the Commonwealth and its economy. Damage to the facilities can do the same, but can also be harmful to people's health or even life-threatening. These facilities are often the subject of terroristic threats. Mr. President, I respectfully ask that my colleagues join me in supporting Senate Bill No. 652 and recognize the need for this important legislation.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, I respect the gentleman from York County and I usually would follow his lead on matters that deal with security because he certainly has some expertise in this matter. But I need to represent my constituents in Chester County, constituents who have felt powerless in terms of the Sunoco building of Mariner I, constituents who know that in Pennsylvania there are no laws involving siting or no laws involving the geophysical aspects of the terrain, and have created a network of about 80,000 people now so that they can gain a say in what happens. They look upon this piece of legislation, as do environmental groups, as does the ACLU, as an attempt to curb their protest. If you talk to these individuals, they are not radicals, they are moms and dads who are simply concerned about the use of eminent domain, who are concerned about the fact that no one will discuss the safety of these pipelines, and they feel powerless because there is not efficient regulation in Pennsylvania. So they look upon this piece of legislation differently than perhaps the maker of the legislation has intended it to be.

We certainly are concerned about the destruction of any property that is involved. In fact, I only know of one instance where there was some destruction of some machinery, and the groups opposed to the pipeline actually put up a reward fund to help catch the people involved. But what they want is the ability to be able to go onto the fringes of the property with signs and be able to protest, and my fear, and I hope Members can understand this, if you have people who feel powerless, if you have no regulations to protect them here in the Commonwealth, which is unfortunately the situation, then what happens is powerless people are made angrier and feel less that the government is going to do anything for them when we take away or what they perceive to limit the ability to protest.

Now, a felony understand, even this particular felony, which has a cap on it, in my own view and the view of many of my constituents, is one that is more serious than a misdemeanor, is one that would add to one's point score on records in terms of future cases that might come before the court. I am sure Senator Leach, who is our chair of the Committee on Judiciary, can talk better than I can, I know he will talk concerning the illegality and the making of this as a felony.

What I am trying to do is stand up and say this to you quite clearly: if I am a citizen in a house and my private property rights have been taken away because of eminent domain given to a corporate entity based on a 1930s piece of legislation, if I am a property owner who sees that they can destroy my backyard with sinkholes and there is nothing that anyone does about it, if I am a property owner who goes to the government, but yet in the State of Pennsylvania we have no regulation of those who build these lines, and now we are going to create a felony if they step foot on that property with a protest sign which further threatens their rights, you are only going to make people angrier. You are only going to make people feel more powerless. Let us keep the bill as it is, let us keep the law as it is where it is a misdemeanor charge anyway, and there are various levels of misdemeanor charges and, in fact, on the highest level of the misdemeanor charge the punishment is actually the same in terms of the \$5,000 fine, or the period of 1 year you go to jail, as this bill would. I think it is an insult to those who have been screwed over, to be quite blunt, by Sunoco that we now at this moment in time put this bill in. If this was 2 years ago, you would not have the reaction that you are having now.

And, finally, let me say to all my colleagues, that I support gas lines. I support and understand the prosperity that comes from this. But, you cannot do this against someone without taking into consideration how people feel on this issue, they feel powerless and this piece of legislation will make them angrier and feel more powerless, and that is not going to solve our problem of getting products to market so we can share in the prosperity that comes from natural gas. So, I stand up to voice my opposition, but I want to make this clear, I do so with great respect for my colleague from York County because he really is and has probably great expertise in this matter, but I stand up in the interest of my colleagues, and I stand up because I do not want people to feel more powerless, which I believe will be the result of this legislation.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Leach.

Senator LEACH. Mr. President, I want to talk a little about the law as drafted and what I think the consequences are and some of the things we may not have completely thought out. Let me begin first by saying that I support the idea that people who break into facilities with the intent of doing damage or who do damage, that should be a serious offense. Public safety is at risk. Those people should be punished. That is not what my objection to this bill is about. I note that there already are plenty of provisions in criminal law which allow punishment of that sort of activity. This is a strange and, I think, poorly crafted law that will have, I think, severe unintended consequences and will not accomplish what I think the authors of the bill are trying to accomplish.

Let me say that under current law, there are both statutes prohibiting trespassing and vandalism. Under current law you can be convicted of felony trespassing. You can be convicted of third-degree felony trespassing if you enter a facility by subterfuge or surreptitiously. You can get a conviction of second-degree felony if you physically break into a building or occupied structure. It does not have to be a critical infrastructure facility, but it could be. That is covered under these laws. So anyone who goes in with the intention of destroying an electrical facility or doing damage to a pipeline is already subject to a felony conviction under current law. However, you must show some things. The State must show to convict someone of these severe criminal offenses, A, it is subterfuge if it is a third-degree felony, meaning that they lied, they did some other things knowingly to get into that facility. To get a second-degree conviction, you have to show that they physically broke in. Under the current law, that is the situation. Under Senate Bill No. 652, you do not have to show any of that. Essentially, all you have to show, and I have the language of the bill, I am looking at section 3503(i) "Enters or attempts to enter property containing a critical infrastructure facility, knowing that" you are not allowed to be in there. The fact is, it is a strict liability offense essentially as long as you are on the property. You do not have to do any damage, you do not have to lie to anybody, and you do not have to break in.

One of the big problems with that, of course, is that, and I will get to the pipeline issue because I think that is what we are getting at here, I think that is the purpose of this law, because there is a controversial pipeline in the southeastern part of the State, and there have been a lot of protests and we are trying to stop those protests. But I have been to those pipelines. These pipelines, first of all, they are not fenced; and second of all, they run through people's backyards. So, people can literally step onto that property and under the language of this law be guilty of this offense simply by walking through their yard, in some cases, and certainly by protesting near these facilities. And so, that is a huge problem. The current law does not cover peaceful protesting. You cannot be convicted for peaceful protesting. Here, this makes peaceful protesting extremely risky, which is something I do not think we want to do.

It also makes more things felonies. Things that look a lot like protesting. Even entering an unfenced area, refusing to leave, and, again, if you are not doing damage and you are not blocking anything, that is part of protesting. If anyone ever watches civil disobedience, whether it is protesting on the right or on the left, whether protesting the war in whatever country, abortion, the President, the opposition to the President, whatever protesting it is, often you see people sit in the streets and have to be taken away. That is part of the normal sort of civil disobedience of protesting. And under current law, you can be charged with misdemeanor trespassing if you do that. But here, it would become a felony. And I just want people to understand the consequences of making things a felony, because there are a lot of consequences beyond jail time, and I will get to jail time because there is something very strange about this bill in regards to that.

But, if you are convicted of a felony, putting aside jail time, you, for example, cannot own a firearm anymore. You cannot hold certain public offices. You cannot serve on a jury. You are prohibited from working in certain areas such as nursing, education, gaming, healthcare, in some cases, plus employers are permitted to consider the potential employee's criminal history. You have all heard about bosses who make you check a box. Well, you would have to check the box that you were convicted of a felony, if you were convicted under this law, for the rest of your life, which would seriously impede your ability to get employment.

It also serves as a basis to deny State licenses for professional occupations and activities. For example, architecture, physical therapy, or legal licenses. It disqualifies individuals from State and Federal benefit programs such as higher education loan assistance programs and Medicare and Medicaid in certain circumstances. So this is really significant.

Now, there is one thing that I mentioned that is very strange about this law, because under current law, and I used to be on the sentencing commission and I did a lot of criminal law when I was practicing law. Under current law, felonies are subject to significant jail time. They are subject to 5 years to 10 years of first-degree felony, 20 years, long prison sentences. However, this law caps prison sentences at 1 year, except for the first-degree felony, which is a repeat offense, which is 2 years. I have never seen a law that we have passed before override the sentencing guidelines that apply to all laws to create a lesser penalty. And I asked in the Committee on Appropriations yesterday, what is the purpose of this law? And the purpose of this law, I was told specifically, is to increase penalties for these offenses. In reality, under current law if I commit a trespass, if I break into a structure as a second-degree felony, I can go to jail for a long period of time. I can go to jail for a decade for that. I can go to jail for 10 years. Under the new law I can only go to jail for 1 year. Now, that raises some interesting questions. Why would you pass a law to get tough on something when you cap the penalty so it is less than current law?

Well, the cynic in me suggests there are a couple of reasons. Number one, you could charge someone with both laws. You could charge someone under Senate Bill No. 652 and under the current criminal trespass laws. We are not repealing the current criminal trespass laws. So, the person would face the possibility of a felony conviction under one law and a lengthy prison term under another law. It would be a very difficult position to be in and it would give, obviously, the State a lot more power on issues like plea bargaining, and that is troubling.

The other thing is the conspiracy part of this law is troubling. There is no conspiracy part under the current criminal trespass law. Under this law, you can be convicted of a felony, under section 4, for conspiring with another person to commit a prohibited act, which, again, could be walking on property that belongs to Sunoco, for example, where they are building their pipeline.

Doing no damage, climbing no fence, telling no lie, just walking onto that property which may be in your backyard. If you talk to another person about it first, that would be a conspiracy charge, and conspiracy charges in the context of protesting are extremely problematic because, for example, under this law, and under every conspiracy law, you do not have to actually commit the act. All you have to do is something in furtherance of the act. One overt act in furtherance of what the statute prohibits. So for example, you do not actually have to go on someone else's property. You could just solicit people to go on other people's property. So let us say the Sierra Club sends an email around and says, we are protesting the Mariner II Pipeline tomorrow at noon and someone shows up, and let us say someone walks onto the property, the Sierra Club, or the person from the Sierra Club who sent that email could be liable. This is a very effective but damaging way to stifle lawful, peaceful protest. And as Senator Dinniman eloquently said, when you stifle lawful, peaceful protest, you unleash the risk of not so peaceful protest. I mean, that is an outlet for people to be able to express themselves. When people cannot express themselves, bad things happen and that is not what we want. That is why we allow peaceful protest.

I would say also in terms of this law, it is weird because I assume someone will say it is not specifically designed to address the Mariner East Pipeline situation. However, the bill contains a long list of critical infrastructure facilities, but out of the 19 paragraphs, I believe--and I am going to make sure, I am sorry, the 21 paragraphs--that talk about what a critical infrastructure is, they mention pipelines three, four, five, they mention pipelines eight times. They mention them over and over again, the same thing over and over again in paragraphs 5 and 6 and 15 and 16 and 17 and 18 and 19. Pipelines used to transport natural gas; liquid or chemical pipelines; a pipeline; a pipeline connection; an above-ground pipeline; pipeline interconnection again; and a natural gas pipeline. They keep saying it over and over in the bill. It is hard to not believe, given that and given there is nothing else that is mentioned eight times, the bill is just as effective if you only say it once, and it suggests a real effort to stop the protest of this pipeline.

Again, just to conclude, this is a very cumbersome cudgel, a sledgehammer of a bill which has all kinds of unusual provisions that we do not see anywhere else in the criminal law in an effort to stifle protest against a current controversial issue. That is not the kind of legislation we should be passing. I would note, the one thing we do want to stop, and that is the one thing I mentioned in the beginning of my remarks is, we want to stop damage. We do not want people doing damage to the pipeline. That could be really harmful. There has been, to my knowledge, not one example of anyone committing any sort of damage on these pipelines. So in order to solve a problem that has not yet happened and there is no indication is about to happen, we are creating an entire new crime, an entire new class of felonies, and we are doing it by targeting people who have been peacefully protesting, which is what we tell them they are supposed to do when they disagree with the law. No one has committed any vandalism that I am aware of. Certainly the people I am working with, they show up with their signs, they chant, they give speeches, that is what America is. If nothing else, that is what America is.

So I understand, whether you are for or against this pipeline, because keep in mind, this sort of philosophy can be used against all kinds of protest. So whether you are for or against this pipeline, I would urge a "no" vote because the bill does not make sense, it is odd, it is poorly drafted, and the one thing it does do is it puts peaceful protesters at risk of serious criminal charges. And I think that is the wrong way to go in a period of American history where the right to protest is already under significant assault.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, I rise today in opposition to Senate Bill No. 652 and I have already made some -- I have already spoken on the bill before, so I will keep my comments brief. I am going to take a little bit of a different approach and talk about an issue that I have addressed before, and that is one of free speech. Now, I understand the intent of the bill is to create a deterrent to trespassing on certain facilities and structures with the goal of keeping the public safe. I understand that and I applaud the maker of the bill for that intention. But while I support that intent, I believe that the bill, as it is drafted, goes a bit too far. I fully recognize that the rights of free speech and assembly may be limited, and the irony here is that this is a point which is sometimes lost in translation with my colleagues on the other side of the aisle when we talk about the Second Amendment. Second Amendment, First Amendment, we accept reasonable limitations on these rights. This bill, when you boil it down, is essentially an attempt to responsibly limit our right to free speech. It is not the only amendment that can be limited, but this bill certainly does attempt to do that in a responsible and reasonable way. We could footnote that there because this is a discussion that we have had in this Chamber many different times. But if we are going to limit those rights to free speech, it needs to be done for a very important purpose and it needs to be very carefully drafted.

Now, Mr. President, I personally dealt with the struggle to find a balance between free speech when I was pushing my anti-SLAPP legislation. Again, that is a bill which is, like this, pinpointed on the right of free speech and to exercise one's right to free speech. But in my opinion the balance between free speech and protecting the public is a bit off here.

Senate Bill No. 652 makes it a third-degree felony to enter a critical infrastructure facility even--and this is the problem--even if there is no intent to cause any harm. Think about that. It is a third-degree felony to enter a critical infrastructure facility even where there is no intent to cause any harm. So that means, Mr. President, that a protester could spend time in prison if found to have entered a facility, even if all parties agree that there was no intent to cause damage and that they just wanted to have their message heard, or otherwise they chose to, on that particular day, at that particular place to exercise their right to free speech. But this bill and the maker of this bill intend to put a reasonable restriction upon that. That is what we are doing. This is the maker of the bill attempting to put what he believes to be a reasonable restriction upon the right to assemble, the right to free speech.

Now, there is a balance, Mr. President, that needs to be performed, and it is not a balance to me, but instead, when I look at this bill, the overall effect is that one's right to free speech is essentially chilled. In committee, there was a discussion where Members expressed that it was not the intent of the bill to apply to protesters standing on the sidewalks surrounding the facilities, but that clarification is not found anywhere in the text. Let me say it again. There was a discussion during committee where Members expressed that it was not the intent of this bill to apply to protesters peacefully standing on the sidewalks surrounding these facilities. However, that clarification is not found anywhere in the bill. How do I know that? Number one, I was on the committee, I participated in those discussions, I raised those issues, and I looked through the bill and it is not there. Clearly, it was an issue that was raised during the committee process. It was raised during a debate at the committee process, but somehow it did not get its way in. That clarification, the protection of those folks peacefully there on sidewalks to protest, a clarification was never included within the final version. So, again, we could have a situation where peaceful protesters are gathered with absolutely no intent to cause damage, no intent to be disruptive, no intent to be violent, and yet are still hit with a felony charge.

I will point this out, Mr. President, for the record. If a court ever looks at this law, these same issues existed with a similar bill passed by the Wyoming legislature and it was vetoed by the Republican Governor early this year for the reasons that I have stated at the beginning of my remarks, and that is that it was not carefully drafted.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, I rise, too, to ask for a "no" vote on this bill. I do so because we have to be careful about how we restrict our rights in our First Amendment. Others have talked about other parts of the bill, so I am going to turn my attention to the definition of a critical infrastructure facility.

Clearly, there are some things, a place that has nuclear missiles or something like that, that we would want to consider critical infrastructure, we would want to protect. But this bill would also define some places that I think people might find to be surprising. So a place that manufactures basketballs or Barbie dolls, according to line 26, page 4, because it would involve the production of plastic materials, it would be considered a critical infrastructure facility and if one were to be there protesting, that would be considered a felony because it is critical that we have basketballs and Barbie dolls.

A critical infrastructure facility would be considered any SEPTA station or any public rail station in the Commonwealth, because if someone is late for the bus, that would be considered a critical infrastructure facility and that is under line 11 on page 5.

A school or a daycare center, and truly we do care about our children, but any group of teachers or any person or disgruntled parent who stands outside and says, do not go to this daycare center, if it is on the property of the daycare center, you would be considered to now have committed a felony because daycare centers and schools are critical infrastructure.

Cable TV lines, when the Communication Workers of America or the International Brotherhood of Electrical Workers protest saying that they need to have better contracts, that, too, would be at a critical infrastructure facility, because, you know, if we cannot see HBO, that is critical to the existence of Pennsylvania society under this bill, and that is on page 5, lines 6 through 10. The schools and daycare centers are on page 6, lines 22 through 27.

A warehouse that is storing machinery that could be used at one of the other kinds of facilities, even if nothing to do with those facilities is taking place at that location, so if the machinery might be one day used for something else that is defined as a critical infrastructure facility. Say some Teamsters or folks who work there wanted to protest at that facility, that would be a critical infrastructure facility because excess machinery being stored under the definition of this bill is a critical infrastructure facility, and that is under page 6, line 20.

A trucking terminal, any trucking terminal shipping anything. So if I were to go down to the trucking terminal that ships my favorite iced tea from Wawa, that would be a critical infrastructure facility under this bill, and if the workers there wanted to protest that, that would now be a felony.

If we were to say--I love the morning sports talk radio, but if somebody was a fan of an opposing team and did not like what was being said and were to go down and protest at that sports talk radio station, if it were in the radio station, under page 5, lines 8 through 10, that, too, would be a critical infrastructure facility.

So my concern is that while we all want to protect truly important facilities, while none of us want to see anything explode or anybody hurt, we have gone too far. We must be intellectually honest about what is really critical infrastructure. If we were to narrowly tailor a bill that really protects only things that are a necessity for the function of society, then that would be different. So because this is too broad of an encroachment on free speech, because there are too many places that are listed as a facility, I urge a "no" vote on this bill.

The PRESIDENT. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, just a quick response. I do not mean to butt in if the Senator from Allegheny was going to speak. If you are going to go down and protest the local sports talk show or protest your favorite iced tea from Wawa, if you do it peacefully, this bill does not affect you. I am not sure you would argue whether that is really critical infrastructure or not, that is fine, but the point of all this is, we are not changing the law as far as peaceful protest. You can protest anything you want still, absolutely anything you want, and you should have the right to protest whatever you like. That is the American way. It is to get out and make your voices heard, and this bill does not change any of that ability to have a peaceful protest. But what we are trying to protect is the critical infrastructure of Pennsylvania. Now, whether this definition is further out than you think it should, that is a fair discussion to have, but at the end of the day no matter what you are protesting, whether it be a nuclear bomb missile to go somewhere or whether it be something much less important, as long as you do it peacefully you are not going to be charged with a felony or any other crime. So that is an important distinction we all have to understand here. As long as you continue to act in a peaceful way, as we all should, no matter what the issue may be, this bill would not apply to you.

So as technology continues to grow and infrastructure becomes more and more important to things that we do, it is important that we protect infrastructure here in Pennsylvania and critical infrastructure, and so I think this bill does that. It does send out a very important message but at the same time keeps the same balance that, again, anywhere from a nuclear missile to your favorite iced tea, as long as you are doing it peacefully, this bill will not affect you in any way, shape, or form.

The PRESIDENT. The Chair recognizes, for the second time, the gentleman from York, Senator Regan.

Senator REGAN. Mr. President, a couple things. I certainly respect the opinion and the comments of all my colleagues in the Senate, but one of the comments I want to address is that someone who is waking through their backyard where there is a critical infrastructure juncture is going to be prosecuted. I mean, I just think that is completely absurd and beyond the pale.

It is interesting that one of my colleagues mentioned that there have not been any problems on any critical infrastructure facilities, whereas in April, 600 pounds of dynamite was stolen from a critical infrastructure facility after a trespassing had occurred. Six hundred pounds of dynamite. Mr. President, in this day and age of terrorism, in this day and age where people actively seek to harm American citizens, the average American citizen should be given the same amount of credit as the person who wants to demonstrate or the environmentalist. The average citizen on the street deserves to be protected. It is our job as public servants when we come here to introduce legislation that will protect our citizenry. That is what we do.

When criminals commit crimes, they are prosecuted. That is how our system works. Do not commit a crime, do not trespass, do not destroy property, and you will not be prosecuted. That is the way it works. This bill protects Pennsylvanians. It protects our infrastructure. It protects our economy. It does so many things. It is an important bill, especially in this day and age. We would be neglectful not to take steps to protect the citizens of this great Commonwealth. This bill does that, and I ask for your support. Thank you.

The PRESIDENT. The Chair recognizes, for the second time, the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, briefly, I tend to agree that what we are faced with today are extraordinary circumstances where, as the speaker commented, people are, quote, actively seeking to harm, end quote, American citizens. And that is true. Maybe there are these circumstances that rise to the level where we as citizens are willing to consider responsible limitations on our right to free speech. But if you agree with that argument and you start with the premise that my good friend from the other side of the aisle began with, the quote that in these terroristic times, people are actively seeking to do harm, then is it not incumbent upon us to not only look at ways to curb or restrict free speech, which may be in some people's views an antagonistic piece to those threats, but also in these times, in these terroristic times, in these times when people, like my good friend has said, want to do harm across the State and across the country, is it not time that we begin to take a look at other amendments with the same logic and the same ideas that have been put forth by my good friend across the aisle? Because if a restriction on free speech is able to save a life, Mr. President, I guarantee you that a responsible restriction on the Second Amendment will equally have the same effect as the one put forth by my good friend, the maker of this bill.

The PRESIDENT. The Chair recognizes, for the second time, the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, a brief note that under this bill, since transportation is a critical infrastructure, Rosa Parks, who rode on that bus, would not have been charged with a misdemeanor but would have been charged with a felony. Thank you.

## **SENATE RESOLUTION No. 322, ADOPTED**

Senator CORMAN, without objection, called up from page 12 of the Calendar, **Senate Resolution No. 322**, entitled:

A Resolution directing the Legislative Budget and Finance Committee to study standardized tests in public education.

On the question,

Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Aument.

Senator AUMENT. Mr. President, in recent years, discussion on standardized testing and the effectiveness of the data they produce has intensified. Across the country, teachers, parents, and administrators are engaging in a debate over the way standardized testing is administered, how much time is being devoted to standardized testing in our schools, how instruction has been impacted, and how the scores these tests produce should be used. Over the last year, the Senate Committee on Education has energetically discussed possible alternatives to the Keystone Exams and how this change could impact Pennsylvania's current accountability and educator effectiveness in the system.

I believe further investigation is necessary to determine if possible alternatives to the Keystone Exams, such as the SAT, align with Pennsylvania core standards, and if such a shift in this assessment would require costly curriculum realignment, and if these alternative assessments can or should be used as a measure of a teacher's effectiveness. It is for these reasons that I have introduced this resolution to direct the Legislative Budget and Finance Committee to study the effectiveness of standardized testing, including the Keystone Exams and SATs and their use as indicators of student academic achievement, school building performance, and educator effectiveness.

Though I believe there is a role in our system for standardized assessment, it is clear to many that the pendulum has swung entirely too far. We have an obligation to work together to get it right and to do all that we can to insure that our educators, families, and students have full confidence in our standards, assessment, and accountability systems. I think the adoption of this resolution represents a significant step forward.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, will the maker of the resolution stand for interrogation?

The PRESIDENT. Senator Aument agrees to stand for interrogation. Senator Dinniman, please proceed.

Senator DINNIMAN. Mr. President, friendly interrogation, I might humbly add.

During the process of trying get this through quickly so we can get this study going, I made a number of comments in our Committee on Education, and rather than put in an amendment that would have delayed us today, since I think what you are doing is great, Senator Aument, I wanted to ask you some questions to make sure that it would go in a letter that we would be sending--

The PRESIDENT. Senator, the procedure is to ask the question to the Chair.

Senator DINNIMAN. Mr. President, let me say that I am in agreement with the resolution and I am trying to get some clarification, and would the maker of the resolution be willing to send a letter to the Legislative Budget and Finance Committee, with myself, dealing with some of the concerns that were expressed in the Committee on Education?

Senator AUMENT. Mr. President, I appreciate my colleague's questions. I think the issues that he has raised are important and I certainly look forward to joining with him and I am happy to do so in a letter to insure that the information that he is seeking with regards to poverty and a number of other factors are certainly included as part of the study.

Senator DINNIMAN. Mr. President, then I joyously urge the Members to vote for this resolution, and I thank the maker of this resolution for understanding, as he so well articulated, the importance of us looking at this question of testing and comparing the Keystones vis-a-vis other tests and we finally have all of the documentation information before us. I hope we all vote for it unanimously.

Senator BAKER. Mr. President, in the world of criminal justice and investigation, remarkable technology is used in finding fugitives, keeping tabs on wrongdoers, and ferreting out all sorts of information shining light on old crimes. We read how DNA has been used to solve cold cases and to reveal the innocence of the wrongly convicted and incarcerated. Yet for the families of missing persons, all the technological capacity and found knowledge can be disconcerting. It makes the complete lack of answers in their situation all the more emotionally difficult to deal with.

Years ago, a news story gave the scope of the missing persons problem powerful context. The national number is the equivalent of the population of the city of Reading. The number of Pennsylvanians counted among the missing is higher than we might guess. When a loved one vanishes, be it family, friend, coworker, or neighbor, it creates an unimaginable void. No finality, no closure, no answers, just endless suspicion and speculation that tears at the soul. Compounding things is the pain of hearing the fate of your loved one classified as a cold case.

Attention has been given to two cases in my district. In the one, a mom learned the day after Mother's Day that the search for a her missing daughter for 14 years turned up not a trace. No way to see where Phylicia Thomas is. Her mother, Pauline Bailey, has been searching for 14 years. In the other case, a mom departs her daughter's graduation party, is sighted later that evening and then nothing in the 5 years since. The family of Shelva Rafte are still looking, still hoping, and searching. There is a greater appreciation for the overwhelming emotional conflict the uncertainty over the fate of a loved one produces, the mix of hopes, fears, frustration, desperation, anguish, and anger. People want to know the truth and deserve to discover it. There are steps available to help bring closure and justice. As with everything else individuals and groups seek, it is a matter of resources, priority, and tenacity.

This resolution encourages people, officials and citizens alike, to never forget the missing and to never give up the search. Our obligation is to consider potential changes in law and procedure that could prove helpful in bringing closure. The more information that is gathered, the more that is made accessible, and the more that the information is shared between enforcement agencies and authorities, the better the chances that answers can be found. We also show our respect and support for the efforts of the families of the missing and the various advocacy groups who provide much needed assistance and commitment.

So on behalf of the families of Shelva Rafte and Phylicia Thomas, we raise up this resolution in their memory and in their honor and hope that we can bring closure to their families.

(The following prepared remarks were made part of the record at the request of the gentleman from Philadelphia, Senator FARNESE:)

Mr. President, I rise today to offer a resolution designating May 2018 as "Amyotrophic Lateral Sclerosis Awareness Month" in Pennsylvania. ALS, also known as Lou Gehrig's disease, is a fatal neurodegenerative disease affecting over 1,200 Pennsylvanians.

ALS is marked by muscle weakness which leads to impaired use of the arms and legs. As the disease progresses, essential functions become a daunting task and many ALS patients lose their ability to walk, gesture, speak, and breathe on their own. Eventually, complete paralysis sets in. While there is no cure to ALS, there is now a new drug, Radicava, which was approved in 2017. This is the first new treatment approved for ALS in over 20 years and has been shown to slow down the physical effects of the disease.

I want to thank the ALS Association for their great work supporting patients and families across the Commonwealth. Yesterday was ALS advocacy day, so I hope everyone had the opportunity to hear about the efforts of the association in their communities. I am proud to have an ALS Association Certified Treatment Center of Excellence in my district at Thomas Jefferson University Hospital. The ALS Association Greater Philadelphia Chapter is also the principal charity of the Phillies and they have raised nearly \$18 million to Strike Out ALS since 1984.

Thank you for joining me in raising awareness of ALS in Pennsylvania.

## PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, I rise today to briefly address some of the comments that the mayor of Philadelphia has made about the school district's finances and the role of State legislators. A few times now in a public capacity, most recently this morning in the May 23 paper, the mayor stated that the financial situation of the Philadelphia School District is dire and that the city is not able to provide safe buildings for its students. I wholeheartedly agree with the mayor and I agree with him that it is the duty of elected officials to keep kids safe and provide them with a quality education. I also applaud his zeal and persistence in keeping this issue in front of the public time after time.

But what I do not agree with, Mr. President, is his conclusion that, quote, Harrisburg has left these teachers and students to fend for themselves. That is not true. For example, under the Wolf administration, this Chamber has consistently seen increases in education funding to fill some of the gaps created by the previous administration, amounting to over a \$1 million increase in basic education funding over the last few years. Mr. President, those votes were made by people on this side of the aisle and that side of the aisle. On top of that, my colleagues have created and supported new streams of funding. For example, the cigarette tax created in 2014 yielded another \$150 million through 2017 and continues to bring in revenue. We have pushed for provisions in past budgets that would cover revenues if the tax did not reach anticipated levels. We have also required TNCs--a piece of legislation I personally worked on very, very closely and authored many parts, and so did Senator Hughes--like Uber and Lyft to be a partner to the school district with two-thirds of their 1.4 percent gross receipt tax going to the School District of Philadelphia. Finally, we have enacted a more fair funding formula to send new dollars where they are most needed.

Many of us, Mr. President, in this Chamber have taken and driven these votes to send the much-needed money to the school district and many of us, including yourself, Mr. President, when you were a Member on the floor of the Senate, refused to vote for proposals that would do any harm to the School District of Philadelphia. Now, our work is far from being done, but many of my colleagues and I have fought tirelessly and those efforts should not be disregarded. I think it would be more productive for the mayor to come to the table and create an open dialogue between the city and the State. At home, Mr. President, I get questions and hear concerns from constituents about the mayor's proposed tax increases, and here in Harrisburg, all of us from Philadelphia have questions about where the money is going and how it is being used. Both are valid. I hope the mayor sees the importance of being on the same page with those who have taken tough votes and made these issues their priority, and not acted in disregard of the school district or simply failed to act.

With that being said, I look forward to getting back here in June and continuing the work we have done to better support the teachers and children and parents of this Commonwealth. But again, Mr. President, again, there was no time that Members, at least on this side of the aisle, and specifically those from Philadelphia, from Pittsburgh, from around the counties on this side of the aisle, my side of the aisle, ever turned their back on the School District of Philadelphia or ever failed to deliver for the School District of Philadelphia, despite time and time and time again being asked.
