(a) Power and authority.--An agent of the Office of Attorney General as defined in paragraph (2) of the definition of "enforcement officer" in 71 Pa.C.S. § 5102 (relating to definitions) in addition to the power and authority vested by law, shall have the power and authority to enforce the laws of this Commonwealth or to perform a function of a municipal police officer in the following circumstances:

(1) If the officer has been requested to immediately aid or assist a Federal, State or local law enforcement officer or park police officer or has probable cause to believe that the other officer is in need of aid or assistance.

(2) If, while on official business, the officer views an offense and makes a reasonable effort to identify himself or herself as a police officer and the offense is:

(i) A felony.

(ii) A misdemeanor.

(iii) A breach of the peace or other act that presents an immediate clear and present danger to a person or property.

(3) If the officer views an offense that is a felony and makes a reasonable effort to identify himself or herself as a police officer.

(b) Applicability.--An agent of the Office of Attorney General acting in accordance with the authority granted under this section shall be subject to section 8953(b), (c) and (d) (relating to Statewide municipal police jurisdiction) to the same extent as would a municipal police officer.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, this is not my first time addressing my colleagues about the importance of our Commonwealth's dairy industry, and it likely will not be the last, but I must say that our dairy producers are in trouble. We are operating in a global market, there is an oversupply of milk, fewer people are drinking milk, fewer places or plants process milk, and there are far more options to choose from, like nut milk, for example. This combination has created historically low milk prices. Family farms are in trouble. We have asked a lot of our dairy farmers over the years to invest in good conservation practices, and we have asked them to continue producing high-quality milk while facing dismal prices for their work. Now, they have asked us for help. That is why I am sponsoring this Senate resolution directing the Legislative Budget and Finance Committee to conduct a study and issue a report making recommendations for initiatives to assist dairy producers in the Commonwealth in response to the decreasing demand for dairy products and decreasing milk prices. Before we invest in new processing plants or make other large investments, we need more information, we need some facts to insure we take the right steps.

This resolution asks the Legislative Budget and Finance Committee to identify measures proposed by the Pennsylvania Milk Marketing Board and the Pennsylvania Department of Agriculture to assist dairy producers. The other thing it does is examine statutes, best practices, and proposed measures. Other States are taking action, Mr. President, and we ought to take a look at them and see if there is anything there that we can use in Pennsylvania. Here is an interesting thing, Secretary Redding of the Department of Agriculture told me we have no idea what kinds of specialty milk products are actually being sold in Pennsylvania. We have no numbers. We have no way of quantifying what impact they are having on our fluid milk sales. We need to know that. Maybe that will give us some ideas as to what other products we could be producing with our milk. If this resolution is passed, the committee will have 1 year to conduct the study and report its finding to us. There is no quick fix to this problem, but this is a start. A robust dairy industry is part of our heritage and most certainly part of our economy. We have to do what we can to encourage its survival.

I thank my colleague, Senator Vogel, chairman of the Senate Committee on Agriculture and Rural Affairs, for supporting this resolution, moving it through committee so that we can consider it, and I hope my colleagues will join us in supporting it. Thank you.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, I rise to thank my colleague for this important resolution. Growing our dairy industry and supporting it is important, and there are many issues. There are issues around whether we should move forward with additional producers. There are many who believe that if we adopted additional producers, particularly in the area of producing yogurt and cheese, there could be great opportunities to help and create new markets for our dairy producers, but we need to know that because we may not have multiple opportunities to make these kinds of important investments and we want to get it right.

There could also be issues like where to place these production facilities. There are some who have suggested that placing a production facility in the southeast, which had not formally been looked at, would be a possibility, Mr. President, in areas that you and I represent that would create new markets for our dairy industry and help create some more robust product lines. Mr. President, we cannot ignore the fact that there have been over 24 months of declining profitability for this industry. This is an important industry in Pennsylvania, so I thank my colleague for bringing attention to it and I urge my colleagues to vote "yes" on her resolution so that we can look at how we can strengthen this important industry.

Finally, I point out that our economies are so interconnected. The \$4 billion of cocoa that we bring in through the Port of Philadelphia is only possible with a robust dairy industry because most of that gets mixed with Pennsylvania dairy milk to make the delicious chocolate products that we know of and we all like. So what is good for the dairy industry in central and northern Pennsylvania is also good for our economy in the southeast as well because we truly are an interconnected Commonwealth. So with that, I urge support for this important resolution and thank the maker for offering it.

And the question recurring,

HB 1346 (Pr. No. 2167) (Rereported)

An Act amending Titles 18 (Crimes and Offenses) and 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in burglary and other criminal intrusion, defining the offense of unlawful use of unmanned aircraft; and, in preemptions, prohibiting local regulation of unmanned aircraft.

Senator GREENLEAF, from the Committee on Judiciary, reported the following bills:

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in criminal history record information, further providing for general regulations and for order for limited access and providing for clean slate limited access, for exceptions, for order to vacate order for limited access, for effects of expunged records and records subject to limited access and for employer immunity from liability.

HB 1929 (Pr. No. 3731) (Amended)

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in First Chance Trust Fund, further providing for use of fund.

Senator WARD, from the Committee on Labor and Industry, reported the following bill:

SB 714 (Pr. No. 1888) (Amended)

An Act establishing the Pennsylvania Career Readiness Council; and providing for its powers and duties.

Senator CORMAN. Mr. President, this resolution designates the month of September 2018 as "Suicide Prevention Awareness Month" in Pennsylvania. Approximately 1,300 Pennsylvanians lose their lives to suicide every year. This resolution coincides with National Suicide Prevention Awareness Month, recognizes the seriousness of this issue, and encourages Pennsylvanians to learn more about the warning signs of suicide and possible preventive measures.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, this resolution designates June 30 as "Arthrogryposis Awareness Day" in Pennsylvania. Arthrogryposis Multiplex Congenita, AMC, is a condition which develops prenatally, caused by various conditions, in which a baby with this condition could be born with at least three joints in two different areas in the body that are highly or permanently immobilized. It presents itself as either a limited or fixed range of motion in the arm and leg joints, difficulty in bending of wrists and fingers, dislocated hips, and inwardly bent heels and feet. This occurs in about 1 in 3,000 births. There are 400 distinctive identified types of this congenital defect, and it is a situation which certainly impacts many infants in Pennsylvania as well. It is not curable but it is treatable, and that is what this resolution is about, encouraging further treatment for this syndrome. Thank you.

PETITIONS AND REMONSTRANCES

The PRESIDING OFFICER. The Chair recognizes the gentleman from Philadelphia, Senator Williams.

Senator WILLIAMS. Mr. President, I am off from a wonderful Sunday where I celebrated Father's Day and had wonderful activities with my two daughters and my grandson. Like many fathers, we had barbecue because the joke is that on Mother's Day you have to have reservations, on Father's Day there is barbecue. So, it is not quite as crowded or active. I have had an extraordinary life that has encompassed a variety of activities, but there has been none greater than the ability to see my children grow, to enjoy my grandson as he grows. He is 4 years old. I could not imagine a moment, as imperfect as this country is, where the government would intrude upon that relationship between me and my children, even if I, unfortunately, did something wrong.

I witnessed, as many Americans have over the last few days and weeks, families and children separated from their parents because of a policy that we want to implement in this country, one that is defined as and, I guess, described as zero tolerance of those who would violate the law to illegally enter our country. I want to underscore illegally enter our country. I was raised in a household of modest means. I was raised in a household that was also active in the civil rights movement that fought to change laws; so those things that were wrong, we made right. While we are not a perfect union, we are a growing country that recognizes a variety of human beings from a variety of backgrounds. There were a few moments in our history that sort of pushed against that. You can certainly look at slavery, you can certainly look at World War II where they interned Japanese, who were in fact many Americans. There are other moments, unfortunately, where we can look at the imperfect activity of human beings holding positions of authority in our country to sort of define what America should look like as opposed to what America was looking like, or does look like, to sort of carve out a country that has never been the promise of the Fore-founders. The promise of the fore-founders was, bring us your weak, your tired, those who are most vulnerable. Allow them to display their strengths and make this country great, and it is great, and it has been great for a long, long time.

Unfortunately, we have decided that those who want to get to this country, those who seek the promise of this country, we decided that they do not necessarily represent the value that many others of us represent and have been here for generations. Now we come to a moment where we would suggest that the law allows us to enact a policy called zero policy for those who would enter the country and thereby allow the government to separate them from their children. I do not know about you, this has noth-

ing to do with being a Democrat or Republican, it only has to do with me being an American; an American who knows that my grandfather, not even my great-grandfather, my grandfather came out of a segregated South and felt promise in the North. My great-great grandparents, one was a white Irishman and one was a Native American, an African American, my great-grandmother, who married and joined union in a southern State where it was illegal at the time when they did it and suffered because of it. My great-grandfather never ended up a day in jail but he did suffer economically. I have experienced literally the things that these families are going through and that is the separation of families artificially because of those who are in superior positions can extract that. My comments today are not out of anger, even though I do feel that. My comments today are not out of frustration, because I do feel that. My comments come from a moral imperative that has never changed in this country. Never. Right has always triumphed wrong in this nation. Wrong has always been pointed out by those who are righteous and those who are not even paying attention, and because of that, right won out.

This space we occupy that some adult tries to get to a promised land because they were oppressed in a foreign land, and they do not do it the proper way, has never been met with this kind of intolerance. Have we forgotten when the Irish and the Italians got on boats, some legally, some illegally, and snuck into this country? There are many who did legitimately get into this country, but there are many who did not legitimately get into this country, and they changed their names, they shortened the vowels in their last name, they did all sorts of things that allowed them to seek out the American dream. I know this because I have many friends of a lot of different ethnic backgrounds - Jewish, Italian, Polish - who tell me the stories of their great-grandparents and what they did to be a part of this country. I am not sure why we think that this period of time should be different than my generation when we decided that slavery was no longer appropriate, or when we decided that those of other like ethnic backgrounds were allowed to migrate into the cracks of this country. I am not sure why this moment would occupy a space where we would violate the basic human fundamental right of family and use the backdrop of a policy to do that.

I am not here to suggest that those who enter this country should do that illegally. I am not here supporting that. I am not here suggesting that breaking the law should be greeted with indifference or a blind eye. I am standing here today to suggest to you that our families, our history, our heritage, our immigrant status of all Americans - there is only one population that was a true American, that was a native American, the rest of us are immigrants. Illegal, as people would describe themselves or legal. And we have never occupied this space morally ever, right? Trump is wrong. I would hope that in this space that I occupy today as a simple American asking my government to reconsider its position. Yes, there is much politics to be done with regard to what the immigration policy should be. Yes, there is much division between those who are Democrats and those who are Republicans. Yes, there may be even differences in parts of this country about how we do it. Those are all appropriate conversations for debate, but that should never lead us to a moment where we have a 4-year-old separated from an adult, and the 4-year-old looks

with wonderment, confusion, and fear at an adult. There is no way you can separate a child from a parent and explain it away to the child, mommy and daddy are gone, they will be back with you some other time. That is impossible to even fathom, that we would even think that that would work. I would hope that more reasonable minds would occupy this space.

I do not have much to say to my Attorney General, who for some reason thinks it is not by the rod, but frankly, by the assault weapon that we punish people. That we take a fly of innocence of a 4-year-old child and step on their whole possibility and framework of their future. We stain it with the oppression of power. I hope and I pray that those in higher offices begin to listen to the people, because the people are speaking, and they have spoken. They do not always speak in demonstrations. They have spoken in churches, in mosques, in synagogues, they have spoken in general assemblies, they have spoken in Congress, they have spoken in the Senate, they have spoken in neighborhoods, they have spoken in editorial boards, they have spoken in this country in short-term and immediacy to tell us all this is wrong. We can certainly make sure that those parents who enter this country illegally are not allowed to continue along that path without separating the family. We can put them in a space and a place that the family is together while they either return or they are allowed to pursue legitimate citizenship. There is no logical, no ethical, no legal, no moral, no imperative that allows us to separate those children from their parents in the way that we are doing it and suggest we are doing something that strengthens our nation. There is nothing we are doing in this regard that strengthens our nation. What we are doing is stepping on the foundation of this country.

I stand here not as a black man, not as a 61-year-old person, not as a male, I stand here as an American whose family has shed blood for this country, paid taxes for this country, and served this country. I have a right, as all of us do, to be heard. Now it is about listening and immediately acting. Not arbitrarily, slowly, and gradually getting to an end where we negotiate the terms of internment, but immediately putting those families back together and then working out the details of what you do with the adults who broke the law, who violated our policies, who inappropriately entered the country. First, start with a moral imperative that this country has always stood upon. And whether we like it or not, we are embarrassing ourselves internationally. One may argue it through political eyes and a personality, but when you really understand and you really appreciate and you look at yourself as an American in the mirror, you are embarrassed because there is no reason to do this. There is no reason to continue this and most importantly, there is a reason to remove this stain today.

I hope, and most importantly I pray. I pray because that is what I do as an American. I turn to my God in moments where man and woman cannot solve their problems, cannot seem to find their way, I pray. My comments are those of man and woman's government. My prayers are to the universe of the human spirit, that which recognizes and respects all. That which treats all fairly. That which truly loves life at its highest and greatest plain. I pray that this policy will stop. I pray that those who seem to feel that zero tolerance would make us stronger as a nation will truly

listen to those of us who are pushing--the majority of us who are pushing--against this policy. I pray that those children will not be harmed for the rest of their lives.

I thank you, Mr. President, for this opportunity to express my perspective, and I thank those of you who have listened.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, it is with a heavy heart that I also rise to address similar issues to my colleagues. We stand here on the floor of the Senate and I look at a picture of a resemblance of men who gathered in Philadelphia some years ago, who thought that the mere statutory rule of law of the country, of their country, was insufficient. They spoke words of lawbreakers that we now hold to be important. They said, "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the Pursuit of Happiness." They did not say that those laws were endowed by statute, and they certainly did not say they were endowed by the bureaucratic principles of the Justice Department or the whims of an Attorney General who is heartless and uncaring. I have to imagine that the right of life, liberty, and the pursuit of happiness included in those minds the right to be with one's child, the right of a mother or father and a family to be held together.

Those Founders believed that there were certain rights that we now call human rights, that each and every person is invested in. We have literally traveled around the world and sent our sons and daughters into harm's way to defend those principles globally. We have been known as the beacon on a hill that lit the path of justice and truth for the world. Yet, today, once again we are violating many of those basic principles. Now, this is not the first time this country has done that, but we have, through this country, continually moved on a path of doing better. Of increasing the rights and the recognition of rights to citizens, but we are now at a place where we appear to be moving away from that. We appear to be moving away from basic principles of human decency. Two-thousand children and counting held captive, some in cells or cages meant for animals, separated from their families who are guilty of coming to this country and seeking a better life.

Well, there is another inscription--as people talk about how we are not doing the American thing by securing our border, that we should keep out certain people. Well, another famous inscription on a big statue on Ellis Island says, "Give me your tired, your poor, Your huddled masses, yearning to breathe free...The wretched refuse of your teeming shore. Send these, the homeless, tempest-tossed to me; I lift my lamp beside the golden door." We have held out through the Statue of Liberty that we are the beacon for all of humanity around the world. All of those who fled oppression from wherever they were, that if they wanted to come here they could find a place where things would be better, and we did not give the promise of a golden path, but we gave the promise of an opportunity to build a better life. People did not come here because they knew that they would be handed something when they got here, but they came here because they knew that their basic rights that were talked about, the rights of life, liberty, and the pursuit of happiness, they would be welcomed with an opportunity to build a life for themselves. That is why people by the thousands, and sometimes by the millions, seek to come to

the United States of America. Now we have reached a place where we are huddling children in cages, we are guilty of human rights violations that would shock the consciousness and indeed would have Americans calling for action if they were occurring anyplace else.

So I stand here in the place where those words were spoken, "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain inalienable Rights." We have an administration that talks about faith yet ignores the basic rights for which our Creator has endowed us. We must stop impounding children in cages. We must stop breaking apart families. We cannot be the moral leader of the world if we act in an immoral way. Our credibility as a leader in the world is on the line, but more importantly, the soul of this country is on the line because if we compromise the basic principles that are emblazoned upon the Statue of Liberty and walk away from the words that were spoken in the Declaration of Independence, we are truly losing the very ideals that this country has always worked to move toward.

So I ask every Member of this body, every member of this Commonwealth, every Senator, Representative, every mayor and council person, but more than that, every citizen in this Commonwealth and indeed across the country who truly believes that while we may not have always achieved the greatest values, we have always worked toward them. While we may not have always executed in the best way, we have always had the principles in front of us that sort of were a north star morally as to the direction we should be traveling. We cannot abandon that north star today. It does not matter whether these children come from Honduras or Mexico, it does not matter that they walked here, it does not matter that they did not have the appropriate pieces of documentation, which, in fact, they could have lost along the way, maybe they never had at all. There are still certain basic rights that each of them and each human being, when brought into the world by God himself, was endowed with.

Maybe I am old-fashioned or maybe I am just invoking what some would call conservative values, but I do believe that those citizens who came tempest-tossed to our shores were endowed with the rights of life, liberty, and the pursuit of happiness, and that those values in the face of God should be respected and we must stop the immoral, illegal, and unjust imprisonment of children in inhumane conditions, the separation and destruction of families, because it is in fact immoral, a violation of what God wants from us, and un-American.

Mr. President, I thank you for this time.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, thank you to my colleagues for indulging me for a few moments to make some remarks. I wish I could speak in the lofty way that my colleagues do about the founding principles of our nation and all things so true about this current crisis, but I am coming to you today and speaking from the standpoint of being a mom and being a grandmother. Looking at the images that I have seen over the weekend, one in particular has been seared into my mind. It looks like about a 2-year-old little girl and she is standing in the photo and you can see the legs which appear to be of a government person or an agent or something of that nature, and then on the other

side are the legs of likely a woman, her mother, and the little girl is crying her heart out. I suppose at that moment that is when that little girl was separated from her mother. I cannot imagine how that mother must have felt. I have a granddaughter about the same age as that little toddler in the photo and in my eyes, Mr. President, the sun rises and sets on that little girl, and I know it goes without saying that her parents probably feel the same way. I know they do. I cannot imagine, again, how her mother must have felt. It is too painful even to think about. How could anyone who has children, grandchildren, nieces, nephews, anyone who has ever smiled at a little kid that they saw somewhere, anyone who has a heart, how can they withstand the policies that our country, our nation, the United States of America is now implementing in terms of these illegal immigrants who have come across our borders with their children?

As it currently stands, Mr. President, about 2,000 children have been separated from their parents at the border and they are being sent to different places. I am following this very, very closely and my understanding is there is no plan in place yet for reuniting parents with their children, for even letting these children communicate with their parents. We are talking about infants, we are talking about toddlers who cannot comprehend life without their parents. That is just unbelievable to believe that we would allow a human rights violation like this to occur in this country. What will happen to these children? I cannot stand it when a baby cries and I am babysitting. I cannot imagine what it must be like in these facilities to hear these children crying at night. What will be the psychological impact? The long-term effect? No matter how we look at it, this is going to be our problem, and we are going to have to resolve it.

I recognize that we need to have a policy on our border. That certainly is something which I can accept. What I cannot accept, though, is that we would treat human beings in this way while we try to figure out what that policy exactly is going to be. This is wrong. This needs to be condemned. Even in Europe where they have been undergoing a migrant crisis, an immigration crisis for years, they are more humane than we have been in terms of treating individuals who are trying to come to our country. I cannot be dispassionate about this and I certainly do not want to be condemning, but I have to condemn this policy and those who would implement a policy such as this. We in Pennsylvania may need to address this at some point because when there is a resolution, some of these children may be coming to our counties, to somewhere in this Commonwealth, and we need to be prepared for that, and I would hope that we would be much more humane than our Federal government has been to date.
