**SB 634 (Pr. No. 860) (Amended)**

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, in soil and conservation, providing for Conservation Excellence Grant Program; and making an appropriation.

**HB 370 (Pr. No. 360)**

An Act amending the act of June 30, 1981 (P.L.128, No.43), known as the Agricultural Area Security Law, further providing for purchase of agricultural conservation easements.

**HB 404 (Pr. No. 380)**

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, in controlled plants and noxious weeds, further providing for noxious weed list.

**SB 699 (Pr. No. 836)**

An Act amending the act of October 5, 1978 (P.L.1109, No.261), known as the Osteopathic Medical Practice Act, further providing for physician assistants.

**HB 1166 (Pr. No. 1344)**

An Act amending the act of May 11, 1889 (P.L.188, No.210), entitled "A further supplement to an act, entitled 'An act to establish a board of wardens for the Port of Philadelphia, and for the regulation of pilots and pilotage, and for other purposes,' approved March twenty-ninth, one

thousand eight hundred and three, and for regulating the rates of pilotage and number of pilots," further providing for rates of pilotage and computation, for pilotage fees and unit charge and for charges for services.

**HB 1172 (Pr. No. 1989) (Amended)**

An Act amending the act of July 2, 1993 (P.L.345, No.48), entitled "An act empowering the General Counsel or his designee to issue subpoenas for certain licensing board activities; providing for hearing examiners in the Bureau of Professional and Occupational Affairs; providing additional powers to the Commissioner of Professional and Occupational Affairs; and further providing for civil penalties and license suspension," providing for licensure by endorsement.

Senator LANGERHOLC, from the Committee on Education, reported the following bills:

**SB 462 (Pr. No. 858) (Amended)**

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in preliminary provisions, repealing provisions relating to report of racial and ethnic groupings and to study of public schools that provide Internet instruction; in school districts, repealing provisions relating to corporate seal, to submission of plans, to disapproval of plans, to Department of Public Instruction to prepare plans, to establishment of reorganized school districts and to advance establishment; in duties and powers of boards of school directors, repealing provisions relating to special school watchmen-school districts in townships of the second class, to copies of school laws and to educational broadcasting; in grounds and buildings, repealing provisions relating to residences for teachers and janitors, to heating stoves to be shielded, to ventilation and thermometer, to fireproof construction, to doors to open outward and fire escapes, etc., to completion of abandoned WPA projects in districts of the third and fourth class and to condition of grounds and shade trees; in certification of teachers, repealing provisions relating to summer schools, etc.; in pupils and attendance, repealing provisions relating to possession of telephone pagers prohibited, to nonprofit school food program, to antitruancy programs and to medical care for children under six with defective hearing; in safe schools, repealing provisions relating to report; in school health services, repealing provisions relating to care and treatment of pupils and to local wellness policy; in terms and courses of study, repealing provisions relating to foreign language academies, to monthly reports to school directors of the districts second, third and fourth class, to Read to Succeed Program and to department duties and powers; in vocational education, repealing provisions relating to schools or classes, supervisors, principals, instructors, etc., to estimate of expenses and reimbursements and appropriations and to teachers of evening schools; in transfers of credits between institutions of higher education, repealing provisions relating to duties of public institutions of higher education; repealing provisions relating to medical education loan assistance; and, in reimbursements by Commonwealth and between school districts, repealing provisions relating to special study on the revenue impact of out-of-State tax credits.

**SB 536 (Pr. No. 859) (Amended)**

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, establishing the Public Higher Education Funding Commission.

**SB 590 (Pr. No. 705)**

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in charter schools, establishing the Charter School Funding Advisory Commission.

**SB 700 (Pr. No. 846)**

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, providing for construction and renovation of buildings by school entities; and establishing a grant program for maintenance projects.

Senator YAW, from the Committee on Environmental Resources and Energy, reported the following bills:

**SB 108 (Pr. No. 80)**

An Act amending Titles 27 (Environmental Resources) and 75 (Vehicles) of the Pennsylvania Consolidated Statutes, providing for Keystone Tree Fund; and, in registration of vehicles, providing for contributions to the Keystone Tree Fund.

**SB 305 (Pr. No. 283)**

An Act designating certain activity by the Delaware River Basin Commission as the exercise of the power of eminent domain that entitles the owners of the property in question to appropriate and just compensation.

**SB 575 (Pr. No. 856) (Amended)**

An Act amending Title 27 (Environmental Resources) of the Pennsylvania Consolidated Statutes, in environmental stewardship and watershed protection, further providing for agencies; providing for Pennsylvania Clean Water Procurement Program; establishing the Watershed Innovation and Improvement Fund; and making an appropriation.

**SB 619 (Pr. No. 857) (Amended)**

An Act amending the act of June 22, 1937 (P.L.1987, No.394), known as The Clean Streams Law, in general provisions and public policy, further providing for definitions; and, in other pollutions and potential pollution, providing for notice of discharge endangering health or the environment.

Senator BROOKS, from the Committee on Health and Human Services, reported the following bills:

An Act establishing the Pennsylvania Rural Health Redesign Center Authority and the Pennsylvania Rural Health Redesign Center Fund.

**SB 432 (Pr. No. 401)**

An Act amending the act of October 27, 2014 (P.L.2911, No.191), known as the Achieving Better Care by Monitoring All Prescriptions Program (ABC-MAP) Act, further providing for access to prescription information.

**SB 454 (Pr. No. 449)**

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, providing for public notice of provider payment rates for individuals with an intellectual disability or autism.

**SB 569 (Pr. No. 861) (Amended)**

An Act amending the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, providing for dispensing of fentanyl.

**SB 572 (Pr. No. 862) (Amended)**

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in public safety, providing for opioid treatment agreements.

**SB 633 (Pr. No. 863) (Amended)**

An Act providing for the declaration of a public health emergency, for duties of the Department of Health, for temporary regulations and for immunity from liability.

**SB 675 (Pr. No. 820)**

An Act providing for certification of buprenorphine office-based prescribers; limiting the use of buprenorphine; and imposing powers and duties on the Department of Drug and Alcohol Programs.

**SB 695 (Pr. No. 833)**

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, further providing for medical assistance payments for institutional care; in nursing facility assessments, further providing for time periods; in intermediate care facilities for persons with an intellectual disability assessments, further providing for time periods; and, in hospital assessments, further providing for time period.

**HB 856 (Pr. No. 1333)**

An act amending Title 67 (Public Welfare) of the Pennsylvania Consolidated Statutes, in preliminary provisions, further providing for definitions; in medical assistance hearings and appeals, further providing for definitions; in public welfare generally, providing for adoption opportunities and for family finding and kinship care; establishing the Kinship Care Program and the Subsidized Permanent Legal Custodian-ship Program; making related repeals; and making editorial changes.

**SB 223 (Pr. No. 407)**

An Act amending the act of September 27, 1961 (P.L.1700, No.699), known as the Pharmacy Act, further providing for definitions and for unlawful acts.

An Act amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, in Pennsylvania National Guard, further providing for compensation of division commander or equivalent; and making a related repeal.

**GUESTS OF SENATOR WAYNE LANGERHOLC  
PRESENTED TO THE SENATE**

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Langerholc.

Senator LANGERHOLC. Mr. President, I rise today to seek recognition for the Bedford High School's Battle Bot team on winning the National Robotics League championship. They qualified for nationals after clinching a first-place finish at the Southwestern Pennsylvania BotsIQ finals in April. The team's efforts began a year ago when they began by engineering two bots, which would battle opponents from other schools in an enclosed ring in a gladiator-style competition. The bots can weigh up to 15 pounds and be no larger than 4' by 8'. At nationals, they competed against 58 other high school and college teams in a 2-day double-elimination contest. They suffered just one loss when their bot suffered some minor damage, but they were able to make the repairs and get back in the competition. They then won three straight battles, including a victory against Kansas State University to put them in the championship round. They beat their next opponent twice to capture the national title. This is the second year that Bedford has claimed the National Robotics League championship.

Battle Bots is designed to teach students about engineering and manufacturing while they learn to work as a team under pressure and quickly on their feet. The skills they have learned will serve them well as they further their educational pursuits.

This is evident by the four seniors on this team. Of the four seniors on this team, two will enter the United States Air Force Academy, one will attend Georgia Tech, and one will attend Johns Hopkins University.

It is my honor today to recognize the following team members who are seated on the Senate floor: Caleb Debski, Gannon Ziviello, Cameron Calhoun, Ashton George, Riley Dibert, Lance Dague, Nathaniel Semanek, Luke Dague, Michel Conklin, Isaac Arnold, Joey Windows, and the team advisors Doug Alexander and Doug Pauley. They made their school, their friends and family, their community, and this Senator very proud.

Please join me in giving a warm Senate welcome to the National Robotics League champions of Bedford High School.

But even more, he teaches two weekly Bible classes, even at managing a church of this size. One of these classes he has taught in center city Philadelphia as well as in northwest.

He and his wife have been staunch advocates for sexual and domestic abuse victims and have been an instrumental part of last year passing the antihuman trafficking legislation that we were able to do. He is a voice for the underserved and the oppressed. He has created a men's service initiative, starting in 2016, by gathering hundreds of men to participate in going and being a presence in various parts of the city where there is significant level of crime in our town. He has participated in a partnership with the Philadelphia Police Commissioner to assist with safer streets. He has helped me in actually assisting young people in Cheltenham Township who have suffered a significant achievement gap to try to raise their achievement. Not only that, he has been involved internationally providing services in Kenya, Uganda, South Africa, South Korea, and England. Finally, I will say Reverend Waller is someone you may or may not know is an accomplished musician, singer, vocalist, and songwriter. He established the Enon Music Group, of which they have some recordings. He is most recently an author. His most recent book is called *The Code of the Righteous Warrior: 10 Laws of Moral Manhood for an Uncertain World*.

Senator REGAN. Mr. President, I rise in support of Senate Bill No. 589. In 1996, Pennsylvania established the National Guard Educational Assistance Program. This program provides men and women a free college education in exchange for a 6-year enlistment in the Pennsylvania National Guard. Since then, over 50,000 Army and Air Guard members have taken advantage of this program. In return, our Pennsylvania National Guard, the second largest in the nation, has remained strong both at home and abroad. Pennsylvania's program was the first in the nation and has been replicated across many States. Knowing that the military is not just an individual commitment, but a family commitment, this legislation supports our National Guard families who are called on to sacrifice when their spouse or parent is training once a month or when they are deployed overseas. The Military Family Education Program, or the Pennsylvania GI Bill for Families, will enable men and women in our National Guard to earn educational benefits for their spouse or their children by committing to a second enlistment of 6 years. Overall, the program will provide for 5 years of higher education at the State System of Higher Education tuition rate.

While Guard enlistment rates are steady, reenlistment numbers are starting to drop off. When a Guard member completes their initial 6-year enlistment, they are likely to have started a family and a career. As such, an educational assistance program for spouses and children is likely to help incentivize the Guard

member to re-up for another 6 years. Guard members and their families are located in every community across the Commonwealth. They have been deployed to every major engagement in our nation's history. In fact, the Pennsylvania National Guard's 28th Division has been deployed to more places at home and abroad than any other National Guard unit. Its roots can be traced back to Ben Franklin in 1747. In order for us to maintain a strong National Guard over the next several decades, it is important that we retain these citizen soldiers beyond their first enlistment. The Military Family Education Program will help in this case.

Thank you, Mr. President, and I ask my colleagues for an affirmative vote.

Senator L. WILLIAMS. This article provides the exclusive means for a school entity or nonpublic school to authorize school security personnel to possess a firearm on school premises.

On the question,

Will the Senate agree to the amendment?

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Regan.

Senator REGAN. Mr. President, the genesis of Senate Bill No. 621, as a whole, stems from an oversight in last year's Act 44 that neglected to include sheriffs and deputy sheriffs as school resource officers. Prior to Act 44, school districts in six counties across the Commonwealth, including Big Spring School District in my district, have been using deputy sheriffs as school resource officers. After passage of Act 44, they found themselves out of compliance and without school resource officers, which was never the intent of the original legislation. Unfortunately, as I was working on a simple piece of legislation to address this oversight, the Department of Education issued to school districts an interpretation of Act 44 related to armed school security personnel. Essentially, they informed schools that security guards were not allowed to be armed. Prior to Act 44, schools were already utilizing armed security guards and continued to do so following the passage of Act 44. However, a resolve of the department's interpretation, schools found themselves out of compliance again, and this was not the intent of Act 44. Therefore, we began looking at ways to address both issues with Act 44. What resulted was Senate Bill No. 621, which was amended in the Senate Committee on Education and which we aim to further amend today.

The ultimate goal is to strengthen our current school safety law and to insure our schools can keep operating and protecting students and staff, as they have been doing, but also to insure that all security personnel, at a minimum, have a standard level of

training. This is particularly what the Governor wanted when we met. This is accomplished by the requirement of NASRO basic school resource officers training course. NASRO is the National Association of School Resource Officers. This course is a 5-day, 40-block of instruction covering multiple aspects of working in a school environment, including violence prevention in school settings, understanding special needs students, interacting and supporting students, and effects of youth trends in drug and the school culture. Since the Senate Committee on Education approved Senate Bill No. 621, we have heard from the PSEA, the teachers' union, the Pennsylvania School Boards Association, the county commissioners association, as well as the Governor's policy office. The amendment we are considering today is a compilation of some of the requests from all four entities, and it is our effort to further make the laws that make our Pennsylvania schools safe stronger.

Thank you, Mr. President.

Mr. President, I understand that each school district has complicated decisions and discussions around armed people in the schools, and I understand the intent of the bill is to correct some things that were in Act 44. One of my questions is with regard to third-party school security officers. My concern is that training be at a level playing field for every person who carries a weapon in a school. What I would like to know is, what is to prevent a third party who is not a former police officer, does not have MPOETC training and some of those other trainings, from going into the school with a weapon?

Senator REGAN. Mr. President, that is not included. I am informed that the interrogation should be constrained to the elements of the amendment. That is not within the amendment.

POINT OF ORDER

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, that is a sincere question about the heart of this matter. The gentleman talked about the standard level of training that is going to be necessary to be able to have this situation move forward. The question that the gentlewoman from Allegheny County raised is specifically related to the comments that were made by the Member when he spoke in support of the amendment, and, therefore, are within the confines of this discussion.

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Regan.

Senator REGAN. Mr. President, I am happy to answer the question. But since the time has elapsed, could you please repeat it?

Senator L. WILLIAMS. Mr. President, my question is, what is to stop someone who is hired by a third-party security agency, who is not a former police officer, who does not have MPOETC training, who does not have the training that a former police officer or law enforcement officer would have, from going into the school with a weapon?

Senator REGAN. Mr. President, the way the law currently is, which is required of a school security officer who is hired from a private contractor, is that they have Act 235 training, which is the lethal weapons training that is sponsored by statute. With the amendment, it is required that they have Act 235 and the NASRO training. The NASRO training--it is important that I have mentioned that the NASRO training is the training that teaches those individuals how to deal with students in the school, how to read groups, how to identify gangs, how to identify drug users, and how to deal with children with special needs. The intricacies of being a school resource officer or an officer within the school who is able to perform their job at a high level, I will say this anecdotally, that during this whole process of Act 44, whenever we had an expert on hand to provide us with information when we drew up the bill, was a question I asked every single time, if you could only do one thing, what would it be? To the man they said put an armed, trained, vetted officer in the school with a firearm, and I think this NASRO training brings us up to the next level where they can. I will say this, too, when we talked with the school resource officers and those who are in the school, one of the points they made is that it is so important for these guys to be able to interact with the students because they are intelligence gatherers. More so than anything else, they know whose parents are getting divorced, they know who is breaking up, they know who the gang members are, they know who the drug dealers are, and I think this NASRO training, which we are now going to require with this amendment, really brings our officers, who are already in the schools, armed, up to the next level where they will be able to function in that fashion much more effectively.

Senator L. WILLIAMS. Mr. President, I have another question. In the amendment itself, "Section 1316-C. Authority to assess a firearm, this article provides the exclusive means for a school entity or nonpublic school to authorize school security personnel to possess a firearm on school premises." Where in the bill is "school security personnel" defined?

The PRESIDENT. Senator Regan, did you hear the question?  
 Senator REGAN. Mr. President, it is currently not clearly defined in the amendment, but we are willing to entertain further language which identifies school resource officers, school police officers, and school security officers as those which should be defined in the amendment.

Senator L. WILLIAMS. Mr. President, may I have a moment?  
 The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, may we be at ease for a moment?

The PRESIDENT. The Senate is at ease.

Senator CORMAN. Mr. President, could we be at ease?

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Regan.

Senator REGAN. Mr. President, in the scenario that the gentleman painted was something that really will be less likely to occur when these officers within the schools receive the NASRO training. As I look at the criteria and the training blocks within the NASRO training, one is developing and supporting stressful relationships with diverse students. So, I think that any officer who is afforded the opportunity to have this training as part of his job as a resource officer or security guard within a school, I think would be way less likely to handle a situation like that in a proper manner.

Senator HAYWOOD. Mr. President, that ends my interrogation.

Senator DINNIMAN. Mr. President, it is never easy to oppose a Governor whom you respect and like, and it is not easy to oppose your own Caucus. But I was not elected to the Senate by the Governor or by my Caucus. I was elected by my constituents. Like others of you here, I am elected to represent their views, and, quite frankly, the citizens of my district feel that DEP has not represented their interests in terms of the Mariner pipelines. I do not oppose pipelines. I oppose pipelines that are done in an unsafe manner. Let me say, as I speak here today, the returning fluid and water is pouring out as it has been for the last 3, 4 days actually, onto Boot Road in Senator Killion's district, adjacent to my district. They should have never been given a permit in the first place. My staff just informed me that someone was taken out of the area on a stretcher, and I do not know any more information at this point to tell you.

What I am trying to say is this, that before we confirm a nomination, we need to make sure that an investigation going on at this time, there is a grand jury that is sitting in West Chester, as we sit here today, that is looking into whether Energy Transfer and whether some of the regulatory agencies such as DEP have done their job appropriately and whether any misdeeds were done. I would have preferred to wait on this nomination until that grand jury report is completed, which will be in September or October, hopefully. As we stand here today, an investigation is going on by the Attorney General of this Commonwealth at the request of the district attorney of our neighboring county, Delaware County. The Attorney General, Mr. Shapiro, said that he will leave no stone unturned in this investigation. Let me say that there are other investigations going on that I cannot, at this point, speak about.

So I oppose this nomination, and I do not care if I am the only one who opposes it. I was elected to represent my constituents, and I will continue to represent my constituents. As I have mentioned before, in summary, they feel that they were done in by DEP, to be quite frank. I sat there one night as DEP showed up at a location where there was a sinkhole. In that sinkhole was an exposed active pipe carrying highly volatile liquids. Neither DEP nor anyone else called it in to the PUC and to the various agencies that were responsible for safety. When my citizens and myself finally called it in, what occurred was this: we finally called it in because DEP did not call it in. The PUC showed up with their inspectors, and PHMSA showed up, and they closed it down. Why should my constituents be in danger for 3 days because they would not call and follow protocol when a pipeline that is 87 years old carrying highly volatile liquids is exposed?

My constituents have made it clear to me, oppose this nomination because we do not believe that the way Energy Transfer is building in this pipeline is safe. I respect every Member to vote the way they wish and I would say that every Member here knows that there was a time when, despite what your Caucus says, despite how the Governor might feel, all of whom I deeply respect and feel a part of, there comes a time when you took an oath of office and your obligation is to represent your constituents. So on behalf of the constituents of the 19th Senatorial District of the Commonwealth of Pennsylvania, I will have to vote "no."

A Resolution designating the week of June 1 through 7, 2019, as "Cardiopulmonary Resuscitation and Automated External Defibrillator Awareness Week" in Pennsylvania.

The PRESIDENT. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Mr. President, I am pleased to join my colleagues, Senator Scavello and Senator Killion, in offering this resolution which aims to lift up public awareness of a serious problem, encourage education into what we can do, and underscore the importance of having lifesaving technology accessible. The number of individuals struck down by sudden cardiac arrest is alarming. The low survival rate, slightly over 1 in 10, is scary and unacceptable. The first time I really felt this was when friends of mine, Rachel and John Moyer of Monroe County, lost their son at a basketball game during high school, a young man with much promise, much to offer in life. He had no signs, no symptoms, and yet he had an incident and the school did not have an Automated External Defibrillator (AED).

We know sudden cardiac arrest is survivable, but it requires immediate intervention, preferably by someone who knows what they are doing. If individuals are prepared, they are more likely to act and much more likely to do so effectively. Placing the 911 call is imperative, but statistics show waiting until emergency personnel arrive means it will be too late for the majority of individuals stricken. Greg Moyer, unfortunately, passed away. And in his memory, his mom, Rachel, and his dad persuaded schools to add AEDs. They have created a foundation to create training programs, train-the-trainer events, provide equipment, and help with public awareness. So, when a dire emergency confronts us, there is no time for hesitancy or uncertainty. Despite years of public education, too few people have followed through on CPR or have become familiar with how to use an AED. That is the message wrapped in this resolution. We must make it ready for the worst crisis and at the most unexpected time or place.

Today we just voted on Senator Killion's effort to strengthen CPR for school students. There is a misconception that this situation involves strangers, but of course it may be a family member or friend who needs our assistance. Either way, the pain and loss of someone is so much greater when we know we could have been prepared to act. So for those who have taken the time to learn lifesaving procedures, you are to be commended. For those who have not quite found the time or sense of urgency, this is that timely reminder to take those necessary steps. The life you may save will be a precious one.

So please join Senator Scavello, Senator Killion, and me in proclaiming June 1 through June 7 "Cardiopulmonary Resuscitation and Automated External Defibrillator Awareness Week" in Pennsylvania.

Senator SCHWANK. Mr. President, this resolution is sponsored by myself and Senator Killion, both members of the parks and recreation caucus here in the Senate. When we talk about government services, Mr. President, I almost never have anybody compliment me on the status of our tax collection effort or on the criminal justice system per se, but one thing people do talk to me about are the quality and the number of our parks and

recreational facilities. I think we can all agree, when you visit a park, we want it to be clean, safe, and ready to use. If we go swimming, our family goes swimming, we want to ensure that the lifeguards are well trained and the water quality is the best. If we have a loved one with a disability who wants to camp, swim, paddle, or fish, that all of the facilities are well marked, well maintained, and easily accessible. When we attend a public festival, which we all like to do, all safety and security systems are capable and functioning. And, of course, that our children, our teenagers, our young children can participate in youth sports and that they thrive with the coaching, playing, and growing that they will be able to do as a result of that participation. These are the expectations that we have of our park and recreation facilities, but we have to remember there are people who actually make this happen, and those are the park and recreation professionals who provide those services.

The third Friday in July is "Pennsylvania Park and Recreation Professionals Day," and it honors the men and women who provide those services behind the scenes. So when you are visiting your park and you are there at a festival and you see workers picking up the trash, we ought to thank them for doing that. When we see coaches at athletic fields, or even the folks who mow the grass and line the fields, we ought to be thanking them for providing those services to us. We kind of just anticipate them to be there, but they would not be if it were not for those professionals. And, just for the record, we have 121 State parks in Pennsylvania, we have cultural sites, we have skate parks, we have dog parks, we have athletic fields, we have pools, beaches, we have bandshells and amphitheaters, we have all kinds of facilities available to us, both on the State and on the local level as well, and 8,000 full-time and part-time professionals provide the services that make those available to us. I think, again, that is something we can all agree on, Mr. President, those folks deserve thanks, and I hope that everybody will join me visiting a park on July 19, 2019, and saying thank you to a park and recreation professional.

**PETITIONS AND REMONSTRANCES**

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, it has long been said that time waits for no man, but as of today, Pennsylvania's low-wage earners have been waiting 4,713 days since their State legislature last raised the minimum wage in the Commonwealth. That is almost 13 years, and it is far too long. Since that time, executive salaries have continued to soar, the middle class has continued to shrink, the nation's income inequality has reached an all-time high. All of this has happened as worker productivity has risen to unprecedented heights. These are the fundamental reasons why I introduced Senate Bill No. 12, to raise Pennsylvania's minimum wage from \$7.25 an hour to \$12 this year followed by annual raises of \$.50 until it reaches \$15 by 2025. My legislation would also eliminate the sub-minimum wage of \$2.83 for tip earners and create annual cost-of-living adjustments so that Pennsylvania's low-wage workers will never again be stranded while economic factors beyond their control overwhelm them.

The year 1968 is a great starting point to explain our current unsustainable trajectory. Pennsylvania enacted its first minimum wage law that year. American income inequality reached its lowest point on record, while the real value of the minimum wage was at its all-time high of \$11.75 in 2019. At \$7.25 per hour

today, minimum wage workers earn \$.38 less than their counterparts did a half-century ago. This dramatic pay reduction has occurred while the productivity of American workers has more than doubled. Year after year, day after day, hour after hour they are doing more work for less pay. Studies show that if minimum wage rose in proportion with worker productivity, it would already be more than \$20 an hour, and workers at the low end of the pay scale would not face the harsh challenges and grave financial decisions that confront them every day. There is no disputing that \$7.25 an hour amounts to poverty wages. For a full-time, year-round worker, that is just \$15,000 a year. It is almost \$2,000 below the poverty level for a single parent or a worker who is trying to care for an incapacitated spouse or relative.

Twenty-nine States have already raised their minimum wage above the Federal minimum wage in recent years. Yet, there is still no State in the country where a person working a full-time minimum wage job can afford to rent an average two-bedroom apartment. Adequate housing is just one of the many necessities, with costs that are growing beyond the reach of millions of low-wage earners. Senate Bill No. 12 would establish the Commonwealth as a national leader on this critical economic issue, and it would grant millions of Pennsylvanians the financial independence that they have worked so long and hard to earn.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I will be brief. I rise to communicate with my colleagues about the ongoing issue with respect in the western part of the State with regard to the UPMC/Highmark dispute that is very important to a lot of the residents of the Allegheny County area, in particular, and certainly my district as well. More recently, we learned yesterday that the Commonwealth Court will conduct hearings next week, on Monday and Tuesday of next week, and then ultimately have a decision at the Commonwealth Court level by Friday, which would be June 14 of next week, that they will be able to make that decision. While those dates are important, the expectation is that the matter will ultimately be appealed to the Pennsylvania Supreme Court. As my colleagues know, on June 30 is when the consent decree, that some of us in this Chamber worked on, myself included, and a number of other folks worked on, would end. At the heart of the matter is whether or not that contract could be extended.

Mr. President, I am a firm believer that there is an obligation upon the entities to come together, sit at a table, and hash out an agreement, and we will continue to work towards that end. More specifically, for the purposes of me standing here today, Mr. President, I have introduced legislation, two measures, Senate Bill No. 310 and Senate Bill No. 311, earlier this year, and on two occasions we have asked that those measures be moved forward for our consideration in the Senate Committee on Banking and Insurance. Mr. President, those measures are instrumental in trying to get this issue resolved. We have the wherewithal and we have the number of days to be able to achieve that long before the June 30 deadline occurs that would allow for these two entities and require them to enter into binding arbitration. If they cannot reach an agreement, then have them go to binding arbitration and have them be able to do what needs to be done to settle this dispute.

Secondarily, we also have another bill in that mix, as I have mentioned, that deals with, what I would call, an oversight council to look at and determine how we more appropriately handle these integrated healthcare delivery systems, for which we have no real set of rules or regulations. We certainly have regulations governing our hospitals, and we have regulations governing our insurance industry, but we lack a sufficient amount of regulations in laws that address the integrated healthcare delivery systems that is playing itself out in western Pennsylvania, but I share with my colleagues, your communities are going to be next, because this is something that is taking place, and it is high time we get things in order along those lines to manage that.

More specifically, Mr. President, my view is that it is unconscionable that an entity of the magnitude of a \$20 billion entity, UPMC, be in a position to deny healthcare coverage to those men and women, those individuals, who, through no fault of their own, are holding a Highmark insurance card, denying them the opportunity to be able to visit the doctors of their choice along those lines, and I would be remiss if I did not say that both entities, whether it be Allegheny Health Network or UPMC healthcare system, the men and women who work there provide excellent and exceptional coverage. They provide exceptional healthcare delivery. This is not about those men and women. This is about an administration or organization that fails to recognize that we in the public have put forth resources, our State resources in terms of budget resources, that we provide. We have put resources in with respect to the tax forgiveness that takes place across these communities across Pennsylvania. We have put resources into them to try to support them through RCAP projects and the like. These are the types of things where public investment has been made, particularly into one institution, but yet they refuse to be part of the conversation where they will be able to look to the people who have Highmark coverage and allow them to have services provided to them along those lines.

The most egregious thing, Mr. President, is something that occurred more recently when this dispute began earlier this year. Through this process, individuals who would be Highmark customers who would want to avail themselves to the treatment of UPMC services, they are asking, particularly our seniors, asking that they pay for these medical bills and costs up front, even before the services are provided, and then they are asked to go chase Highmark for the reimbursement of those services. To me, that is unconscionable and violates the public trust that we have in a public charity notion that these folks are supposed to provide to our residents across Pennsylvania. To think that a \$20 billion industry is going to need to receive several thousands of dollars from a senior mom or senior dad or someone, a family member, who is going to have a service done because they do not want to wait for Highmark and they have this dispute with them, it is unconscionable and it is something that should not be allowed to take place. That would be one of the things that would be governed under this conversation about having an integrated delivery system that is regulated with an oversight commission or board.

That all being said, Mr. President, to the end that we spoke about the Attorney General having a lawsuit pending before the Supreme Court, as I mentioned, next week will bring closure, but there is no way through this process that the Supreme Court, when it receives the appeal for the underlying decision from the Commonwealth Court, and only one issue of the Commonwealth Court, there are still three that will be there, there is no way that

they will be able to get it done by June 30. My concern is that there is an attempt to maybe just run out the clock. So June 30 comes and we will not have any opportunity to be able to do anything along the lines of protecting those seniors who want services and who need those services available to them. Particularly, again, through no fault of their own. There are many folks, we are blessed in this Chamber and our employees who live in the western part of the State, they can make the choice, they can choose either UPMC or Highmark, but there are a lot of folks who for years and years have dealt with doctors or facilities at a UPMC facility that their employers, for whatever reason, made the decision to have Highmark insurance. We are cutting those folks off from some of the best healthcare coverage in this Commonwealth and in this world, which is unfortunate.

So, we filed an amicus brief to support the Attorney General in his efforts to be able to advance the motion that we can modify this agreement. My hope is that the Commonwealth Court will see its way clear after they hear the evidence on Monday and Tuesday of next week and, more importantly, make a decision next Friday that will be likely to be appealed, regardless, but my point is, we need to move legislation. I respectfully ask my colleagues to consider moving Senate Bill No. 310 and Senate Bill No. 311 out of the Committee on Banking and Insurance, where they have languished not only last Session but also this Session as well so far. It is imperative that we talk about this issue as we move forward trying address it as soon as we can because the clock is running. With less than 20 legislative days left here, we have an opportunity to get it done, but more importantly, we need to do so before June 30. At least provide a hearing for us to have this discussion in a formal hearing setting and then the Members can make up their own minds along those lines. But the clock is running, we have to take steps to be able to address that. I am calling upon my colleagues to join me in moving Senate Bill No. 310 and Senate Bill No. 311 through the Committee on Banking and Insurance, onto this floor for debate, and ultimately over to the House for their consideration.
