An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in professional employees, further providing for rating system and for persons to be suspended and providing for a revised rating system.

**HB 265 (Pr. No. 2177)** (Amended)

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in preliminary provisions, providing for career information and recruitment; in terms and courses of study, further providing for Commission for Agricultural Education Excellence; in vocational education, further providing for career and technical education equipment grants and providing for utilization of credits; providing for classification of program code; and, in transfers of credits between institutions of higher education, further providing for definitions, for duties of public institutions of higher education and

State-related institutions, for Transfer and Articulation Oversight Committee and for duties of department.

Senator HUTCHINSON, from the Committee on Finance, reported the following bills:

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in additional special funds, providing for the Enhanced Revenue Collection Account; in 2018-2019 budget implementation, further providing for Department of Revenue; and making an editorial change.

**HB 1549 (Pr. No. 2118)**

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in sales and use tax, further providing for definitions and for imposition of tax; and, in special taxing authority, further providing for special taxing authority.

Senator BROOKS, from the Committee on Health and Human Services, reported the following bills:

**SB 277 (Pr. No. 236)**

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, providing for medical assistance deemed eligibility program for home care, home health and older adult daily living center services.

**HB 786 (Pr. No. 2178)** (Amended)

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in emergency medical services system, further providing for definitions and for Pennsylvania Trauma Systems Foundation, providing for accreditation of trauma centers, for submission of list, for funding, for notification of trauma center closure, for reporting and for certification and financial report; and making a related repeal.

Senator STEFANO, from the Committee on Law and Justice, reported the following bills:

**SB 61 (Pr. No. 1006)** (Amended)

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for wine and spirits auction permits.

**HB 131 (Pr. No. 857)**

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in preliminary provisions, further providing for definitions; in licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for malt and brewed beverages manufacturers', distributors' and importing distributors' licenses and for breweries; in distilleries, wineries, bonded warehouses, bailees for hire and transporters for hire, further providing for limited wineries and for distilleries; and, in miscellaneous provisions, further providing for construction and applicability.

**HB 423 (Pr. No. 2175) (Amended)**

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in general provisions applying to both liquor and malt and brewed beverages, further providing for local option.

**HB 947 (Pr. No. 2176) (Amended)**

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in licenses and regulations, liquor, alcohol and malt and brewed beverages, further providing for sales and liquor licensees and restrictions, for performing arts facility license and for hours of operation relative to manufacturers, importing distributors and distributors; and, in distilleries, wineries, bonded warehouses, bailees for hire and transporters for hire, further providing for distilleries.

**HB 1524 (Pr. No. 2066)**

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, in preliminary provisions, further providing for definitions; and, in licenses and regulations, liquor, alcohol and malt and brewed beverages, further providing for limiting number of retail licenses to be issued in each county and for licenses not assignable and transfers.

Senator FOLMER, from the Committee on State Government, reported the following bills:

**SB 300 (Pr. No. 1011) (Amended)**

An Act amending the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, in preliminary provisions, further providing for definitions; in qualifications of electors, further providing for qualifications of electors at primaries; in party organization, further providing for only enrolled electors to vote at primaries or hold party offices; in nomination of candidates, further providing for candidates to be nominated and party officers to be elected at primaries and providing for procedure for unenrolled electors to cast primary ballots; and, in preparation for and conduct of primaries and elections, further providing for manner of applying to vote, persons entitled to vote, voter's certificates, entries to be made in district register, numbered lists of voters and challenges.

**SB 411 (Pr. No. 1012) (Amended)**

A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, further providing for absentee voting.

**SB 414 (Pr. No. 1013) (Amended)**

An Act amending the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, in voting by qualified absentee electors, further providing for applications for official absentee ballots, for absentee electors files and lists, for delivering or mailing ballots, for voting by absentee electors and for canvassing of official absentee ballots.

**SB 418 (Pr. No. 1014) (Amended)**

An Act amending the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, in ballots, further providing for number of ballots to be printed and specimen ballots.

**SB 421 (Pr. No. 1015) (Amended)**

An Act amending the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, in ballots, further providing for form of official election ballot; in voting machines, further provid-

ing for requirements of voting machines and for form of ballot labels on voting machines; in electronic voting systems, further providing for requirements of electronic voting systems, for forms and for election day procedures and the process of voting; and, in preparation for and conduct of primaries and elections, further providing for instructions of voters and manner of voting in districts in which voting machines are used, for count and return of votes in districts in which ballots are used and for what ballots shall be counted, manner of counting and defective ballots.

**SB 422 (Pr. No. 399)**

An Act amending the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, providing for Pennsylvania Election Law Advisory Board.

**SB 693 (Pr. No. 838)**

An Act amending the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, in ballots, further providing for form of ballots, printing ballots, stubs and numbers; in voting machines, further providing for form of ballot labels on voting machines; and, in electronic voting systems, further providing for forms.

**HB 448 (Pr. No. 2181) (Amended)**

An Act amending the act of June 12, 2018 (P.L.136, No.28), known as the Pennsylvania Commission for the United States Semiquincentennial Act, further providing for definitions, for establishment, for composition and for report to the Governor and the General Assembly.

**HB 1461 (Pr. No. 2064)**

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, in Office of State Inspector General, further providing for criminal charges.

Senator MARTIN, from the Committee on Local Government, reported the following bills:

**SB 493 (Pr. No. 527)**

An Act amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in consolidated county assessment, further providing for definitions, for changes in assessed valuation and for abstracts of building and demolition permits to be forwarded to the county assessment office.

**SB 494 (Pr. No. 528)**

An Act amending the act of October 27, 1979 (P.L.241, No.78), entitled "An act authorizing political subdivisions, municipality authorities and transportation authorities to enter into contracts for the purchase of goods and the sale of real and personal property where no bids are received," further providing for title of the act; adding a short title; and providing for contracts for services.

**SB 495 (Pr. No. 529)**

An Act amending Title 8 (Boroughs and Incorporated Towns) of the Pennsylvania Consolidated Statutes, in elections of officers, further providing for decrease in number of members of council.

**SB 688 (Pr. No. 827)**

An Act amending Title 8 (Boroughs and Incorporated Towns) of the Pennsylvania Consolidated Statutes, in powers and duties of elected

officials, further providing for organization of council, quorum, participation by telecommunication device, voting, compensation and eligibility; and, in mayor, further providing for salary of mayor.

**SB 689 (Pr. No. 828)**

An Act amending the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, in township supervisors, further providing for compensation of supervisors.

**SB 690 (Pr. No. 829)**

An Act amending the act of May 27, 1953 (P.L.244, No.34), entitled "An act relating to and regulating the contracts of incorporated towns and providing penalties," further providing for power to convey.

**SB 691 (Pr. No. 830)**

An Act amending the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, in corporate powers, further providing for real property.

**SB 692 (Pr. No. 831)**

An Act amending Titles 8 (Boroughs and Incorporated Towns) and 11 (Cities) of the Pennsylvania Consolidated Statutes, in corporate powers, further providing for real property; and, in corporate powers, further providing for city property and affairs.

Senator K. WARD, from the Committee on Transportation, reported the following bills:

**SB 114 (Pr. No. 83)**

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in miscellaneous provisions, further providing for snow and ice dislodged or falling from moving vehicle.

**SB 778 (Pr. No. 1003)**

An Act amending Titles 74 (Transportation) and 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in sustainable mobility options, further providing for Public Transportation Trust Fund; and, in Pennsylvania Turnpike, further providing for definitions.

**HB 915 (Pr. No. 1487)**

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in size, weight and load, further providing for permit for movement during course of manufacture; and, in powers of department and local authorities, further providing for power of Governor during emergency.

**HB 1077 (Pr. No. 2180) (Amended)**

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in fees, further providing for annual hauling permits; and, in size, weight and load, further providing for conditions of permits and security for damages and for permit for movement during course of manufacture and providing for permit for movement of hot ingots or hot boxes.

Senator REGAN, from the Committee on Veterans Affairs and Emergency Preparedness, reported the following bills:

A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, further providing for exemptions and special provisions.

An Act amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in volunteer firefighters, further providing for definitions, for statement of purpose, for funds and for audits.

**HB 1324 (Pr. No. 2179) (Amended)**

An Act amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, in military educational programs, further providing for definitions, for eligibility, for grants, for amount of grants, for limitations, for recoupment of grant payments, for regulations, for administration and for Educational Assistance Program Fund and providing for a military family education program; and making editorial changes.

Senator BAKER. Mr. President, I am so delighted to rise and introduce my guest shadow, who is also seated here on the Senate floor, Shelby Carr, a recent graduate of Dallas High School, my alma mater. Shelby has been an honor student while participating in varsity and travel sports. She enjoys volunteering, playing volleyball, cooking, and baking. She plans to attend King's College and hopes to graduate with her degree in 3 years through the accelerated law program and get her degree in political science and then complete her Juris Doctor at Villanova University School of Law. ### **GUESTS OF SENATOR JOHN M. DiSANTO PRESENTED TO THE SENATE**

The PRESIDENT. The Chair recognizes the gentleman from Dauphin, Senator DiSanto.

Senator DiSANTO. Mr. President, it is my honor to recognize in the gallery the Harrisburg University Storm Overwatch Team, who recently won the first Esports ESPN Overwatch National Championship. The team went undefeated this season, 33-0, and beat three of their competitors from across the country during the national championship tournament in Houston, culminating in a 3-1 victory over the University of Utah in the finals.

Senator COSTA. Mr. President, I intend to not support the amendment. If I understand correctly, this is an amendment that creates an exception, if I am not mistaken, for the management

of pain associated with major surgical procedures. In addition to that, it creates an opportunity for prescribing unlimited amounts of opioids along those lines. My concern is that we are creating an exception that could, at some point, create problems for unscrupulous physicians who would want to use that particular provision to be able to dispense an inappropriate amount.

The gentleman from Lycoming County, Senator Yaw, has been at the forefront of this conversation for a number of years, and I certainly respect the work that he has been doing, and I can appreciate what he is trying to accomplish with respect to creating an exception in this space for those individuals who are experiencing major surgery. The concern that I have is that there is no real definition of what a pain associated with a major type of surgery means, and, secondly, what it means as it relates to the length of time that this could continue to be able to prescribe these narcotic drugs to individuals.

For those two reasons, Mr. President, it is my intention to not support this amendment because I believe that it opens up an exception that is far greater than I believe is the intent of what is trying to be accomplished here. If, in fact, it had a limitation on the number of days, and maybe some reference to a specific type of surgery, then I think I would be more comfortable. To that end, I am not supporting the amendment for those reasons.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, I ask for an affirmative vote on the amendment. Even if a physician would do an extended period of time on the prescription, they would still have to enter that information and post it with the Pennsylvania Prescription Drug Monitoring Program. I know the concern of unscrupulous physicians, as it was mentioned by the previous speaker, but it still would have to go through the process and register so it would be peer reviewed and looked at publicly if this was a real consideration and real problem. Obviously, major surgery could have significant chronic ailments, and that is why it is an exception just for this one area. I certainly understand the underlying concern that we all have and why we are moving the issues both in a bipartisan way on opioid abuse and trying to curtail prescriptions, but also for those people who are suffering from significant ailments, there is reason to allow some flexibility for the physicians as long as it is still reviewed and still registered with the Prescription Drug Monitoring Program. The concerns are understandable by the Leader on the other side of the aisle, but I think the safeguards are still in place. So I ask for an affirmative vote.

By providing these organizations access to the program, the Commonwealth would be able to better identify potential prescription drug abuse among individuals enrolled in the State's Medicaid program. Additionally, this proposal will save taxpayer money in the short term by identifying waste in prescription drug abuse within Medicaid, and it would save taxpayers money in the future by reducing the need for drug treatment and rehabilitation. Mr. President, the Department of Human Services has indicated that they are supportive of this measure and agree that MCOs should have access to the PDMP.

Senator J. WARD. Mr. President, I offer this resolution recognizing June 24, 2019, as "Cystinuria Awareness Day" in Pennsylvania. I am offering this resolution on behalf of a young woman I met who is battling this disease. Cystinuria occurs in individuals in which a rare genetic defect prevents the body from regulating amino acid concentration, subsequently leading to elevated levels of cystine and the formation of cystine stones in the kidney, ureter, and bladder. Cystinuria patients often endure episodes of debilitating pain, nausea, vomiting, and recurrent urinary tract infections. Patients may also suffer from life-threatening complications such as hypertension, renal insufficiency, end-stage renal disease, and the need for a kidney transplant. The majority of patients will require numerous stone removal procedures and surgeries. One in every 10,000 Americans are believed to be genetically at risk for cystinuria. In Pennsylvania, there are 30 known cases of this disorder. That being said, I ask for your support for this resolution to raise awareness about cystinuria and to show support for research at the Pennsylvania medical research centers that take an active role in the fight against cystinuria.

WARD and KEARNEY, by unanimous consent, offered **Senate Resolution No. 174**, entitled:

A Resolution recognizing the 100th anniversary of ratification of the 19th Amendment, the constitutional amendment extending equal voting rights to women.

On the question,  
Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentlewoman from Mercer, Senator Brooks.

Senator BROOKS. Mr. President, when I bring young students onto the Senate floor, I often tell them the story about Violet Oakley, the famous painter who was not even permitted to view the murals she had painted in this magnificent Chamber. She was prohibited from entering because of one reason, and one reason only: that was, she was a woman. This tidbit of history was one that Lieutenant Governor Catherine Baker Knoll told me when I was first elected to the House in 2006. Fast-forward to today, when we have 12 women in the Senate and more than 50 women in the House. One-fourth of the legislature is comprised of women today. When I tell the story to young children who are visiting the building, the students are shocked that only 100 years ago women were taken directly to a ladies-in-waiting room while their husbands did their business here in the Capitol. As you know, Mr. President, one of those ladies-in-waiting rooms is in your office. They are also shocked to learn that women were not given the right to vote until 1919, a full century ago, and were ultimately permitted to vote for the first time in 1920.

In celebration of this milestone in history, I rise today with Senator Laughlin to commemorate the 100th anniversary of women's right to vote brought about by the ratification of the 19th Amendment to the U.S. Constitution. Many community organizations, including the League of Women Voters, will celebrate this milestone with events that begin this month and continue through August 18, 2020, the date the 19th Amendment was ultimately ratified. The campaign for women's rights to vote represented one of the longest and largest grassroots movements in American political history. Commencing in the late 1800s, strong women of principle gathered in meetings and marches to assert their rights to assemble and dissent on behalf of women's suffrage. For more than 50 years, they forged a nonviolent, mass movement that embraced decades of strategic outreach and persistence. In 1915, Pennsylvania voters actually defeated a statewide referendum giving women the right to vote. Three years later, President Woodrow Wilson endorsed women's suffrage as a wartime measure. In a major victory, the U.S. Congress ap-

proved the measure on June 4, 1919, and Pennsylvania went on to become the fourth State to ratify it on June 24, 1919. By August 18, 1920, the required 36 State legislatures had ratified and approved the Susan B. Anthony amendment. Ultimately, all 50 States went on to ratify the change.

After decades of advocacy, millions of women voted in national elections for the first time ever in 1920. The story of how women won the vote embodies the highest ideals of democracy and civic engagement and highlights the remarkable women who led the charge, leaving behind a proud and inspiring legacy of bravery and sense of purpose.

Please join us in honoring this successful transformative landmark in our Commonwealth's and our nation's history.

The PRESIDENT. The Chair recognizes the gentleman from Erie, Senator Laughlin.

Senator LAUGHLIN. Mr. President, I rise to support my fellow Senator, Senator Brooks, in this resolution. I rise to speak on this resolution commemorating the 100th anniversary of the 19th Amendment to the U.S. Constitution, which granted women the right to vote. Today, the impact of that landmark amendment has faded somewhat, as society has seemingly forgotten the uphill battle against the millenia of chauvinistic history waged by dedicated women such as Susan B. Anthony, Alice Paul, Carrie Chapman Catt, and Elizabeth Cady Stanton.

The women's suffrage movement in America can be traced back to an 1848 convention in Seneca Falls, New York. That meeting was well before the 1870 enactment of the 15th Amendment, which stated the right of citizens of the United States to vote shall not be denied or abridged on account of race, color, or previous condition of servitude. Of course, that amendment did not include women, and the battle continued on. Over the ensuing years, the suffrage movement grew in strength and scope and, as such, led to one not very glorious day for the U.S. House of Representatives. On January 12, 1915, Congress took up the issue of women's suffrage during a 10-hour debate. Those officials certainly spoke their minds in a manner that was very much reflective of the sentiments of the male-dominated society of the early twentieth century, and, of course, this was a time before political correctness, C-SPAN, and social media. Speaking on the issue, North Carolina Congressman Edwin Webb is recorded as saying, (*reading*):

Mr. Speaker, I am opposed to woman suffrage, but I am not opposed to woman. I am unwilling, as a southern man, to force upon her any burden which will distract this loving potentate from her sacred, God-imposed duties. I am unwilling to force her into the vortex of politics, where her sensitiveness and her modesty will often be offended.

Congressman Charles Carter from Oklahoma added:

Were it not for shattering an ideal, were it not for dethroning her from that high pedestal upon which we are accustomed to place her, and dragging her down to the level of us beastly men, I believe I might even today be willing to vote for universal woman suffrage.

In fact, during the 1915 floor debate, Democratic Congressman Edward Taylor of Colorado offered that:

In future years, we will look back and marvel at the supreme effrontery of the male population arrogating to themselves all the wisdom, honesty, and patriotism for so many generations after generations. Posterity will be amazed when it reads the history of the many centuries that women were disenfranchised.

These brief comments clearly show that suffrage and women's roles in our nation were very much societal issues, and any changes to the status quo would have to confront and overcome deeply entrenched beliefs and biases.

As such, on January 12, 1915, the suffrage amendment failed in Congress by a vote of 204 to 174. It would take 4 more years and the courageous efforts of women across our nation before Congress approved the 19th Amendment on June 4, 1919. On June 24, 1919, Pennsylvania became the fourth State to ratify the amendment. This marked a major turnaround in public opinion from 1915, when a women's suffrage referendum was defeated by the State electorate. A little more than a year later, enough States had ratified the amendment, and the rest, they say, is history. However, Mr. President, this is a history and a struggle that must be memorialized and never forgotten.

I ask for an affirmative vote. Thank you.

**PETITIONS AND REMONSTRANCES**

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, today marks 4,727 days since the Pennsylvania legislature last raised our minimum wage. Mr. President, this is far too long. By any reasonable measure, \$7.25 an hour is a poverty wage. Yet, as I stand here today, I remain hopeful that our General Assembly will soon, at long last, agree on a minimum wage plan that offers Pennsylvania's low-wage workers the relief they deserve. I am hopeful because the citizens of the Commonwealth want it to happen. Seventy percent, let me say that again, 70 percent of registered voters say they want a higher minimum wage. I am also hopeful because raising the minimum wage right now makes sense for workers, business, and for our economy. But, most of all, I am hopeful because of the people who are uniting behind this cause, people like home healthcare workers who gathered for a rally outside this Chamber yesterday afternoon. Those of us who attended the rally heard from a woman named Grace Johnson, a home healthcare worker from Pittsburgh. Grace has dedicated her life to taking care of others, including her sister who now has epilepsy and diabetes. Grace cooks for her sister, cleans, does her shopping, takes her to the doctor, and helps her with many other essential life tasks. Grace works with other clients, too, yet she does not make enough money to support her own two children or even herself. As she tells it, she gets up every day wanting to make other people's lives better. But when she comes home every day, she can barely keep a roof over her head. Grace makes less than \$12 an hour and hates that she depends on house subsidies, welfare, and food banks to make ends meet.

Mr. President, she is not alone. Pennsylvania has 220,000 direct care workers. Their median hourly wage is just \$11 an hour. More than half of those workers rely on public assistance to fill the gap created by stagnant wages. As Pennsylvania's population ages rapidly, we need 37,000 more direct care workers by 2026. Frankly, we will never satisfy the dire need if we do not act now to improve the wages they earn. My legislation, Senate Bill No. 12, will give immediate raises to those 220,000 direct care workers, as well as workers across an array of employment sectors like food service, hospitality, retail, manufacturing, administrative services, and educational support. It would establish the Commonwealth as a national leader on minimum wage, and it would grant millions of Pennsylvanians the financial independence that they have worked so long and so hard to earn.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise, certainly, to begin my remarks by supporting the good work of our colleague, the gentlewoman from Philadelphia County, in her consistent pursuit of trying to address the issue of minimum wage. Mr. President, I, too, am very disappointed that we are not at a place in time where we are beginning to have serious conversations about this legislation. The gentlewoman has introduced Senate Bill No. 12, which is a modest increase in the minimum wage, which we think we should be talking about. If it may not be where folks want to be, let us at least have a dialogue. Mr. President, I know in my heart that the Members in this Chamber are supportive of doing something along the lines of increasing the minimum wage and addressing, similarly, the tip wages as well, which is part of the gentlewoman's legislation. It seems to me that the problem is on the other side of this building, and while we recognize that, I think despite that fact and despite knowing that--when I say the other side of the building, I mean over in the House--I believe it is important that we work together to be able to fashion a piece of legislation, minimum wage legislation, that we could then move over to the House to begin to apply the appropriate pressure to get those Members over there to understand how important, how critically important, it is to impact the quality of lives of the men and women who are impacted by this, the numbers that Senator Tartaglione talked about.

Mr. President, we have the opportunity in the limited number of days here. We have vehicles that are already in place to be considered. We have an opportunity, in the next couple of days of this week but, more importantly, the 4 or 5 days, maybe 6 days we will be here next week, to bring this conversation to closure. It is time for Pennsylvania to raise its minimum wage.

As you look across every other State that surrounds us, and I wish I had the map that I had before, Mr. President, to show the viewers, Pennsylvania is the only State that has not raised its minimum wage in a number of years. When we look at New York and New Jersey, I believe on January 1 it is going to go to \$11 an hour. All the other States around us, at a minimum, are around \$8.75 or \$8.55, with projected increases in the upcoming January 1 timeline. It is imperative for us, in this Chamber, to lead this effort by looking to increase the minimum wage, particularly Senate Bill No. 12. If that is not going to work, let us talk about what will work, because we know that the Governor is on board for this measure, and we will continue to fight, as we did a number of years ago, when the gentlewoman spoke about it. Senate Democrats will continue to make this the highest priority as it relates to these last 9 or 10 days we are here in Harrisburg.

There are other measures that are important, but this is one that seems to be getting left behind in our negotiations and in our conversations. To me, that is unconscionable because the lives that we are impacting along those lines are the people who want to be able to have a standard of living, a good family working wage that allows them to raise themselves out of poverty and raise themselves out of the benefits they are receiving so they can become productive members of society. Mr. President, as the Governor has pointed out, it generates about \$120 million in tax revenue for the Commonwealth. That is what we should be talking about on this Senate floor, and we should move forward on that.

Similarly, Mr. President, there are two other bills that I will speak about again today. I rise again today to talk about the lack of effort, the lack of consideration of two measures, Senate Bill No. 310 and Senate Bill No. 311. This legislation would look to and require our integrated healthcare delivery systems to contract with one another, and if they did not do it, they would do a binding arbitration. We know that the Commonwealth Court has ruled against the continuation of the consent decree between Highmark and UPMC. I am disappointed, certainly, in the outcome, but at the end of the day, we know it will be before the Supreme Court in the next day or so. I ask my colleagues to join us in an amicus brief to support the efforts of the Attorney General to try to do that.

This all can be fixed very simply. If we, in this General Assembly, or, more specifically, in this Senate, have the will to consider Senate Bill No. 310 and Senate Bill No. 311, we would be able to provide an appropriate remedy to allow the people, in this case in western Pennsylvania, the opportunity to be able to visit the doctors they want to visit, go to the facilities they want to go to to have procedures done, not have to pay in advance for procedures, but also looking forward to being able to have the opportunity to receive the care that they are entitled to from a nonprofit agency that has benefitted from the work the people in this Commonwealth have done, specifically, as it relates to the resources we have provided, and will continue to provide, in this upcoming budget. Looking to make certain that we do things along the lines of insuring that the people in this Commonwealth have access to the appropriate level of care.

Now, listen, Mr. President, this is about quality of care and the people who provide it in these two facilities. These two entities, these two integrated healthcare delivery systems, UPMC and Highmark, provide exceptional healthcare. They deliver it very, very well. More importantly, their docs and their facilities are some of the best in the country, state of the art, and are making investments in our community. But, to me, it is unconscionable that somebody who lives two blocks away from what would be a world-renowned vision center in uptown Pittsburgh, that somebody two blocks away who has a Highmark card will be denied access to one of the most world-renowned vision centers that we are going to have with some of the leading researchers. That is unconscionable. We should not allow that to happen. People in this Chamber are preventing that from happening and that has to change.

I asked the question yesterday, what did you do when you had the opportunity to do something good for people? What did you do when you were in charge and you had the opportunity to make a difference? In this particular case, Mr. President, there is silence. There is silence out of the Committee on Banking and Insurance. I am very disappointed. After two letters asking for at least a consideration of either one of those pieces of legislation, I have not heard a word back. That is disappointing. That is how we are operating here. These are measures that impact the quality of lives of people across our Commonwealth with respect to the minimum wage and also in southwestern Pennsylvania today. It is coming to your neighborhoods, Mr. President, sooner than you realize. Until we get our arms around how we define public charities in this Commonwealth, this is going to be a problem for Pennsylvanians. We need to address it in this Chamber. We still have time to be able to do it before June 30. I am asking my colleagues to consider moving Senate Bill No. 310 and Senate Bill

No. 311 out of the Committee on Banking and Insurance, or, at minimum, asking them for an opportunity for a hearing or discussion along those lines to find out what we can do to be able to advance this measure.
