It is with great pleasure that we present the Pennsylvania Commission on Sentencing's *2018 Annual Report*. This year represents the Commission's 40th anniversary. Over the past decades, the Commission undertook work to meet many new legislative mandates, conducted research, evaluations, and analyses, incorporated evidence-based practices, responded to new initiatives, and collaborated with other criminal justice agencies to coordinate and improve the criminal justice system. The Commission is indebted to court officials and practitioners throughout the Commonwealth who contributed their efforts and to the many agencies at both the State and local levels who partner with the Commission.

In accordance with Act 15 of 2019, the structuring of the appointments of Commission members will change October 1, 2019. The mem-

bers of the Commission give of their time and energy, without any compensation, to work toward policies that are grounded in empirical data and evidence-based practices, and they are committed to transparency in the process, vigorous vetting of ideas, and accountability to the Commonwealth. Their hard work and dedication are greatly appreciated.

The *2018 Annual Report* details the work of the Commission and its staff during 2018 and provides a review of sentencing practices and aggregate statewide sentencing data during the same calendar year. A total of 131,002 offenses with corresponding sentences were reported to the Commission by the Courts of Common Pleas through February 2019, representing 91,249 criminal incidents. Sentences for 2018 reported after March 1, 2019 will be included in revised tables to be posted on the Commission's website in December 2019.

Over the past several years, the Commission worked on its numerous mandates. These efforts culminated in the adoption earlier this year of 7th Edition Amendment 5 Sentencing Guidelines, Resentencing Guidelines, and the Sentence Risk Assessment Instrument. They were each submitted to the General Assembly for a 90 day review period. Unless rejected by concurrent resolution, they will be effective in 2020.

As an agency of the General Assembly, the Pennsylvania Commission is charged with the responsibility of serving as a clearinghouse and information center for the collection, preparation, and dissemination of information on Commonwealth sentencing practices, and with assisting courts and agencies in the development, maintenance, and coordination of sound sentencing policies. We hope that the information contained in this report, as well as that available through our website (<http://pasentencing.us>) and from our staff, will be used to promote fairer and more uniform sentencing practices in the Commonwealth of Pennsylvania.

Under Section 1415 of the Public Utility Code, 66 Pa.C.S. § 1415, the Pennsylvania Public Utility Commission is required to submit a report every five years to the Governor, the Chief Clerk of the House of Representatives and the Secretary of the Senate reviewing the implementation of the Responsible Utility Customer Protection Act of 2004, which is codified in Chapter 14 of Title 66 of the Pennsylvania Consolidated Statutes. Initially, biennial reports were filed on or about December 14 of 2006, 2008, 2012, and 2014, with the 2010 report having been

granted an extension to January 14, 2011. In 2014, amendments to Chapter 14 changed the reporting requirement to every five years.

This first quinquennial report is due on December 22, 2019. By this letter, the Commission respectfully requests an extension until *January 31, 2020* to submit its report.

The Chapter 14 report is required to include a discussion of the degree to which the statutory requirements have been successfully implemented; the effect on the cash working capital or cash flow, uncollectible levels and collections of affected public utilities; the level of access to utility services by residential customers, including low-income customer; and the effect on the level of consumer complaints and mediations filed with and adjudicated by the Commission. As part of the report, the Commission may also propose any legislative or other changes which it deems necessary to the Governor and the General Assembly.

A draft of the Chapter 14 report is presently being prepared by Commission staff. Commissioners and staff desire more time to thoroughly review and discuss its content, as significant time has elapsed since the previous report was published. Chapter 14 will expire on December 31, 2024, unless sooner reenacted. As the General Assembly continues its review of this law, the Commission would like to provide a more detailed analysis. This additional time would facilitate the comprehensive review needed, and we appreciate your favorable consideration. Please let us know if you need any additional information.

On behalf of the Tuition Account Program Advisory Board, I am pleased to present the annual report of the Pennsylvania 529 College and Career Savings Program (PA 529) for fiscal year 2018-19.

Since the program's beginning it has helped more than 130,905 students and paid more than \$3.7 billion in higher education expenses. 29,838 students used PA 529 accounts to pay \$440.7 million for their higher education this year alone.

PA 529 continues to excel by virtually any metric. The total accounts of both the Guaranteed Savings Plan (GSP) and the Investment Plan (IP) grew to 238,741, which is a 4.47% increase from last year. Total account owner contributions grew by 3.54% to \$588.2 million, bringing the total assets of PA 529 under management to \$5.2 billion, -- an increase of 9.6% from the previous year.

For the first time in the history of the program, the PA 529 IP was awarded the Morningstar Bronze Rating™. This rating puts the PA 529 IP in the "Top 529 College Savings Plans" and among the elite 30 "Best in Class" plans. This rating recognizes the hard work of Treasury over the past few years to improve the IP through age-based investment options, portfolio diversification, fee reductions, and overall better oversight of the plan. This designation will help us continue to make improvements that will help Pennsylvania families save for higher education costs.

The IP was also able to lower fees again for account owners. The reduction of 0.01% was a result of an increase in assets under management. Treasury anticipates further reductions as assets continue to grow and meet new thresholds. This new reduction will save families approximately \$310,000 across the IP.

For the seventh consecutive year, the PA 529 GSP is more than fully funded, at 127.35%. Recently, the actuarial assumed rate of return was reduced to 5.5% from 6%. This rate reduction allows more assets to be allocated with lower-risk investments and the ability to manage the plan more prudently.

While the PA 529 program continues to grow, the addition of Keystone Scholars is making a significant impact across the Commonwealth, and helping families start saving as early as possible. The program, which offers a \$100 starter deposit into a PA 529 GSP account for every baby born or adopted by a Pennsylvania family, started statewide in 2019, following the passage of legislation in 2018.

Keystone Scholars started in 2018 with a demonstration project in six counties. Researchers have helped us conclude that the availability of Keystone Scholars has a positive impact on families opening PA 529 accounts during the first year of their child's life. Families in pilot counties were twice as likely to open a PA 529 account during their child's first year than those in other counties--this was true across all demographics.

This promising finding shows the power of Keystone Scholars and the impact it can have on every new Pennsylvanian. The program helps jump-start savings for every child without using any taxpayer funds. Keystone Scholars is funded by existing earnings dollars by the GSP and philanthropic donations.

We are excited by these accomplishments, but even more so by the bright future for the PA 529 College and Career Savings Program. Helping families save for postsecondary education is important not only for their individual goals, but for the well-being of the Commonwealth's economy, workforce, and next generation.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from York, Senator Phillips-Hill.

Senator PHILLIPS-HILL. Mr. President, I rise in support of Senate Resolution No. 153. This week, and seemingly almost every week, we see partisan gridlock at our nation's Capitol. However, out of all the news coming out of Washington, D.C., this week it appears a bipartisan deal has been reached on the United States-Mexico-Canada Agreement, otherwise known as USMCA. Earlier this year I met with Vice President Mike Pence in York County, where he advocated for the passage of USMCA. Canada is our nation's largest export market at \$320 billion a year. While the United States is Canada's largest export market at \$308 billion as of 2017, this trade supports 9 million jobs in the United States and 2.1 million jobs in Canada. In fact, Canada and Mexico are the first-ranked and third-ranked markets, respectively, for agricultural exports from the United States of an estimated \$20.6 billion sent to Canada and \$18.6 billion sent to Mexico, up from \$8.7 billion in 1992, the year that NAFTA was signed. The USMCA makes a number of significant upgrades to NAFTA's environmental and labor provisions. It incorporates them into the core of the agreement and makes them fully enforceable, which will help level the playing field for U.S. workers and businesses. It will also dramatically enhance intellectual property protections, which drive innovation and economic growth.

Passage of this resolution today tells our counterparts in Washington, D.C., that we support their bipartisan consensus to protect American jobs and move our trade agreement with our neighbors into the 21st century.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, I move that the Senate do concur in the amendments made by the House to Senate Bill No. 501.

On the question,

Will the Senate agree to the motion?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Philadelphia, Senator Anthony Williams.

Senator A.H. WILLIAMS. Mr. President, is it appropriate to begin the process of interrogation of the maker of the bill?

The PRESIDENT pro tempore. Senator Anthony Williams requests interrogation of the maker of the bill. Will the maker of the bill stand for interrogation? The Senator does so indicate he will stand for interrogation. The gentleman from Philadelphia may proceed.

Senator A.H. WILLIAMS. Mr. President, you do a fabulous job as a part-time employee. I want you to know that.

The PRESIDENT pro tempore. Thank you very much.

Senator A.H. WILLIAMS. Mr. President, the issue for me is that, for those of us who are struggling with supporting the bill, a large part of this, it is a really tremendous gift to Pennsylvanians, especially those of us who have worked on these issues of reform for a long time. So I want you the Members to understand that, and I want those watching to understand that. That said, the bill was amended in the House and it introduced a portion that deals with mandatory minimums. So the first obvious question is, does the maker of the bill support mandatory minimums?

Senator KILLION. Mr. President, as the gentleman has said, we know what the intent of this bill is, it is to streamline the parole process for nonviolent offenders and help people to get into drug treatment programs. As was mentioned, it was amended in the House to provide a minimum mandatory, but that minimum mandatory deals with child sexual offenders, and the minimum mandatory is actually less than what the current courts are sentencing at 11 years. So, it is actually less than that, and because of that I do not oppose that amendment because it does not affect the underlying intent of the bill which would result in, over the next 5 years, up to 600 inmates being released from prison, at a savings of \$45 million. There is no fiscal impact of that, and it deals with child sexual offenders. Although the bill, we are moving away from minimum mandatories, that minimum mandatory I am not opposed to.

Senator A.H. WILLIAMS. Mr. President, I appreciate that, but as I read this, certainly those of us who would have concerns about mandatory minimums would be supportive of directing it toward sexual predators. But as I read the amendment, it does not only deal with sexual predators, it deals with murder, aggravated assault, rape, and several other categories. Is that accurate, Mr. President?

Senator KILLION. Mr. President, all those are charges against children. Those crimes you have mentioned are against children in the amendment, but now are part of the bill.

Senator A.H. WILLIAMS. Mr. President, for the benefit of those listening, is it not also true though that while it is a charge that begins the process, in fact, it ends up affecting the adult population as well?

Senator KILLION. Mr. President, could you repeat the question?

Senator A.H. WILLIAMS. Mr. President, the victim may be, in fact, a minor, but under many of these charges, and we can go into some of those, it will trigger an adult charge. You are a minor and you will be charged as an adult. There are no mandatory minimums for a 16-year-old charged with murder, robbery, or aggravated assault. There cannot be.

Senator KILLION. Mr. President, as I said, the intent of the bill was cost savings. We do not necessarily support minimum mandatories, but it is all part of negotiations. The House put this in. It does not affect the real crux of the bill, and that is the savings that will occur by getting folks out who should not be in jail, nonviolent offenders. The House apparently felt that they needed to make a statement about adults who offend against children and they put the amendment in, it was part of the process, it is in the bill. I encourage the Members to vote for the bill so we can get it to the Governor's desk and realize these savings that I just talked about, close to \$45 million that we can put into programs helping those who have offended and get back into society.

Senator A.H. WILLIAMS. Mr. President, for the benefit of time, I would appreciate just directing the answers at the questions that are asked. I did not ask about the fiscal impact, I did not ask about the sexual predator part. What I specifically asked was a question that was not answered, and that was, it was framed as a consequence to children, sexual predators specifically. We are now clear to beyond just those who are sexual predators and we outlined those charges. You agreed to that. Now I am asking a secondary question; that is, does that process trigger an adult charge, potentially, in terms of this amendment?

Senator KILLION. Mr. President, my understanding is it would trigger an adult charge if that adult committed any of those offenses against a child.

Senator A.H. WILLIAMS. Mr. President, my apologies. I did not hear the last part of the answer. I am sorry.

Senator KILLION. Mr. President, my understanding of the amendment that was added to the bill is that those additional charges that you mentioned, murder, et cetera, are charges that could be applied to an adult when committed against a child.

Senator A.H. WILLIAMS. Mr. President, so you do not understand it that a minor at the age--

Senator KILLION. Mr. President, I am hearing that maybe you are asking if a minor commits the crime?

Senator A.H. WILLIAMS. Mr. President, if a juvenile commits a crime that you are classifying in this category, in order to have the mandatory applied, they will be charged as an adult.

Senator KILLION. Mr. President, that is a decision that is made by prosecutors every day when they look at crimes that are egregious and they charge juveniles as adults. That happens every single day, and that is nothing different with this other than, as I mentioned earlier, a minimum mandatory which, in fact, in most of the cases is actually less than what current courts are giving out now, so it is actually below that. So, again, it was a process of negotiation. It was not in the bill that we passed unanimously and sent over to the House. They amended it. Our goal is to get this on the Governor's desk and realize the savings and continue the process that was started under Senator Greenleaf of reforming our criminal justice system.

Senator A.H. WILLIAMS. Mr. President, and mine is to make sure people know what they are voting for and what people are receiving. You mentioned the word "egregious." A 16-year-old playing in a football game gets into a fight on the field. He picks up a helmet, he hits the other juvenile with the helmet. In Pennsylvania, he can be, and has been, charged with aggravated assault. Aggravated assault is one of these areas that the mandatory minimums would be applied to. Is it your intention for a 16-year-old in the throes of emotion, takes his helmet, slams it into another child, and I guess under your words, egregious, should be charged as an adult and then find himself in front of a judge using the requirement of the mandatory minimums?

Senator KILLION. Mr. President, the bill, as amended, does not trigger an automatic charge as an adult. Again, it would be up to the prosecutor and them looking at the situation if it was egregious enough to charge that juvenile as an adult. The bill does not mandate that. The bill simply says that there is a mandatory minimum if, in fact, the prosecutor decides to prosecute them as an adult. It is not required.

Senator A.H. WILLIAMS. Well, Mr. President, it is never required. As a matter of fact, in Pennsylvania, nothing is required. A DA could never charge anybody if they choose to. You could shoot somebody in cold blood in the middle of Broad Street in Philadelphia, as it has been said by somebody else in higher office, and not be charged because the DA chooses not to prosecute you. So, we are clear about that. The question is, if the DA chooses to use that and charge, that 16-year-old would then be triggered to be charged and the consequence would be an adult for the mandatory minimum.

Senator KILLION. Mr. President, I believe I have answered the question. It is a decision that is made by the prosecutor. It is not mandated in the bill. Again, the purpose of the underlying bill is to realize \$45 million in savings and get folks out of our jails who do not need to be in our jails, to get people with drug addiction problems in treatment. This is part of the negotiations. I hope that my Members vote "yes." Thank you.

Senator A.H. WILLIAMS. Mr. President, I take that as a "yes."

The other part I would ask is the example of rape, which is an egregious crime. A 20-year-old in college dates a 16-year-old senior in high school, has consensual sex, and under this particular mandate, that 20-year-old could, I guess, if the prosecutor chooses to--

POINT OF ORDER

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Centre, Senator Corman to state his point.

Senator CORMAN. Mr. President, I do not mean to interrupt, it is an important point. I want to let him know that I think Senator Killion has decided to end interrogation. He is certainly more than welcome to speak to the bill as he so chooses, but I want to make sure he knew the interrogation has concluded.

The PRESIDENT pro tempore. The Senator points out that the interrogation has ended, and the Senator is free to speak on the bill.

Senator A.H. WILLIAMS. Mr. President, I kind of figured it had ended when he left the mic in that regard. So, I will speak on it.

I will tell you that I have spent a lot of years here in public service hoping for a moment where those of us who consider ourselves Democrat or Republican, conservative, moderate, or progressive could join around issues reforming a system that has long been outdated and, frankly, oppressive in that regard. I think that this particular bill does go a long way in regard to that. That said, the conversation around negotiations become significant in this building and should become more significant in public arenas. Increasingly, the public is concerned about what those negotiations are, what we will compromise away, and what we will deal away. In this case of mandatory minimums, a bridge we have long crossed and discovered is, whether you are a conservative, or a moderate, or a progressive, we have long discovered that mandatory minimums, and I was in the Special Session when we had it under a Governor whom I particularly enjoyed working with, Tom Ridge, we discovered that they did not work, and, in fact, turned back the clock and hurt a lot of people. So, we as a Commonwealth, collectively, decided to move forward and remove that oppressive process from how we operate in Pennsylvania. While I appreciate the manner in which the gentleman described this is targeted toward a certain population of sexual offenders, it is not. It is unfortunate that we are representing it as such, but it is inappropriate to represent that it is limited in that regard. It is not in that regard and should not be represented as such. It is a series of charges that quote, unquote, as my colleagues said that a potential DA can use, but more importantly, as a potential person could use.

The example I was getting ready to outline is that of a 20-year-old in college who has a girlfriend who is 16 in high school, a senior getting ready to graduate, they are in the throes of love, which we would describe as puppy love, but, nonetheless, they decide to have a consensual relationship. The parent of that child, son or daughter, or vice-versa, is not happy about that relationship and quote, unquote, knows that DA in that town. It should not shock anybody in this General Assembly, or in this Senate, or anybody watching us that that parent may know somebody in a position of authority and power and decide to charge that young person, of which they would have to defend themselves and if found guilty, they will, for a long time, be described as a sexual predator. It is not the intent of us to do harm to the innocent by doing good to the many. The mandatory minimums that are amended into this bill, which was not introduced by the original author of the bill, is a deterrent to those of us who would support the overwhelming majority of issues in this bill. It is simply insulting to suggest though that it is narrow in scope and, therefore, has no consequence. I believe others on my side of the aisle will testify to that or speak to that as an issue. So, for those reasons, unfortunately, Mr. President, I have to stand in opposition to this bill and ask the Members to vote "no."

Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, first of all, not to make light of this very serious subject, because the Senator brings up very important issues, I want the body to know I am for a mandatory minimum for any Cleveland Browns defensive end who would swing a helmet at a Pittsburgh Steelers quarterback.

But in all seriousness, because it is a very serious subject, everything in this building is done in negotiations. Negotiation means you give a little, you get a little. We have done great bipartisan work in this Chamber for years now in working on justice reinvestment. Senator Greenleaf, a former Senator from Montgomery County, really began that charge for us all and educated us all in the importance. I think we have made great strides in that area to the point where in the late 2000s, our prisons were growing 1,500 new prisoners a year, which essentially is building a new prison every year. I think our collective correctional approach was a failure. Now we are at least at a point of flat growth in our correctional institutions. I would still like it to get better, continue to improve upon that, but we have made great strides from sort of the lock-them-up-and-throw-away-the-key attitude that we had back in the 1990s.

This bill was an important bill. We liked it the way it was. It was voted out of here near unanimously. Our friends on the other side of the Capitol like mandatory minimums in a lot of areas. When they put this in, you have to make a decision, is this enough to kill the bill, or is there enough good in this bill to accept this amendment, which is an important amendment that does fly into the face of some of the things we have been fighting for here. But when you look at its practicality, again, with the fact that in those particular cases, judges are sentencing without mandatory minimums at a much higher rate than what the mandatory minimum is, I think it is something that you agree to get the greater good done. I share the concerns of the gentleman from Philadelphia. I think a lot of us do. But in the greater scheme of things, we think this bill, as is, is worth passing.

So, with all of that together, and understanding the negotiations of the building, and the Governor is willing to sign it, we think it is worth getting completed here today, notwithstanding the gentleman's very legitimate concerns.

Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, I rise to express concerns about the bill, as amended. One, I concur with the Majority Leader, we have done a lot of good things in the space of criminal justice reform in this Chamber, and certainly the bill as originally crafted was a piece of legislation that I wholeheartedly supported. But there are changes in addition to those changes that my colleagues have already talked about around mandatory minimums. There are changes around increasing the number of folks who would be subject to supervision after leaving prison that are disturbing. Pennsylvania is known for having more folks per capita under supervision than quite possibly any State in the country. Moreover, the use of technical violations because of extended periods of supervision in Pennsylvania has been cited by both conservative organizations, like Americans for Prosperity, and more progressive organizations, like the American Civil

Liberties Union, as one of the factors that is most problematic in our reducing the costs associated with our prison population.

The reality is that the provisions of extending a year of government mandated supervision for all parties who are given a sentence of 4 years or more is unnecessary. It stacks additional supervision on top of what judges have already required without regard to what judges have required, and it further exacerbates the situation. Moreover, estimates from the Department of Corrections are that there are an additional \$6 million a year in costs associated with that provision alone. So in addition to all of the problems of the mandatory minimums, there is an additional problem that it runs counter to our reducing our costs in that the provisions of extending supervision will make it more likely that people will be subject to technical violations, more likely that people will be returned to incarceration, more costly as we have to monitor those folks, and it is completely unnecessary.

So with those provisions, Mr. President, I have to urge a "no" vote on this bill, and regretfully so, given the fact that what this Chamber originally passed was really one of our finest moments of bipartisanship and moving the Commonwealth forward in a collective way.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise to concur in particular to the comments of my colleagues from Philadelphia, both Senator Anthony Williams and Senator Street. I think they articulated, and Senator Corman as well, the good work that we have done in this Chamber in terms of advancing many of these measures.

It was referenced earlier about supporting mandatory minimums, and the indication I got from the other side of the aisle was that they do not necessarily support them. While we allowed the House on that side to be able to bring that conversation into this side of the building, I do not necessarily agree that that is something we should simply be doing just because they put it in the bill, and, more importantly, the Governor has agreed to sign it.

As I understand it, Senate Bill No. 501 is part of a package of bills: Senate Bill No. 500, that we just passed, but also we are still waiting for Senate Bill No. 502 that this Chamber passed I believe probably unanimously, or near unanimously, over to the House, and we are waiting for that bill to come forward, back to us after being passed there. That is what is going to complete the process with respect to the goal we are trying to achieve with the various bills that were put together as part of this package. My suggestion is, and I go back to looking at the role that mandatory minimums have played in this Chamber. It was referenced earlier the good work that Senator Greenleaf did in that space, and I served with Senator Greenleaf for about 8 years as chairman of the Committee on Judiciary for the Democrats. I will tell you, just about every single measure that came over from the House to the Committee on Judiciary, we, in a bipartisan way, working together, stripped those measures out of the measures that came to this Senate floor, and we did not deal with those things. More importantly, the work done by our Pennsylvania Commission on Sentencing, they indicated to us a few years back that they simply do not work and they should not be part of our sentencing structure along those lines.

So, I am not quite sure why it is that we feel the need today to advance these measures, given that Senate Bill No. 502 is still

not there and that we have not completed the process with all of those. To that end, Mr. President, I respectfully move that we table this measure for today and allow it the opportunity to have further conversations and further discussions as it relates to being able to manage a more appropriate way in which we can address the significant concerns that have been raised by my colleagues, particularly my colleagues from Philadelphia.

While there are many measures that are very important in part of this whole process and is indicative of the good work that we tried to do here when this measure passed unanimously many months ago, when Senate Bill No. 501 passed here. It has been changed considerably, and we should not be adopting those changes simply because the House sent them to us without having further conversations about how we can mitigate some of the harm and some of the damages that could occur, given some of the statements that my colleagues have made and some of the examples that they have provided.

Senator COSTA. Mr. President, so, to that end, I respectfully ask that we table this measure until a later point in time when we have an opportunity to discuss and figure out how we can mitigate some of the concerns that were raised.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, I have the benefit of having the luxury of serving in this great body under the leadership of

former Governor Tom Ridge. In his leadership in the Commonwealth he provided and asked for, and this body, the General Assembly, granted him a Special Session on crime and how to address criminal justice matters in that time period. I can tell you, Mr. President, that the explosion in our criminal justice system, both in terms of the number of individuals who are incarcerated and the amount of money that has been spent over the decades, the past several decades, largely comes, is largely driven out of that period, that Special Session on crime.

Many of us, those who spoke on the floor at that time, were very clear in our opposition that the ideas that were being advanced would not help, they would only hurt. We have come to find out 24 to 25 years later that the predictions that were made were true, and, in fact, in the last year or 2 we have begun a process to try to reverse, as I think the Leader has indicated, to reverse and change course on some of the decisions that were made during that time period. In fact, our former colleague, the former chair of the Committee on Judiciary, was very public about the mistakes that were made and, in fact, spent a significant portion of the last year or so of his tenure as a Senator traveling around the Commonwealth of Pennsylvania speaking to broad communities of all types - urban, rural, suburban - all corners of the Commonwealth of Pennsylvania, and basically saying that the things that were done in the past were wrong, did not work, and, in fact, publicly apologized for those decisions, those votes, that direction that the State had taken.

I raise that, Mr. President, because the benefit is here in the history. Benefit is in having the luxury of remembering what was done, what was said, and in this particular bill on this particular matter, Mr. President, we all need to be reminded that the conversation about increased mandatory minimum sentences, three strikes and you are out, in that litany of language supported by a litany of legislation that became law, has led us to the point that we are in right now, a need to reverse the decisions that were made some 20-odd years ago. So, when the gentleman speaks about advancing mandatory minimum sentences, we need to be very thoughtful, Mr. President, even in the context of a piece of legislation that might have some good qualities to it, which we appreciate and we thank. But even in that context, we must always be mindful of, as we know in our language, the slippery slope. That we begin a process of repeating, going down the slippery slope that repeats the measures that were taken decades ago that have proven to be unsuccessful in addressing the issues of crime and, in fact, have proven to create an environment where criminal justice reform needs to flourish and has begun flourishing in a bipartisan fashion not just here in this building, but, in fact, believe it or not, even in Washington, D.C.

So, Mr. President, I raise that history just to make sure that folks are conscious of the fact that it was the whole idea of increasing mandatory minimum sentences, it was the whole idea of, as I said earlier, three strikes and you are out and punitive legislation like that that created the environment that we are in right now: exploding our corrections budget, exploding tremendous failures of justice for individuals all across the State of Pennsylvania, of all colors and from all communities. We need to be mindful that we not repeat the failures of the past and again go down that slippery slope, which we have publicly apologized for in the last couple of years; at least the gentleman who is no longer a Member of this body had done so when he was chair of the Committee on Judiciary.

Mr. President, I rise in opposition, but my opposition comes from having the benefit of a history that saw what was done to create the moment that we are in right now. While we try to work hard to retreat from that, we need to be very careful that we do not upend that retreat and start back down the path of some very negative consequences for this State and for the individuals who seek justice on a daily basis.

We ask that the members of our communities be aware of those kids who may be struggling and remember that homelessness does not necessarily mean living on the streets. It can be that child who always seems to want to spend the night with friends, the family who has recently lost work and has moved to a motel, the LGBTQ youth who has come out and now has nowhere to go. We as a community come together today to wear red as a symbol of our willingness to help, to say to any youth that is struggling that they are valued and that we are here to help.

I want to thank Representative Donna Bullock for partnering with me to introduce a companion resolution in the House and hosting a press conference to discuss the issue of student homelessness yesterday. We heard some inspiring stories of students overcoming great odds. Many times it was thanks to a caring teacher or family member. On that note, I would like to thank Sonia Pitzzi, director of education for children and youth experiencing homelessness at Lincoln Intermediate Unit 12 in York County, for speaking at yesterday's press conference for everything she does to keep kids in school and in safe places.

Senator MARTIN. Mr. President, I offer this resolution to honor and congratulate the Pennsylvania State University 2019 wrestling team on its eighth NCAA Division I National Wrestling Team Championship in the past 9 years and their ninth championship overall. This is the fourth consecutive national title for the team under the leadership of head coach Cael Sanderson, who has coached 23 national champions, including repeat champions since the start of his tenure. Coach Sanderson was also the recipient of the 2019 Big Ten Coach of the Year award. A number of Penn State wrestlers earned prestigious awards, including four time All-Americans Jason Nolf and Bo Nickal, who each won their third consecutive NCAA wrestling titles, making them the third and fourth three-time champions in the school's history and co-recipients of the Big Ten Wrestler of the Year award. Nolf set a school record of 60 pins, while Nickal went on to receive several other top wrestling awards, including the 2019 Hodge Award as the top collegiate wrestler in the country.

Another dominant wrestler was All-American Anthony Cassar, who impressed everyone when he moved up to the heavyweight division at the beginning of the season and ended up winning the national championship. Wrestlers Vincenzo Joseph and Mark Hall, both three time All-Americans, ended up placing second in their respective divisions and joined the seven total All-Americans on a team that was awarded the NCAA Public Recognition Award for posting elite scores in the academic progress-rate compilation for the fifth consecutive year.

PETITIONS AND REMONSTRANCES

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Mr. President, long before becoming chair of the Committee on Judiciary earlier this year, I received valuable insight into the significance of our courts and the qualities of highly regarded jurists. First, when I was working for Senator Bob Jubelirer, whose father was an outstanding judge in Blair County; my time serving with Senator Charles Lemmond, who served on the Luzerne County bench before becoming a respected State Senator; and working extensively over the years with some of the finest judges during the reform push to fix juvenile justice after the fallout from the Kids for Cash scandal. So, I have been fortunate to gain extensive understanding into the qualifications and capabilities of judges. So, it is through this lens and experience that I supported, earlier today, the confirmation of Drew Crompton. There was probably no other Member in this Caucus who has gone back and forth with Drew on provisions or implications of major legislation than I have. While we may have a disagreement from time to time, I can tell you that I have never doubted his qualifications, his credentials, or his integrity. I have respected his legal skills, his strength of argument, his ability to assist us in creating solutions, and his commitment in all of those years for responsible public service.

There is no better way for his record than for us to examine it. We did that earlier today in the hearing of the Committee on Judiciary, where he offered remarks, was asked questions, and did so all on the record, and answered them very, very well. He received a vote of favorable recommendation from the committee. We have seen Drew's capabilities as practiced and demonstrated over 26 years. This is not the case when we have to look at credentials on a piece of paper and make educated guesses or reviews of someone's ability or ethics. These have been proven during Drew Crompton's service. That is why it is so disappointing for me to see innuendo carelessly thrown around about an effort to block his confirmation, which was not successful. We have a good, solid, extensive, factual record on which all of us based our vote. In my view, Drew was nominated to the one court where his knowledge, skills, and experience are readily transferable. As one of Pennsylvania's two intermediate appellate courts, it hears appeals and final orders of State agencies and cases from courts of common pleas on public sector legal questions and regulations. So, I believe his knowledge and skills fit that the best.

One of the most important roles played by the Commonwealth Court is determining how legislative intent fits with the dispute before the court. Drew, in my judgment, has earned a doctorate in legislative construction, and he has defended his work during litigation that has become an inevitable last step in the legislative process. The perspective that Drew Crompton brings will strengthen the court, not diminish it. We must also consider the high standards held by judges he will be joining. The idea that he would take the oath and immediately sway judges to his point of view is an insult to their character and their deliberative ability. Every judge finds cases that challenge their long-held perceptions, and Drew will be no different on that score. His wealth of knowledge on which to draw to make necessary distinctions is unique.

I understand the concerns expressed by those who do not care for our method of filling judicial vacancies, but such an argument is not just applicable to one vacancy, or one nominee, or one administration. The quarrel is with the State Constitution and the traditions built and practiced by both parties for decades. Going back decades across administrations, governors have employed a screening process for evaluating potential nominees. Rejecting our nominee, Drew Crompton, would not have changed that process.

This is not the first instance where a senior legislative attorney has been elevated to a higher position. Consider the case of Gladys Brown Dutrieuille, who chairs the Public Utility Commission, where she has earned praise for intelligence, demeanor, even-handed performance. Why would we place so much trust and responsibility in the hands of valued members of our Senate team, valued members of our staff when they work for us, but then contend they are unqualified to do anything else? Such a contradiction makes absolutely no sense. The nomination and the confirmation process sifts through the prospects and provides us with individuals to consider. Drew Crompton is a talented, publicly spirited individual with credentials that align well to the position for which he was nominated and thus confirmed. I believe his potential is to make crucial, valuable, and significant contributions to the Commonwealth Court, and that is why I supported his confirmation earlier today.

Senator COSTA. Mr. President, on behalf of Senator Tartaglione, I submit comments for the record as it relates to the minimum wage for Petitions and Remonstrances. Thank you.

The PRESIDENT pro tempore. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentleman from Allegheny, Senator COSTA on behalf of the gentlewoman from Philadelphia, Senator TARTAGLIONE:)

Mr. President, today marks 4,910 days since the Pennsylvania legislature last raised the minimum wage. That is more than 13 years, and it is far too long.

Four weeks ago, just before the Thanksgiving holiday, the Members of this Chamber voted overwhelmingly and with strong bipartisan support to adopt Senate Bill No. 79, legislation that would raise Pennsylvania's minimum wage by more than \$2. As I stated at that time, the version of the legislation that we adopted has many deficiencies. In my

view, it does not go far enough to ensure fair, family-sustaining wages for all Pennsylvanians. Yet, it was a welcome first step toward our goals and a shining example of the potential for true collaboration and compromise across the aisle within this distinguished body. More than that, Senate Bill No. 79 had the potential to deliver some much-needed financial relief to Pennsylvania's long-suffering low-wage workers just in time for the holidays. But certain forces within this venerable Capitol have contrived to undermine our noble efforts.

To say that the leadership of the House has been indifferent toward Senate Bill No. 79 would be a misnomer. Their silence on the bill speaks volumes about their commitment to fairness and to the working families of this Commonwealth. After all, it is not the moms and dads, the working teenagers, or the grandparents and senior citizens of Pennsylvania who oppose a \$9.50 minimum wage. It is not the labor community or even the many employers who already pay above that rate and who know that a healthy middle class is good for business and good for the economy. We know this because time after time, when researchers ask Pennsylvanians how they feel about raising the minimum wage, the answer is a resounding "yes." Therefore, those who refuse to acknowledge Senate Bill No. 79 or to allow a public hearing or a public debate on the issue are not engaged in the people's business. Rather, they speak for the special interests, the elite, those who measure prosperity by the success of the Fortune 500, and not the satisfaction of the multitudes.

Mr. President, in this, the season of giving, I encourage all Members of this General Assembly to remain ever mindful of the condition of low-wage Pennsylvanians and to redouble our efforts to ensure the financial security that they have worked so long and hard to earn.
