Senator LANGERHOLC. Mr. President, I rise to ask for an affirmative vote for Senate Bill No. 850. Senate Bill No. 850 establishes a new article in the Public School Code by establishing the community-engaged schools for success pilot program to

encourage community engagement with community partners in the provision of student support services which remove academic and non-academic barriers to a student's success. This includes eligible schools which are ranked in the lowest 15 percent of combined math and reading scores and located in areas with poverty greater than 30 percent. Those schools that were deemed eligible would then submit a community engagement plan to the department for review, including a list of student support services. These services are things such as behavior intervention, mental health, healthcare, and dental services, to name a few. Those schools would then be eligible for up to \$125,000 under this grant program. You may be surprised to learn that dental pain, as well as toothache, is a major reason for missing school, and these schools will now be able to avail themselves within the school district to help these students continue their academic success. A school within my district, the 35th Senatorial District, Greater Johnstown School District, actually benefits from a similar program within this Commonwealth. I also thank my counterpart on the Senate Committee on Education, Senator Dinniman, for his diligent work on behalf of this legislation. I ask for an affirmative vote.

The PRESIDENT. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Mr. President, I rise in support of House Bill No. 1001, which will now regulate milk banks here in the Commonwealth of Pennsylvania. This measure is rooted in both pediatric health science and common sense. My perspective is not just one as a legislator interested in health issues, I was a premature baby, and at that time, I could not be nourished with mother's milk. I also could not tolerate the formula they supplemented, and, as a result, experienced complications common in pre-term babies. Fast forward to today and what we know about mother's milk and its fundamental role in the survival and development of preemies. Exclusive human milk gives vulnerable infants the best chance to be healthy. There is no disputing the valuable and indispensable work of milk banks in collecting this incredible life-enhancing resource from donors. The milk is used in neonatal units and given to babies with medical issues who have been able to go home. These are medically fragile, very at-risk infants. Many NICU moms often have difficulty providing all the supplemental nutrition their babies need, so this donated milk is truly a godsend.

This is all really incredible and good; however, as the practice of milk banking is expanding, there are safety and ethical concerns being raised in the absence of regulation. Quality control matters, compassion, and understanding for donors matters. Whenever there is a growing demand for a product, dishonest individuals can surface. Because of the stakes involved, the activity cannot be self-policed. We have shared interest in and a duty to promote a safe, stable supply of human milk and milk products. On the necessity of the State stepping in with standards of a long regulation of practice, it is important to note that we are acting in conjunction with responsible entities running milk banks, both here in the Commonwealth and across the country. We have all received compelling correspondence attesting to this. This is not big government just intruding into another private activity. This measure truly represents important compromises that were agreed to during the legislative process and contain vital components carefully crafted in Senate Bill No. 811, and my work on this effort along with my colleague, Senator Schwank.

We are grateful for the assistance of milk banks and their advocacy. Those include Keystone Mothers' Milk Bank, Prolacta Bioscience, and the National Coalition of Infant Health. I also take a moment to acknowledge the work of our chair of the Committee on Health and Human Services, Senator Brooks, her staff, and the maker of the bill on the House side, Representative Oberlander. When this measure becomes law, Pennsylvania will be at the forefront of States regulating and insuring the safety of milk banks.

I urge an affirmative vote. Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, I join my colleague, Senator Baker, in urging our colleagues throughout the Senate to support this legislation. I thank Representative Oberlander as well, and I know that Senator Baker helped prepare amendments that made this legislation even stronger. Focus again on the common sense. We understand so much better how important mother's milk is to the health of all infants, but particularly those who are medically fragile. The opportunity to have mother's

milk, and in the case where a mother may not be able to produce the milk herself, it is essential that we have some resource to provide that. So under this legislation, we can help allay the fears of a new mother and her family and help improve the health of medically fragile infants by assuring them that the milk that they will be receiving will have been screened, collected, stored, and processed in a way that is very safe. So I am very pleased to add Pennsylvania to the States that are starting to approve this type of legislation, and I am thankful, certainly, to hopefully see it pass. Thank you.

BILL ON THIRD CONSIDERATION
AND FINAL PASSAGE

HB 1100 (Pr. No. 3259) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, providing for energy and fertilizer manufacturing tax credit.

Considered the third time and agreed to,
And the amendments made thereto having been printed as required by the Constitution,

On the question,
Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Luzerne, Senator Yudichak.

Senator YUDICHAK. Mr. President, I respectfully ask my Senate colleagues for an affirmative vote on House Bill No. 1100, bipartisan legislation that would establish the energy and fertilizer manufacturing tax credit program here in Pennsylvania. The tax credit is designed to promote the creation of thousands of prevailing-wage construction jobs and will support the development of a robust petrochemical manufacturing industry in Pennsylvania. The tax credit is modeled after the Pennsylvania resource manufacturing tax credit program that helped secure the \$6 billion Shell cracker plant in Beaver County. I should note that the Shell cracker tax credit passed this body 48-1, but there are two significant differences from the Shell tax credit and the tax credit that is before us today in House Bill No. 1100. For the first time in Pennsylvania history, this tax credit will guarantee that prevailing wage is paid and local labor will be used on these projects.

In his budget material today, the Governor called the Shell cracker plant an economic win for Pennsylvania. I agree with the Governor. It is a big economic win, and I believe the energy and fertilizer manufacturing tax credit will give the rest of Pennsylvania a shot at an economic win. Opponents of the bill have raised two main concerns. One, the tax credit may attract too many companies to Pennsylvania willing to invest a minimum of \$450 million and create over 800 prevailing-wage jobs. Is there such a thing as too much economic growth? How do you explain to the Pennsylvania building trades, who support House Bill No. 1100, that you want fewer prevailing-wage jobs in Pennsylvania? The second criticism is that there are no projects in the queue to warrant the passage of the tax credit at this time. If I may, let me reference a letter from the CEO of Ellis Energy who writes to the Governor today asking him to support the energy and fertilizer tax credit and stating emphatically that if the tax credit is available to his company, he will invest \$450 million to construct a manufacturing facility in northeastern Pennsylvania.

Again, I ask my colleagues for an affirmative vote on House Bill No. 1100, and let us give every region of Pennsylvania a chance at an economic win.
