AMENDMENTS AS AMENDED**

**SB 841 (Pr. No. 1623)** -- The Senate proceeded to consideration of the bill, entitled:

An Act amending Titles 35 (Health and Safety) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing for the Health Care Cost Containment Council, for its powers and duties, for health care cost containment through the collection and dissemination of data, for public accountability of health care costs and for health care for the indigent; providing for COVID-19 disaster emergency; in local organizations and services, further providing for general authority of political subdivisions; and, in Uniform Unsworn Foreign Declarations Act, further providing for heading of chapter, for short title of chapter, for definitions, for applicability and for form of unsworn declaration.

On the question,

Will the Senate concur in the amendments made by the House, as further amended by the Senate, to Senate Bill No. 841?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, I move that the Senate do concur in the amendments made by the House, as further amended by the Senate, to Senate Bill No. 841.

On the question,

Will the Senate agree to the motion?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lancaster, Senator Martin.

Senator MARTIN. Mr. President, Senate Bill No. 841 reauthorizes the Pennsylvania Health Care Cost Containment Council for 10 years. In addition, it requires a study of the impact

of COVID-19 on medical facilities within the Commonwealth. In addition, Senate Bill No. 841 will allow any municipality, including counties, to adopt a resolution to extend their discount period for property tax collection and/or waive any fees and penalties until the end of the year. It is completely optional, but they have to make the decision within 30 days of the bill being signed into law.

Next, Senate Bill No. 841 also expressly permits any local government or affiliated entity, like a zoning board or planning agency, to meet remotely via telecommunications, which requires a minimum of audio communication, without the need to have a quorum physically present. They just need to have a quorum of members participating on the actual telecommunications device. In addition, for permit applications and other related matters, there is a 30-day suspension of any required timeline for pending or new applications and appeals. Next, Senate Bill No. 841 extends the deadline and waives some of the requirements for the Educational Improvement Tax Credit Program. Finally, Senate Bill No. 841 adds e-notary services to become available and permitted in the Commonwealth. I urge my colleagues to please support the bill.

Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognize the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I thank the gentleman for providing the elements of the latest version of Senate Bill No. 841, and I would like to take a moment to thank my colleagues on both sides of the aisle. This is another example of where, during this crisis, we have worked together to compromise, understand, and work with the stakeholders to come to a place where we move legislation to allow us to be able to operate our local governments, and other folks as well, through this time as we go forward through this crisis. It is another example of our working together to address these issues, and I appreciate the work that has been done, largely by the staff of our respective Caucuses, and thank them for the work they have done to bring us to this point in time, and, hopefully, the House will concur in this measure very, very soon.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Montgomery, Senator Muth.

Senator MUTH. Mr. President, I submit my remarks for the record.

The PRESIDENT pro tempore. The remarks will be spread upon the record.

*(The following prepared remarks were made part of the record at the request of the gentlewoman from Montgomery, Senator MUTH:)*

Mr. President, today I submit the following remarks for the Journal regarding Senate Bill No. 841 and the COVID-19 pandemic. Today, the Senate voted unanimously for an important piece of legislation that empowers local governments, expands provisions for those workers contracted by school districts and provides for necessary extensions to ease the burden every Pennsylvanian is carrying during the COVID-19 pandemic.

This bill, in its current form, allows for school districts to renegotiate with contracted providers to make sure school contractors are paid during the period of school closures caused by the COVID-19 pandemic. It also allows for remote notarization abilities and for county and local governments to extend or delay the collection of certain property

taxes. These aspects of the bill are clearly aligned with the legislature's goal of keeping as many people employed as possible, allowing for an increase of various tele-work, and providing flexibility for local entities so that taxpayers aren't burdened more so than they already are.

In addition, I applaud the provisions in the bill that allows local governments to establish a virtual quorum, to maintain transparency through sunshining meetings five days in advance, and to extend time limits to review applications and plans. These important provisions will give local governments the ability to respond to the COVID-19 pandemic in a flexible manner. However, these measures are only the first of many steps that need to be taken in order to accommodate the needs of our local municipalities across the State. If the House concurs Senate Bill No. 841 in the form the Senate passed, then the day the Governor signs the bill, a 30-day clock begins for local governments before they will need to review applications and plans. That same 30-day clock cannot be applied to the COVID-19 pandemic. So I encourage my colleagues on both sides of the aisle to not forget that we must be sensitive to the COVID-19 mitigation needs, as they may fluctuate in the coming months. We must act legislatively to support our local governments as they are on the front lines supporting our local districts, constituents and industry. Furthermore, Mr. President, I think it is disgraceful for the Leadership in the Pennsylvania House of Representatives to not consider Senate Bill No. 841 today. As of today, it has been 32 days since the Governor declared a state of disaster/emergency. That means for 32 days our local governments have not had legal clarity on how they are able to operate and support their citizens during the COVID-19 pandemic. For the House to not consider this bill today, they leave local governments to continue facing legal questions with no legislative support or answers. Those questions and concerns will only get more complicated as time progresses, increasing wasted tax dollars on backtracking when we could have passed the solution they need today.

Every Member of the Pennsylvania General Assembly should be working together, in a collaborative and urgent manner, to protect our State and our constituents from further harm caused by this pandemic. Going home without passing a single bill that would provide any sort of relief during this public health crisis is simply unacceptable. The majority party in both chambers failed to use their legislative power to help so many people in need.

Senator MENSCH. Mr. President, I made a comment for which I would like to apologize. It was an offhanded comment to another person in the office. I cautioned everyone that the microphones were opened, I looked, I thought it was closed, but it was a personal comment, a personal observation, and I apologize. Thank you.

Senator CORMAN. Mr. President, as you can see, I am wearing a mask here today, under the guidance of the Governor and the Secretary of Health during this crisis, and I want to point out, of course, there is a little logo of my alma mater, Penn State, on the mask. It was actually made by Anita Powell, who is the mother of Ashley Albert, who works in my office, and Ruthann Shoenfelt, her aunt. They made over 150 masks to give to different people in the community. I know a lot of different members of our community are doing such a thing. Senator Scavello mentioned to me last night that his wife is making a bunch of masks that they are giving out to the community and his neighborhood, and it is another example of all of us pulling together during a very, very difficult time to try to help members of our communities. I thank Ms. Powell and Ms. Shoenfelt for their efforts. Go Penn State, and I appreciate their interest in keeping us all healthy.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, first, I acknowledge, again, that Senator Tartaglione would like to submit her comments for the record.

*(The following prepared remarks were made part of the record at the request of the gentleman from Allegheny, Senator COSTA, on behalf of the gentlewoman from Philadelphia, Senator TARTAGLIONE:)*

Mr. President, today marks 5,021 days since the Pennsylvania legislature last raised the minimum wage. That is more than 13 1/2 years, and it is far too long.

It has been barely one month since Governor Wolf made the difficult but necessary decision to declare a statewide emergency due to the coronavirus pandemic. This public health crisis has already had a devastating effect on Pennsylvania's workforce, particularly its low-wage workers.

More than 1.1 million Pennsylvanians have filed new unemployment claims since March 15. The Department of Labor and Industry has been working hard to make sure these displaced workers receive the benefits they deserve as soon as possible. We are all looking forward to the day when those folks can return to their jobs. But today, I would like to highlight the valuable contributions of a group of workers who are still on the job. These workers provide essential goods and services to the people of this Commonwealth. Tragically, many of them do not get paid like essential workers. I am referring to the workers who staff our grocery stores and restaurants, those who serve as vital links in our food distribution chain.

Mr. President, I have spent many years--decades, in fact--fighting to raise Pennsylvania's minimum wage to a family-sustaining level. Our current minimum wage, just \$7.25 an hour, is not a living wage. Opponents of the minimum wage do not even dispute that. Instead, opponents often argue that jobs such as grocery store clerks and fast food cashiers do not warrant \$15 an hour, or even \$12 an hour. They argue that these are "entry-level" jobs for people who lack the training or skills, or maybe even the motivation, to do better for themselves. I find this logic to be disrespectful and insulting, and so is our minimum wage.

Amid a public health emergency, when communities need them most, grocery store and food service workers are on the front lines. They are risking their own health to ensure that the job gets done. They do this because they want to provide for their families. And they do it because they are dedicated to their communities. Their work ethic is not limited to the current public health crisis. It is something they do week after week, month after month, and year after year. They are just like low-wage workers in many other industries. They deserve to make a living wage all the time, not just when there is a coronavirus pandemic. They deserve a raise in Pennsylvania's minimum wage. We in the General Assembly should grant it to them.

Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, secondly, I concur in the comments made by my colleague, the Majority Leader, Senator Corman, regarding thanking folks who are making masks. Now, while I am not wearing a University of Pittsburgh, or an IUP, or even a Community College of Allegheny County mask, I am proudly wearing one that was made by my wife, who has been home working and creating masks for the community. My hat is off certainly to her and so many other folks across our Commonwealth who are pitching in whatever way they can to be able to help all of us address this crisis as we move forward trying to combat this coronavirus. So thanks to all of those folks for what they are doing, all of those individuals who are working and trying to help our community, the businesses that are converting their equipment into other things going forward. All of those things are important to this cause.

So thank you, Mr. President, for the chance to be able to thank those folks.
