(b) Visitation.--Visitation by an essential family caregiver may be conducted through different means based on a facility's structure and

the needs of the residents, such as use of resident rooms, dedicated visitation spaces and the outdoors and visitation in circumstances beyond compassionate care situations. The following shall apply:

- (1) Except for on-going use of virtual visits, facilities may still restrict visitation by an essential family caregiver due to any of the following:
 - (i) A COVID-19 county positivity rate greater than 10% according to the United States Department of Health and Human Services Centers for Medicare and Medicaid Services.
 - (ii) The facility's COVID-19 status.
 - (iii) A resident's COVID-19 status.
 - (iv) Visitor symptoms.
- (2) Except as provided under paragraph (1), a facility may not restrict visitation by an essential family caregiver without a reasonable clinical or safety cause.
- (c) Essential family caregiver requirements.—The decision to designate an essential family caregiver may be individualized and integrated with resident-centered care planning. A visit shall be held outdoors whenever practicable. For inside visits, the following shall apply:
 - (1) Designation shall be by the facility executive director or equivalent position or designee, in consultation with the resident and the resident's representative, and only upon agreement by the resident and their representative.
 - (2) A schedule and the amount of time allowed in a facility by an essential family caregiver shall be agreed to prior to an essential family caregiver entering a facility and may not exceed more than two hours per day.
 - (3) Notwithstanding any other provision of law, visitation shall be contingent upon the facility having no new COVID-19 cases in the last 14 days. No facility may conduct visitation during the time period the facility is conducting outbreak testing.
 - (4) All who enter the facility must be screened for signs and symptoms of COVID-19 and the denial of entry of those with signs or symptoms must occur.
 - (5) Proper hand hygiene must be implemented.
 - (6) The wearing of a face covering or mask covering both the mouth and nose must be enforced.
 - (7) Physical distancing at least six feet between individuals shall be maintained by an essential family caregiver with staff and other residents while in the facility.
 - (8) An essential family caregiver shall provide care and support similar in nature as provided prior to the proclamation of disaster emergency issued by the Governor on March 6, 2020, published at 50 Pa.B. 1644 (March 21, 2020), and any renewal of the state of disaster emergency.
 - (9) An essential family caregiver shall adhere to any conditions specified by the facility.
 - (10) Restriction or revocation of essential family caregiver status shall be at the sole discretion of the facility executive director or equivalent position or designee.

On the question,

Will the Senate agree to the amendment?

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Mensch.

Senator MENSCH. Mr. President, recently, new guidelines issued by CMS require nursing homes to allow for visitation unless there is an outbreak or a case of COVID-19 in the facility. This is important because it basically was requiring facilities to allow for visitation, something our own Department of Health has not been doing. While this is a positive step in the right direction, the CMS guidelines only cover facilities regulated under the Department of Health. So, it does not cover assisted living facilities, retirement, or personal care homes. DOH, Department of Health, is quickly revising their guidelines to adhere to CMS guidelines, if they have not already. However, the other facilities under their jurisdiction are not subject to the same requirement

to allow for visitation. DHS has indicated that they want to revise their guidance to mirror DOH/CMS guidelines, but that is not out yet.

The amendment would make the bill only pertain to DHS-regulated facilities: personal care homes, assisted living facilities, and intermediate care facilities. The amendment also aligns the requirements in the bill to the current CMS guidelines for guidance for facilities under the direction of the Department of Health. The bill still would allow for long-term care facilities to designate one or more essential family caregivers, known also as an EFC, per resident. Any individual 18 years or older who has visited or had interactions, was regularly engaged with the resident at least once a week, such as a family member, can qualify as an EFC. The decision to designate an EFC should be individualized and integrated with the resident-centered care planning. A schedule and set amount of time allowed in the facility will be established and agreed to and may not exceed 2 hours per day. This gives the facility the ability to set schedules for residents and potentially stagger EFC times throughout the day so as to not completely flood the facility with outside visitors at certain periods of the day.

This bill represents the best effort to allow families to see their loved ones while still allowing facilities the flexibility to manage any potential outbreaks. All of our offices are hearing about this issue, and we are not trying to negate safety or go around any in-place protocols. Simply, we are trying to give facilities and families a clear picture of when and how they can visit or care for their loved ones. Families have been waiting for 8 months to see their loved ones, and continued interference by the departments will only drag that out further. Portrayals by DOH, DHS, and PDA that this bill would put facilities out of compliance with Federal regulations are simply not true. Not only does the amendment narrow the scope of the bill but, again, the language is tailored to conform with Federal CMS guidelines.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise to ask for a negative vote on this amendment. While I recognize that the amendment is well-intended, I think, as we all have begun to see earlier today, the Governor, along with the Secretary of Health, reminded and informed us that we are on an uptick with respect to COVID-19. As someone who saw firsthand the impact of what I will call isolation recently with a loved one in a facility, it was very difficult to watch. But it was more difficult to watch when I knew that folks were entering and exiting these facilities who were infected and causing even more difficulty for the administration. The Department of Health has indicated to us that they are not supportive of this amendment, and I do think, at this moment in time, it is not appropriate for us to pass this particular amendment. I ask for a negative vote. Thank you.

The facility must allow each resident to designate the resident's choice of one or more essential caregivers and a facility that utilizes care plans must use the person-centered service planning process to identify each resident's designated caregiver. The following shall apply:

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Muth.

Senator MUTH. Mr. President, as mentioned by the previous speaker, many of our constituents have been waiting for months to see their loved ones in long-term care facilities. This amendment was drafted using direct guidance and input from Community Legal Services and the Center for Advocacy for the Rights and Interests of the Elderly, as well as residents of long-term care facilities and nursing homes. This amendment does the following: it clarifies that a resident or a resident's responsible party is the person who selects who the essential caregiver is. Many LGBTO residents self-select their family, and their family may not fit the traditional definition found in the bill. Other residents may also not have family that meet the traditional definition or whose immediate families live too far away to meet this need. Adding this language will insure that all residents have access to an essential caregiver of their choice. It also adds in nieces and nephews as eligible people under the definition of "immediate family member."

It also requires that facilities follow necessary precautions outlined by both the Federal and State government. It also requires that facilities have visitors only when the facility has the capability to use rapid testing for all staff, visitors, and residents, and also provides adequate and consistent access to PPE for all staff and visitors. It also authorizes the department to limit essential caregivers if the facility is not yet in compliance with those safety measures. It requires the essential caregiver to comply with the facility's infection control and safety protocols. It also provides more flexibility around the time limitations to help meet identified needs of individual residents. These recommendations prioritize the residents' choices and needs while also highlighting explicit safety precautions that must take place for the essential caregiver program to work safely during this pandemic.

I ask for an affirmative vote on this amendment so families can see their loved ones in person instead of continuing this between-the-glass visitation.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Mensch.

Senator MENSCH. Mr. President, this bill, as amended, would already take into account some of what my colleague has described in her amendment. As this bill has been out of committee since September, there was ample time to work collaboratively, but this amendment would make Senate Bill No. 1279 confusing and redundant at the last minute. This amendment would require rapid testing. While these tests are not readily available and they can be very expensive, we prefer that the testing guidance be left up to department regulations and guidelines in order to stay current.

While I appreciate my colleague's willingness to put forth language to make this bill better and allow for families to see their loved ones, I must respectfully ask for a "no" vote. Thank you.

Senator GORDNER. Mr. President, I offer remarks on behalf of Senator Regan for the record.

The PRESIDENT. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentleman from Columbia, Senator GORDNER, on behalf of the gentleman from York, Senator REGAN:)

Mr. President, 2 weeks ago, the Senate Committee on Veterans Affairs and Emergency Preparedness unanimously inserted provisions from 13 fire and EMS-related measures--prime sponsored by both Republicans and Democrats--into House Bill No. 1673. Today, this amendment:

Number one, ensures that the terminology in the bill is consistent throughout, particularly in regard to the "Fire and Emergency Medical Services Loan Program"--formerly the Volunteer Loan Assistance Program--as well as the "State Advisory Board" and "municipal fire companies."

Number two, clarifies that the nonvoting members to the Fire Advisory Board are appointed--"shall" instead of "may."

Number three, clarifies that the Fire Commissioner may use up to \$500,000 of the Fire and Emergency Medical Services Loan Program for administrative purposes. Current law permits up to \$250,000.

Number four, clarifies that under the fire and EMS grants the 15 emergency response calls are for fire or rescue.

Thank you, Mr. President. I ask for an affirmative vote.

The PRESIDENT. The Chair recognizes the gentlewoman from Allegheny, Senator Iovino.

Senator IOVINO. Mr. President, I rise in opposition to amendment No. A7739. When the underlying legislation came up in committee, I expressed support for assigning new duties to the State Fire Commissioner. However, I also shared that it was done without providing adequate funding to carry out their expanded mission. The unfunded mandate is approximately \$1.5 million. In committee, my counterpart, Senator Regan, acknowledged that this was an issue that warranted further discussion. So, I am disappointed to see that instead of the concerns being further addressed, the problem of the unfunded mandate has actually been exacerbated by the amendment we will be voting on. It has grown the unfunded mandate from \$1.5 million to \$2.2 million. During a pandemic, when our first responders are assuming an even greater risk than normal, we cannot hamstring the State Fire Commissioner by assigning them duties that we know full well are not resourced to perform to the full extent that our firefighters and our EMS personnel expect and deserve. I ask my colleagues to consider a "no" vote on amendment No. A7739.

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in adoption, further providing for definitions, for hearing, for grounds for involuntary termination and for petition for involuntary termination, providing for notice if identity or whereabouts of birth parent or putative father unknown, further providing for consents necessary to adoption and repealing provisions relating to consents not naming adopting parents.

HB 86 (Pr. No. 88) (Rereported)

PETITIONS AND REMONSTRANCES

The PRESIDENT. Senator Tartaglione has submitted remarks for the record. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentlewoman from Philadelphia, Senator TARTAGLIONE:)

Mr. President, today marks 5,216 days since the Pennsylvania legislature last raised the minimum wage. That is more than 14 years, and it is far too long.

Mr. President, there are countless ways to convey the point that Pennsylvania's minimum wage is simply far too little, but I do not think I could put it any more directly than two national news headlines that were posted within hours of each other this past weekend. On Friday evening, NBC News reported, and I quote: "8 million Americans slipped into poverty amid coronavirus pandemic." On Saturday afternoon, Salon.com reported: "Billionaire wealth rises to more than \$10 trillion for first time ever amid pandemic." Reading both articles--which were based on new academic and scientific research produced by venerable institutions including Columbia University, the University of Chicago, the University of Notre Dame, the investment banking firm UBS, the Institute for Policy Studies, and Americans for Tax Fairness--it becomes

abundantly clear that we have been sowing the seeds of our economy since long before the first positive case of COVID-19 landed on our shores.

Here are the horrifying numbers so far. Just before the pandemic, 15 percent of Americans were living in poverty. By September, that rate had risen to 16.7 percent. Since May, 8 million Americans have joined the ranks of the so-called "poor," raising the total figure to 55 million. That is an increase of roughly 17 percent. The vast majority of those folks, about 6 million, have joined the ranks of the poor in the last 3 months as extended unemployment benefits have been allowed to expire and in the absence of a new round of Federal stimulus payments.

It should also be noted that when we use the term "poor," we are talking about the Federal poverty line as defined by the U.S. Department of Health and Human Services. For a family of four, the income level is just \$26,200 a year. That is just \$12.60 an hour for a full-time, year-round worker, which, frankly, is not even close to enough income for anyone anywhere to feed, house, and clothe his or her family.

On the opposite side of the coin, we have the growing wealth of billionaires. Worldwide, the number of billionaires has risen from 2,158 to 2,189 as more than 1.1 million people have died from COVID-19, including more than 220,000 in the U.S. The billionaires' combined wealth surpassed \$10 trillion--that is with a "T"--for the first time in history, eclipsing the previous record of \$8.9 trillion set in 2017. At latest count, their combined wealth is \$10.2 trillion and growing. In the U.S., billionaires' wealth has grown by 27 percent--that is \$792 billionsince the start of the pandemic, raising their total wealth to \$3.7 trillion. Amazon CEO Jeff Bezos has seen his wealth rise more than 60 percent, to \$195 billion. Tesla CEO Elon Musk, a vocal critic of COVID19--mitigation policies, has seen his wealth more than triple, to \$85 billion during the pandemic.

Researchers have pointed to the 2017 Federal Tax Cuts and Jobs Act for helping billionaires keep more of their earnings. UBS, the Swiss multinational investment bank, noted that, as we speak, the White House is pushing for even more capital gains tax cuts and promoting them as pandemic-related stimulus, but they would overwhelmingly favor the richest Americans.

The current widening of wealth disparity amid an economic crisis is not unprecedented. Following the Great Recession of 2008, the wealthiest 400 Americans grew their wealth by 80 percent over the next decade. Yet, the bottom 80 percent of the nation's earners still have not recovered fully

In a news release accompanying his organization's new findings, the leader of the Institute for Policy Studies' program on inequality said, "For billionaires, this is a heads-we-win, tails-you-lose economy, boosted by...policies to funnel wealth to the top." That said, the question becomes, what must we do to reverse this unsustainable trend?

Americans for Tax Fairness argues that taxes on the wealthy must be raised substantially to narrow the wealth gap and "raise revenue vital for our big climb back from disaster." Others, including the London-based High Pay Centre, argue for a more balanced pay scale. That organization's executive director told *The Guardian*: "Anyone accumulating riches on **the current** scale could easily afford to raise the pay of the employees who generate their wealth, or contribute a great deal more in taxes to support vital public services, while remaining very well rewarded for whatever successes they've achieved."

Mr. President, it is long past time for the Pennsylvania General Assembly to catch up with our neighboring States and 29 States across the country. It is long past time that we do our part to reverse wealth inequality for working families today and for our future generations. It is long past time to raise Pennsylvania's minimum wage.

The PRESIDENT. The Chair recognizes the gentleman from Franklin, Senator Mastriano.

Senator MASTRIANO. Mr. President, I rise today to celebrate the service, sacrifice, and heroism of our veterans in honor of Veterans Day, which, of course, comes up on the 11th of November and was established in the aftermath of the First World War in 1918. Jesus said in the Gospel of John, Chapter 15, greater love has no man than this but to lay down one's life for his friends. In many ways, this personifies the ethos of our veterans, willing to put their lives on the line for our nation. This is an uncommon virtue that earned our veterans a special place in American history. In this, Pennsylvania remains exceptional. As the national average for any who have served across the nation is about 2 percent, Pennsylvania has over 800,000 veterans living amongst us today who, at one time in their lives, wore the uniform, pushing between 6 and 7 percent of our population. We are a very patriotic and selfless State, going back all the way to the Revolution. Fighting for freedom in these modern days is clearly in our DNA.

Looking across the century, our great First World War veterans sacrificed so much to defeat militarism in Europe, and even this day in 1918 they were fighting across the Meuse Valley in vicious warfare surrounded by a determined foe using chemical weapons to blunt the advance of the Americans, including many members of the 28th Division and other divisions comprised greatly of Pennsylvanians. Our Second World War veterans, of course, fought against fascism and militarism around the world and displayed uncommon virtue. Our great Korean War veterans held the line against the first militarized socialist attack against a free nation, pushed them back, and restored liberty to South Korea. Our great Vietnam War veterans fought a vicious foe in the deltas, jungles, and mountains of southeast Asia and won every battle, but they returned to an ungrateful nation and faced rejection and shame. I remember as a young man that my dad, serving in the Navy at the time, was prohibited from wearing his uniform off base, and I was a bit bewildered by how that could be in America. We owe them a profuse thanks for paving the way for us and remaining steadfast and sure in those dark days when so many in America turned their backs on our heroes. So I continue to say, when you see a Vietnam-era veteran, please thank them for their service and welcome them home.

We do, indeed, owe a great gratitude to our veterans for so much sacrifice. I would also like to point out, of course, so many of our veterans today wore the uniform during the Cold War - a time when the world was split asunder along ideological lines from 1947 through 1991. On the one side was a Moscow-led atheistic Union of Soviet Socialist Republics; there, the government controlled everything, and this repressive, intolerant system demanded total obedience in word and deed. On the other side was the American-led free world. In the 1980s, I was honored and blessed to serve with the 2nd Armored Cavalry Regiment along West Germany's Cold War borders with Czechoslovakia in East Germany, being at the pointy end of the spear for freedom. With great delight and after much sacrifice, we watched with satisfaction in late 1989 and early 1990 when the repressive

system collapsed and the peoples of the east rose up, threw off the oppressive system, and enjoyed freedoms for the first time in their lives, something we take for granted in the west. I remember the East Germans coming across the border, and I had the pleasure, with my own platoon, to welcome such a group to West Germany for the first time and, looking into their eyes, seeing the joy of freedom and liberty for the first time. What an honor it was to know that our vigilance saved so many lives. In this one instance along the border north of Hof, West Germany, a group of East Germans gathered around me and my men and I was just amazed at the joy they had, something I never saw in an eastern European before.

For the Cold Warriors, we did something unmatched in world history - we helped usher in, for western and central Europe, the longest period of peace they had experienced in over 1,500 years. The longest peace in European history since, basically, the fall of the Roman Empire. Thanks to our great veterans, generations of Europeans have lived without war, and countless millions of lives were saved thanks to our veterans. Winston Churchill's words about the brave men who saved the United Kingdom during the Battle of Britain may be applied to our Cold War veterans: "Never in the field of human conflict was so much owed by so many to so few." The academics in the west, of course, belatedly beat their chest in triumph, predicting a new world order where world peace would prevail, and oh, how we wished it was so, but the heart of man remained unchanged, and as the Bible rightly says, while people say peace and safety, destruction will come upon them suddenly.

I remember serving in northern Germany monitoring the last Warsaw Pact operation. The British, at the site I was working from, had a TV on showing Iraqi tanks moving to Kuwait City in 2 August 1990. I imagined that would never affect our lives in Germany as we were so far away, but the United States responded quickly with the deployment of thousands of men and women from across the States, and then, later, a large part of the forces out of Germany, including my own unit. I remember the uncertainty of those days. Was this going to be a new border mission along the Saudi Arabian border with Iraq? Would there be high casualties? Would Saddam Hussein use chemical weapons on us, and biological weapons as well, as he had during the Iran War that lasted for 8 years and ended just 2 years before? He had even used these weapons against his own people in Halabja in 1987 and 1988. Would he give orders to his commanders to use them against Americans if we came on Iraqi soil?

As my regiment deployed to Saudi Arabia, I remember how the American people rallied around us. Yellow ribbons went up, and our people ceaselessly prayed that God would protect us. Signs popped up everywhere across Pennsylvania saying, please pray for our troops. Never before had a nation so beseeched God for His protection over its men and women in uniform spontaneously like this. Indeed, God heard those prayers, and when we saw the answers to those prayers during Desert Storm, I was a bit bewildered and taken aback.

One of the things working to the advantage of Saddam Hussein's forces, the wind blows from Iraq into Saudi Arabia, giving them every reason and advantage to use chemical weapons upon us. In fact, we received intercepts that, indeed, Saddam Hussein authorized his division commanders to use chemical weapons if we stepped foot on Iraqi soil. But something strange happened the day before the ground war began. My regiment

was actually given orders to enter Iraq on the 23rd of February at 13:00, 1 o'clock, and just as our first tank, after a series of barrages of air strikes against forward Iraqi positions coming out of Saudi Arabia into Iraq, I was amazed that the wind shifted around me. All these little dust devils and sand devils popped up around me and the wind started blowing from Saudi Arabia into Iraq, taking away any ability for Saddam Hussein's forces to use chemical weapons as they would blow right back on his own troops. That was clearly a miracle.

The prayers continued to be answered as a shamal, a sandstorm with thunder, lightning, and rain, blinded the Iraqi Republican Guard during the fierce Battle of 73 Easting, which my regiment led. Although facing a force twice our size, we had a decisive victory, and thanks to that storm, they were blinded, and we were able to break through. All the Americans and coalition forces with us, together, we liberated Kuwait, vanquished the determined foe, and came home to a grateful nation.

In the aftermath of this, the 1990s was a time of transition, with costly humanitarian missions in Somalia that, indeed, in the end, saved hundreds of thousands of lives, and then later joined with the allies in Bosnia to end a genocidal civil war that the United Nations was incapable of stopping. We also went into Kosovo to stop another genocide, saving countless, tens of thousands of lives. So, I thank all those who served across the 1990s during that turbulent time who wore the uniform in all the forgotten conflict issues and peace deployments.

Of course, our veterans cannot but think back to the dark day of 9/11, when our world was turned upside down. The attacks on New York, Washington, D.C., and, of course, in Pennsylvania shook us to our core. But we stood together with our allies and partners in Afghanistan, where we have the longest ongoing mission and war in American history, 19 years and going. Even today, our men and women wearing the uniform serve us in Afghanistan in that difficult mission, as our men and women stood firm against Saddam Hussein's forces in Iraq in 2003 onward and helped push to complete the destruction of the radicals of ISIS. Our men and women have served with distinction in far-flung places around the world in Asia, Africa, South America, and elsewhere. Each veteran can look back with pride and satisfaction that they made a difference. They stood in the gap to protect our people and our way of life.

As the Apostle Paul wrote, our veterans can say, I have fought the good fight, I have finished the race, I have kept the faith. But what is next? As the famed General Douglas MacArthur wrapped up a life of military service, he said, "Old soldiers never die - they just fade away." But I would say, in these times that try our souls, this is no time for old soldiers, or any veteran, to fade away. The nation still needs you, and your Commonwealth calls you as well. I hope you continue to serve. It was the same motivation that propelled me to enter the Pennsylvania Senate after reflecting upon my 30 years of active duty. My heart was broken that, after so many years of service and sacrifice, I was handing off the nation and the State to the next generation less secure, less free, and less good than the way it was given to me by my father's generation. This is no time for anyone to fade away but to continue to fight the good fight for freedom in a different capacity. Let us stay in this mission until the job is done.

I ask veterans to share their story, tell people what it is like to serve overseas, to wear the uniform, seek ways to continue to serve, and keep fighting the good fight for freedom and honor for all the veterans in all of America's wars across the generations of centuries. Thank you, veterans, for all you have done to defend our nation from those who mean us harm. May God continue to shine His face upon you, your families, and our great Commonwealth.

Senator MENSCH. Mr. President, I rise to show tribute and thanks to a group of men from Montgomery County who showed some incredible selfless dedication to providing PPE to the many EMS organizations throughout our county. They worked under the aegis of the 21st Century America-Korea-China Leaders Society. As a result of the shortage of personal protective equipment--we all know how difficult it was to find the supplies that were necessary--these men banded together in working with some colleagues in Korea, their land of birth, each of these gentlemen, to bring PPE to America at their expense. A constituent and friend of mine, Master Bong Pil Yang, enlisted the help of his friends, Osang Park and Jay Sung, to come together and help procure and provide thousands of masks and pairs of gloves for the frontline workers throughout Montgomery County. Master Yang and his group of inspirational citizens accepted the challenge to do more, and for months they have been providing protective equipment for myself and my other legislative colleagues to donate to organizations such as our local fire departments, police, and EMS organizations. Not only did this equipment help protect those who needed it the most, our first responders, but it represents a very heartfelt and selfless act of kindness demonstrated by these gentlemen. They were recognized earlier today in the House of Representatives for their efforts as well. So, I think it is fitting and appropriate that we in the Senate extend to them our same gratitude.

Mr. President and fellow colleagues of the Senate, it is clear that the COVID-19 pandemic will be remembered for a long time, and for a lot of reasons. But it is selfless acts, as demonstrated by this group, that should be at the forefront of our thoughts when we look back at these trying times. These individuals stepped up when they were needed most and did the right thing, asking for nothing in return. That, I hope, Mr. President, is the legacy for these gentlemen that lives on for years to come. Thank you.
