I am writing to inform you that I am resigning from my office as Senator in the General Assembly for the 22nd Senatorial District effective March 8, 2021. It has been a great privilege and honor to serve the

people of the 22nd District and of Pennsylvania for over a decade. I have dedicated myself to being responsive to the needs, concerns and aspirations of the people I have proudly represented and I have, with vigilance, voted in Senate Committees and in the Senate Chamber always with their best interests foremost in my mind.

I have been offered and have agreed to accept a position in the office of U.S. Congressman Matt Cartwright, serving the people of the 8th Congressional District, which includes, of course, all of PA's 22nd Senatorial District. I will miss them in the weeks, months and years ahead. I also must express particular thanks to all of my past and current Senate colleagues on both sides of the aisle. It has been an honor to serve with them.

Finally, I want to express thanks to you; to Senate Secretary Megan Martin; and indeed to all Senate personnel, particularly senior staff in the Senate Democratic Caucus, who have aided me and ensured I was always an informed legislator. Their tireless, dedicated work is what ensures that all State Senators are the best public servants they can be.

SPECIAL ORDER OF BUSINESS LINCOLN DAY ADDRESS

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Robinson.

Senator ROBINSON. Mr. President, it is a tremendous privilege to have been chosen to represent the Senate as a standard bearer on the Lincoln Day Address before my colleagues here today. Lincoln once said that "...a man's character was like a tree, and his reputation like a shadow; the shadow is what we think of it, and the tree is the real thing." We walk in the shadows of many great Pennsylvanians throughout this magnificent building: William Penn; Benjamin Franklin; and then, on the opposite side of Lincoln in the Chamber is George Washington, whose birthday happens to be today. It is not coincidental that Washington and Lincoln cast their shadows on this Chamber, writing so much early history of our Commonwealth and our nation.

Lincoln, with a profound sense of history, having lost a mother and being abandoned by his father, sought the comfort of the nation's forefathers as his paternal example. Being mostly self-taught, barely educated formally, one of the only biographies Lincoln read was that of George Washington, citing his struggles in the Revolution at Trenton and Valley Forge. Within those pages, Lincoln realized what was created and fought for so many years ago. He remarked: "...there must have been something more than common that those men struggled for." As he toured the country on his inaugural journey as more and more States continued to secede from the Union, Lincoln stopped at Independence Hall 160 years ago today in Philadelphia, February 22,

1861, George Washington's birthday. He stated: "I have never had a feeling politically that did not spring from the sentiments embodied in the Declaration of Independence... It was not the mere matter of the separation of the Colonies from the motherland; but that sentiment in the Declaration of Independence which gave liberty, not alone to the people of this country, but, I hope, to the world, for all future time."

As we look at George Washington's image here, we see him standing, arms stretched in a manner to bestow a gift of triumph. Across the rostrum is Lincoln at Gettysburg, solemn, reflective, and recognizing the weight of consecrating a plot of land that so many people fought and died for. He is solemn, contemplating that thought of what his address, Presidency, and life was truly about. The responsibility of every American laid bare in the preamble to the Constitution written in Independence Hall, to insure we all strive for a more perfect Union for all. In invoking the image of "Four score and seven years ago," our forefathers had a vision for the world, a vision that was not bestowed on us, but passed along to future generations to insure the betterment of humanity.

The Gettysburg Address really spoke of Americans' unfinished work and the acknowledgment that work can never actually be completed. He told Congress in December 1861 that the struggle to preserve the Union "...is not altogether for today--it is for a vast future also." Mr. President, that is why we are all here. That is why the legend of Lincoln will never go away, why he encapsulates the image of our nation and that of the world. A walking contradiction, everyone sees something different in Lincoln because they see a piece of themselves. No matter where we come from, all of America traces our DNA to its forebears. Lincoln's DNA is woven throughout our nation, and that is why we work under these shadows, to always remind us of our responsibility as Americans to always insure a more perfect Union for future generations.

Thank you, Mr. President.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Westmoreland, Senator Kim Ward.

Senator K. WARD. Mr. President, I am submitting remarks on behalf of Senator Corman.

The PRESIDING OFFICER. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentlewoman from Westmoreland, Senator KIM WARD, on behalf of the gentleman from Centre, Senator CORMAN:)

Mr. President, today, I rise to speak on the successes of the Penn State IFC/Panhellenic Dance Marathon, know as "THON." This year, THON was held virtually for the first time since it began in 1977, from Friday at 5:15 p.m. thru Sunday at 4 p.m. It is very fitting that this year's theme was "Rise and Unify."

Typically, over 16,500 student volunteers donate more than 5 million hours of their own time to help raise funding year-round to combat pediatric cancer—an effort that culminates in a 46-hour dance marathon traditionally held at the Bryce Jordan Center on Penn State University's campus in Centre County, part of the 34th Senatorial District.

This year, those same student volunteers proved successful in rising above the pandemic that we are all facing to replicate that same high-energy experience, but this time, remotely—and not just at the Bryce Jordan Center, but to everywhere around the world. There were over 165,000 viewers across 70 countries bringing the magic of THON into homes of supporters around the world. Last fall, these students recognized that they would need to hold this annual event as virtual, and they successfully worked together to make that happen. Many of the Four Diamonds families and THON's beneficiaries are immunocompromised, so this was more important than ever to "Rise and Unify." Four Diamonds funds pediatric cancer research through start-up grants and the Four Diamonds Pediatric Cancer Research Center and cares directly for 500 children with cancer, 100 of whom are children who have been newly diagnosed.

I introduced Senate Resolution No. 25, which would designate the week of February 15 through 21, 2021, as THON Week in Pennsylvania. Yesterday afternoon, the virtual events of the THON weekend concluded. I am advised that \$10,638,078.62 was raised to go towards treating and research for childhood cancer. Last year, THON raised over \$11 million, and has raised over \$180 million total since it began—\$100 million of these dollars have come in the last 10 years alone.

Since its introduction, THON has supported more than 4,000 children and families with childhood cancer and to this day, continues to enable research, improve treatments, cures, and benefits to children with cancer.

Mr. President, today I ask that we recognize this year's successes of THON, and thank all the student volunteers and individuals who made this happen. Although it is a challenging year for all of us, we are proud of your work to "Rise and Unify," and to help support all Four Diamonds families in our fight against pediatric cancer.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, today marks 5,343 days since the Pennsylvania legislature last raised the minimum wage. That is more than 14 years, and it is far too long.

Mr. President, the world of basketball lost a great ambassador recently, and our Commonwealth lost a champion of social justice with the passing of longtime Temple University head coach John Chaney, whose lifetime of achievement on the court was exceeded perhaps only by the life lessons he taught countless young people. I, like most folks associated with Temple, have spent considerable time thinking about the extraordinary legacy Coach Chaney has left for the university and the positive influence he has had on communities throughout Philadelphia. I have sought to learn more about his enduring message. For that, I turn to a stern speech that Coach Chaney delivered some 20 years ago upon his enshrinement into the Basketball Hall of Fame. I was inspired, but not surprised, that Coach Chaney's remarks made no mention of his more than 500 basketball victories and 17 NCAA tournament appearances in 24 years at Temple. He made no mention of the national championship he won prior to that at the Commonwealth's own Cheyney University. On the contrary, Coach Chaney spoke of his own triumph over childhood poverty and the opportunities he worked so hard to provide for young people growing up in similar circumstances.

When someone says you are poor, it does not mean you do not have money, he explained, it means you have nothing. Coach Chaney spoke of the lettuce, tomato, and mayonnaise sandwiches he ate each day in grade school because his family could not afford lunch meat. He spoke of a high school coach who bought him clothes and took him to camp in the Poconos for a brief respite from the social problems he witnessed and experienced in his north Philadelphia neighborhood. He spoke of being told by a high school counselor that he was not suited for college prep classes, that he should focus on industrial arts. He spoke of failing those wood shop classes and the machine shop classes intentionally so he would be reassigned to the college prep curriculum. He told of the invaluable role that the historically black colleges and universities have had in his life and his career. First as an undergraduate at Bethune-Cookman in Florida, then as a coach at Cheyney, the oldest historically black college. "I believed so strongly in the black schools at that time because they never, ever put a ceiling on what you could learn," he said. "They believed so strongly in building up the floor so you could reach all ceilings....And I believed strongly in that. They believed in access and opportunity, and they gave me that chance."

Mr. President, the same message can and should be said about the minimum wage. Time and again, those who resist raising the minimum wage tell us that it was never meant to be a living wage. They say that the minimum wage is merely a statement, a starting point for teenagers in entry-level jobs. They say that young people should be more focused on gaining valuable work experience rather than the size of their paychecks. Mr. President, I am here to say that our current minimum wage is indeed a valuable teaching tool. Unfortunately, the lessons it conveys are all bad. The paltry rate of \$7.25 an hour teaches workers, young and old, what it is like to live in despair and on the brink of destitution with little or no hope of paying for food, shelter, transportation, healthcare, childcare, or tuition. It teaches them that we, as a society, do not value their labor, no matter how hard or how long they work. The current minimum wage teaches us all about depriving honest, hardworking people the access and ability that Coach Chaney valued and promoted so much.

Mr. President, it has been more than 14 years since the General Assembly raised Pennsylvania's minimum wage. It is long past time that we raise the floor so our low-wage earners can reach all ceilings and beyond.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Beaver, Senator Vogel.

Senator VOGEL. Madam President, it is my pleasure this afternoon to recognize the week of February 20 through 27, 2021, as FFA Week in Pennsylvania, also the subject of Senate Resolution No. 15. The FFA was previously known as the Future Farmers of America. It is comprised of students in grades 7 through 12 and college. Last year, the Pennsylvania FFA had 13,170 members from 148 chapters throughout the State. Notably, this is the third-highest membership of all time in the Commonwealth. Nationwide, the FFA broke their membership record last year with over 760,000 members and 8,739 chapters. Members of the FFA come from diverse backgrounds and are pro-

vided an agricultural education that includes fields such as agribusiness, agriscience, biotechnology, agriculture mechanics, horticulture, and animal science, among others. In addition to the education they receive, these young men and women have the opportunity to participate in leadership development events; compete at the local, State, and national level; and gain hands-on experience to prepare them for their future careers.

In representing their organizations, members may be easily identified by the traditional blue corduroy jackets which they wear with pride, and rightfully so. Additionally, FFA officers make an incredible commitment, dedicating a year of service to their organization. Pennsylvania's 2020-21 officers are: president, Mikara Anderson of Huntingdon County; vice president, Cody Lehman of Columbia County; secretary, Jessica Herr of Lancaster County; treasurer, Cheyenne Bastian-Brown of Bradford County; reporter, Alayna Harrell of Lebanon County; sentinel, Emily O'Brien of Bedford County; and chaplain, Emma Musser of Lancaster County.

Madam President, I ask that my colleagues join me in honoring this exemplary youth organization and its dedicated participants, as well as their advisors and families, by recognizing FFA Week in Pennsylvania this February 20 through 27.

The PRESIDING OFFICER. The Chair appreciates your recognition of FFA, as I was honored to be a Keystone degree recipient from FFA a couple of years ago. Thank you very much, Senator Vogel.

The Chair recognizes the gentleman from Lehigh, Senator Browne.

Senator BROWNE. Madam President, I rise today to recognize the week of February 22 through 28, 2021, as Eating Disorders Awareness Week in Pennsylvania. The goal of Eating Disorders Awareness Week is to shine the spotlight on eating disorders by educating the public, spreading a message of hope, and putting lifesaving resources into the hands of those in need. Eating disorders have the highest mortality rate of any mental illness, and approximately 30 million Americans struggle at some point in their lives with an eating disorder. Eating disorders affect people across all backgrounds and include anorexia, bulimia, and binge eating disorders.

The 2021 theme is "Every Body Has a Seat at the Table." This theme invites inclusivity in the greater eating disorder community and sends a message to individuals at all stages of body acceptance that their eating disorder recovery issues are valid and recognized. Signs and symptoms of eating disorders are often overlooked, and many individuals, families, and communities are unaware of the devastating mental and physical consequences of eating disorders, as well as the pressures, attitudes, and behaviors that shape them. Eating disorder experts have found that prompt, intensive treatment significantly improves the chances of recovery. Unfortunately, many cases of eating disorders go undetected, and less than one-third of youths with eating disorders receive treatment.

I hope that by recognizing February 22 through 28, 2021, as Eating Disorders Awareness Week in Pennsylvania, it brings awareness by highlighting the importance of screenings for early detection and intervention of eating disorders, dispels myths, and presents eating disorders as a public health issue with close connections to substance abuse, obesity, trauma, and other mental health conditions such as depression, anxiety, and obses-

sive-compulsive disorder. I ask the Members to reflect on the challenges of those with eating disorders during this week.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Montgomery, Senator Cappelletti.

Senator CAPPELLETTI. Mr. President, stories of gun violence across Pennsylvania have been slipping through the headlines and between the focus on vaccines and the economy. But the importance of these stories cannot be forgotten in the ever-changing news cycle. The facts are this: gun violence is a national epidemic, one that touches every State, and one that we are experiencing firsthand in this Commonwealth. This past weekend, there was a shooting right in my backyard in East Norriton where my husband and I live. A shooting occurred that left one dead and four others injured at our local bowling alley. Bowling, a place for family nights and hanging out with friends, first dates, and fun. Among those there on Saturday evening were children - children who I know personally, traumatized by gun violence. Our bowling alley, a pillar of family wholesome fun, is now scarred by this tragic event.

Across the Commonwealth, we have seen instances of gun violence that were preventable. Last year in Philadelphia alone, there were over 2,000 victims of shootings, and the city is on trend to set new records on gun violence occurrences this year. In February of 2021, we already know this. This is not just a problem for southeastern Pennsylvania, it extends all across our Commonwealth. In 2018, firearms were reported as the number one leading cause of death among children and teens in Pennsylvania. Out of our 67 counties, only 10 of them reported zero total deaths by gun violence between 2015 and 2019. Through the pandemic, gun violence has only been exacerbated. We know this is a problem. In fact, that is all we ever say: this is a problem.

Here today, I am asking my colleagues to help give Pennsylvanians solutions. Keep this issue at the forefront of this body's legislative agenda, because our collective priority needs to be keeping Pennsylvanians safe from the threat of gun violence. We are in derelict of our duties not to move on this issue because we know commonsense gun laws are proven methods of reducing violence. We know it has worked because we have seen it work elsewhere, and now it is time for Pennsylvania to do the same. Please join me in prioritizing the end of gun violence in our Commonwealth and near our homes.
