It was an honor to be able to attend, witness the event, and proclaim the day to be Girls' Wrestling Day in Pennsylvania. These girls' accomplishments are a testament to their hard work and dedication. As is the tradition here in the Capitol, those who are crowned State champions were invited to join us in the Chamber today. Some of our State champions are joining us in the Senate gallery, and we have several girls who are three-time State champions and national champions seated with us on the floor. In becoming champions, they have proven that they have put in the time and effort to be the best in their sport.

Wrestling has been a great positive influence on my life, and I am glad to see that the opportunity for girls to experience that influence is growing in our State and across the country. However, these girls have a different experience than I did. They are not only champion athletes, but also champions of growing their sport. It is for that reason that I would again like to voice my support for the SanctionPA effort. I am proud of the work that this organization has accomplished and hope to see girls' wrestling become a PIAA-sanctioned sport in the near future, because the girls in this Commonwealth should have the opportunity to compete to become PIAA State champions.

These young ladies are joined today by family members, coaches, and other supporters who are so proud of what they have done and what girls' wrestling means for our Commonwealth. Today, my Senate colleagues would like to honor their

constituents specifically, and I look forward to everyone hearing about their individual accomplishments. But before I turn it over to them, I ask that my colleagues welcome our special guests who are here today to not only honor these young ladies, but who have been amazing advocates to grow the sport of girls' wrestling and to push it to become an official PIAA-sanctioned sport.

Member of the National Honor Society; honor roll student; leader of the school's public communications; holds career wins and records in Pennsylvania for female against male opponents--I am not going to wrestle her, that is for sure--first female to count as scoring competitor at the Pittsburgh Classic; three-year varsity team captain at Gettysburg High School; volunteer coach at Gettysburg Youth Wrestling--passing it on to the next generation--and will be continuing her academic and athletic career at King University in Bristol, Tennessee, for psychology. Please join me in welcoming these great athletes.

This notable feat comes with an interesting sidebar. She won the 140-pound weight class in 2020 and the 134-pound weight class in 2021. She has signed a letter of intent with Lock Haven University for a wrestling scholarship. So, no doubt these young women have heard over the years that wrestling is not a sport for girls. They proved them wrong, they never gave up. When you consider what they invested in training, strength, agility improvement, and competitive spirit, they made a choice that we all are here today to laud and admire. We applaud them for their athletic accomplishments, but also for their character and perseverance that they have displayed. Lily is seated here on the floor of the Senate. She is accompanied by her

mom, Vivica, and her coach Lou DeLauro. Unfortunately, her proud dad, Allen, could not make the trip today but he is with her in spirit. Also in the gallery are Lexi Schechterly and her parents, Alison and Tim.

I would also like to take a moment to thank our colleague, Senator Martin, for his advocacy and leadership in advancing girls' wrestling here in Pennsylvania. He has been a steady, constant, and passionate champion for growing the sport, and we are doing this today because of his leadership and dedication. So as we honor these young women, let us give them a warm Senate welcome and also take a moment to thank Senator Martin for his efforts.

Senator SAVAL. Mr. President, I rise today in opposition to Senate Bill No. 516. I appreciate what I perceive to be my colleague's intention to create accountability in our court system and consistency across it. But, along with criminal justice reform advocates and the Pennsylvania Coalition Against Domestic Violence, I worry that the impact of this bill will be to hurt indigent defendants who are already targeted by the current system. Referral to a private collection agency has both the potential to affect a defendant's credit as well as adding a surcharge to existing fees, restitutions, etc., which are already punitive. Current practice only allows it to referral after a hearing in which the defendant is determined to be, quote, financially able to pay. Referral to a collection agency in the case of non-appearance makes no allowances for why people fail to appear in court - because of a lack of child care; inability to take off work; or any similar, reasonable barrier. The creation of additional penalties for a system that is multifarious in the ways that it penalizes indigent defendants makes it difficult for me to support this legislation, and I urge my colleagues to vote "no." Thank you.

As the public is becoming increasingly more interested in government, I believe they have a right to know in advance what is to be considered at a public meeting so they have an opportunity to engage in the issues that matter most to them. The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from York, Senator Phillips-Hill.

Senator PHILLIPS-HILL. Mr. President, I rise in support of Senate Bill No. 618. Senate Bill No. 618, which I have sponsored alongside the Senators from Mercer and Blair Counties, is a simple concept. It would ban the State, county, local municipality, school district, or college that receives State taxpayer subsidies from requiring a proof of the COVID-19 vaccine to enter a facility within its territory. The State could not require proof of vaccines for a citizen to enter into a restaurant, barber shop, or live their daily lives. New York State created the Excelsior Pass, which is a QR code that individuals show to prove they have received the vaccine. Taxpayers in New York State paid IBM to develop this vaccine passport app to the tune of \$2.5 million. Here is something to be aware of. The three approved vaccines have been approved under emergency use authorization. None of the vaccines have been fully approved by the Federal Food and Drug Administration. Under Federal law, an individual must be given the option to accept or refuse administration of the vaccine. The good news is that the administration has stated that they have no plans to implement a vaccine passport in Pennsylvania. This bill will ensure that remains the case.

Yesterday, the gentlewoman from Blair County amended the legislation to prohibit the Secretary of Health from unilaterally putting in place prohibitions that we have all experienced and heard a lot about from our constituents over the last 15 months. Over the last few months, we have seen a massive data breach over very sensitive personal healthcare data and information from the third party vendor the Department of Health tasked to contact trace citizens here in the Commonwealth. We still do not have the answers for the more than 70,000 Pennsylvanians impacted. This legislation will assure the people of Pennsylvania that the State will not even entertain a possible vaccine passport smartphone app, as well as ban any requirement of proof of vaccine to carry on with our day-to-day lives. I respectfully ask for an affirmative vote.

Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, I was very supportive of this legislation when it started out prohibiting proof of vaccination, but there are 67 counties, 500 school districts, and 2,561 municipalities in this Commonwealth; so the idea that there could be 3,128 different vaccination policies across this Commonwealth was concerning to me, made no sense. So the legislation at that time made some sense. Since then--let me put it this way--since we are now roughly 60 percent fully vaccinated for people over 12 and over 70 percent have received their first shot, I do not believe we really need a policy requiring individuals to show proof that they are vaccinated at this point. Everywhere you go a lot of people are not wearing their masks, mitigation orders have been lifted, and many people are now acting as if life has gone back to normal.

Unfortunately, what happened with this legislation was that an amendment was added yesterday that is totally irresponsible policy. The amendment precludes the Secretary of Health from instituting protective measures to address future public health crises and some that could be far more contagious, far more deadly than COVID-19. Why are we doing this? Just because some people in this building do not like Governor Wolf, and that makes no sense to me. We should never legislate off emotion. Tying the hands of future secretaries of health, future administra-

tions, and future legislators is political nonsense. It really is. It does not belong in this bill. Quite frankly, it is reckless policy. So, while inserting this amendment may have been very politically popular for some in this Chamber, it is clearly not the responsible thing to do. The legislation started off, it was great policy, but then this whole thing turned into, to me, a political punch at our Governor. So because of this amendment, it is an easy--I was going to vote "yes"--it is an easy "no" vote for me because it is so totally irresponsible.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, very briefly, I want to build upon the comments of my colleague, the gentlewoman from Northampton. I think she explained exactly some of the reasons why, including the portion with some of the amendments that were added. More specifically, there was one that was added yesterday that dealt with higher education institutions, and I think it is an overburdened situation that we have developed here. Beyond that, I understand the Governor will be vetoing this legislation, and to the point that was made by my colleague, why are we doing these things? I ask for a negative vote.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Montgomery, Senator Haywood.

Senator HAYWOOD. Mr. President, this is tyranny. Taking away the decisions of local school districts which are in the communities all across our Commonwealth is nothing short of tyranny. Those individuals are fully committed to protecting our citizens and our residents. Taking away the decisions of private higher education institutions just because they receive some level of annual support from the Commonwealth, tyranny. How are they now to protect the students, the faculty, the staff at these organizations? We all should know that the spread of the virus is a population matter and that the schools are typical places where these viruses spread. From children to parents, teachers, and shop owners, all throughout the communities. What we are saying to these local leaders is that the most effective ways of preventing the spread of the most infectious disease, the most deadly disease that we have had, that they would be prohibited from using that which is most effective. This is a hostile attack on everyday people. Infectious diseases like mumps, chicken pox, rubella, those are immunizations that are currently required. Now, after 27,000 people have died from COVID-19, will we strip those same school districts from immunizing the young people who attend? Will we know that those young people may be infected and therefore it will spread as I have said?

Now, this legislation in fact, Mr. President, encourages the spread of COVID-19 by stripping those with the most responsibility to stop it from using the most effective message to do so. Including something as simple as washing hands. There has been no assessment or hearing on this matter to test whether this makes any sense whatsoever. I am certain that at some point we would have thought of some kind of public health assessment as to the wisdom, or lack thereof, of this prohibition. Mr. President, with freedom comes responsibility. There is no amount of individual freedom that can protect us from a contagious, infectious disease. The very nature of infectious disease means it is beyond individual solution. This legislation is wrong and, Mr. President, I encourage a "no" vote. Thank you.

BILL ON SECOND CONSIDERATION, AMENDED AND REREFERRED

HB 854 (Pr. No. 1155) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for COVID-19 record retention.

On the question,

Will the Senate agree to the bill on second consideration?

Senator K. WARD offered the following amendment No. A1582:

Amend Bill, page 1, line 21, by inserting after "retention":
and for temporary regulatory flexibility authority
Amend Bill, page 1, lines 25 and 26, by striking out "an article" and inserting:
articles
Amend Bill, pages 2 and 3, lines 1 through 30; page 4, lines 1 through 8; by striking out all of said lines on said pages and inserting:
COVID-19 RECORD RETENTION

Section 2101-E. Definitions.

The following words and phrases when used in this article shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"COVID-19." The coronavirus disease 2019, being an infectious disease caused by severe acute respiratory syndrome coronavirus 2 that was first identified during December 2019 in Wuhan, China.

"Executive agency." An office, department, authority, board, multistate agency or commission of the executive branch of the Commonwealth which is subject to the policy supervision and control of the Governor.

"Order." Any of the following:

(1) the declaration of disaster emergency issued by the Governor on March 6, 2020, published at 50 Pa.B. 1644 (March 21, 2020); or

(2) a declaration of disaster emergency relating to COVID-19 which is issued after March 6, 2020.

"Record." Information, regardless of physical form or characteristics, that documents a transaction or activity of an executive agency and that is created, received or retained pursuant to law or in connection with a transaction, business or activity of the executive agency. The term includes a document, paper, letter, map, book, tape, photograph, film or sound recording, information stored or maintained electronically and a data-processed or image-processed document.

Section 2102-E. Retention of records related to COVID-19.

An executive agency shall preserve all records in possession of the agency relating to the order in accordance with the executive agency's existing record retention policy.

Section 2103-E. Construction.

Nothing in this article shall be construed to reduce the retention period of any Commonwealth record as provided by law or prevent the transfer of records to the State Archives for permanent retention.

ARTICLE XXI-F

TEMPORARY REGULATORY FLEXIBILITY AUTHORITY

Section 2101-F. Definitions.

The following words and phrases when used in this article shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"COVID-19." The coronavirus disease 2019, being an infectious disease caused by severe acute respiratory syndrome coronavirus 2 that was first identified during December 2019 in Wuhan, China.

"Order." Any of the following:

(1) the declaration of disaster emergency issued by the Governor on March 6, 2020, published at 50 Pa.B. 1644 (March 21, 2020); or

(2) a declaration of disaster emergency relating to COVID-19 which is issued after March 6, 2020.

Section 2102-F. Temporary regulatory flexibility authority.

(a) Extension.--The suspension of a regulatory statute prescribing the procedures for conduct of Commonwealth business, or an order, rule or regulation of an Commonwealth agency which was suspended under 35 Pa.C.S. § 7301(f)(1) (relating to general authority of Governor) as of the last day that the order, as amended and renewed, was in effect is extended until September 30, 2021, unless sooner terminated by the authority which initially authorized the suspension.

(b) Applicability.--A suspension which is extended under subsection (a) shall be retroactive to the last day that the order, as amended and renewed, was in effect.

(c) Notice.--Upon the termination of an extension of a suspension under subsection (a), the authority which terminated the extension of the suspension shall notify all of the following:

(1) The President pro tempore of the Senate.

(2) The Majority Leader of the Senate.

(3) The Minority Leader of the Senate.

(4) The Speaker of the House of Representatives.

(5) The Majority Leader of the House of Representatives.

(6) The Minority Leader of the House of Representatives.

(7) The chair and minority chair of each committee of the Senate and of the House of Representatives which have oversight authority over the Commonwealth agency which administers the regulatory statute, order, rule or regulation.

On the question,

Will the Senate agree to the amendment?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I did not know whether or not anyone else was going to be speaking on the amendment. I personally rise and ask for support for this particular amendment. There has been a lot of controversy with respect to the emergency declaration that we now have in place and more importantly the viability of the continuance of that emergency declaration. I support the comments that were previously made by my colleague from Montgomery County who is part of the Committee on Veterans Affairs and Emergency Preparedness that there are concerns with the underlying House Resolution No. 106 that will terminate and end this declaration. That is a whole conversation that we will deal with tomorrow, I believe, on the Senate floor as to whether or not that is something that is appropriate and should be done.

That all being said, Mr. President, what this amendment does--as we understand it--is continues to put into place a num-

ber of the waivers that have been granted under the authority of Title 35 that the Governor has put into place over the course of the 15 or 16 months of the emergency declaration related to the COVID-19 pandemic. It is our belief that these waivers would remain in effect until September 30 or until such time as the Governor would make the decision to terminate the emergency declaration, if there would be one in place, or make changes along those lines to these regulations. If these regulations would be changed, this amendment also requires that notice be provided to the various subject matter committees to make sure that folks are aware of those types of things. At the end of the day, what we will have in place with the authority of this amendment and the Members voting in support of that would allow the Governor and his administration to continue to waive the various regulations pursuant to Title 35 as we go forward. For those reasons, I think that is a good step for all of us to be taking.

Again, not knowing what the outcome of Senate Resolution No. 106 will be and an emergency declaration's length and a certification of the election, et cetera--those are complicated legal issues that need to be resolved at some point in time--but the ability of this to be applied retroactively to the very last day of that declaration, I think, is what is important so there will be no gap with regard to the manner and nature in which these waivers would be put into place to protect the people of Pennsylvania.
