§ 9621. Definitions.

As used in this subchapter, the following words and phrases shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Nonprofit membership association." A nonprofit organization whose mission is to support veterans, reservists, National Guard members, their spouses and families.

"Veteran-owned business." A business owned or controlled by a veteran.

§ 9622. Veteran-owned business logotype.

(a) Logotype.--Except as provided under section 9623 (relating to nonprofit membership association), the department shall develop and design an official Commonwealth logotype to be used by a veteran-owned business.

(b) Application.--Except as provided under section 9623, the department shall develop an application, criteria and affirmation upon which an eligible business may apply for a license to use the logotype under this section.

(c) Eligibility.--A veteran-owned business shall be eligible to be issued a license to use the logotype if:

(1) the business is registered with the Department of State;
and

(2) at least 51% of the ownership interest in the business is held by a veteran.

(d) Verification of military service status.--Except as provided under section 9623, the following shall apply:

(1) The department shall verify the military service status of each business owner seeking status as a veteran-owned business without additional verification, by confirming that the business:

(i) possesses a valid verification issued by the Department of General Services as a Veteran Business Enterprise, including a Veteran-Owned Small Business Enterprise or a Service-Disabled Veteran-Owned Small Business Enterprise.

(ii) possesses a valid verification issued by the United States Department of Veterans Affairs through VETBIZ or its successor.

(2) Nothing under this subsection shall prohibit the department from working with another State agency or an additional third-party entity to establish veteran-owned business verification.

(e) Notice.--Within 10 days of the creation of a logotype under this section and the establishment of the criteria necessary to use and display the logotype and the applications and instructions on how to complete and submit an application, the department shall post on a publicly accessible Internet website of the department, a notice that:

(1) The logotype under this section is available to an eligible business.

(2) Includes the criteria necessary to receive a license to use and display the logotype and allows for access to the applications and instructions on how to complete and submit the applications.

(f) Issuance.--Except as provided under section 9623, the department shall issue a license to use and display the logotype to an applicant deemed eligible under subsection (c).

(g) Fee.--

(1) An initial fee of \$250 is established for the issuance of a license to use and display the logotype.

(2) A renewal fee of \$100 is established for each subsequent license renewal terms.

(3) Fees collected under this subsection shall be used as follows:

(i) Fifty percent of the fee shall be transferred to the Veterans' Trust Fund.

(ii) Fifty percent of the fee shall be used for administrative costs.

(4) If a nonprofit membership association is chosen under section 9623, the nonprofit membership association shall:

(i) collect the fee under this subsection;

(ii) transfer 50% of the fee quarterly to the department for disposition under paragraph (3)(i);

(iii) retain 50% of the fee for administrative costs; and

(iv) annually submit an audit to the Auditor General of the fees collected, transferred and retained under this paragraph.

(5) The department shall adjust the fee amounts under this subsection every three years to reflect any upward changes in the Consumer Price Index for All Urban Consumers for the Philadelphia-Camden-Wilmington, PA-NJ-DE-MD area in the preceding 12 months and shall transmit the adjusted fee amount to the Legislative Reference Bureau for publication as a notice in the Pennsylvania Bulletin. The fee shall be adjusted by multiplying the annual fee amount by any percentage increase to the Consumer Price Index for All Urban Consumers for the Philadelphia-Camden-Wilmington, PA-NJ-DE-MD area, rounded to the nearest \$10. The resultant product shall be added to the fee amount, and the sum shall become the new annual fee amount under this subsection.

(h) Penalty.--

(1) An individual commits a misdemeanor of the third degree if the individual fraudulently holds the individual out to be a veteran for the purpose of obtaining a license or using a logotype under this subchapter.

(2) Notwithstanding any other provision of law, the full amount of each fine collected for a violation of paragraph (1) shall be deposited into the Veterans' Trust Fund.

(i) Report.--By March 31st of each year, the department shall prepare an annual report on the number of veteran-owned businesses issued a license to use the logotype, the annual applications and renewals of the license to use the logotype and the administration fees collected during the preceding year. A copy of the report shall be sent to the Veterans Affairs and Emergency Preparedness Committee of the Senate and the Veterans Affairs and Emergency Preparedness Committee of the House of Representatives.

§ 9623. Nonprofit membership association.

The department may, except for section 9622(d) (relating to veteran-owned business logotype), contract with a nonprofit membership association to perform the duties and responsibilities under section 9622.

Senator MARTIN. Mr. President, I rise today to speak on Senate Resolution No. 118--sponsored by Senator Corman, Senator Pittman, and myself--to honor and congratulate the Penn State University 2021 Wrestling Team on its second place finish at the NCAA Division I National Wrestling Championship. We celebrate the respective individual wins of several members of that team and also recognize all of the wrestlers who competed in this championship tournament who hail from Pennsylvania.

As mentioned in our resolution, four of the Penn State wrestlers, Roman Bravo-Young, Nick Lee, Carter Starocci, and Aaron Brooks, won individual NCAA titles in their respective weight classes while also earning All-American distinctions. In addition to these personal achievements, the Nittany Lion Wrestling Team sent the most wrestlers of any team to the finals and ultimately saw the most individual champions going 4 for 4.

Mr. President, it is no secret that Pennsylvania has a rich history of wrestling, and that is exemplified by looking at the fact that we saw so many Pennsylvania natives participating in the tournament. Of the 330 wrestlers who competed in this tournament, 50 hailed from Pennsylvania. I would like to acknowledge and congratulate those outstanding wrestlers on their achievements during the NCAA Division I Wrestling Championship. In particular, I want to congratulate Spencer Lee and Michael Kemerer, both from Murrysville; Sammy Sasso from Nazareth; Jake Wentzel from South Park; Trent Hidlay from Lewistown; and Nino Bonaccorsi from Bethel Park for their respective first and second place wins in the tournament.

Mr. President, I ask my colleagues to join me in celebrating and congratulating these young men on their outstanding efforts both on and off the mat, as well as head coach Cael Sanderson and the rest of his coaching staff and to wish them the best of luck as they enter the 2022 season.

Senator PITTMAN. Mr. President, I rise to echo the comments of my friend and colleague, Senator Martin, and would like to specifically express congratulations to Mr. Spencer Lee, a graduate of Franklin Regional High School and a former resident of Murrysville. Spencer was actually here in the Capitol a few years ago to be recognized along with the entire Franklin Regional team. His success is quite extraordinary. Spencer is a three-time individual NCAA champion, first securing a championship as a true freshman. He is a winner of the Hodge Trophy award and has served as a very distinguished young man in his career. While he played for the University of Iowa, we will not hold that against him, instead we will embrace and thank him for his success in what he has brought to Pennsylvania. I, too, would

like to thank Senator Martin for this proposed resolution and express my congratulations to Mr. Spencer Lee as well.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, today marks 5,461 days since the Pennsylvania legislature last raised the minimum wage. That is almost 15 years, and it is far too long.

Mr. President, we are now less than 3 weeks away from reaching a terribly dubious and bleak milestone in the history of the Commonwealth and in pursuit of a fair, family-sustaining minimum wage. July 9 will mark the 15th anniversary of the last time we raised the Pennsylvania minimum wage. This is the longest we have ever gone without raising the rate. On July 9, 2006, Governor Rendell formally signed Act 112 into law, which raised the minimum wage from \$5.15 an hour to \$7.15 an hour. It took an act of Congress 3 years later to raise our minimum wage another 10 cents to the current level of \$7.25. But the Leadership of the General Assembly has denied our attempts to ensure that all Pennsylvania workers, especially those on the low end of the pay scale, are paid fairly, relative to economic growth, and the value they provide to their employers.

With the conclusion of yet another fiscal year at hand in the coming days, I want to explain why my current minimum wage legislation, Senate Bill No. 12, is vital to the Commonwealth as we strive to recover from our devastating pandemic and fix our dysfunctional labor market. Senate Bill No. 12 is more than just a \$15 minimum wage bill. It includes many components that address our most needed labor market reforms. One of those elements is the elimination of the antiquated sub-minimum wage for tipped earners. Simply put, the tipped minimum wage is a moral and functional failure. Now, in the wake of the pandemic, with so many hospitality and leisure businesses scrambling to find help, we are seeing why the tipped minimum wage should be discarded.

The tipped minimum wage is a relic from the post-Civil War era in America, when industries that commonly employed formerly enslaved people—largely restaurants and railroads—encouraged tipping so they did not have to pay Black employees directly. Instead, workers made their money, or the lion's share of it, from tips. They still do, even today, 159 years after the Emancipation Proclamation and 156 years after the last slaves were freed in Galveston, Texas, an event we now commemorate in our newest national holiday, Juneteenth. Federally, the tipped minimum wage is just \$2.13 an hour and has been since 1991. That is 30 years ago. Pennsylvania's rate is not much better at \$2.83. This is bad for workers and for customers. Customers are forced to pay the difference between the tipped minimum wage and the regular minimum wage. In Pennsylvania, that means customers pay \$4.42 of every worker hour while employers pay only \$2.83. If business is slow and the worker is not generating enough tips, then the employer is responsible for paying the difference. But we all know what happens in those situations. The employer simply tells the worker to go home for the day, in which case nobody wins.

Mr. President, therein lies one of the fundamental economic failures of the tipped minimum wage. A weakness that has been vividly exposed by the pandemic. Tip income can be woefully unreliable. Workers are at the mercy of ebbs and flows in the marketplace and the whims of individual customers. If an em-

ployer decides to rearrange the work schedule and an employee ends up with an unfavorable shift, their monthly personal expenses do not change. They still must find a way to pay for food, housing, transportation, healthcare, education, child care, and many other necessities. With each passing year, more and more American workers are ending up in this situation. For example, prior to the pandemic, employment in the full service restaurant industry was growing incredibly fast. Between 1990 and 2014, it grew by 85 percent, compared to the 24 percent growth for all private sector employment. It is yet to be determined whether this trend will resume in the post-pandemic year, but as we in Pennsylvania navigate a new course for the future, one that will finally enable many of our lowest paid workers to shed the shackles of our ignominious national past while we recalibrate our wage structure to fulfil the economic needs of the present. Mr. President, I urge my colleagues to advance and adopt Senate Bill No. 12 and thereby end the tipped minimum wage in Pennsylvania.
