The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Montgomery, Senator Muth.

Senator MUTH. Mr. President, my amendment would simply add additional members to the Motor Carrier Safety Advisory Committee, who would help implement better policy that would be more effective. The Motor Carrier Safety Advisory Committee does important work to ensure the safe operation of motor carriers across our Commonwealth. While the current bill does add important perspectives to the membership of this advisory committee, there are additional motor safety concerns and rules that could be at the table. My amendment would add one representative of a manufacturer of an alternative fuel-powered commercial vehicle, one person who represents the Hazardous Materials Response Team, and two representatives of organized labor who represent a commercial vehicle driver or operator. The additions to the Motor Carrier Safety Advisory Committee contained in my

amendment are helpful to developing policies for this advisory committee. If it is a safety advisory committee, you would think that someone who had hazardous materials experience, especially when accidents occur along the roadways of the Commonwealth, and also with the increased use of electrical vehicles--which fire-fighters actually have to have special training to learn how to put out fires relative to electric vehicles because they are so difficult to contain--and also having people at the table who actually drive and operate commercial trucks seems to make sense to me. But unfortunately, I do not believe this amendment is agreed to, although I still ask for an affirmative vote on my amendment.

Thank you, Mr. President.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Westmoreland, Senator Kim Ward.

Senator K. WARD. Mr. President, it is my understanding that there are already positions on the advisory committee that would cover the concerns of the maker of the amendment. So, I ask for a "no" vote. Thank you.

The PRESIDING OFFICER. The Chair recognizes, for the second time, the gentlewoman from Montgomery, Senator Muth.

Senator STREET. Mr. President, this amendment simply lifts a deed restriction on the property located at 900 North Broad Street, prohibiting the operation of a homeless shelter in the building. The building was originally owned by the Commonwealth but was conveyed to a private owner in 1974. A record search indicates that at all times since its conveyance, the building has housed various types of residential treatment programs. Because the building has consistently been used for residential services with the full support of the community, DGS supports the rescinding of this restriction. I ask for an affirmative vote on this amendment.

MOTION TO PROCEED TO SPECIAL ORDER OF BUSINESS TO CALL UP DISCHARGE RESOLUTION No. 2, DEFEATED

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I move that Discharge Resolution No. 2, discharging the Committee on Judiciary from further consideration of Senate Bill No. 134, Printer's No. 107, be called up for consideration.

The PRESIDING OFFICER. Senator Costa moves that Discharge Resolution No. 2 on today's Calendar be considered as a Special Order of Business. For the information of the Members, debate on this motion is very limited. Debate is not on the merits

of the resolution or the underlying bill, rather debate is limited to whether to take up the Discharge Resolution.

On the question, Will the Senate agree to the motion?

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Fontana.

Senator FONTANA. Mr. President, this motion is vital at this time for the citizens of our State. Coming off a weekend when there was a bipartisan agreement announced in Washington on gun control, should we not also follow that example and act? Why not, Mr. President? Let the process play out here in the Senate, where both sides get to debate their views on gun reform legislation. Why not bring these bills, like Senate Bill No. 134, up for a vote? When are we going to start working together on these bills? I think it is time. It is time because of the safety, for the safety measures of Pennsylvania residents.

Mr. President, if we prevented one murder, one massacre, by passing this legislation, is it not worth it? I think it is. You know, 86 percent of Americans across this country, and across party and demographic lines, support red flag laws. The people of Pennsylvania want us to work together on this issue.

POINT OF ORDER

Senator K. WARD. Mr. President, point of order. Senator FONTANA. Nineteen other States and the District-Senator K. WARD. Point of order.

Senator FONTANA. -- of Columbia have enacted these types of laws.

The PRESIDING OFFICER. Will the gentleman suspend? Senator Kim Ward with a point of order.

Senator K. WARD. He is debating the merits of the underlying bill at this point, and I think that is out of order.

The PRESIDING OFFICER. Yes, the gentleman is reminded that debate on the motion--and the motion is for a special order of business--is very limited. Debate is not on the merits of the resolution or on the underlying bill, rather the debate is limited to the special order of business of whether or not to take up the discharge resolution. The gentleman may continue.

Senator FONTANA. Mr. President, I have not mentioned anything about the bill itself, but on the motion itself, and why it is relevant or very important that we consider it, I think, is what I am talking about. I mean, there are so many statistics out there that say that a bill like this should be heard, and that is what we are doing. We are making a motion to hear that bill. So why should we not talk about the statistics, like 19 other States have it? What is wrong with mentioning something like that? How many more lives need to be lost before we start working in a bipartisan fashion?

POINT OF ORDER

Senator K. WARD. Point of order, Mr. President. Senator FONTANA. That is what this is, working together. Senator K. WARD. Point of order, Mr. President.

The PRESIDING OFFICER. The gentleman will suspend. Senator Kim Ward, point of order.

Senator K. WARD. My colleague across the aisle has gone beyond whether or not this is a special order of business. He is getting into the details of the bill. Thank you.

The PRESIDING OFFICER. The Chair does agree that we are venturing well beyond the motion for the special order of business and getting to the merits of the underlying bill. Again, the motion is on the special order of business, calling up the discharge resolution. The Chair would ask the gentleman to confine your remarks to the motion.

Senator FONTANA. Mr. President, it is about the timing.

The PRESIDING OFFICER. Does Senator Anthony Williams have a point of order?

Senator A.H. WILLIAMS. Mr. President, can you be specific as it relates to what parameters are to be discussed? The gentleman is talking about motivation. He is not discussing the bill. So, for the benefit of the Members who may speak, we do need what that actually means.

The PRESIDING OFFICER. Again, as the Chair stated, the debate on the motion is very limited. Debate is not on the merits of the resolution or the underlying bill, rather the debate is limited to whether or not to take up the special order of business, the discharge resolution. Reading directly from Mason's Manual, a motion to set a special order is debatable only as to the question of setting the special order and does not open the main question to debate. So, again, it is debatable only as to the question of setting the special order, and I would ask the gentleman to continue to confine his remarks to the reason for calling up Discharge Resolution No. 2 as a special order of business.

The Chair recognizes, for the second time, the gentleman from Philadelphia, Senator Anthony Williams.

Senator A.H. WILLIAMS. Mr. President, so, for the layperson, opening up is relegated to defining the purpose of the vote or simply the process? That, I think, frankly, is very important to all of us who may make comments going forward while respecting the rules. But the comments, the reflections which are provided to us, do not necessarily say that you are not allowed to say X, Y, and Z about the desires or the needs.

The PRESIDING OFFICER. Yes, just to restate for the gentleman, from the Mason's Manual, as well as past precedent of the Senate, that a motion for a special order is debatable only as to the question of setting the special order and not to the main question of the debate. So, yes, the debate is centered on the process of the motion for a special order of business.

Senator A.H. WILLIAMS. Thank you, Mr. President.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Fontana.

Senator FONTANA. Mr. President, on the process, if that is what we are talking about, this is a process, right? This is one of our processes that we think is timely and appropriate to bring this particular bill up for a lot of reasons that I can state at this time. It is something that we should be considering. We should have considered it a long time ago, but here we are going by the process that has been set up, which is the discharge resolution and the motion to bring it up. We are bringing it up for the reasons that we feel are very timely and appropriate for what is happening not only in this State, but in this country.

So, it is time that we acted on these types of bills, debated them, and brought them up through committee onto the floor of this Senate. They did it in Washington. We should act in a bipartisan way. Why not do it here? That is the process that you are talking about. Let us do it, get it done, have that debate, and talk about it. It is for the good of all, not just Democrats or Republicans, it is good for all the citizens here in Pennsylvania. Let us get it done, Mr. President.

Senator K. WARD. Mr. President, I request a legislative leave for Senator Martin.

The PRESIDING OFFICER. Senator Kim Ward requests a legislative leave for Senator Martin. Without objection, the leave will be granted.

LEGISLATIVE LEAVE CANCELLED

The PRESIDING OFFICER. Senator Dush has returned, and his temporary Capitol leave is cancelled.

And the question recurring, Will the Senate agree to the motion?

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Westmoreland, Senator Kim Ward.

Senator K. WARD. Mr. President, there is a committee process, and this goes around the committee process, so, I am asking for a "no" vote. Thank you.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I did not intend to speak after the Majority Leader, but there is a committee process. That is precisely the problem. We cannot get anything done in the committee process. That is why the rules of this Senate provide for discharge petitions after so many days in the committee where nothing happens. That is why we are here today with this discharge petition and every other discharge petition we put on the Calendar today. That is precisely the problem. The process you just described does not allow us to bring our voices to the table to discuss these matters. It is incomprehensible that we cannot talk about these issues, especially right now when Washington D.C.--the place where they can never agree on anything--they come together and agree on modest gun reform measures, including this particular measure, this one, and they say to us, we are going to let you States determine how it should be done. That is what we are here for, to be able to address those types of things. That is why the gentleman from Allegheny County wants to advance this measure.

POINT OF ORDER

Senator K. WARD. Point of order, Mr. President.

The PRESIDING OFFICER. The Chair recognizes Senator Kim Ward for a point of order.

Senator K. WARD. My colleague is going beyond whether or not we should be using this discharge resolution as a special order. The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I will be very brief. The Majority Leader brought up the word "process" and that there is a committee process. I wanted to make sure the public and every Member in this room understands that this discharge petition process is something that is called for in our rules and allows us this opportunity, exactly when the committee structure does not do anything. But that all being said, I ask for an affirmative vote.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Mr. President, I rise in support of the bill before us. Lead poisoning has been a matter of concern and emphasis for Members of this body on both sides of the aisle. Several years ago, Senator Yudichak prompted a study by the Joint State Government Commission to look into the risks and sources of lead poisoning. We also had a task force focused on the issue. This serious health problem was underreported and poorly understood. We have long known the health and environmental hazards of lead, eliminating its use in products ranging from paint to gasoline. Still, there remain many legacy issues that have not been eliminated or remediated. Lead poisoning is entirely preventable. If children are properly screened and positive cases determined, sources can be found and eliminated. Yet only one quarter of our children are currently being screened in Pennsylvania. This is entirely unacceptable when 9,000 cases per year are found, even with the low level of testing we are doing.

Lead poisoning can have devastating consequences. Risks include severe, irreversible neurological and developmental disabilities. It is hard to imagine the pain and costs to families. While we have heard stories about lead dust and paint chips containing lead in older homes, the sources of lead poisoning can be something we do not ordinarily suspect, in some cases, certain children's toys. So, two primary recommendations for preventative steps include a universal blood screening for children and assessing and testing pregnant women, as needed. Over the past several months, my staff and I have worked with various State agencies, health officials, and insurance providers to develop a screening system and a timetable that offers a comprehensive solution to the lead poisoning problem. With these parties invested in the effort, we can hope for a quicker rollout once this bill does become law. There have been many who have made good faith contributions to this measure, and I appreciate all that they have done. I want to commend the cooperation and the spirit that leads to the point of action today, and I urge an affirmative vote on Senate Bill No. 522.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Montgomery, Senator Haywood.

Senator HAYWOOD. Mr. President, I rise in full support of this legislation, and I would like to briefly share my experience in Flint, Michigan. Several years ago, I visited Flint when they were in the midst of the water crisis. I met with the mayor and several citizens in several locations in Flint, and we saw bottled water all over major streets where individuals were driving up to get water so that they would have clean water for drinking, showering, and other water uses. It was that direct experience in Flint that made it crystal clear to me that we here in Pennsylvania and across the nation need to do all that we can to make sure that our children and adults are not victims of lead poisoning. During my time in Flint, I also learned about the serious developmental disabilities and deficiencies that young people have once they have ingested lead, and that is for long-term loss of mental capacity. So, it is for these reasons that I fully support this legislation and doing all that we can to make sure that our young people, as well as older, do not ingest lead for their health.

Thank you, Mr. President.

PETITIONS AND REMONSTRANCES

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Montgomery, Senator Cappelletti.

Senator CAPPELLETTI. Mr. President, I rise today to advocate for passing good government reforms at the beginning of our next legislative Session. These reforms will pave the way for a functional legislature that can pass solutions to the problems our constituents are asking us to solve. At the beginning of this legislative Session, I joined colleagues to introduce a package of 14 resolutions aimed to update and reform Senate rules to promote bipartisanship in our legislature. Currently, the Majority party has the power to determine which legislation moves through committee, which bills get a committee hearing, and which bills move on the floor. This system has no incentive for us to work together. It has led lawmakers in Harrisburg to be distracted by partisan games when we could be focusing on bettering the lives of the people we represent.

One example of this happened in the Pennsylvania House today, where bills move similarly to how they do here in the Senate. In an effort to create a bipartisan opportunity to address and tackle the growing statewide issue of gun violence, House Democrats introduced discharge resolutions to give the House Committee on Judiciary a chance to debate and vote on bills that would enact reasonable measures to keep our communities safer from the threat of gun violence. Instead of dealing with these bills, the Majority party rereferred the four bills to a committee that is not really the right one to deal with them in an effort to circumvent these checks and balances. This theme of trying to circumvent checks and balances for political ends is further exemplified by the avalanche of constitutional amendments that have been introduced this Session. Since the last 2-year Session began in January 2021, Democratic and Republican legislators have proposed more than 70 changes to our State Constitution. This is not a sustainable way for us to legislate. This process also eliminates the gubernatorial oversight and results in these constitutional amendments showing up as questions on the ballot during low-turnout elections, meaning we are changing our Constitution with the smallest number of Pennsylvania citizens participating in that process.

As we look forward, I encourage everyone to consider these reforms that will better our legislative process and provide us with real results for the Pennsylvanians who elected us to be here.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Fontana.

Senator FONTANA. Mr. President, this morning I woke up very hopeful, coming off a weekend when a bipartisan agreement was announced in Washington on gun control. My feelings were further elevated when the Pennsylvania House scheduled to consider several bills on this matter, including a version of my Senate

Bill No. 134: extreme risk protection order. However, those feelings quickly sank when the House Committee on Judiciary motioned to rerefer those bills to the Committee on Local Government. What do you think is up with that? I am not sure. Well, maybe I am sure. It is a clear sign, I think, that the Majority party is not interested in working together. In fact, this is a clear sign that Senate and House leaders will do whatever is possible to continue to silence those who do not share the same views as themobiously, with the process here this afternoon.

But I have to ask, why not let the process play out here in the Senate, where both sides get to debate their views on gun reform legislation? Why not bring these bills, like Senate Bill No. 134, up for a vote? When are we going to start working together for the safety of all Pennsylvanians? After all, this legislation is not about taking away guns from lawful citizens, it is about temporarily taking the guns away from those who already have a gun and have a mental illness and those who may be a threat to themselves and others. An extreme risk protection order can only be achieved after a hearing takes place before a judge, where all parties get to present their sides; that is due process.

Mr. President, if we can prevent one murder, one massacre of our children and others, is it not worth it? Just one? Eighty-six percent of Americans across party and demographic lines support red flag laws. Again, the people of Pennsylvania want us to work together, especially on this issue. Nineteen other States and the District of Columbia have enacted these types of laws. How many more statistics will it take before our voices are heard? How many more lives need to be lost before we work in a bipartisan fashion? Are we not better than this? It is time to debate and vote on Senate Bill No. 134. It is clear that, unlike Washington, the Pennsylvania legislators are not looking for compromise, even though our constituents are begging us on all sides to come to the table. I had a constituent email me, and her statement was something like: you know, it appears that Democrats are trying to protect children, but the Republicans seem to only want to protect guns.

Thank you, Mr. President.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, very briefly, to build upon what my colleague from Allegheny County talked about with respect to these emergency risk protection orders, I think we need to recognize, while the belief is that it is centered around these mass shootings, school shootings, supermarket shootings--I can go on, right, synagogues, churches and the like--we have to also recognize that one of the biggest things that occurs is with respect to suicides, suicides with our young adults and veterans. We hear that so frequently, the number of veterans we lose every single day around this country, and the number of young folks who are dealing with the situation as it relates to COVID-19, the impact of COVID-19 on the students and young adults, and how many take their lives by using weapons. The goal here is to recognize those individuals who are facing a crisis and be able to make certain that we remove, temporarily from that situation, the weapon that could end their life, particularly as it relates to these individuals.

So, when we talk about the need for this legislation, while it is critically important for us to talk about the incidents that have already occurred, we also need to recognize as we go forward access to weapons as it relates to young adults and our veterans who commit suicide at a high rate as we know it today, and we talk about it all the time. This is one of the things that could prevent that, or at least diminish the numbers that we are talking about in this space. So, I applaud my colleague for speaking today on this really important subject, and it is one of the issues that we are going to continue to talk about over the course of the next 3 weeks.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, on behalf of Senator Tartaglione, I would like to submit these remarks for the record during petitions.

The PRESIDING OFFICER. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentleman from Allegheny, Senator COSTA, on behalf of the gentlewoman from Philadelphia, Senator TARTAGLIONE:)

Mr. President, I rise because today marks 5,818 days since our Commonwealth's legislature last passed an increase in Pennsylvania's minimum wage. I, for one, Mr. President, think our failure to act is unconscionable. We must move to provide relief to our Commonwealth's lowest earners.

Just a few hours ago, the senior Senator from Florida, Marco Rubio, put a tweet out saying: "When people who work full time can't afford food, clothes, housing, and gasoline the people in charge of government should be spending most of their time focused on that." It may not happen often, Mr. President, but I wholeheartedly agree. The people in charge of our governments can and must do more. We have the opportunity, right now, to pass Senate Bill No.12, bring it out of committee and to the floor so that we can raise our minimum wage and ensure people are able to afford food, clothes, housing, and gasoline, as the good Senator suggested.

We have the opportunity to put Pennsylvanians on the path to \$15 an hour and earn a wage they can survive off of by putting food on their tables and roofs over their families' heads. As we come into Session for another week deliberating how to spend billions of dollars on projects and programs around Pennsylvania, we must not run the risk of losing sight of ways we can directly and immediately help the people of Pennsylvania.

Mr. President, the time to act is now. We can and must pass Senate Bill No. 12 for the people of Pennsylvania who need it most.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Philadelphia, Senator Anthony Williams.

Senator A.H. WILLIAMS. Mr. President, I would be remiss if I did not provide comments representing Philadelphia and Delaware County, where we have unfortunately received continuing levels of homicides and shootings. Most notably, the mass shooting on South Street in Philadelphia has drawn the nation's attention to Philadelphia in non-positive ways. So, today, I was hopeful that we as a body would acknowledge that if the most divided legislative body in America—that is the U.S. Senate—can resolve itself to work in a bipartisan way that acknowledges that whether you are a Democrat or Republican, the overwhelming majority of Americans—whether you are a member of the NRA or not—believe that there is a place and a space where we can reform the gun policies in America without threatening the Second Amendment, without making us less safe, but acknowledging that there are some people who should not be in possession of a gun; that

there are rules that we can do something about to control that. To come to the Senate and realize that we sit in a State that has had some of the heaviest bloodshed because of illegal guns in the country--that our cities, whether they are Harrisburg, York, Philadelphia, or Pittsburgh, whether a rural county that has had extraordinary numbers of suicides--that we, as a body, still sit on the island that is separate from the norm; that we will deny the obvious; that the majority of people in Pennsylvania, when asked the question: should we and can we do more to reform gun laws in Pennsylvania? They overwhelmingly say, yes. For some reason we are so disconnected in our politics that we bring the old script of ways that are in the past to the floor today to the point of where we do not even want to acknowledge that we can publicly talk about it. Understand what happened today, because I am sure that many people watching do not necessarily know what a discharge resolution is. It is a mechanism that forces a bill to the body to vote upon. Now, it does not remove the Member's ability to vote. The Members still have the right to say "yes" or "no," but because we are so stuck in the past, we chose not to even debate it.

Now, I do not know about you, but I have heard a lot about transparency, letting the public decide, and defending democracy. All of those things are hallmarks of political conversations today. Well, today was a shameful moment. If that is the standard, if that is the political rhetoric--whether you are Democrat or Republican--to cease and not even allow discussion about a bill is an embarrassment to this institution. Regardless of how you would have voted upon the bill--and there are arguments on both sides that are legitimate--but to not even allow for the discussion to occur lacks courage, vision, transparency, and most importantly, is not patriotic nor democratic. I can only tell you and apologize to those Pennsylvanians who are watching us today--pretend like we are doing the people's business--that we failed you today. We came woefully short. We did not honor the history of this Commonwealth, the bravery of its founders, and the vision of those who do believe in the Second Amendment and what it really was meant for. My hope is that, upon reflection, those of you who are watching will call all of us and say, shame on you. Whether you are a Democrat or Republican, shame on you. You need to get back to the people's business and find a way to resolve this to correct the standard in Pennsylvania.
