Senator MUTH. Mr. President, the current draft of Senate Bill No. 907 establishes a board called the Animal Welfare Board to meet at least one time during the legislative Session to review Pennsylvania's animal-related laws and make recommendations for legislative and regulatory changes. While this may sound like a good idea--because yes, I am, and I am sure all of you are concerned about the welfare of animals--but as currently written, the board would have a majority composition of organizations that have no expertise or knowledge of the laws that the board would be reviewing and limited representation from members of organizations who work with animal-related statutes on a daily basis.

Mr. President, my amendment would change the composition of the proposed Animal Welfare Board to better represent the organizations and interests of those who work with animal-related statutes on a daily basis by removing the following entities: the Northeast Beagle Gundog Federation; the Pennsylvania State Grange; the Insurance Federation of Pennsylvania; and the PennAg Industries Association, and would add members representing the Humane Society of the United States, who would reside in the State of Pennsylvania, and one additional member from the Federated Humane Societies of Pennsylvania, one of which must employ a humane society police officer. It would also clarify that the member representing, as I said, the American Kennel Club, would live here in our Commonwealth. Lastly, my amendment includes a sunset provision of 2 years from the effective date to issue a report to the General Assembly.

Mr. President, these are commonsense additions to any board that is tasked with representing the interests of actual animals and the laws written to better protect their welfare. This amendment language was offered by stakeholders and written by stakeholders who have the best interests of animals and their welfare. I ask my colleagues for an affirmative vote to this commonsense change to make this legislation truly impactful.

PETITIONS AND REMONSTRANCES

THURSDAY, JUNE 23, 2022

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Chester, Senator Comitta.

Senator COMITTA. Mr. President, I rise today to support protecting some of the smallest but most important creatures of our world, our pollinators. Birds, bats, bees, butterflies, moths, beetles, and other small animals that pollinate plants are responsible for bringing us 1 out of every 3 bites of food. They also sustain our ecosystems and support our natural resources by helping plants reproduce. This week marks Pollinator Week, an important opportunity to raise awareness of the vast contributions of pollinators and the urgent need to protect them from pollution, pesticides, climate change, and other threats. These tiny creatures have a mighty impact.

According to the Pollinator Partnership, somewhere between 75 and 95 percent of all flowering plants on Earth need help with pollination; they need pollinators. Pollinators provide pollination services to over 180,000 different plant species and more than 1,200 crops. Pollinators add \$217 billion to the global economy, and honeybees alone are responsible for billions of dollars in agricultural productivity in the United States.

In addition to the food we eat, pollinators support healthy ecosystems that clean the air, stabilize soils, protect from severe weather, and support other wildlife. I have introduced a legislative package aimed at protecting pollinators and supporting their habitats in Pennsylvania. Senate Bill No. 1249 and Senate Bill No. 1250 call for establishing a program to create native grass and perennial wildflower-filled habitats along our State highways to support the migration of pollinators and letting Pennsylvanians support the program by purchasing pollinator license plates.

In addition, while we are talking about the contributions of insects and insect life, I want to point out that this week also begins the annual Lights Out for Lightning Bugs campaign. The firefly is our State insect, and scientists believe the world is losing firefly populations. One reason is, simply, light pollution. When fireflies are blinded by lights or their flashes are overpowered by extensive and prolonged light intrusion, they cannot find a mate, and the next generation is lost. So, to help the fireflies--the lightning bugs--find each other, Pennsylvanians are asked to turn off or to shade their outdoor lights, at least for this week. Watching fireflies twinkle and light up a summer evening is a magical experience, one that evokes childhood memories for many of us. Let us do our part to help ensure that our children and grandchildren can share in that experience by taking one simple step to protect fireflies, other insects, and all of the pollinators in Pennsylvania. Thank you.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Montgomery, Senator Cappelletti.

Senator CAPPELLETTI. Mr. President, today I rise to inform all of my colleagues that June is National Great Outdoors Month, and as residents of this Commonwealth, we have access to over 300,000 acres of outdoor, recreational activities. From parks to waterways, there are so many positive benefits to exploring what Pennsylvania has to offer. For example, exploring our natural lands offers plenty of positive benefits to our actual, physical well-being. A brisk walk on the Schuylkill River Trail or kayaking down the Delaware can assist with physical health benefits such as weight management and lowering blood pressure; emotional benefits such as reduced anxiety and depression; and intellectual benefits such as increased confidence, improved creativity, and better self-esteem. Finally, it is a great social activity to do with our friends and family.

The most important benefits, perhaps, are the economic impacts of the great outdoors. Overall, the outdoor industry generates \$689 billion in consumer spending and 4.3 million jobs nationally. In Pennsylvania, it generates \$11.8 billion and contributes to 146,127 jobs. In fact, earlier this month, I had the distinct pleasure of going to Clinton County to learn more about ATV tourism and even had the opportunity to take a ride and explore our trails. It is an economic driver in some of our more rural communities, and it is a growing industry.

However, the outdoor industry absolutely relies on a healthy and safe environment in order to thrive. Without healthy lands and waterways, our outdoor economy will suffer, as will our public health. As we work our way through budget season, it is important to prioritize efforts that will guarantee the health of our natural lands and increase access to green spaces. One such piece of legislation that would conserve our natural lands is Senate Bill No. 525, otherwise known as Growing Greener III. Part of an ongoing effort since 1999 to preserve our natural lands, this vital piece of legislation would establish a framework for a Growing Greener program to preserve and protect our natural lands, waterways, forests, and other natural resources. By investing in this critical framework, we are investing in our future generations.

Another piece of vital legislation is Senator Schwank's bill to impose liability on owners and operators of pipelines that may harm our public, and even private, water supplies. As our natural waterways are public domain, it is only right that the general public has access to healthy and clean water. Should a consumer see that their waterways have been polluted or disrupted, they should have the right to report it to the DEP and request an investigation. Once an investigation is conducted, and if DEP determines that the pipeline is liable, the owner or operator must restore or replace that water source.

Finally, another critical piece of legislation that would preserve our natural lands is Senate Bill No. 872, or Go 100 PA, something that I share with Senator Muth. Go 100 PA would establish a bureaucratic framework to transition this Commonwealth to 100 percent renewable energies by 2050. I may be slightly biased when it comes to this legislation, but I do believe that by investing in clean energy, we are investing in our futures. If our public health is suffering, there is no doubt that our natural lands are suffering as well. So, if one of your ways to de-stress after a long Session day is to take a walk along the Susquehanna River, I strongly encourage you to bring these pieces of legislation to the floor for a vote. Our natural lands cannot be salvaged

once they are gone, so let us work together to preserve what we have.

Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise today because it marks 5,825 days since this legislature last passed an increase in our State's minimum wage. Mr. President, as we draw closer to July 9, we move close to 16--yes, 16--years since Pennsylvania's minimum wage was increased by our own doing. Fifteen years, 11 months, and 11 days of inaction and ignoring the problem has hurt Pennsylvania's workers and families, but we have a chance to do something. Right now, in the Committee on Labor and Industry, Senate Bill No. 12 is waiting for a vote that, if held today, I am confident would pass. This issue is not just a moral issue of paying people a dignified wage for the work they do.

Mr. President, when I travel my district, I hear about two things consistently: drugs and violence and how we must take action on our minimum wage. I do not see them as separate issues, Mr. President. If people are not earning a livable, dignified wage, they will turn to other means of making ends meet. People will resort to desperate measures to survive desperate times. We hear consistently after a mass shooting and other tragedies that it is not the gun's fault; it is the systemic issues that are causing those things to happen. Well, Mr. President, we can address one of those issues right now. We have the chance to help lift families out of poverty and prevent people from making the regrettable decision to turn to drugs or violence to survive. I hope we continue the conversation around violence and gun violence prevention. We can pass Senate Bill No. 12 as well to help address some of the underlying causes of violence that plagues our communities. Mr. President, let us pass Senate Bill No. 12. Thank you.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise today to continue to talk about some of the major initiatives Senate Democrats have been pursuing and will continue to pursue over the course of the past several weeks, but also moving forward the last several days. For the benefit of my colleagues and folks who are watching, I want to reiterate some of the spaces that we have been working in and trying to advance legislation to be able to enhance the quality of life of people here in Pennsylvania. One of the areas that we heard a lot about and advocated quite a bit for on this Senate floor was gun reform measures. There is a series of gun reform measures that we have talked about here to the point where we have even introduced discharge petitions to try to dislodge many of these measures out of the committee and onto the Senate floor for a vote by this Senate. We have not been able to achieve those goals, but at the end of the day, we are going to continue trying, and later this week we will do the same thing.

The other areas we talked about, which I think we are starting to get some traction on with respect to bipartisan support, relates to investments. Investments in mental health programming, particularly mental health programming in our communities, to ensure we are providing resources through this budget process to put dollars into our communities, so they are able to combat some of the mental health problems and concerns that people are dealing with on a regular basis. Similarly, it relates to mental health issues that are taking place in our school districts across

Pennsylvania. School safety and security programs this General Assembly passed, and this Caucus supported many initiatives, particularly the part that talks about putting resources behind school counselors, psychologists, psychiatrists, and the like. A lot of school districts that are opting for those proceeds are looking to do that. What we have in place right now is simply not enough. We need to make significant investments along those lines. That is something that we have been advocating for a while and will continue to advocate for. Senate Democrats also believe that we need to put resources and expand the resources over and above what we have done in years past to places in our community to try to prevent violence that has taken place in our communities. Community violence prevention programs are needed to be able to get those dollars into the community, make those investments, and allow those folks who are working in that space to be able to operate.

Finally, Mr. President, we have talked quite a bit about women's reproductive rights, and we know what we may be seeing tomorrow, or maybe on Thursday, if the Supreme Court makes a decision. We are going to continue to talk about that issue as well; how imperative it is that we take steps to protect women's rights to make their own choices about their own bodies. At the end of the day, that is the series of things we are working on right now. Given where we are today, in this last week, our final days of our budget process, where we have an opportunity to redirect and drive out investments and resources maybe totaling \$10 billion that we have available to us here in Pennsylvania, we believe that we need to connect with the people of Pennsylvania and drive out resources to those men and women in this Commonwealth; to be able to provide them the support they need to meet the demands of what they are dealing with on a regular basis, whether it be gas prices, prices as it relates to food that they are purchasing, all those types of things. Folks need resources, and they need access to them. When you frame it against what we did here last week, when we voted on two corporate net income tax reductions for the business community, we have not done anything on the other side of the equation to support what needs to be done to work with families across Pennsylvania. That is what we are going to be advancing, and that is what we are going to be advocating here today as we go forward the next several days here in the Senate.

Some of the things that we believe would be appropriate for the people of Pennsylvania. Some of them are not new ideas. The Governor has talked about a \$2,000 stipend to people in Pennsylvania. That is something we should be looking at, ladies and gentlemen. We have the resources. I do not need to repeat that we are looking to probably have close to \$7 billion in General Fund revenues coming in over what we expected, as well as resources we are not spending, for a total of about \$8 to \$9 billion that we will have available to us to be able to spend through this General Fund budget in addition to the \$2.2 billion that we have available to us in ARP money. We can use that ARP money to provide a stipend to the people of Pennsylvania to help offset some of those costs. It does not need to be the \$2,000 that the Governor talked about, but we need to acknowledge that if we are going to give the corporate community--which many of us agreed we needed to address the rate of the corporate net income tax--we need to take steps to recognize that there are folks who are hurting and suffering who we need to address as well. That is what we are going to call for, that we make some type of a payment to our people in Pennsylvania to provide them the support they need to help get them through what it is that they are dealing with as we deal through this inflation situation.

We also recognize that we have an issue with regard to property taxes, and broadly, it comes in two categories: property tax and rent rebate program, which we think is an integral part of what needs to be done in this budget as we go forward; making sure that we will be able to support our senior citizens and those who are disabled, to be able to provide them with some level of relief as we go forward along those lines. That needs to be something that can be done, and it provides immediate relief. That is what is important here, immediate relief. That is what the resources I mentioned first--provides immediate relief to the people in Pennsylvania as with the property tax and rent rebate program. Then, more broadly, we need to have a conversation about property tax relief that is going to make its way to middle class families across Pennsylvania. That, to me, is something that is important as well. We have talked about it a lot here. We have never had the resources to be able to do it. Now is the time; we have the resources to be able to make those investments to be able to provide the relief to property taxpayers and to our school districts here in Pennsylvania. We can either do it through the ARP side or we can do it through the General Fund side by enhancing the amount of money we send through the appropriations for our school districts. At the end of the day, we have the opportunity here to do that.

Finally, Mr. President, one other major initiative that we are going to continue to pursue and talk about has been led by our colleague, Senator Saval, and it is the Whole Home Repair Program. This presents a wonderful opportunity for folks to be able to make investments in this space to fix and secure their homes. By supporting that, you are also supporting rebuilding a community as well. When you repair a home, you repair a community as well. These are programs that are important for us to be able to advance as we go forward.

Again, it comes down to choices; it comes down to will. Do we want to help people in Pennsylvania, as we stand here today, to be able to address some of the immediate concerns that they are dealing with? The things that Senate Democrats have outlined--talk about that as we go forward. There are a number of other initiatives that my colleagues on both sides of the aisle have introduced, but we need to consider all of those. At the end of the day, Senate Democrats will continue to advance the four points I talked about: the payment or stipend back to the people of Pennsylvania; addressing the issue of property tax relief for seniors and for the general public as well as it relates to school district taxes; looking at the Whole Home Repair Program, which, to me, I think is a novel idea to be able to help folks deal with some of the immediate crises that they are dealing with. The goal is if we can help people today, at the same time we are going to be working to reduce the CNI tax, we should be able to do something for the people of Pennsylvania. I would be remiss if I did not build upon the comments of my colleague who spoke before I did, Senator Tartaglione, who for 16 years has been working to increase the minimum wage. We have the opportunity to do that, folks. We just have to have the will and the commitment to be able to do it. Just think if we did \$3 an hour; \$3 an hour would be an immediate \$6,000 a year increase to those men and women, primarily women, women of color, single moms, who are working at these

low-wage jobs. Providing them a \$6,000 increase in their wages would be remarkable to them. Those are the types of things that we have the opportunity to do as I stand here today. We, us in this room, when we work together, we can achieve these things, and we have the resources to be able to do it. We just have to put our minds to it; we have to do it in a comprehensive way. I think, together, we can do it by working with one another to be able to recognize what the needs are right now. Yes, CNI is important to the business community and for the future of Pennsylvania on the business side, but I will tell you, we hear from people all the time, every day, this weekend. People are saying we need help. We need you to help us with our resources, minimum wage, and property taxes. Over and over again, that is what we hear. That is why it is important to us that we address these things now.
