The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Montgomery, Senator Collett.

Senator COLLETT. Mr. President, I am really honored to stand today with my colleague, Senator Mensch, to welcome a group of visitors from Montgomery County who are in the gallery today. George Whitehair, Khoi and Heather Pham, Bibhu and Bimal Moktan, and Dr. Francis Jeyaraj have come to Harrisburg to celebrate the signing into law of House Bill No. 1560, which renames State Route 2004, also known as North Broad Street, in the Borough of Lansdale and Hatfield Township, as the Dr. Frank Erdman Boston Memorial Highway. Thanks to the tireless efforts of my guests, Dr. Boston's achievements are being recognized far and wide, and this unsung trailblazer is finally receiving the accolades he deserves.

Dr. Frank Erdman Boston was born in Philadelphia in 1890. After graduating from Lincoln University and Medico-Chirurgical College and establishing himself as a physician and surgeon in 1917, Dr. Boston made the brave, difficult decision to enlist in the Army. While serving as a medical officer with the 317th Engineer Regiment, one of the few Black regiments, Dr. Boston stood out in his skills and character and ultimately rose to the rank of major. After returning to civilian life, Dr. Boston settled in the Lansdale area, where he became one of the first Black Americans to found both a hospital and an ambulance corps, both of which are still active today. All of this is a mere glimpse into Dr. Boston's many accomplishments and the legacy he left. Thanks to my guests and the Boston Legacy Foundation, Dr. Boston's fascinating and inspirational life story has been brought out of the shadows of

history. He is even the hero of a comic book designed by Pennsylvania's own Marvel artist, Khoi Pham, and written by his wife, Heather Pham, both of whom are part of today's group. Please join me in giving this incredible group a warm Senate welcome.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Montgomery, Senator Mensch.

Senator MENSCH. Mr. President, you know, it was about 10 years ago when I first met the group of people who are here today. They welcomed me to Lansdale politically, and I began to develop a deep relationship with these people. Dr. Jeyaraj, who is Indonesian, others who are of varied racial and ethnic backgrounds, that is the picture of the Borough of Lansdale. I was speaking with the superintendent of schools the other day, and in the school district, North Penn School District, there are 92 dialects that are spoken in the school district. So it speaks to the diversity of the area, and the people who are here today are very representative of the effort that is being made to move the notion of inclusion throughout the entire area of the North Penn School District. Dr. Jeyaraj was a founding father of something called the International Festival, which is held one day a year but has a life the other 364 days, when they work constantly on the idea of inclusion and furthering the lives of everyone who is around the Borough of Lansdale. It is an extraordinary effort. I do not find it anywhere else in my district quite in this fashion.

So, in addition to recognizing Dr. Boston--and it was their effort, again, these individuals who are here today--it was their effort that brought Dr. Boston to my attention and to the attention of Senator Collett. I still remember when we were standing in freezing weather in a parking lot--we could not go inside because of COVID-19, but we were having a dedication, the first experience and dedication to Dr. Boston--when the idea occurred that we should name the street immediately in front of the hospital where we were standing for Dr. Boston. It has taken a little bit of time, as some road names do, but we are very appreciative, and I know that the people who are here today representing all of Lansdale and the International Festival are very appreciative of the fact that we are now naming that street the Dr. Frank Erdman Boston Memorial Highway. So, Mr. President, thank you very much, Senator Collett, thank you.

Senator ARGALL. Mr. President, this is a bill that many of us have seen before. It would establish proper guidelines to ensure that our corrections officers and forensic employees retain their rights when they are accused of wrongdoing. This effort started when eight corrections officers were suspended without pay and benefits for almost a year, without the ability to ask questions related to why they were suspended or to defend themselves. They were never even given the benefit of a hearing. Since that time, this legislation has passed this House, this Senate, several times, each time with large, bipartisan majorities. With the compromise amended, that passed unanimously on the floor yesterday, we have satisfied several of the concerns noted by the Department of

Corrections. We eliminated the 24-hour provision, we are keeping the name of the complainant anonymous, and we have eliminated language which could have potentially resulted in the loss of Federal funds. Like many of you, I represent many people who work in corrections facilities, and let me be clear, I strongly believe that any corrections officer who has been found guilty of a crime should be prosecuted to the fullest extent of the law. However, this legislation will guarantee and preserve the constitutional rights of the accused, so that they are not punished without due process.

Senator DUSH. Mr. President, I too rise in support of this bill. As a former State corrections officer, I actually saw some of those abuses take place. The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Allegheny, Senator Lindsey Williams.

Senator L. WILLIAMS. Mr. President, this amendment is a standalone piece of legislation that I sponsored after my steelworkers at Allegheny Technologies Incorporated, or ATI, in my district were forced to strike due to unfair labor practices. One thousand three hundred steelworkers were on strike from March 30 to July 13; 3 months, 1 week, and 6 days. They walked out at nine different locations, one of them in Brackenridge in my Senate district. According to *Northwest Labor Press*, the ATI strike was among the country's largest in 2021 by number of strikers involved. Despite paying into the unemployment insurance system, ATI steelworkers were not automatically entitled to unemployment compensation under current Pennsylvania law. These workers spent months in limbo waiting for a determination to be made on their unemployment claims, unable to make ends meet. They came to my office seeking help.

My staff spent hours and hours helping these workers navigate the ID.me system and file their weekly claims, all in hopes that they would eventually get a check. The Department of Labor took months to evaluate their case only to decide that they got nothing. Months standing up for themselves and their coworkers; months fighting for benefits they never should have had to fight for; months without a paycheck, and they got nothing from a system that they had paid into. This is not fair to workers. We know that going on strike is never an easy decision. In fact, it is a last resort taken when an employer is not acting in good faith. Striking workers spend their time trying to figure out how to pay their mortgages and feed their kids while their employers continue to operate and make money, and employers know that they hold that advantage. That is what happened in my district; ATI hired scabs to cross the picket line and keep the plant running while steelworkers walked the line outside in the rain and snow. My steelworkers said one day longer, one day stronger, and they did exactly that. They held out and got the best contract that they could, but that was not without a lot of pain.

Our current unemployment law puts workers at a significant disadvantage during contract negotiations, and it does not have to be that way. There are other States that allow striking workers to collect unemployment, including our neighbors in New York and New Jersey. I wanted to help all workers across the Commonwealth who are fighting for the wages and benefits they deserve. That is why I introduced Senate Bill No. 823, which would protect unemployment eligibility for striking workers by allowing a claimant who files a UC claim and meets the existing eligibility provisions to be eligible for UC benefits if that claimant is unemployed due to a stoppage of work caused by a labor dispute. This legislation is companion legislation to Representative Dan

Miller's, of the 42nd Legislative District, House Bill No. 90. Neither my bill nor Representative Miller's bill has moved from committee, which is why I offer this amendment today. We talk a lot about helping workers, especially our building trade union members. Here is a great opportunity to do just that. We have the ability to help level the playing field between employees and employers by giving workers access to the benefits that they have paid into while they fight for a fair contract. Our workers deserve our support; it is time we put our words of support for workers into action. I am glad that the underlying bill fixes the UC system as it applies to military families, and I encourage my colleagues to take this opportunity to make this fix for striking workers at the same time.

Nearly every State provides protection for a spouse caught in this difficult situation. Regrettably, Pennsylvania is one of the few lacking this very sensible protection. The cost of doing this is not large, but the cost is not the compelling consideration, it is indeed the principle. By protecting the economic position of the spouse, we come much closer to fulfilling our obligation to those who serve to protect us. I would like to thank the Committee on Labor and Industry and the co-chairs, Majority chair Senator Bartolotta and Senator Tartaglione, for advancing this bill, and I urge an affirmative vote on Senate Bill No. 1083. Thank you.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, just very brief comments. I stand to raise my objection to Senate Bill No. 1124. It is my understanding that this is clearly a redundant measure, something that does not need to be done. In many instances, in many respects, it is a solution in search of a problem that, in my opinion, does not exist. The work that is being called for in this bill, to my understanding, is already being done. It is required by the Federal government, and it is simply something that is not necessary. For those reasons, I intend to vote "no." Thank you.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Schuylkill, Senator Argall.

Senator ARGALL. Mr. President, I am disappointed to hear those comments. I would have hoped that, in a time of ever-increasing political partnership, this is one issue today that we could have all agreed on. This bill will require the Department of Human Services, on a monthly basis, to check death certificates at the Bureau of Vital Statistics against recipients of medical assistance and the Supplemental Nutrition Assistance Program. It was drafted in response to former Auditor General Eugene DePasquale's investigation, where 2,324 recipients received benefits after they died. The Auditor General noted when a person receiving benefits dies, the benefits should stop, period. That is not a radical suggestion.

Now, the former Auditor General and I certainly represent different political parties, but on this issue, I agree with him 100 percent. Three decades ago, President Clinton and a Republican Congress took some common steps forward to reform our welfare systems. I would have hoped that we could have done so today on a bipartisan basis. Again, the purpose of this legislation is simple: to make sure that benefits are not wasted, so that in the future we can provide additional benefits to those alive in general need.

Thank you, Mr. President.

The PRESIDING OFFICER. The Chair recognizes, for the second time, the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, in response, certainly we do not want resources to be wasted or fraudulent along those lines. That is not the reason for my opposition. The opposition I stated is that this is a redundant piece of legislation that is not necessary, and it is really only trying to create this environment, this atmosphere, that there are nefarious things going on with folks. The bottom line is: it is not necessary, in my opinion. The department has already had the obligation to respond to what needs to be done. It was through these actions that Philip Jaisohn laid the groundwork for future generations of Korean Americans. Korean American immigrants continue to come to America to establish it as a new homeland and to naturalize their children. They are part of a vibrant and growing community that continues to make innovative contributions in distinguished fields such as law, medicine, business, education, the arts, and architecture. And for these reasons, it is my pleasure to have the Senate adopt House Resolution No. 203 and recognize the contributions of these citizens and commemorate June 19 as Korean-American Citizen Day.

This resolution authorizes the Joint State Government Commission to research the pandemic's effect on the staffing needs of the State's long-term care facilities, particularly as they pertain to Pennsylvania's expenditure of Medicaid funds. The study would examine several factors surrounding these staffing needs, including the wage rates for both staff nurses and contract nurses working in these facilities. It will look at the rates charged by staffing agencies to provide these nurses, the increase in wages from 2018 through today, as well as the level of care required by the residents over the same time period. The changes will be measured against the inflation rate. The study is to be completed within 7 months and then submitted to the Senate. I urge my colleagues to vote in favor of this resolution, which will give us a clear picture of what is driving the challenges that keep our long-term care facilities from obtaining and keeping staff. Then, using the study's findings as a roadmap, we can provide much-needed help to this critical industry.

PETITIONS AND REMONSTRANCES

The PRESIDING OFFICER. The Chair recognizes the gentleman from Chester, Senator Kane.

Senator KANE. Mr. President, I rise today with my friends and colleagues, Senator Tartaglione and Senator Bartolotta, to speak on an issue that threatens the health and well-being of the people who throw on their hard hats, day in and day out, to build and repair our beautiful Commonwealth. Since the COVID-19 pandemic, drug usage is on the rise in the United States. Our country is under a tremendous amount of stress as we recover from such a traumatic time in history. There is an overwhelming amount of depression, anxiety, and uncertainty plaguing our nation. To survive these intense feelings and emotions, Americans are turning to drugs and alcohol to escape. Far too many times during my career in the labor industry, I have seen my friends and coworkers turn to addiction in an attempt to fix their problems and ultimately lose their lives. These troubles are what led to last year's opioid drug use, reaching its all-time high in the United States. We can reinforce one of the pillars of our country's workforce. I would like to thank the over 15 groups and associations that are recognizing this week and are working to prevent opioid addictions. I especially want to shout-out the Pennsylvania Building and Construction Trades Council that is in Harrisburg this week for their annual conference. Working with these groups, we could reach out and help save the lives of our construction workers, our Pennsylvanians, and our Americans.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Washington, Senator Bartolotta.

Senator BARTOLOTTA. Mr. President, today I rise to join Senator Kane and Senator Tartaglione in raising awareness of the risk of opioid use in the construction industry. Studies have shown that construction workers are at a higher risk of opioid addiction and death from overdose. Data from 2011-2016 showed that construction workers experienced 15 percent of all workplace overdose deaths despite representing only about 7 percent of the workforce. Drug abuse in the construction industry is not only dangerous for the individual worker, but also creates potential hazards for other workers on the job site and the public who may be near a job site. As chair of the Committee on Labor and Industry, I was pleased that legislation sponsored by Senator Langerholc was enacted last year to require workers' compensation safety committees to provide education to employees about the dangers of substance abuse, including opioid abuse. I applaud the planned efforts of contractor groups and building trade unions to raise awareness of the risks of opioid abuse during Construction Opioid Awareness Week to be held the week of July 25.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise today to support the resolution that my colleagues from [Delaware] and Washington Counties, Senator Kane and Senator Bartolotta, and I introduced, designating the week of July 25 through 29, 2022, as Construction Opioid Awareness Week in Pennsylvania. I thank my colleague from [Delaware] County for his leadership on this issue. As you all know, the opioid epidemic is continuing to ravage communities across the Commonwealth. Workers in the construction industry especially continue to suffer from opioid addiction. Construction workers are especially vulnerable to opioid addiction due to the physical nature of their work. Our friends in organized labor continue to take great steps to educate their members about the risks and dangers of opioids. As the resolution says, the Keystone Contractors Association has partnered with the National Safety Council to create tools to educate its members on the dangers of opioid and prescription drug use for members of the construction industry. These are continuing to save lives. While great work is being done, more work and partnerships are needed to ensure not even one more individual succumbs to this tragic epidemic. Our goal should be that one day in the future, we will not have to make this designation because the opioid epidemic will be in the rearview mirror due to the tremendous work that has already been done educating and preventing the addiction to opioids. Until then, I ask my colleagues to join me in designating the week of July 25, 2022, as Construction Opioid Awareness Week in Pennsylvania.

The PRESIDING OFFICER. The Chair recognizes, for the second time, the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise because today marks 5,826 days since this Commonwealth's legislature last passed an increase in our State's minimum wage. Mr. President, just a few months ago, during the State of the Union Address, President Biden called for an increase to the minimum wage to \$15 an hour by 2025. Mr. President, while that increase to the minimum wage is faster than it would be under Senate Bill No. 12, my legislation would put Pennsylvanians on a path to the same ending place as President Biden's plan, \$15 an hour.

According to a recent study from the Economic Policy Institute, raising our nation's minimum wage to \$15 an hour would provide a raise to nearly 32 million workers across the country. That is 21 percent of all the workers in America. Mr. President, while nationwide, 21 percent of workers would see an increase in their pay, here at home in Pennsylvania, a State where we have ignored our workers, nearly 40 percent of our hourly workers across the Commonwealth would see their pay increase under a \$15 an hour of minimum wage. According to the Commonwealth's own study on the minimum wage, more than 1.2 million Pennsylvanians are making under \$15 an hour and would see an increase in their pay. We cannot allow this body to continue ignoring the needs of our constituents. Mr. President, 1.2 million Pennsylvanians are enough to populate almost five State Senate districts. Workers earning under \$15 an hour would be represented by the second-largest coalition in the State, after only the Philadelphia delegation.

So, it is time, Mr. President, to recognize the sheer, undeniable size of the population that would see an increase in their pay. My question to my colleagues is this: I am fighting for those 1.2 million workers, are you? If you are, Senate Bill No. 12 is currently sitting in a committee waiting for a vote. Let us bring it out of committee, pass it, and increase for 1.2 million of our neighbors, to be able to make ends meet and are paid a fair and humane wage for their work.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Franklin, Senator Mastriano.

Senator MASTRIANO. Mr. President, I rise today together with Senator Argall in designating June as Lithuanian Partnership Month in Pennsylvania. The ties between Lithuania and Pennsylvania are extensive and deep. There are tens of thousands of Lithuanians who immigrated to Pennsylvania in the 1800s and 1900s, an estimated 80,000 of whom still remain in our State. Additionally, Pennsylvania was designated as a partner State with Lithuania after the Cold War. This year, we are celebrating 29 years together in partnership with our Pennsylvania National Guard and the Lithuanian Armed Forces. This has resulted in thousands of our service men and women training with Lithuanian soldiers here in Pennsylvania and, likewise, deploying to their country. Our National Guard affiliation with Lithuania is one of the most successful partnerships in the nation. I would say, even more importantly, Pennsylvanian and Lithuanian soldiers have fought side by side in numerous NATO missions, such as those in Iraq and Afghanistan. Although Lithuania enjoys peace and prosperity today, most of the past century was unimaginably painful and tragic for the Lithuanian people. The suffering is numerous, but I will go back to 1940, when it was invaded and occupied by the Moscow-led Union of Soviet Socialist Republics, or the U.S.S.R., in 1940. The brutal Soviet leader Stalin came up with a nefarious plan to destroy the ethnic identity of most of the nations it brutally occupied, and Lithuania personified the experience of living under Soviet Socialist rule, and its population suffered horribly. Anyone perceived as a threat to that regime was executed, imprisoned, or deported to Siberia.

The first of these atrocities occurred on June 14, 1941, with the forced deportation of 30,000 Lithuanians by the Soviet Union to Siberia. This included national leaders, Catholic priests, business and educational leaders, and the families of anyone perceived as a threat to the Soviet system. The crimes that could result in one's deportation were simply not agreeing with the government's view on economics, culture, or religion. In total, there were 35 mass expulsions carried out in 1941 and between 1945-1952. In total, an estimated 300,000 Lithuanians were deported to Siberia, 70 percent of whom were women and children. Many of these deported victims of Soviet Socialism died in Siberia due to starvation, disease, and unimaginable living conditions.

Meanwhile, in all the Baltic states of Estonia, Latvia, and Lithuania, the Soviet Socialists eliminated all freedoms during this time. No longer were Christians permitted to openly follow the precepts of their faith, and all religious and personal freedoms were removed from the land. An intrusive and oppressive government arrested any Lithuanian who did not subscribe to the Soviet Socialist narrow ideas of culture, society, and politics. For those who dared to step outside of what Soviet Socialist leadership allowed, there was a terrible cost to pay. Torture houses were

set up by the KGB, and in them, innocent men, women, and children were subjected to brutality and even executions at the hands of the Soviet Socialists. In response to the Soviet atrocities that occurred in all the Baltic nations, the people of Lithuania, Latvia, and Estonia rose up in 1945 and began an armed resistance against this system. The Lithuanian resistance lasted for nearly a decade and included 30,000 local freedom fighters dubbed the Forest Brothers. As the Soviet empire began to collapse, the Lithuanians were the first to stand up against the oppressive and intolerant Soviet Socialists to declare their sovereignty in January 1991. In the struggle to secure their independence, 14 brave Lithuanians were killed and 702 were wounded by the Soviet military.

But, in the end, the strength and conviction of the Lithuanian people to fight for freedom secured their independence. It was the spark of freedom that spread to Latvia and Estonia and made all three Baltic nations free. We admire the resolve of the Lithuanian people, who endured decades of oppression and risked everything for the freedom of religion, speech, and a representative government. We appreciate the longstanding friendship, partnership, and bonding that has developed between Pennsylvania and Lithuania due to our partnership over the many years gone by. We honor Lithuania's sacrifice in standing with the United States after we were attacked on 9/11, which included deploying many of its sons and daughters to fight by America's side in Afghanistan, Iraq, and elsewhere around the world. Pennsylvania stands in solidarity with our friends and allies in Estonia, Latvia, and especially Lithuania, due to our deep and long relationship with the Commonwealth and them. Therefore, let it be resolved that we recognize June as Lithuanian Partnership Month in Pennsylvania.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Chester, Senator Comitta.

Senator COMMITTA. Mr. President, I rise today to call on my Senate colleagues to refocus our efforts and discussions on supporting and investing in the people of Pennsylvania and the future of Pennsylvania. With more than \$2 billion in Federal funding and a multi-billion-dollar budget surplus of over \$9 billion, we have a golden opportunity to invest boldly in public education, childcare, special education, and services for Pennsylvanians with disabilities. Instead, over the past week, my colleagues in the Majority have taken up bills aimed at limiting the ability of transgender kids to participate in youth sports, banning certain books from schools, and our own Pennsylvania version of the "Don't Say Gay" or trans bill. Unfortunately, none of these bills or measures contribute to a positive learning environment; none of them help our schools educate strong, healthy, safe, and well-rounded students; none of them help people who are waiting for much-needed disability services. As we approach the budget deadline, it is time to prioritize the real issues at stake instead of divisive and partisan-driven rhetoric. It is time to help our students, our young people, and our families who need it the most.

This morning, I stood with parents and childcare providers from across the Commonwealth who are facing a crisis point in the shortage of workers. More than 90 percent of childcare programs in Pennsylvania are facing staff shortages, and more than 30,000 children sit on waiting lists due to inadequate staffing, preventing parents from going back to work or pursuing career advancement. We can help. The average childcare teacher makes less than \$11 per hour. Pennsylvania can afford to fund a \$2 per

hour supplementary wage increase for childcare teachers and workers. It is not that much, but it can go a long way in attracting and retaining teachers and workers to the profession. Similarly, right now, as many as 12,000 individuals with intellectual and developmental disabilities are on a waiting list to receive services, and more than 5,000 are in emergency need, requiring services within the next 6 months. Most human services professionals and direct service providers are paid less than \$15 per hour. Is it any wonder why more than 60 percent of them leave the job within the first year? Again, we can help; we can do something about it. We can increase funding for direct support professionals, we can allocate at least \$19 million in Medicaid funds to remove hundreds of individuals from the emergency waiting list, and we can boost special education funding by more than \$200 million. These are important steps to expand and strengthen the vital support network that allows all individuals to thrive, to live, within their communities.

Finally, we can take additional steps to close the gap in education funding; a gap that is tragically reflected in a lack of opportunity for students, families, and some of our most financially distressed communities. On top of a \$200 million funding increase for special education, we can provide \$300 million in Level Up funding to support the 100 most underfunded schools. We can invest \$1.25 billion in basic education funding, bringing the total going through the Fair Funding Formula to more than \$2 billion, raising the percentage of State funding through the Fair Funding Formula from 11 to 26.5 percent. As we approach final budget negotiations, I have heard my colleagues in the Majority talk about the need to save funding for a rainy day. If you are a family who cannot access childcare, an individual on the disability waitlist, or a student who is falling behind due to a lack of resources and opportunity, that rainy day is now. For the first time in memory, we have significant funds, billions of dollars, on hand. No one is calling for us to spend it all at once. I believe we can invest in the people of Pennsylvania today, the people who need it the most, while we plan for the uncertainty of tomorrow. Of course, we may not agree; but the bottom line is, I would welcome these conversations. I would much rather have these debates than to spend our time arguing over wedge issues, distractions, and bills that we know the Governor is going to veto anyway. Making a positive difference in the future of children, students, and families; that is what we were elected to do. And I hope you will join me in refocusing our efforts to the horizon to shape a healthy future for the children, the students, and the families, and future of Pennsylvania. Thank you.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Montgomery, Senator Cappelletti.

Senator CAPPELLETTI. Mr. President, each and every one of us has heard from constituents facing financial strain--whether it is gas prices; the cost of food; the fact that our utility bills are due to increase on July 1; a significantly less-than-adequate minimum wage, as Senator Tartaglione reminded us today; or rising property taxes, as Senator Boscola often talks about. Our constituents, the citizens of this Commonwealth, well they are just looking for some help, some relief. Mr. President, there are any number of policy solutions that we can and should implement to help our people to invest in the economic stability of our Commonwealth. You would be preventing oil companies, such as BP or Sunoco, from price gouging the gas prices and ensuring that they pay taxes

just like the rest of us--which they do not--alleviating property taxes or raising the income for property tax and rent rebate programs. Those are just a few of the pieces of legislation that would put money back into Pennsylvanians' pockets. In this fiscal year, we genuinely have the opportunity to do this. Pennsylvania has a \$9 billion surplus and \$2.2 billion in American Rescue Plan funding that must be spent by 2024. This is an unprecedented opportunity to invest in the basic infrastructure of our Commonwealth, including our public education system.

Do you know what happens when we invest in our public education system? We remove the need for school districts to raise property taxes. It could even lead to a reduction of property taxes. We are also investing in our future economy, because we know that a well-educated society is a productive one; one that often has less contact with the criminal justice system, too, which is a huge economic burden on society. It is an investment with both long-term and short-term benefits and absolutely no downside. By strengthening Pennsylvania's educational opportunities, we are not only fostering better educational programs for our younger Pennsylvanians, but we are setting up their entire families for economic success. We have the funds to invest in high-quality education for students all across the Commonwealth, and we must ensure that all students are receiving an education that is equitable across the board. But if we are investing in our students, we also must invest in our teachers. The COVID-19 pandemic has demonstrated that our teachers go above and beyond expectations on a salary that barely pays the bills, typically supplementing their salaries with second or even third jobs and buying what they need for their classrooms with their own money from those second and third jobs. By increasing the beginning teacher salary wage to at least \$45,000 a year, we can not only bring many of them out of poverty, but we can attract and even retain some of the highest-quality educational talent in the Commonwealth and alleviate the economic strain that so many are enduring right now. As we work our way through this year's budget, we must do everything we can to make things easier for struggling Pennsylvanians, and that begins with fully and adequately funding our public school systems and properly supporting those who work there.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Montgomery, Senator Collett.

Senator COLLETT. Mr. President, I rise today to offer remarks in support of the resolution I introduced, which recognizes the month of June 2022 as Alzheimer's and Brain Awareness Month and thank my colleagues who have signed on as cosponsors to this important resolution. Today, June 21, 2022, the beginning of the summer solstice, has been declared "The Longest Day," with teams around the world coming together to honor the strength, passion, and endurance of individuals facing Alzheimer's disease and other forms of dementia. This day will be marked with a day of activity and advocacy to carry out the slogan, "The day with the most light is the day we fight." It is estimated that well over 5 million Americans of all ages are living with Alzheimer's disease, including more than 280,000 Pennsylvanians age 65 and older. The majority of individuals diagnosed with Alzheimer's are over 65, but, regrettably, we all know that the disease can strike people earlier. Unfortunately, as deaths from other common causes like cancer and heart disease decrease, deaths from Alzheimer's are on the rise. Barring the

development of medical breakthroughs, the number of people 65 years of age or older with Alzheimer's may almost triple to nearly 14 million people by 2050. We know that 1 in 3 seniors dies with Alzheimer's or another type of dementia, and that they and their families face a complex set of physical, emotional, financial, and care-related challenges during the course of the illness.

Having worked as a bedside nurse in an elder care setting, I have seen firsthand how much more challenging care can be for both the caregiver and the person receiving care when they are experiencing the effects of a disease like Alzheimer's. Those with Alzheimer's and dementia require more and more support and resources as cognitive, behavioral, and physical functioning worsen over time, placing enormous strains on both government budgets and individual caregivers. The lifetime cost of care for those with dementia is nearly double that of those not experiencing the same decline. With the cost of assistive care for patients with Alzheimer's and dementia being greater and harder to find, it often falls on family members, potentially taking them out of the workplace or putting them in financial jeopardy. For all these reasons and more, it is so important that we increase awareness about these issues. I am proud to stand before you, Mr. President, and before my colleagues to offer my support to our constituents in the Commonwealth who have been diagnosed with or are treating a loved one with Alzheimer's or another type of dementia. I hope that we will all take the time to learn more about the struggles associated with Alzheimer's disease and dementia, and that we can work across the aisle to address the needs of these individuals and their families.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, very brief. I just want to stand and amplify the comments of some of my colleagues here tonight, who spoke about the need for us as a Commonwealth to reinvest and provide resources back into the communities; individuals who have paid their taxes and now looking to us to try to help them get through this financial crisis that they may be dealing with. Whether it is to help them address the rising cost of goods and services; whether it is helping them to deal with the rising costs of our gasoline prices, whether it is a variety of other ways in which they are hurting financially, we have an opportunity to be able to assist them. With the resources available, which was mentioned by my colleagues, from the American Relief Plan, from the overwhelming billions of dollars that we have available to us to make investments in a variety of different ways, we have a chance to be able to address that now.

Earlier this afternoon, we learned that our House colleagues canceled Session for Thursday and Friday. To me, that is very disappointing because we are running out of days here to be able to act and to be able to provide the relief to Pennsylvanians. So, time is of the essence. As Senate Democratic Leader, I stand here on behalf of our colleagues, asking our colleagues on the other side of the aisle to work with us to be able to provide resources back to the people of Pennsylvania. Whether it is a stipend that we talked about in the past that would provide resources to help offset those costs; whether it is in the property tax relief space as it relates to our school district property taxes or whether it relates to the property tax and rent rebate program, helping people, particularly as we go into August and September when folks have to

pay their property taxes, have the opportunity to use the resources we have in front of us and put them into place and make those investments. Whether it is looking at the Whole Home Repair Program is another option that we have. There are a variety of options that exist there, we just have to have the will to get something done, and we are calling upon our colleagues to join our Senate Democratic colleagues to be able to make investments and give back to the people of Pennsylvania, who helped us create the revenue surplus that we are dealing with right now. That is what is critical to us. Be mindful, of course, of what we do as we go forward in terms of other investments in the General Appropriation bill, as Senator Comitta talked about, as it relates to making investments in education and also folks on the disability waitlist. There are a variety of things that we can do, and we can do it together. We are calling upon our colleagues to join us in our effort to be able to give resources back to the people of Pennsylvania, who helped create them.
