Judge CLARK. So, before I administer the oath, I just want to let everyone know--I know some in this room know what a privilege it is for me to be here today for this historic moment to do this, so, for those of you who do not know--it is a privilege. I am so honored and humbled to be here for this historic moment. And Austin, I just have a few words of advice for you as you go forward in your work, because you are a shining example. You are hope for all the little boys and girls in Pennsylvania who look like you, and so, be a servant leader, first of all. Remember that you will lead wonderfully; you will lead and do great things if your leadership is based on the foundation of service. Number two, just be humble. Every one of us got where we are with the help of others, and never forget that. We never do anything by ourselves. We have almighty God who guides us and helps us, and we have a whole lot of people, many in this room who helped you, many in this room who helped me get where I am, so be humble. And lastly, but most importantly, just be kind. Kindness is just the easiest thing to do, and it is the most effective way to do business. So be a servant leader, be humble, and be kind. God

Would you place your left hand on the Bible and raise your right hand and repeat after me:

I, Austin A. Davis, do solemnly swear that I will support, obey and defend the Constitution of the United States and the Constitution of the Commonwealth of Pennsylvania and that I will discharge the duties of my office with fidelity.

# GAVEL PRESENTED TO LIEUTENANT GOVERNOR AUSTIN A. DAVIS

The PRESIDENT pro tempore. I now present the gavel of authority of the Senate to the Honorable Austin A. Davis, Lieutenant Governor of the Commonwealth of Pennsylvania and President of the Senate. Lieutenant Governor Davis, congratulations. [Applause.]

The PRESIDENT (Lieutenant Governor Austin A. Davis) in the Chair.

# INAUGURAL ADDRESS OF LIEUTENANT GOVERNOR AUSTIN A. DAVIS

The PRESIDENT. Thank you, good morning. This is a special day, truly, for me personally and for our great Commonwealth. This day would not have been possible without the unwavering love and support of Pennsylvania's now Second Lady, my wife, Blayre Holmes Davis. [Applause.] Every day, she pushes me to be the best version of myself day in and day out, whether as an elected official, or simply as a man.

Growing up, my parents instilled in me the values of hard work, compassion, and empathy, the very values we hope are instilled in all of our leaders. I would not be the man I am today without my parents, Kathy and Ankarie Davis. Thank you, and I love you. [Applause.]

I would be remiss if I did not take a moment to acknowledge the historic nature of my swearing-in as Pennsylvania's Lieutenant Governor. Today, I became the 35th Lieutenant Governor of Pennsylvania and the first African American to ever hold this office. [Applause.] While I am blessed with this awesome opportunity and responsibility, it was paid for by the blood, sweat, and tears of those who came before me. People like Speaker K. Leroy Irvis; people like Chief Justice Robert Nix, and countless activists and concerned citizens whose names may not show up in print but were just as important to our Commonwealth's trajectory. They paved the way for this moment. This moment is a symbol of our progress here in the Commonwealth we love, and it is one that I hope serves as a point of pride for millions of Pennsylvanians who have never before seen themselves represented in the halls of power. Today, the son of a union bus driver and a hairdresser, a boy who grew up in a small steel town often overlooked by those in power, a young man driven to his first city council meeting because gun violence came to my neighborhood, has reached the second-highest office in this Commonwealth. I am humbled by the chance to carry this history and to serve.

More importantly, today we are sending a message to the next generation of leaders--young people across our Commonwealth, especially Black and brown young people--that Pennsylvania has and will always be a place where all are welcomed and where everyone has the opportunity to succeed. I say to all the young people watching right now who are worried and unsure about their future, that the American dream is alive and well here in Pennsylvania. That no matter how you grew up, no matter where you come from or what you do look like, this Commonwealth will always be a place where you can create your own destiny. But my experiences and the history we are making today are not ends of themselves. But rather, the value resides in the promise that every single Pennsylvanian who feels unseen, unheard, or

forgotten will have a voice for their concerns and aspirations, a say in Pennsylvania's future, and that in the Shapiro-Davis Administration, they have leaders who are fighting for them.

Over the past year, I have traveled across this Commonwealth, and I have had the opportunity to meet Pennsylvanians from all walks of life. Whether it be at a fair in Huntingdon, a church in Erie, a VFW in Williamsport, or a barber shop in Philadelphia, I can tell you that the things that unite us are so much greater than the things that divide us. Pennsylvanians across class, color, and creed want good schools for their children, the opportunity to join the middle class and live the American dream. They want to keep their families and communities safe, and they want real freedom. At a time when our politics has become mean and divisive, and simply out of touch for the needs of those it is meant to serve, I have come away with a singular message from the conversations I have had. Pennsylvanians want leaders who will put delivering real results for them and their families above all else. Because of this, I say to my colleagues in the Senate and in the House that we must no longer measure our success through the counting of insignificant political points or transient headlines. Our success must be measured by the results we deliver for Pennsylvanians and their families. The only victories that matter are those achieved on behalf of the people we serve.

In the weeks and months leading up to this moment, I have thought a lot about my grandparents: Guy and Sadie Simmons, and Vernon and Josephine Davis. One grandfather was a steelworker, the other was a railroad foreman for B&O railroad. All of them came to Pennsylvania from the South to create a better life for our family. When they made their journey, they sought refuge from the suffocation of Jim Crow and the sting of segregation. I do not think in my grandparents' wildest dreams they would have ever imagined that their grandson would one day be sworn-in to the second-highest office in this Commonwealth. But while they may not have been able to envision this particular future, they fought to make sure that their children and their grandchildren had the opportunity to chart their own paths; that they had the right to vote, and that when they walked into a room, they would not just be listened to, but they would be respected. And their sacrifice and hard work was not in vain. It is, in fact, embodied in this very moment. It is their sacrifice and the sacrifice of countless others that allow me to stand here today as the first African American to ever hold this office.

This moment is truly historic. But while what is happening today may be unique, the story of generation upon generation working to build a brighter future for those who succeed them is not. That story is one you can find all across this Commonwealth: hard-working families across Pennsylvania fighting to give themselves and their children a brighter future. Their struggle, their hopes, and aspirations are what fuels me; what drives me; and continues me to do this work.

I often have said that the people closest to the pain should be closest to the power. That is why, today, I have a message for every parent working the night shift to give their child a fair shot, every small-town kid looking for a path to make a better life for themselves, or anyone who feels unseen or forgotten across our Commonwealth. I say to you, that you are not alone, that I hear you and understand your concerns, because I have lived them. And as your Lieutenant Governor, I will be your champion. I will work tirelessly to ensure that every child and family in this

Commonwealth has ladders of opportunities to succeed, so that every generation that comes after it can be better off than the one that came before them.

I could not be more honored to take on this fight with anyone else but our next Governor, Josh Shapiro. [Applause.] Josh has become more than just a running mate, but a friend and a partner. I have seen the care in his eyes when talking to Pennsylvanians throughout our Commonwealth, and I have bore witness to the determination and the grit he has to take on the biggest fights. Josh is a fighter, someone who has never backed down in the face of adversity, and I am proud to stand alongside him to make progress on the things that actually matter. Josh and I embarked on this journey over a year ago to make Pennsylvania a fairer, more just, and more prosperous place. Today is another big step in that journey. Here is one more promise that I am going to give you on behalf of Josh and I, and everyone watching at home: we will not let you down as your next Governor and Lieutenant Governor. [Applause.] Now, let us work.

The Chaplain, Reverend ROBERT C. HOLMES, of Christian Life Ministries, Monessen, offered the following prayer:

Father, as we look in Thy Holy Scriptures and we see Your holy convocations, we see, Lord, Your holy meeting times, meeting times known as Passover and Pentecost and Rosh Hashanah, Yom Kippur, and the Feast of Tabernacles. Father, I pray for a double portion of Your spirit to fall fresh and daily upon our Lieutenant Governor, Austin Davis. Bless his help-me, his wife, Blayre Holmes Davis. May Your anointing cover their marriage to continue as one. Lord, we pray and believe that our Lieutenant Governor will help us to protect this great democracy that is no longer taken for granted as many have in the past, as we now can clearly see the opportunity of Thy marvelous theocracy. This day certainly reminds all of us of the song, "How Great is Our God," and we know that all the powers that be are ordained of Thee, Lord, have Thine own way. Please give our Lieutenant Governor great boldness and humility through Your holy spirit as he presides over the Senate, encouraging them to represent all the people, for this is a great land that You have given, representing the birthplace of a nation. Let then this Commonwealth be a shining beacon of hope, leading every State to forget about the past, looking to a new beginning. And as the new beginning begins, let us all press together in great unity towards that mark of the high calling of God in Yeshua.

Lord, we are so thankful for the anointed prayers that have already been offered in this place. As we prepare to conclude this portion of this efficacious celebration called inauguration, we look back to Numbers, the sixth chapter. We see You, Lord, speaking to Thy people through the priests, saying to the people as we say to our Governor, and we say to our Lieutenant Governor, and we say to our First Lady and our second First Lady, to everyone present and throughout this Commonwealth, we say to you all: the Lord bless thee and keep thee; the Lord be gracious unto thee; the Lord lift up his countenance unto thee and give thee peace. And now, unto Him that is able to keep you from falling, to present you faultless before the presence of His glory with exceeding joy to the only wise God, our Savior. Be glory, majesty, dominion, and power, both now and forever. Let us say. Amen.
