The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Austin A. Davis) in the Chair.

Senator VOGEL, from the Committee on Agriculture and Rural Affairs, reported the following bills:

## SB 746 (Pr. No. 835) (Amended)

An Act amending the act of December 7, 1982 (P.L.784, No.225), known as the Dog Law, in short title and definitions, further providing for definitions; in licenses, tags and kennels, further providing for issuance of dog licenses, compensation, proof required, deposit of funds, records, license sales, rules and regulations, failure to comply, unlawful acts and penalty, for applications for dog licenses, fees and penalties, for kennels, for requirements for kennels, for revocation or refusal of kennel licenses, for dogs temporarily in the Commonwealth and for health certificates for importation; in offenses of dogs, further providing for dog bites and detentions and isolation of dogs; in dangerous dogs, further providing for court proceedings, certificate of registration and disposition, for requirements, for public safety and penalties and for construction of

article; in injury to dogs, further providing for selling, bartering or trading dogs; in enforcement and penalties, further providing for enforcement of this act by the secretary and provisions for inspections and for enforcement and penalties; in sterilization of dogs and cats, further providing for definitions; and imposing penalties.

#### HB 156 (Pr. No. 1029)

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, in fertilizer, further providing for definitions and for application of fertilizer to turf.

## HB 157 (Pr. No. 1030)

An Act amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, in Pennsylvania Preferred® Trademark, further providing for definitions, for Pennsylvania Preferred® trademark, for licensee qualification, for duties and authority of department, for trademark license agreement, application and licensure process, for costs, for Pennsylvania Preferred® Trademark Licensing Fund, for injunctive relief, for rules and regulations and for purpose, repealing provisions relating to definitions and further providing for qualified veterans and qualified veteran business entities.

Senator ARGALL, from the Committee on Education, reported the following bills:

## SB 209 (Pr. No. 839) (Amended)

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in professional employees, providing for National Guard or Reserve parent student support.

#### SB 462 (Pr. No. 837) (Amended)

An Act establishing the Adult Education and Workforce Recovery Grant Program; and imposing powers and duties on the Department of Education.

#### SB 565 (Pr. No. 838) (Amended)

An Act amending Title 24 (Education) of the Pennsylvania Consolidated Statutes, in preliminary provisions, providing for student data privacy and protection; imposing duties on the Department of Education; and providing for penalties.

## HB 100 (Pr. No. 1093)

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in terms and courses of study, providing for Cross-age Tutoring Program.

#### HB 301 (Pr. No. 1035)

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in pupils and attendance, further providing for actual cost of tuition and maintenance of certain exceptional children in the four chartered schools for education of the deaf and the blind; making a repeal; and making editorial changes.

Senator ROTHMAN, from the Committee on Game and Fisheries, reported the following bill:

## SB 709 (Pr. No. 841) (Amended)

An Act amending Title 34 (Game) of the Pennsylvania Consolidated Statutes, in game or wildlife protection, further providing for the offense

of unlawful taking and possession of protected birds and for endangered or threatened species.

Senator BROOKS, from the Committee on Health and Human Services, reported the following bills:

#### SB 514 (Pr. No. 481)

An Act amending the act of November 3, 2022 (P.L.2135, No.150), known as the Childhood Blood Lead Test Act, further providing for legislative purpose and for lead poisoning prevention, assessment and testing.

#### SB 520 (Pr. No. 836) (Amended)

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in departmental powers and duties as to licensing, providing for prelicensure waiver of physical site requirements and further providing for regulations and for rules and regulations for personal care home and assisted living residences.

Senator BAKER, from the Committee on Judiciary, reported the following bills:

## SB 159 (Pr. No. 842) (Amended)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, providing for the offense of unauthorized use of an electronic tracking device; and providing for penalties.

## SB 506 (Pr. No. 843) (Amended)

An Act amending Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes, in incapacitated persons, further providing for petition and hearing and independent evaluation, for determination of incapacity and appointment of guardian and for review hearing.

#### SB 527 (Pr. No. 844) (Amended)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in theft and related offenses, providing for the offense of theft of mail.

Senator BROWN, from the Committee on Local Government, reported the following bills:

#### SB 749 (Pr. No. 798)

An Act amending the act of May 1, 1933 (P.L.103, No.69), known as The Second Class Township Code, in auditors and accountants, further providing for surcharge by auditors; and, in township manager, further providing for township manager, appointment, removal, powers and duties, compensation and bond.

#### SB 753 (Pr. No. 800)

An Act amending Title 8 (Boroughs and Incorporated Towns) of the Pennsylvania Consolidated Statutes, in associations and organizations, further providing for associations and organizations for mayors; in elections of officers, further providing for eligibility, for officers elected and for decrease in number of members of council; in powers, duties and rights of appointed officers and employees, further providing for appointments and incompatible offices and for police serving under cooperative agreement or contract; in corporate powers, further providing for specific powers; in taxation and finance, further providing for investment of funds; providing for solid waste collection and disposition; in

ordinances, further providing for ordinances and resolutions and for publication; and making an editorial change.

## SB 754 (Pr. No. 799)

An Act amending the act of July 31, 1968 (P.L.805, No.247), known as the Pennsylvania Municipalities Planning Code, in general provisions, providing for certain transmittals and submissions to governmental bodies.

Senator FARRY, from the Committee on Urban Affairs and Housing, reported the following bill:

#### SB 532 (Pr. No. 477)

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, in realty transfer tax, further providing for transfer of tax.

Senator CULVER. Mr. President, our representatives from the Boy Scouts of America are Chaplain Keeley Nunn and Life Scout Joseph Saveriano.

The PRESIDENT. Would the Scouts please approach the rostrum and present your report.

The Chair lays before the Senate the following report from the Boy Scouts of America.

(The following Boy Scouts of America Report was made part of the record at the request of the gentlewoman from Northumberland, Senator CULVER:)

#### BOY SCOUTS OF AMERICA Commonwealth of Pennsylvania

The Boy Scouts of America program is an ongoing adventure that delivers life-changing experiences, teaches a powerful set of real-life skills, and develops fundamental qualities that help more than 52,951 youth in 2,372 local Scouting groups in Pennsylvania become Prepared. For Life.®

As of December 31, 2022: 52,951 registered youth; 28,224 Cub Scouts; 22,589 Boy Scouts; 1,042 Venturers; 1,096 Explorers. The Boy Scouts of America will prepare every eligible youth to become a responsible, participating citizen and leader who is guided by the Scout Oath and Scout Law.

Doing service projects together is one way that Scouts of all ages keep their promise to "help other people." Eagle Scout service projects are an opportunity for Scouts to show leadership while helping their community.

1,755 Scouts in Pennsylvania earned the Eagle Scout Award during 2022.

2,097 Pennsylvania Cub Scouts earned the Arrow of Light, Cub Scouting's highest award, in 2022.

Senator CULVER. Mr. President, I thank you for allowing us to have this program here today. The Scouts will conclude the program by reciting the Scout Oath and the Scout Law. I encourage any Scout in this Chamber to stand and join along with them. They will begin with the Scout Oath.

Thank you, Mr. President.

[Whereupon, the Boy Scout Oath and Boy Scout Law were recited.]

The PRESIDENT. The Chair thanks all the Scouts who are here today.

## GUESTS OF SENATOR DOUGLAS V. MASTRIANO AND SENATOR KATIE J. MUTH PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Franklin, Senator Mastriano.

Senator MASTRIANO. Mr. President, it is a distinct honor to rise to formally recognize the 54th Adjutant General of Pennsylvania, Major General Mark Schindler. And sir, what a great day to recognize you today, of course, on this day in 1944, the invasion of Normandy, the liberation of Western Europe, the beginning of the great crusade. Eisenhower reminded us of 156,000 Americans, Brits, Canadians, French landed on the beaches of Normandy, joined by 18,000 airborne troopers from the United States and Great Britain, beginning a great crusade to liberate Western Europe. And what a great day to be reminded of that because with you as well, we have the Lithuanians who were not liberated in World War II, who had to fight on until 1990 and 1991 for their own freedoms underneath the iron grip of the Soviet Union. And I am thankful for the role that you and the Pennsylvania National Guard have played in safeguarding the freedom of our Lithuanian brothers and sisters far off on the Baltic flank of NATO.

General Schindler was recently confirmed by the Senate. He oversees a combined State and Federal budget of \$966 million, and it is warranted and justified, as we have the best and the most active Guard in the nation. We have the most successful State partnership program in the United States of America with the great nation of Lithuania, with whom we stand shoulder to shoulder in the defense of freedom and liberty and independence. He oversees the command and control of 18,000 men and women in our great Air and Army National Guard and the complement of 2,500 Commonwealth employees. He oversees, as well, the Keystone State Challenge Academy with growing success in our State--met one of those great kids today, in fact; he has a great story of redemption--and as well as--close and near and dear to many of our hearts--assists with 700,000 veterans in our State, one of the most patriotic States in the great United States of America.

Today is Guard Day at the State Capitol and with Guard members and booths and displays in the Keystone building--I saw those today, I encourage everyone to go over to see that and say hi to our brothers and sisters in uniform there. Pennsylvania is home to one of the most active National Guards in the nation, going back 268 years, all the nation's wars. If you go to Gettysburg, you will see the names of 34,000 Pennsylvanians who served in that bloody battle of 95,000. A third of the forces engaged in Gettysburg in my district were Pennsylvanians. The General Assembly passed Pennsylvania's Militia Law [Act] on November 25, 1755, one month after the French and Indian War began. The rest, as they say, is history. Pennsylvania's militiamen went on to play a key role in every major military action against the French and Indian War through today in the Global War on Terror.

Today is special, as our Pennsylvania National Guard celebrates its 30th year of partnership with the great nation of Lithuania, and what a difference that partnership has made. That partnership, in part, played a role in keeping the Russians from going into the Baltic neighborhood. We have the commanding general of the Lithuanian Land Forces here. He warned us at the War College over a decade ago that the Russians were not to be trusted, and you proved you were right, sir. So, eternal vigilance is key to success. Together with the Lithuanians, over 800 security cooperation engagements, both in Lithuania and in Pennsylvania. In April, the National Guard Bureau recognized our partnership with Lithuania as the best in the nation, and absolutely it is, what a fantastic achievement, congratulations. Congratulations to General Schindler and our Pennsylvania

Guard as well as our brothers and sisters in the Lithuanian Armed Forces. May God bless you all.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Muth.

Senator MUTH. Mr. President, I rise today to welcome our very special guests to the Senate Chamber from our Pennsylvania National Guard and our partners from the Republic of Lithuania. First, I would like to welcome our 54th Adjutant General of Pennsylvania, Major General Mark Schindler, to the Senate. Major General Schindler has done a great job across our Commonwealth leading the Department of Military and Veterans Affairs and our Pennsylvania National Guard. General Schindler oversees a combined State and Federal budget of over \$966 million and was responsible for the command and control of over 18,000 Army and Air National Guard members, the third largest National Guard in the nation. As Minority chair of the Senate Committee on Veterans Affairs and Emergency Preparedness, I have really enjoyed and been honored to work with General Schindler and his team on the many issues impacting veterans, Guard members, and their families. Our National Guard is one of the largest and most highly skilled Guards in the entire world, and it is critical to all of our communities whenever they are called upon to serve. The nearly 20,000 members of the Pennsylvania National Guard have always been ready to provide assistance and support whenever we need it, and ensuring that we support their needs legislatively is a priority for this Chamber. Last Session we were able to enact a number of bipartisan initiatives that were priorities of both the Department of Military and Veterans Affairs and the Pennsylvania National Guard Association. I am hopeful that this month we can, again, prioritize the needs of our Department of Military and Veterans Affairs and the bills to help support our veterans and our National Guard members and their families.

I would also like to welcome our distinguished guests from the Republic of Lithuania to the Senate. The partnership between Lithuania and Pennsylvania is one of the original State partnership programs that was established in 1993. Through this partnership, Lithuania and the Pennsylvania National Guard have conducted over 800 security cooperation engagements in the past 30 years. In May of this year, the partnership between Pennsylvania and Lithuania was named one of the United States Department of Defense National Guard State Partnership Program Partnerships of the Year for 2022. The award criteria included key leader and subject matter expert engagement, the program's capacity to include whole of government events and academic exchanges, and the inclusion of women, peace, and security principles. It was an honor last night to spend time with many of the members from Lithuania who are visiting, including the Defense Secretary and the Ambassador of Lithuania to the United States and meeting all of their team and talking with them about their experiences working with our State. Thank you, again, to our National Guard, our dignitaries from Lithuania, and also to Major General Schindler for your continued leadership. I ask that we give Major General Schindler and all of our guests from Lithuania a warm Senate welcome.

Thank you, Mr. President.

The PRESIDENT. Would the guests of Senator Mastriano and Senator Muth please rise and be welcomed by the Senate.

General Schindler, it would be our honor if you would now address the Senate.

Adjutant General SCHINDLER. Good afternoon, Lieutenant Governor Davis, President pro tempore Ward, Leader Pittman, Leader Costa, Members of the Senate, distinguished guests, and friends of the Department of Military and Veterans Affairs. Nearly 80 years have come and gone since D-Day, and while uniforms, equipment, and tactics have changed, our National Guardsmen have not. They remain always ready, always there. Like the brothers and sisters in arms who came before them, our soldiers and airmen lace up their boots and go whenever and wherever they are needed. Your National Guard serves abroad, throughout the United States, and of course, is always there to serve our local neighbors. Thank you for your united support of the Pennsylvania National Guard. As you know, Pennsylvania has many individuals who do not wear a uniform, yet they serve. They are devoted healthcare workers, folks who provide outreach to veterans, and individuals who work with our youth at the Keystone State Challenge Academy, people who serve their communities every day. It is together that our entire agency makes meaningful impacts on and for Pennsylvania. Thank you all for affirming our work with your continued support. Together we serve. Mother Teresa of Calcutta once said: "I can do things you cannot, you can do things I cannot; together we can do great things." I look forward to the great things we will continue to do for Pennsylvania as we carry on in service together.

Just this year, we were recognized by the National Guard Bureau as the State Partnership Program of the Year, and I would like to recognize our Lithuanian guests who are in the gallery today with us and on the floor: Command Sergeant Major of the Armed Forces of Lithuania, Command Sergeant Major Katinas; and it is my direct and distinct honor to welcome the Republic of Lithuania's Chief of Defense, Lieutenant General Rupšys on the floor here today--not only our partners, but our friends. [Applause.] Thank you, General. Here is to the next 30 years and the great things we will do together. On behalf of the entire department, again, thank you for this opportunity. Your continued support of the Pennsylvania Department of Military and Veterans Affairs, our partners, our veterans, and their families is proof that together we can do great things. My legislation enables the Treasury to proactively match and automatically return unclaimed property up to \$5,000 for single-owner and living claimants for which establishing ownership requires no additional information. Pennsylvania Money Match would return people's unclaimed money more quickly, as it removes the burden of having to search and submit a claim. My legislation is based on successful programs in dozens of other States that have reunited their State's residents with many million dollars in unclaimed property. Treasury estimates it can automatically return millions of dollars annually, all using existing capabilities and without incurring additional expense. These are funds belonging to the residents of Pennsylvania--not the State--and we are currently holding way too much money that should be put back in their hands to use as they see fit, not help inflate the State budget. Unlike some of the things I have seen move through the legislature, Pennsylvania Money Match is truly common sense, makes government work better, and is the right thing to do for everyone with unclaimed property transferred to the Pennsylvania Treasury. I ask for an affirmative vote. Thank you.

(d) Signage.--The Department of Environmental Services may not replace existing signage at department locations with the redesignated name until the signs are worn and in need of replacement. This transition shall be coordinated with changes in administration.

(e) Computer systems.--The Department of Environmental Services shall continue to use the name Department of Environmental Protection on its computer systems until the time of routine upgrades in each computer system in the department. The change in name shall be made at the time of the routine upgrade to the department computer systems.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Madam President, I rise to ask my colleagues to join me in supporting Senate Resolution No. 127, recognizing June 5 through June 11, 2023, as Disability Pride Week in Pennsylvania. This is an issue near and dear to my heart. This week is intended to help shape the way people think about and define disability. Disability pride is all about accepting and honoring each person's uniqueness and seeing it as a natural and beautiful part of human diversity. It rejects the notion that certain physical, mental, or cognitive differences are negative or wrong and promotes acceptance, dignity, and pride.

As many of you know, 20 years ago I had a boating accident which put me in a wheelchair. In that accident, I fractured two vertebrae and partially severed my spinal cord. These injuries have come with countless challenges but also have been a blessing in disguise. While first, I will admit, I was angry; with time I had come to realize that there was a reason I am here today in this chair telling my story. I was put in this position to be an advocate for those who have a disability. I honestly believe that God thought that I would be perfect to be a role model for people with disabilities because I am a Senator. For those 20 years, I have fought to ensure Pennsylvania is a place that is accepting to all. That is why I am honored and delighted to recognize the week of June 5 through June 11 as Disability Pride Week here in Pennsylvania, which celebrates the 24th anniversary of the passing of the Olmstead Act, an important component of the Americans with Disabilities Act, and the 11-year anniversary of Disability Pride Philadelphia. Recognizing Disability Pride Week is crucial to the understanding that disabilities are a natural and beautiful part of human diversity, and we must celebrate our differences and end the stigmas.

Thank you, Madam President.

The PRESIDENT pro tempore. The Chair recognizes, for a second time, the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Madam President, I rise because today marks 6,176 days since this Commonwealth's legislature last passed an increase in our minimum wage, but it is not for lack of trying, Madam President. Every Session since 2006, when we last acted to raise our minimum wage, I have introduced legislation to, again, raise the wage our lowest earners make. But my legislation and action have been met with what can be best described as resistance and potentially can be called a willful ignoring of some of the Commonwealth's most successful and vulnerable citizens

Just last week, Bishop Dwayne Royster, a faith leader and organizer for social justice, shared his thoughts, which I found to be especially timely as we enter budget negotiations and a period at which we lay out our Commonwealth's economic priorities for the coming year. Madam President, he said, "We have a duty to correct the [this] oppression of working families, especially of Black and brown families. It is in our power to uplift every Pennsylvanian by raising the wage across the Commonwealth to fair levels." Adding, [Reading:]

With[out] a livable wage for families in Pennsylvania, we cannot make progress with any of the crises of economic and racial injustice harming communities throughout the state. Raising the wage means more housing access, better health care, fewer struggles with addiction, decreased gun violence, and more affordable childcare. Our next state budget offers us a route forward if we fight to achieve it.

I could not agree more with Bishop Royster. This budget offers us a chance to show Pennsylvanians and the rest of the world what our moral priorities are; to show them that we have not forgotten about the struggles our lowest earners face each day, day in and day out; and that we are willing to take action to ensure every Pennsylvanian is able to survive off their work.

Senate Bill No. 12 is our chance to show the world what Pennsylvania is all about. It will finally do what every other State around Pennsylvania has done and raises our minimum wage. It will put Pennsylvania's lowest earners on a path to \$15 an hour and remove future increases from the legislature's control, so we never have to go through another 6,176 days of legislative inaction, instead, annually readjusting the minimum wage according to the Consumer Price Index. Madam President, Pennsylvanians deserve better, and they deserve it now. Let us pass Senate Bill No. 12.
