Senator YAW. Mr. President, I rise today in support of Senate Bill No. 691. Senate Bill No. 691 will change the name of the Department of Environmental Protection to the Department of Environmental Services. The word "protection" carries a law enforcement or security connotation rather than that of an environmental resource and a partner to the citizens of Pennsylvania. Unfortunately, Mr. President, enforcer has become the prevalent view of the department. This outlook has overshadowed other work and has had a detrimental impact on the open relationship that the department once had with the people it serves. Mr. President, emphasizing that this department is focused on services will be a huge step forward in instituting a much-needed culture change and will have no impact on its current jurisdiction or enforcement obligations, but it will go a long way toward fostering a cooperative effort to address our environmental issues. I respectfully ask my colleagues for their support of Senate Bill No. 691.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise and ask for a negative vote on this measure, Senate Bill No. 691, for a number of reasons. I think, first and foremost, as we know, we believe that this is something that is simply unnecessary. I think, at the end of the day, what the mission of the DEP is to make certain that it respects and honors and protects as was provided in our Constitution, of

course, have upheld, that it is our obligation to make certain that we have clean air, clean water, and the like, and that is something we need to take a look at. This is entirely different in terms of what took place when we made changes--which I was actually involved with, along with then-Senator Mensch--when we made changes to the Department of Welfare when we changed it to the Department of Health and Human Services. Because at the end of the day, there was the negative connotation, a very specific negative connotation to the term "welfare" with regard to folks, and that was something that we wanted to change, that image and that perception, and that is exactly what we did. In this instance, this is entirely different because I think it takes away--it relegates the belief that this department is simply providing a service as opposed to protecting a constitutional right, which I think is extremely important to the people of Pennsylvania. So, for those reasons, I ask for a negative vote.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Indiana, Senator Pittman.

Senator PITTMAN. Mr. President, I ask for an affirmative vote to this legislation, and I appreciate my friend and colleague from Allegheny County bringing up what we did 9 years ago. We did indeed change the name of the Department of Public Welfare to the Department of Human Services. Services, that is what we are talking about here today. We are talking about taking one word in the Department of Environmental Protection, that bureaucracy, and changing it to services. Let us be clear, that agency is here to serve the people of this Commonwealth; to serve the public. And I think every one of us in this Chamber has dealt with that bureaucracy over the years, and it crosses partisan administrations, but the Department of Environmental Protection has been anything but serviceable. We have all experienced the intractable bureaucracy of the Department of Environmental Protection. And so, I think this name change is substantive. I think it is important. I think it goes with the theme of our new Governor about making government work, about reforming our permitting process, and making sure that our government serves the good of the public, and that can include protecting the environment. But it also has to be very clear that we have an expectation of this bureaucracy to serve the taxpayers who we represent. And that is why I support this legislation. I think it is important legislation, and I think it is much more than symbolic. I think it has real value. And, if anything, if it changes a couple of attitudes within our fourth branch of government, the bureaucracy, then I think we are all better off. I would ask for an affirmative vote.

Any amendment offered on the floor of the Senate to the General Appropriation Bill or other General Fund or special fund appropriation bills or other budget implementing legislation (which collectively comprises and shall be referred to as the 2023-2024 Budget) that proposes spending from the General Fund or any special fund for the Commonwealth 2023-2024 fiscal year, or any prior fiscal year, at a level different from the amount contained in the 2023-2024 Budget as reported from the Appropriations Committee shall not be in order and may not be considered unless the amendment contains sufficient revisions or reductions to that 2023-2024 Budget so that the amendment does not result in a net increase to the total spending and yields a balanced budget based on current and projected revenues. Where a proposed alteration in the General Appropriation Bill is balanced, in whole or in part, by a change in other appropriation bills or other budget implementing legislation, the amendment shall have appended thereto a "statement of intent" setting forth the proposed adjustment to the other appropriation bill or bills that will result in no net increase in the total spending from the General Fund or any

special fund contained within the 2023-2024 Budget as reported from the Appropriations Committee.

3. For the purpose of this temporary rule, the Legislative Reference Bureau, in drafting any amendment to the General Appropriation Bill or any other appropriation bill, shall append the "statement of intent" required for a proposal which involves more than one bill.

#### II. Suspension

This temporary rule may be temporarily suspended only by a vote of the majority of the members elected to the Senate.

### III. Expiration

This temporary rule shall expire upon the enactment of a General Appropriation Act for the fiscal year beginning July 1, 2023.

You will see local performances, meet local vendors, enjoy local food and drinks, and experience firsthand what makes Delco so special.

Thank you, Mr. President. Delco rules.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Kearney.

Senator KEARNEY. Mr. President, I rise to honor the most awesome day of the year, Delco Day. A day to celebrate the best county in the Commonwealth, and my home, Delaware County. That is right, we celebrate the 610, which was Delco's original area code, on the 6th month's 10th day. On this day, our Delco event will raise funds for HEADstrong Foundation, which supports families of cancer patients going through treatment in greater Philadelphia. I am proud to have the foundation in my district and my hometown, and we are going to have a fantastic celebration and fundraiser this weekend. So, I invite you all to come down to JT Brewski's--of course it would be called JT Brewski's in a place like Delco--in Primos this Saturday for some levity, some food and drink. There will be heavy metal bands as well as other bands. They have their honorary Delconian celebration occurring at 6 o'clock, and of course the entrance fee is \$6.10.

So, Delco is many things. It is blue collar, it is Black, it is White, it is Asian, it is Catholic, it is Protestant, Sikh, Muslim, and Jewish, it is over 100 different world languages, and even more ethnic groups, it is 49 municipalities, 60-plus fire companies. We are loud, we are rowdy, and the best people you ever met. So, we wear our county pride wherever we go. The Delco flag flies in my office, here in the Capitol--backwards, it is almost illegible [laughter], but it is, you know, it is a, that is Delco for us, right? This flag has been--well not this particular flag, but a Delco flag--has been flown from the top of Mount Kilimanjaro. This year we had a Delconian successfully summit Mount Everest. It is unclear as to whether he had a Delco flag with him, but we think he had Delco in his heart. So, we raise these flags from, you know, at home, at the beaches of the Jersey Shore, up in the Poconos, we show the world our unique regional culture. And as Senator Kane says: Delco rules.

# The PRESIDING OFFICER (Senator Scott E. Hutchinson) in the Chair.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Beaver, Senator Vogel.

Senator VOGEL. Mr. President, it is my pleasure to recognize the month of June 2023 as Dairy Month in Pennsylvania, which is also the subject of Senate Resolution No. 121. As a past dairy farmer myself, I can tell you that farming is the backbone of our nation, and this is certainly true for our Commonwealth as well. Just as our spine is vital to our body, the dairy industry is an integral segment of agri-business, which must be protected. Beyond

the nutritional benefits of milk and other dairy products, dairy provides so much more to Pennsylvanians. This industry generates \$11.8 billion annually in economic revenue, making valuable contributions and infusing money into both State and local and rural economies. What I believe is even more remarkable is that 99 percent of Pennsylvania dairy farms are family-owned, while supporting 47,000 jobs statewide. These jobs reach beyond the farmer and range widely from veterinarians, to nutritionists, to agronomists, to accountants, just to name a few. We commend these hardworking dairy farmers, their families, and all who work tirelessly 365 days a year to make this industry a success, many of whom often find adversities far outside their realm of control. I would be remiss if I did not mention Pennsylvania's 468,000 dairy cows, which remarkably produced nearly 10 billion pounds of milk last year. That is around 2,500 gallons per cow. Mr. President, I ask my colleagues to join me in recognizing this vital and dedicated industry in the Commonwealth as we celebrate this month as Dairy Month. I also ask that everyone please keep Pennsylvania dairy in mind when shopping at your local market or grocery store.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, I also rise to celebrate the dairy industry here in the Commonwealth of Pennsylvania along with my colleague and chair, fellow chair, of the Committee on Agriculture and Rural Affairs. I know--maybe I am a bit biased-but I believe Pennsylvania does have the best dairy farmers in the nation. These are the folks who work long hours to provide Pennsylvania families with the dairy products that they love and need, items like butter, cheese, ice cream, fluid milk--which is what we specialize here in the Commonwealth. It is only fitting that we formally recognize Pennsylvania's dairy farmers for the critical jobs they do each and every day. Pennsylvania is home to 5,200 dairy farmers, and our dairy industry accounts for 52,000 jobs in the Commonwealth. Dairy is a part of our cultural heritage here in the Commonwealth and a massive part of Pennsylvania's agricultural economy.

I would like to ask my colleagues in the Senate and Pennsylvanians from all walks of life to join me in celebrating our dairy farmers this month. And just a quick reminder, as Senator Vogel said, to support our Pennsylvania dairy farmers, when you are at the grocery store, you can support them when you buy milk by looking on the carton and looking for the number 42 stamped at the top of the carton. That means that milk was produced and processed here in Pennsylvania. So, please let us all recall and celebrate our dairy farmers. And when we go home from Session this week, make sure you hit one of our wonderful ice cream parlors that are scattered throughout the Commonwealth.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise today because it marks 6,177 days since this Commonwealth's legislature last passed an increase in our minimum wage. Workers across Pennsylvania are subject to our poverty-level \$7.25 wage which has not been raised by our legislature for more than a decade and a half. But I know workers deserve more. Workers across this

Commonwealth from my home of Philadelphia to Erie, to Scranton to Pittsburgh, deserve to earn a livable, dignified wage.

Mr. President, it is no secret, the minimum wage in Pennsylvania is the lowest of all neighboring States. States like Maryland, Ohio, and West Virginia all have taken action to raise their minimum wage, and it is far past time for Pennsylvania to join them. Our minimum wage here in Pennsylvania and the other States, 19 of them across the nation that operate using the Federal minimum wage, have abdicated and failed to act for more than 14 years. Fourteen years of inflation, chipping away at the purchasing power of our most vulnerable workers. Mr. President, our minimum wage carries just 51 percent of the purchasing power that it did 14 years ago when it was enacted, driving more and more working Pennsylvanians into poverty and sending minimumwage and low-wage earners to our neighboring States where they can earn more for the same work.

Mr. President, Pennsylvania must be a worker State. We need to embody the Commonwealth's name and ensure we act for the communal success of all Pennsylvanians, and one of the surest ways to ensure all Pennsylvanians earn a living wage that allows all of Pennsylvania's workers to thrive. Mr. President, we need to act now and pass Senate Bill No. 12 so we can not only address the systemic avoidance of the economic justice issue, but to ensure no worker ever needs to go decades again without a raise. Senate Bill No. 12 would raise Pennsylvania's minimum wage to \$15 an hour and forever tie annual minimum wage increases to the CPI, removing politics and legislative inaction forever. Pennsylvania's workers deserve better. Pennsylvania's workers deserve Senate Bill No. 12.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Blair, Senator Judy Ward.

Senator J. WARD. Mr. President, my resolution, Senate Resolution No. 126, brings awareness to the benefits of the milkweed plant, which is critical to the survival of the monarch butterfly and other pollinator species. The monarch butterfly is currently an endangered species and has decreased in population by more than 80 percent since the 1990s. Much of the habitat loss is related to the continued loss of the milkweed plant, which has seen a steady decline over the years due to herbicide spraying and land development. Conservation of the milkweed plant would aid in the repopulation of the monarch butterfly and other pollinator species. Thank you to the other Members who have signed onto this resolution and for those who have advocated for this issue, especially Alyssa Horton from Huntingdon County, who brought this issue to my attention. Together, we can save milkweed, the monarch butterfly, and all the other pollinators that depend on milkweed.
