Pennsylvania Senate Resolution 2021-53 (SR 2021-53) directed the Legislative Budget and Finance Committee (LBFC) to conduct a study and issue a report analyzing Pennsylvania state highway maintenance funding for the Pennsylvania Department of Transportation (PennDOT) and its 67 county maintenance offices (CMOs). The scope of this study covered the period 1997 through 2021, emphasizing FYs 2015-16, 2016-17, 2017-18, 2018-19, 2019-20, 2020-21, and 2021-22. PennDOT oversees the Commonwealth's overall transportation system and is statutorily

responsible for constructing, reconstructing, maintaining, and repairing all highways in the state highway system. Although PennDOT has a central office in Harrisburg, it is a decentralized organization. The decentralized nature of PennDOT allows each of the agency's Engineering Districts and CMOs to use either internal resources or external contractors to complete maintenance activities.

She is currently president of the New Hope-Solebury Board of School Directors and, in that position, has done a lot to lead that school district and its continuing tradition of excellence. And I note that Judy's father was involved in Republican politics in Bucks County many years ago. Jim and Judy are proud parents and stepparents to their blended family of seven children. Their son, Jack, is here in the Capitol today. Jack is a rising sixth grader at the New Hope-Solebury Middle School. He plays NFL flag football and basketball. In his free time, he enjoys playing with his dog, Murphy; his numerous friends; and with his dad, against whom he hopes one day to win in a best of three games, one-on-one basketball. And Madam President, I will note that before Session today, when no one else was here, Jack had the honor of standing where you are right now, and it was quite an experience for him. So, he was very pleased with that.

In 2022, James and Judy established the Charles W. McHenry Memorial Scholarship, a \$20,000 award granted every 4 years to a graduating senior aspiring to pursue a career in nursing. ### GUEST OF SENATOR JUDY WARD PRESENTED TO THE SENATE

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Blair, Senator Judy Ward.

Senator J. WARD. Madam President, I rise to welcome a hero from my district, Dave Camisa, who is here today as my guest and the guest of Senator Mastriano. Dave currently lives in Huntingdon County, but he lived in New York City for 50 years, where he was part of the New York Police Department auxiliary program. As part of this program, Dave volunteered to patrol the city, and he eventually worked his way up to Lieutenant. When he woke up the morning of September 11, 2001, like all of us, he had no idea what that day had in store.

That morning, he was working on Wall Street when people began shouting that the World Trade Center had been hit by a plane. Dave rushed to the scene and realized that it was not an accident, it was an attack. He then jumped into action and began assisting the New York City Police Department and other first responders, helping many people flee to safety. While Dave now resides many miles from Ground Zero, and more than two decades have passed since that tragic day, the memories of September 11 remain vivid for him. The heroic actions of Dave and so many other first responders and volunteers will forever be sources of strength and inspiration for all Americans. When we pause to honor those who have lost their lives on 9/11, we also remember individuals like Dave who selflessly made the commitment to rush into life-threatening situations to help save

others. Please join me in giving Dave a warm Senate welcome and thank him for his bravery and his service.

#### A RESOLUTION

Observing June 19, 2023, as "Juneteenth National Freedom Day" in Pennsylvania.

WHEREAS, originating in Galveston, Texas, on June 19, 1865, when slaves in that state learned that they had been freed, "Juneteenth National Freedom Day" is the oldest African-American holiday observance in the United States; and

WHEREAS, "Juneteenth National Freedom Day" commemorates the survival instinct of Africans who endured a transatlantic journey, known as the Middle Passage, on slave ships from their homeland to this country; and

WHEREAS, Approximately 11.5 million Africans survived the harsh voyage to slave markets in the New World during the late 17th century, and the slave population in the American colonies grew quickly; and

WHEREAS, "Juneteenth National Freedom Day" further commemorates the impact of slavery, the abolitionist movement and African-American emancipation in the United States and has become a traditional celebration of independence, human rights and African-American culture in many communities; therefore be it

RESOLVED, That the Senate observe June 19, 2023, as "Juneteenth National Freedom Day" in Pennsylvania.

On the question,

Will the Senate adopt the resolution?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Madam President, a little over 160 years ago, the Emancipation Proclamation was issued by President Abraham Lincoln. That proclamation ended slavery effectively in the United States and all the territories that were in rebellion. However, it was almost 2 1/2 years--because there was no internet, there were no TV stations to make broad announcements-before that news reached every slaveholding community in the United States of America. And so, it was not until June 19, 1865, some 2 years and several months later, before the final communities that were holding slaves in Galveston, Texas, in the deepest portions of the Confederacy, learned of the Emancipation Proclamation, and those enslaved individuals were freed. That is what Juneteenth commemorates. Today marks the 158th anniversary of when slavery really ended in the United States, almost 2 1/2 years after the Emancipation Proclamation was actually adopted. It is a day that is now nationally recognized and a day that symbolizes the end of one of the darkest chapters in American history, and it is known as Freedom Day for so many throughout this country and now nationally celebrated by Americans of all backgrounds, but most especially by African Americans whose ancestors suffered the horrors of slavery.

We thank all those who observe and enjoy and indulge in all of the great celebrations. It has come not only as a celebration of the end of that dark chapter, but also of the rich cultural diversity and history that African American people throughout this country have contributed and all we have contributed to not only this Commonwealth, but this great nation. I thank all those who in whatever small ways or great ways they have contributed to advancing the Juneteenth celebration, recognizing that Pennsylvania communities across the great Commonwealth have had celebrations throughout the course of the week, and many are celebrating today. I ask for a unanimous vote on this important resolution commemorating Juneteenth as a holiday.

Senator COMITTA. Madam President, I rise today in support of Senate Bill No. 621, designating a portion of Route 41--the Gap Newport Pike in my Senate district--the Corporal Brandon Hardy Memorial Highway. The Hardy family are my constituents in Cochranville, Chester County. Upon graduating from high school, Brandon served in the Air Force on multiple deployments in the Middle East, eventually reaching the rank of Staff Sergeant. Later, in 2005, he made the unusual decision to forgo his rank and pay and enlist as a member of the U.S. Marine Corps.

On April 15, 2006, while deployed in Iraq, Corporal Hardy and four other service members were traveling on an aid and assist mission when their Humvee vehicle struck an IED. As a result of the attack, Corporal Hardy, as well as Sergeant Lea Mills of Florida and Sergeant Edward Davis, tragically lost their lives. Mr. President [sic], as we mark the 20th anniversary of the war in Iraq, we must continue to support our veterans and remember our fallen heroes.

I came to know of Corporal Hardy's story through my support of the Chester County detachment of the U.S. Marine Corps League, which is also named in his memory. I think this is a fitting reminder of Corporal Hardy's service and sacrifice. This roadway, close to the Hardy family home, is a route he would have traveled each day on his way to Octorara High School. Thank you, each of you. I ask for a "yes" vote in remembrance of Corporal Hardy and all of those who gave their lives in defense of our nation. Thank you.

I would like to thank my colleagues Senator Stefano and Senator Phillips-Hill for their expertise and assistance in developing this legislation. We are blessed today to be joined by a real-life hero from 9/11 who was a first responder at Ground Zero on that fateful day. Dave Camisa was a Lieutenant in the New York Police Department auxiliary police unit. When the planes crashed into the World Trade Center, he responded. There is an iconic picture of him directing citizens to safety on that fateful day just before tower two collapsed. Dave is sitting up in the Senate gallery, and we thank him for his service and his commitment and are thankful for all he did on that awful day.

It has been over 21 years since that tragic day of 9/11 when the terrorist attacks extinguished 3,000 American and foreigner lives in New York City, as well as in Washington, DC, and in Pennsylvania with Flight 93. September 11 left a deep scar on our generation and this nation as a whole. It is never forgotten in the hearts and minds of Americans that remember that day. Astoundingly, none of today's K through 12 school students were even alive when the attacks happened. September 11 is a somber chapter in our history that kids today only learn about through video footage or photographs. It was disheartening to me during one commemoration one year, just a couple years ago, that I could not find any of my local communities or local schools even commemorating that day. This legislation would change that. Senate Bill No. 290 requires schools to observe a moment of silence every 9/11 to honor the lives lost and the families that were left behind as well as the heroes like Dave. The bill will also ensure that current and future generations of students learn about the events and significance of 9/11 through a State-developed model curriculum. We cannot let the tragedy of these events fade from our collective memories, nor can we ever forget. Senate Bill No. 290 ensures that Pennsylvania students will indeed never forget.

Thank you, Madam President, I urge a positive vote.

Senate Bill No. 607 amends the State Lottery Law to extend the moratorium on the inclusion of the Social Security COLA and the calculation of income eligibility for the PACE and PACENET programs. The current moratorium was enacted in late 2021 and will expire on December 31, 2023, and this legislation will extend that expiration date to December 31, 2025.

Without this bill, as many as 20,000 current program participants could be rendered ineligible solely because the Social Security COLA places them over the income limits. In these difficult times of high costs and persistent inflation, our seniors are struggling and need our help. This legislation ensures our seniors' Social Security COLA does not make them ineligible for PACE or PACENET, so they can continue to count on these life-sustaining programs. This bill was unanimously reported from the Senate Committee on Aging and Youth and is supported by the

Department of Aging along with AARP. I respectfully ask my colleagues for an affirmative vote.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Montgomery, Senator Collett.

Senator COLLETT. Madam President, I rise today to read remarks written by my deputy district director, Lloyd Morgan, on the importance of observing Juneteenth on June 19. [Reading:]

I would first like to thank Senator Collett for her support and for reading these remarks on my behalf. I am deeply disappointed that the Pennsylvania Senate, unlike the House and unlike the administration, decided to observe the Juneteenth holiday on June 16 and not on the actual day of June 19. Long overdue, Juneteenth, also known as Freedom Day, was signed into law and passed by Congress in 2021 to set aside June 19 as a Federal holiday. Not surprisingly, a number of Republican Members, many of whom represented States that were part of the slaveholding Confederacy during the 19th century, opposed the measure without hesitation. As I cannot speak for others who identify as African American in

the Senate, I personally find this disdainful behavior disrespectful to my African American culture, indicating a lack of awareness of the importance of Juneteenth in a country where my ancestors suffered severe atrocities for centuries.

As I am currently investigating the paternal side of my family, I have come to learn that my great-great-grandmother, Lucy McGee, was born enslaved in the early 1840s in Lowndes County, Georgia. As a direct descendant of enslaved Africans, my third great-grandmother was born during the Antebellum Period, a time when large plantations operated solely on the use of slave labor, so I can only imagine her and her family's exuberant emotions when the Emancipation Proclamation freed her and her enslaved family in 1863. She would have been in her early twenties as a finally freed person in America. Unfortunately, this news did not reach Galveston, Texas, until June 19, 1865, and it was in 1866 when the then-freed people started to celebrate Juneteenth.

Juneteenth today celebrates the resiliency of African Americans, while aiding the preservation of the historical narratives that encouraged many types of advancements since June 19 in 1866, something that could not have happened when this country was freed from the British in 1776 after the Revolutionary War and the Fourth of July became a national holiday in 1870 when Congress passed H.R. 2224. Can you imagine being made to celebrate the Fourth of July on July 2? Even though British rule ended and the United States of America was born, many remained in bondage for another 89 years. All people in the United States did not taste freedom until 1865. To acknowledge June 19 on its actual day allows me and others in this situation an opportunity to reflect, celebrate, and enjoy this historical event with loved ones and family members, something that I make sure I do every June. It also lets others learn about the holiday as I hope you have.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Madam President, I rise because today marks 6,189 days since our Commonwealth's legislature last passed an increase in our minimum wage. Madam President, there is an expression, "time waits for no man," and there is no one who is more aware of that than Pennsylvania's minimumwage earners. Mr. President [sic], for nearly 17 years, this body and our counterparts across the Rotunda in the House have failed our low-wage earners. But we do not need to continue our failed path of not acting for the Pennsylvanians who need it most. As we begin to really dig down and set our budget priorities and goals for the coming fiscal year, it is imperative we include lifting Pennsylvanians out of poverty as one of our cornerstone issues.

Madam President, one of the easiest ways we can make sure no Pennsylvanian lives in poverty is to ensure no Pennsylvanian is paid poverty wages. Senate Bill No. 12, Madam President, right now is sitting in committee. It can and it must be part of the discussions and package of legislation that passes as part of our Commonwealth's budget. At its simplest form, this budget we pass is a reflection of this Chamber's moral compass. It shows Pennsylvanians what we care about and what we do not. We cannot allow our low-wage earners to, again, be ignored and cast aside by those in power. We must raise the minimum wage. We must pass Senate Bill No. 12.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Delaware, Senator Kearney.

Senator KEARNEY. Madam President, I rise today in recognition of another important day for people in my district and in the Commonwealth, "Korean-American Citizenship Day," which

is also celebrated on June 19. I would also like to thank Senator Pennycuick, Senator Collett, and Senator Haywood for their continued support for recognition of Korean-American Citizenship Day. Korean-American Citizenship Day in Pennsylvania is celebrated every June 19, which marks the date of the first Korean American immigrant to get United States citizenship, Philip Jaisohn, who at the time lived in what is now the 26th Senatorial District. Philip Jaisohn was a political refugee who made his home in Media, Pennsylvania, and used Philadelphia as a base for supporting Korean independence. He was inspired by the work of the Continental Congresses of the United States and the Declaration of Independence. With that inspiration in mind, Jaisohn, along with Syngman Rhee, who later became the first President of the Republic of Korea, and Han Kyong Jung organized the first Korean Congress in Philadelphia and proclaimed the Korean Declaration of Independence in April of 1919.

It was through these actions that Philip Jaisohn laid the groundwork for future generations of Korean Americans. Korean American immigrants continue to come to America to establish it as a new homeland and to naturalize their children. They are part of a vibrant and growing community that continues to make innovative contributions in distinguished fields such as law, medicine, business, education, the arts, and architecture. For these reasons, it is my pleasure to annually introduce this resolution, Senate Resolution No. 135, and welcome guests from the Republic of Korea at our annual event at the Philip Jaisohn House in Media.
