May this Senate of the Commonwealth of Pennsylvania, founded as it was as a refuge for those seeking religious freedom, be a citadel of protection for all its inhabitants. May all the Members of this body go from strength to strength, guided by kindness, mercy, and compassion. [Translated from Hebrew:] So, may it be God's will. And let us say: Amen.

SB 37 (Pr. No. 939) -- The Senate proceeded to consideration of the bill, entitled:

GUESTS OF SENATOR DEVLIN ROBINSON PRESENTED TO THE SENATE

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Robinson.

Senator ROBINSON. Madam President, I have two very special guests with me here today. One is David Thornburgh, son of former Pennsylvania Governor and U.S. Attorney General Dick Thornburgh. Mr. Thornburgh has been an influential member of the Pennsylvania citizenry for quite some time. He served as executive director of the University of Pennsylvania's Fels Institute of Government. He has been awarded numerous awards, including an Eisenhower Fellowship in 2000. He and his wife, Rebecca, and their two daughters, Blair and Alice, live in Germantown, Pennsylvania, and are lifelong musicians in an alt-country band called the Reckless Amateurs.

The other guest is a good friend of mine, Madam President, Rocky Bleier, who I am honored to welcome to the Senate floor today. It is well-known he is an accomplished football player starting at the University of Notre Dame, when in 1966 the Fighting Irish won the national championship. Later in 1968, the

NFL draft found him to be drafted on the Steelers. Mr. Bleier holds the only honor of being the only player to be drafted twice that year, he was also drafted in the U.S. Army for a tour in Vietnam, where he volunteered for duty in South Vietnam in 1969 assigned to Company C, 4th Battalion, 31st Infantry, 196th [Light] Infantry Brigade and assigned as a squad grenadier operating a 40mm M79 grenade launcher. On August 20, while on patrol in Hiep Duc, Bleier was wounded in the left thigh by an enemy rifle bullet when his platoon was ambushed in a rice paddy. While he was down, an enemy grenade landed nearby after bouncing off a fellow soldier. After trying to leap over it, it exploded, sending shrapnel into his lower right leg, damaging his right foot in the blast as well. He was awarded the Bronze Star and the Purple Heart. Despite these injuries, Rocky Bleier was able to make a full recovery and played in the first four Steeler Super Bowl victories. Rocky retired in 1980 with 3,865 rushing yards, 136 receptions, and 1,294 yards with 25 touchdowns. At the time of his retirement, he was the Steelers' fourth all-time leading rusher.

Thank you, Madam President, and I offer a warm welcome to these guests.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Costa, for further comments on Rocky Bleier.

Senator COSTA. Madam President, I thank my colleagues for indulging me. I certainly want to welcome both guests. David Thornburgh, who I have had the privilege of working with others on the redistricting conversation that we had, redistricting task force, and certainly know his commitment to the good government things along those lines and thank him for that work. With regard to Rocky Bleier, I just want to take a moment to talk, not necessarily about his football career, but the person who he is in Pittsburgh and how well respected he is. Many folks in this room do not really know the magnitude of what Rocky Bleier gives back to the community, and does it unselfishly, and always takes time to particularly meet with veterans. And what I would like to do is just share one story, one experience, that I had with Mr. Bleier about 4 or 5 years or so ago.

Each year I hold a veterans' luncheon where we invite about 150 veterans to a luncheon in my district and sometimes invite speakers. I found myself at the Duquesne University veterans' breakfast one morning, along with Mr. Bleier, and indicated that I do this lunch, and it would be wonderful if you could come out and speak with some of our veterans, 150 veterans and their families. Mr. Bleier took out his phone, looked at his calendar, and said to me: I have a 1 o'clock meeting, but I will move that meeting, and I will come and speak to your folks. And I did not know whether or not it was going to happen. Mr. Bleier shows up at our veterans' luncheon, proceeded to speak with the veterans and their families--well over an hour--sharing stories with these veterans in terms of their service, primarily in Vietnam, and some other places. And I can tell you that he ended up spending nearly 3 hours--3 hours speaking with veterans in my community. And I cannot tell you how much I appreciate that. And that is just a small part and small thing that this gentleman does in our community as it relates to veterans. So, it really speaks to the character of the person who we are recognizing and speaking with here today. So, I just felt compelled to share that with all of you to let you know the type of person who we have. The other good thing

about this visit today is now [Senator] Jimmy Dillon is the second most popular and famous Notre Dame alumni. That being said, thank you, Madam President, I appreciate it, and I thank my Members for allowing me to participate today.

BILLS OVER IN ORDER

BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 414 (Pr. No. 361) -- The Senate proceeded to consideration of the bill, entitled:

An Act providing for access to treatment for sexual assault survivors and for duties of the Department of Health.

Considered the third time and agreed to,

On the question, Shall the bill pass finally?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Beaver, Senator Vogel.

Senator VOGEL. Madam President, I rise today to ask for your support of Senate Bill No. 414, which would expand access to sexual assault nurse examiners, also known as SANEs, across the State and ensure quality care for victims of sexual assault. Pennsylvania is experiencing an extreme shortage of SANEs, and with these shortages comes a greater chance of sexual assault victims either being turned away to another hospital or being at risk of receiving inappropriate or substandard care which could result in forensic evidence being of poor quality or lost altogether. Senate Bill No. 414 would help reduce some of these inequities by expanding existing Penn State University SAFE-T program, allowing hospitals to establish individual SANE programs at their facility, and requiring the Department of Health to publish on its website a comprehensive list of each hospital providing SANE care. Research is showing that trauma-informed person-centered care delivered by SANEs results in improved psychological wellbeing of sexual assault survivors, increased quality of medical care, and positive impacts on prosecutorial outcomes pertaining to sexual assault survivors. I ask my colleagues for an affirmative vote on Senate Bill No. 414.

Thank you, Madam President.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Madam President, I rise in support of this legislation--in strong support of this legislation. Sexual assault is deeply traumatic, and it can have--and usually does have-long-lasting, if not lifelong, impacts on victims. It also carries a lot of stigma, which leaves many victims afraid to come forward. In fact, it is one of the most under-reported crimes in the United States. Compassionate patient-centered care is critical for sexual assault victims to begin the healing process and understand what options they have, not only for treatment, but also for reporting their assault.

I actually saw in action what can happen as a result of passing this legislation. Less than a year ago, St. Joseph Medical Center in Reading partnered with SAFE-T System, a group within Penn State's College of Nursing. The training involved a trauma-informed approach to conduct forensic exams and provide emotional support and expert legal testimony, all within a culturally and developmentally appropriate framework specific to each patient, and it also can be done via telehealth. So, even if you are in the most remote area and you do not have specific or direct access to these nurses and these experts, they will literally guide-through telehealth--the actual nurses or other examiners in the emergency room to assist those patients and give them the proper care.

I was able to attend a launch of this event and actually saw it in action. At every step of the process, nurses work with individuals who have experienced sexual assault to explain exactly what they are doing in terms of the medical examination, documentation of injuries, collection of evidence, infection prevention or treatment, and referrals to community resources and follow-up care for a holistic approach. This is a major step forward in terms of treatment for sexual assault victims, and I commend my colleague Senator Vogel for bringing this forward. I know that he actually had learned about that as well, and that is where his interests had come from. So, I again, I urge the support of all of our colleagues here for legislation that will truly have a positive impact on so many people in the Commonwealth. Thank you.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Muth.

Senator MUTH. Mr. President, I rise in support of Senate Resolution No. 46, which would establish a Task Force on Women Veterans' Health Care to study the healthcare and mental healthcare needs of the tens of thousands of women veterans here in our Commonwealth. Our women veterans sacrifice so much in service to our country, and their experiences in the military are far more unique, sometimes, than that of their male counterparts. So, their needs obviously have different requirements. We need to ensure that all women veterans have the appropriate, high-quality care and support here in our Commonwealth for all of their health needs.

Mr. President, about 18 months ago, Senator Stefano and I-when he was the chair with me for the Committee on Veterans Affairs and Emergency Preparedness--we convened a women's roundtable discussion at Fort Indiantown Gap to hear from women veterans about their experiences, their needs, what we could improve on, and how to better support this population of veterans. It was an amazing discussion where even some of our elected officials and government officials--who are women veterans--participated, sharing their insights and stories and hearing about the challenges they faced while on active duty and also

transitioning into the civilian life. The task force created by Senate Resolution No. 46 will provide such important information on health issues facing women veterans and how our legislature can best support their needs.

Senate Resolution No. 46 also makes specific mention of the challenges of women veterans that they face after being a victim of military sexual trauma. I just want to say thank you to Senator Pennycuick for making sure that that was included in this resolution, as it has been an important issue for many women veterans and many advocates, and I cannot say thank you enough. And over the past few Sessions, Senator Lindsey Williams and I have been working to raise awareness on military sexual trauma and the epidemic in our military which impacts all genders of the military serving our country. This Session, we were grateful that Senator Pennycuick had joined us as a co-prime to show that issues like MST and causes that support our veterans, and especially women veterans, are bipartisan, and they are important. Again, I want to commend Senator Pennycuick for her work on this resolution, and I look forward to seeing the outcome of this study and how we can work together to present these solutions for our women veterans in our Commonwealth. I am proud to support this resolution, and I encourage a "yes" vote on Senate Resolution No. 46.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, the resolution before us today is extremely important for women veterans across this Commonwealth. I have taken up this issue in previous Sessions and have had this legislation move from committee, but it never received a floor vote. So, today is the day it is getting a floor vote, and I am so proud of that. Women veterans across this country are demanding expanded access to specific healthcare needs. Many of these services are not available to female veterans, who make up approximately 10 percent of the overall veteran population. In Pennsylvania, there are approximately 63,000 women veterans, and we need to improve healthcare for them to focus on PTSD, depression, OB/GYN care, and childcare. This task force will report to the legislature and the Governor recommendations on how we can improve the healthcare of female veterans across this Commonwealth. These brave women served our country, and now it is up to us to ensure that we serve them in the best possible way we can as they convert to civilian life. Lastly, I would like to thank fellow sponsors Senator Pennycuick and Senator Farry for bringing this issue back to light, and hopefully, we will improve the lives of women veterans across this Commonwealth.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Pennycuick.

Senator PENNYCUICK. Mr. President, the goal of Senate Resolution No. 46 is very simple. It is to ensure that all veterans have access to healthcare that they deserve, they have earned, and they were promised. Unfortunately, for many female veterans in this great Commonwealth, that is not the case. I have heard from many women on how their option and ability to access care has been nearly impossible. Unfortunately, their stories are all too familiar, as I have had similar experiences as I navigate the VA system and finding healthcare options very limited. The unique needs of female veterans can often be overlooked, as our veteran

healthcare system is designed to care for primarily and historically the male population. Yet, I am proud to say that women continue to grow in percentages in our nation's Armed Forces.

Currently, there are 18.5 million women across the country who can proudly call themselves veterans, and here in Pennsylvania, we have over 70,000 female veterans. Through passage of this resolution and the establishment of the Task Force on Women Veterans' Health Care, we can take a giant leap forward in closing our current gaps in care, access, and coverage. This task force, comprised of subject matter experts with relevant specialties, will study the unique healthcare issues and barriers facing women veterans and make actionable recommendations to the General Assembly. I greatly appreciate the Senate's consideration of Senate Resolution No. 46, and I want to thank Senator Farry and Senator Boscola for their work on this issue well before now. They have been working on this for years, and they should be commended for their diligence in bringing this issue forward. I hope that we can build a better healthcare system in Pennsylvania that meets the needs of every veteran. I hope that this will include future veterans. My three daughters serve currently in the United States Army, and I do not want to see them having the barriers to care that I and so many others have faced.

examination of applicant for driver's license; in rules of the road in general, further providing for prohibiting text-based communications and providing for prohibiting use of interactive mobile device; in miscellaneous provisions relating to serious traffic offenses, further providing for the offense of homicide by vehicle and for the offense of aggravated assault by vehicle; and imposing penalties.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentlewoman from Monroe, Senator Brown.

Senator BROWN. Mr. President, Senate Bill No. 37 is a welloverdue legislative initiative that strives to build driver accountability and change driver behavior when it comes to utilizing a handheld cell phone or wireless device while operating a motor vehicle, all to create a safer environment on our Pennsylvania roadways. There is no doubt we have a problem on our roadways in Pennsylvania, and the question is, what are we going to do to try to help? The PA Department of Transportation, this past April during Distracted Driver [Driving] Awareness Month, put out a press release stating that distracted driving and head-on crashes reached a 10-year high in 2023. The AAA Traffic Safety Culture Index found that most drivers, almost 88 percent, believe that distracted driving has outpaced all other traffic-related issues as a growing safety concern, and virtually all drivers, almost 97 percent, view texting or emailing while driving as a serious threat. Distracted driving was responsible for an estimated 8 percent of fatal crashes, 14 percent of injury crashes, and 13 percent of all police-reported motor vehicle traffic crashes in 2020. That is according to the National Highway Transportation [Traffic] Safety Association [Administration], and we must remember that these are only the ones that are reported.

Senate Bill No. 37 is reasonable, it is responsible, and it is enforceable, and it is what we can do now to deal with the distraction caused by cell phone use. The cell phone has now become the most common distraction that is addictive, it is repetitive, and it will hold the attention of a driver for an extended period of time, increasing the risk of a crash. As a reminder, with Senate Bill No. 37, drivers can utilize their cell phone; however, they must do so by Bluetooth or speaker technology and ensure the phone is not in their hands or supported by any part of their body. It also offers a 12-month warning period for drivers so they can become familiar with the law, and there is education for novice drivers as well. This is a real-world issue, it is daily, it is extremely concerning, and I hope that I will get an affirmative vote from the Members of the Senate for Senate Bill No. 37, sending a clear message that we need drivers to put their phone down while they are driving.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Dauphin, Senator DiSanto.

Senator DiSANTO. Mr. President, I rise today to oppose Senate Bill No. 37. Nobody supports distracted driving, but this issue goes beyond mobile devices targeted in this bill. Will another bill advance making a primary offense of drinking coffee, eating messy fast food, holding pets, applying makeup, using CB radios, or even reading from non-mobile sources? Pennsylvania has had

a ban on texting while driving as a primary offense since 2012. And yet here we are with the State poised to criminalize even holding or supporting a phone. This legislation provides another opportunity for harassment by self-righteous drivers themselves distracted in their search for violations and for police issuing revenue-generating citations without making our families or roads any safer. Paradoxically, another set of Pennsylvania citizens driving newer cars with larger touchscreens--that have the ability to become even more distracted by offered features while being able to text and call hands-free--will not be in violation of the law but, in fact, could be way more distracted trying to ensure their speech recognition-generated texts are accurate. I also believe historically disadvantaged communities in dense urban areas will be inadvertently targeted by this legislation. We should not continue to erode civil liberties under the guise of safety. There will always be bad actors and irresponsible drivers regardless of the laws we pass. But we must not use every tragic situation to justify new statutes, penalties, and expansion of governmental power. In this case, especially, we already have a law that prohibits the conduct in question. And there are many other sources of potential distracted driving not even being addressed. As we so often argue in other legislative context, let us try enforcing the laws we have before making new ones. I would urge my colleagues to vote "no" on the proposed bill. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Bucks, Senator Santarsiero.

Senator SANTARSIERO. Mr. President, I applaud the gentlewoman from Monroe County for working on this legislation. This issue of distracted driving is one that has been in front of our General Assembly now for well over a decade. The last time that we passed any significant legislation on this issue was over a decade ago. And I believe, in general terms, this legislation is an important step forward. As I stated in the Committee on Appropriations earlier, however, I am concerned about an amendment that took a provision out of the bill as it was originally written, and when that amendment was passed in the Committee on Transportation, and that amendment took out a, I believe, a very important reporting requirement that was in the bill. And I understand the reason is because of an issue with the compilation of data, but I would say that it would be better to have that reporting requirement put back in the bill, if not a more robust reporting requirement, and to collect the data and then worry about the compilation issue later. Not to say that the compilation issue is not significant, but the earlier collection of the data as part of the bill would be an important policy goal, I believe, for this General Assembly. So, I am going to vote in favor of the bill today to move it forward, but I urge our colleagues in the House, when they consider this bill, to amend it, to put that reporting requirement back in, and as I said, perhaps even expand the reporting requirement from what it originally was in the original text of the

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, while I do commend the intent of the maker of the bill, we certainly do not want distracted driving, the first rule is to do no harm. Adding provisions that will allow stops without allowing the collection of data is problematic. We are all aware that there have been problems with people being

stopped because of racial profiling. This is not a new topic to the Commonwealth, and it is not limited to the Commonwealth. The legislative Black Caucus has consistently urged that there be reporting requirements as were once in this bill. The unfortunate removal of those requirements makes this bill not something I can support. I also, should it get out of this Chamber, would hope that the House would amend it, but believe today it is important for us to vote "no." We should not advance this legislation without those reporting requirements. We cannot know what we do not measure, and it has once been said, if it is meaningful, you will measure it. Stopping racial profiling is important. We must measure whether there is desperate enforcement of these provisions and, yes, others. We should not have removed the provisions requiring reporting. And unfortunately, because of the removal of those provisions, I must join my colleagues in the legislative Black Caucus by urging a "no" vote on this bill.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Langerholc.

Senator LANGERHOLC. Mr. President, I rise to ask for support for Senate Bill No. 37 and stand in support of my colleague who introduced the legislation. It is no secret that this has been the product of tremendous work on her part over many years to get to this point. And while these efforts started possibly in another Chamber and have found their way here, it bears mention the tremendous work that has been done and what this bill will ultimately serve, should it be enacted. And no bill that we pass out of this Chamber is perfect, and it always amazes me when we put legislation forward and how quick the naysayers are to rise to pick apart each little detail or to say: well, we should do this, or we should do that. You can always find a reason not to do something, but I think it bears mention that the intent of this bill is to save lives and so, in its current form, it may not be perfect, and that will go through the process as it goes over to the House. The point is, we are one State surrounded by States that have similar legislation to this, and if this bill can save one life, I doubt anyone in this Chamber would oppose its merit. I would ask for an affirmative vote.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I intend to support the measure, but I do take offense to the characterization of the comments that were made by Members on this side of the aisle about the collection of data and how important it is to say that it is nitpicking, I find that offensive. The Members of this side of the Caucus raised a very serious concern in the Committee on Appropriations and it was an excellent articulation along those lines, but they continue to express their frustration about language not being included that addresses that issue. So, to that end, I ask my colleagues to disregard the comments about the nitpicking nature and recognize the comments that they made and the concerns they raised as very serious and appropriate concerns about this legislation.

Thank you, Mr. President.
