Senator BAKER. Madam President, I rise to speak on behalf of Senate Bill No. 506. Guardianship programs count as a fundamental and crucial piece of legal and financial protection for Pennsylvania citizens. When age or medical conditions or serious injuries rob individuals of their independent judgment or coherent decision-making powers, we must have the capable people to step in and protect their interests, whether it is to manage their general well-being, oversee financial affairs, ensure proper medical care, or manage and protect personal property. When full guardianship starts to become a first option rather than a last resort, when the oversight power is exercised infrequently, and when there is no standard certification for growing pools of guardians, the system can be subject to unhelpful rigidity and catastrophic abuse. As everyone involved in consumer and public protection realizes, there seems no limit to what bad actors can conceive to exploit our vulnerable citizens.

To underscore this point, the bill before us is rooted in a notorious embezzlement case that victimized over 100 individuals. As is true for any legal proceeding, guardianship is one where you must take care, take care to ensure individuals have proper legal representation and have their rights safeguarded throughout the entire process. This means exploring lesser alternatives to full guardianship. If those approaches prove insufficient, then we must make sure legal representatives are properly certified. It should also be clear to everyone involved in the process that the ability to pay should not be a prerequisite for obtaining qualified, competent, legal counsel. Last Session, a solid bipartisan bill passed the Senate; regrettably, it did not go all the way to becoming law. So, Senate Bill No. 506 builds upon our prior work and incorporates professional and public input to strengthen its provision and to make our intent crystal clear. Back in March, the Senate Committee on Judiciary held a joint public hearing with

the Senate Committee on Aging and Youth featuring testimony from experts, advocates, Area Agency on Aging directors, and many commentators. They reinforce for all of us the necessity and utility of the reforms and protections contained in Senate Bill No. 506. With this measure, we ensure that when guardianship is imposed, the court must review and have an established review hearing procedure to prevent individuals from staying in the system if their incapacity or circumstances change. I would like to thank my colleague from Montgomery County for his collaboration and commitment to reform the guardianship system and for serving as the co-prime sponsor of this very important bill. So, we make a lot of presentations about strengthening and protecting vulnerable citizens. This bill is an effective way for us to carry out this on through our commitments and to the citizens of the Commonwealth. I urge an affirmative vote on Senate Bill No. 506.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Montgomery, Senator Haywood.

Senator HAYWOOD. Madam President, I am glad to join Senator Baker in this tremendous and important effort to protect the most vulnerable individuals in our Commonwealth from exploitation and theft. I, unfortunately, got involved in this effort after a neighbor of mine, Mr. Frisby, became the victim of both. The notorious Gloria Byars took money from him and was involved in taking a second property that he owned. Unfortunately, I was not able to respond at the time that the family desired for the challenges that they endured. But I am glad that today we can pass legislation that would protect those like Mr. Frisby and Marie Frisby from similar misconduct. Most important, in addition to the court-appointed lawyer, is requiring professional guardians to be trained to get a certification. The leading organization in the United States is right here in Harrisburg for doing this kind of training. So, it is both convenient and possible. I would also like to thank Stewart Greenleaf; rest in peace. He was an original motivator behind this guardianship legislation, and this is also to his honor. I also urge an affirmative vote on this critical legislation, to protect the most vulnerable in the Commonwealth. Thank you.

- (d) A school entity shall provide a copy of the opt-out form to parents, legal guardians and students.
- (e) If a FAFSA is not filed or opt-out form is not submitted on behalf of a student, the school entity may exempt the student from the provisions of subsection (a). Prior to making an exemption, the school entity must make a reasonable effort to contact the parent or legal guardian of the student.
- (f) The agency shall provide a school entity with information indicating whether a student of the school entity has completed the FAFSA.

- (g) Nothing contained in this section shall be construed to require a parent, legal guardian or student to provide personal financial information to a school entity.
- (h) Personal financial information inadvertently obtained from a parent, legal guardian or student by a school entity as a result of administering this section is not a public record accessible for inspection and duplication in accordance with the act of February 14, 2008 (P.L.6, No.3), known as the "Right-to-Know Law."
- (i) As used in this section, the following words and phrases shall have the meanings given to them in this subsection unless the context clearly indicates otherwise:
- (1) "Agency" shall mean the Pennsylvania Higher Education Assistance Agency.

- (3) "FAFSA" shall mean the Free Application for Federal Student Aid.

Senator ROBINSON. Madam President, I rise today to support Senate Bill No. 260, legislation to authorize parole agents to use body cameras. With this bill, we are simply amending the definition of oral communication in Title 18 to include parole agents to the list of other law enforcement officers so that they will be authorized to use body cameras. During the 2022 budget hearing with the Department of Corrections, they informed us that it would be extremely helpful for their parole agents to be able to use body cameras like the other types of law enforcement officers who are currently allowed to do so, such as the sheriff's deputies, municipal police officers, and members of the State

Police. Because State parole agents routinely put themselves in harm's way when performing their duties, having body cameras would provide a degree of transparency and protection for both the agent and parolees as well.

With the authorization proposed under Senate Bill No. 260, situations will deescalate because both parties are aware of the recording in process. Liability will reduce false accusations that are made against the agent, and agents will be held accountable for their actions as well. It is important to note that this bill is not a mandate. This is simply authorizing legislation. We worked closely with the Department of Corrections and the Pennsylvania State Police on this language, and we received strong bipartisan and unanimous support in the Committee on Law and Justice last week. Also, the Governor indicated his support for this as part of his proposed budget. And as the son of the former director of Probation and Parole, I am proud to be in a position to advocate for our State agents.

Thank you, again, Madam President, and I respectfully ask my colleagues for an affirmative vote.

Senator BROOKS. Madam President, Senate Bill No. 500--Owen's Law--requires public insurance coverage of human donor milk for babies with acute care needs and moms who are unable to supply breast milk for their babies. This coverage includes during the babies' hospital stay and when they go home for up to 1 year. Owen's family lives in Indiana, Pennsylvania. Owen was born at a gestational age and birth weight slightly below hospital criteria that would have made him eligible, under this legislation, to receive human donor milk. Owen sadly passed away after contracting a serious gastrointestinal inflammation, known as NEC, that causes lifelong disabilities or death in babies. Had Senate Bill No. 500 been in law when he was born, Owen would have received donor milk as a direct result of his birth symptoms and medical needs. Research has proven that an exclusive human milk diet can decrease the overall incidents of NEC by up to 80 percent.

This legislation is so very important, especially during these unprecedented times, coming out of a national baby formula shortage, supply chain issues, and financial stress on Pennsylvania families. The level of medical necessity for donor milk coverage for these babies includes those born prematurely, suffering from gastrointestinal issues or NEC, and sadly, those in the care of our neonatal intensive care units for any number of reasons. not the least of which is an increased prevalence of babies born addicted to illicit substances or alcohol. We have received numerous letters of support for this legislation: American Academy of Pediatrics, Pennsylvania Catholic Conference, Children's Hospital of Philadelphia, Excela Health, Human Milk Banking Association of North America--HMBANA--Mid-Atlantic Mothers' Milk Bank, The Midwife Center, the NEC Society, UPMC Children's Hospital of Pittsburgh. Madam President, I ask that my colleagues support this life-saving measure for babies across this Commonwealth.

Senator SCHWANK. Madam President, thank you for consideration of Senate Bill No 500, which is co-sponsored with my colleague Senator Brooks. This legislation would require medical assistance coverage for medically prescribed pasteurized donor human milk in inpatient and outpatient settings for medically fragile infants under the age of 12 months. The medical evidence is clear, and Senator Brooks covered much of it. Premature and ill infants whose main diet consists of human milk, with donor milk utilized when the mother's own is unavailable, suffer less complications, have shorter hospital stays, experience less readmissions, and are more likely to transition to an exclusive maternal milk diet. In the absence of coverage, there is greater variability in NICU usage and outpatients. Outpatients with complex medical needs go without a simple provision that can so greatly impact their well-being. Medical assistance coverage for medically necessary donor milk is an essential part of any plan to ensure that medically fragile infants have everything that they need to survive. Senate Bill No. 500 does an excellent job of directing resources to hospitalized and outpatient infants with the most critical needs for human milk, and I would certainly ask for an affirmative vote for this commonsense legislation. Thank you.

Senator L. WILLIAMS. Madam President, we considered Dr. Mumin's nomination in the Senate Committee on Education this morning. I would like to submit my remarks from the hearing for the floor record. Thank you.

The PRESIDENT pro tempore. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentlewoman from Allegheny, Senator L. WILLIAMS:)

Good morning Dr. Mumin, it is nice to see you again. We have not been able to spend much time together yet, only one 30-minute confirmation meeting and the Committee on Appropriations hearing a few months ago. But I think we are on the same page on many education issues. You bring a wealth of varied experience to the role of Secretary, from your time at Reading School District to your time at Lower Merion School District. You have spent time in under-resourced districts and in districts that have a local tax base that can provide students with more opportunities than most. And anyone I have spoken to about you has had glowing recommendations.

I was all set to be an enthusiastic "yes". I was all set to come here this morning and ask you about continuing the wildly successful universal free breakfast program and getting on a path towards making sure all kids have full bellies throughout the school day. I wanted to spend time talking about early learning and school facilities. I wanted to dig into opportunities for career and technical education and dual enrollment. And I wanted to figure out what we can do to support our community colleges and PASSHE system and to make higher education more accessible for all students. However, I cannot, in good conscience, focus on any of those issues today. I have to talk about your answer to the first of a list of questions that you received from the Senate Republicans. You stated, the Governor "favors adding choices for parents and education opportunity for students and funding Lifeline Scholarships as long as those choices do not impact school district funding." The Governor and, by extension, you, as the Secretary, are wrong. There is no way to create so-called Lifeline Scholarships without harming public school district funding. Any and every public tax dollar that is sent to a private or religious school is one less dollar that can be sent to our public schools, our public schools that the vast majority of students attend, our public schools that the Commonwealth Court said we are unconstitutionally underfunding and unconstitutionally inequitable funding. There is a finite number of dollars generated each year in revenue, and those dollars will be less as a result of the massive corporate tax cut and the historic increase in the EITC and OSTC tax credits passed last Session.

We do not know the exact dollar amount that will be needed to get us to an adequacy target as ordered by the Commonwealth Court, but it will likely be in the billions. We have students learning and educators teaching in toxic schools that are making them sick. We have schools closing for days at a time because they have no air conditioning and are uninhabitable. We have classrooms without enough books. And we have schools without school counselors, therapists, librarians, paraprofessionals, and substitutes, just to name a few. Basically, we do not have enough caring adults in our buildings.

Any dollar that goes to an unaccountable private institution instead of our public schools is a moral failure and a constitutional violation.

Costa

Public money being spent on private schools has been, and will continue to be, my line in the sand. I have voted against School Code bills that have included my own priority pieces of legislation because they included massive increases to the EITC/OSTC tax credits, which are backdoor vouchers. I want you, and I want the Governor's office, to know that I am vehemently opposed to Senate Bill No. 795 and will be opposed to any bill like it. I will also be vehemently opposed to any budget deal that includes Senate Bill No. 795 or anything similar. The question before me this morning is: do I vote against an otherwise exemplary nominee for Education Secretary because he is promoting the Governor's agenda of diverting much-needed public tax dollars to unaccountable private schools? Deciding how to vote today has been incredibly difficult. I have honestly lost a lot of sleep over it, and I guess only time will tell if I will regret my decision.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Chester, Senator Kane.

Senator KANE. Madam President, today I rise to address an issue that impacts every person in our Commonwealth: drug addiction and overdoses. Addiction is a chronic disease that affects millions of people across our country and must not be taken lightly. Addiction goes--I should say addiction does not discriminate and can destroy anyone regardless of their background or status in life. It is important to understand that drug addiction is not a personal issue but a societal one. It affects not only the individual struggling with addiction but also the loved ones and the community as a whole. By recognizing the gravity of this situation, we can begin to take the necessary steps to address it. In 2021, over 100,000 people in the U.S. died from drug overdoses,

with Pennsylvania alone reporting 5,331 deaths. As someone who has witnessed the devastating impact of addiction, these statistics represent real people with families and loved ones left to mourn. The thought of so many lives lost to overdose is heartwrenching and is imperative that we prioritize access to resources and support for those struggling with addiction. We must provide individuals with the tools they need to rebuild their lives and break the cycle of addiction. Senator Kearney and I have introduced Senate Resolution No. 142 to recognize August 31, 2023, as Overdose Awareness Day in Pennsylvania. This resolution will bring awareness to help those who have struggled with overdoses and drug addiction. This August 31 at the State Capitol front steps, we will join families to remember those who have lost their loved ones to drugs and overdoses and honor their memory. To those struggling with addiction, you are not alone, and it is not too late to save your life. There is absolutely no shame in asking for help before any overdose claims your life. Reach out to me or to any of the resources available to you and know that this community of people are there to help and support you.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Delaware, Senator Kearney.

Senator KEARNEY. Madam President, I rise today along with my colleague Senator Kane to speak on Senate Resolution No. 142 that will mark August 31, 2023, as Overdose Awareness Day in Pennsylvania. It is far past time for our Commonwealth to shed light on an epidemic that continues to plague residents across the Commonwealth, which is what Senate Resolution No. 142 seeks to do in recognition of overdose awareness. Overdose awareness is about finding the understanding, compassion, and love for those who continue to struggle with drug addiction. It is about understanding the impact that overdoses have on families, on mothers, fathers, brothers, sisters, and grandparents alike. Often, overdoses can bring a sense of shame to individuals and families, and this shame can cause us to push the issue aside. We cannot let that continue to happen. Drug addiction and substance abuse does not impact one individual or one community, it impacts us all. On average, Pennsylvanians will see nearly 15 overdoses a day in this year alone. That is why it is so important to bring awareness, to listen to individual stories, and to remind each other that we are not alone. Awareness brings about better understanding and leads to innovation and hope. We are making progress; last Session we took steps to legalize fentanyl test strips, but even further, we allow for those test strips for future drugs, like psilocin, to also be used so that we can stop deaths before they happen. But until we lift up individual stories and cast aside the shame that comes to individuals struggling with substance abuse, we will continue to alienate and push away the issue. Bringing awareness is about bringing our sense of compassion, our understanding, and our love to those who continue to struggle, to acknowledge their struggle, and to continue the fight.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Madam President, I rise because today marks 6,196 days since this Commonwealth's legislature last passed an increase in our minimum wage. For those counting along and playing at home, 6,196 days are 885 weeks, 203 months, or 16 years, 11 months, and 16 days. It is striking, Madam President, that we have failed to act for nearly 17 years on behalf of our low-wage earners. Now, the Commonwealth's June 30 budget deadline is just a few days away. This Friday, we are tasked to have a budget passed and in place so that our Commonwealth may continue to operate for the coming fiscal year. But more than just making sure we can pay our bills and continue to serve our residents of Pennsylvania, this is not just a financial plan we are setting forth, it is a moral benchmark. We are showing and telling our neighbors, our fellow Pennsylvanians, and the rest of the world that we understand in 2023, \$7.25 an hour just does not work. Across our Commonwealth, tens of thousands of our neighbors and our constituents are barely getting by on our embarrassing, low, poverty-level minimum wage. Pennsylvanians deserve better, Madam President. No Pennsylvanian should work a full-time job and have to worry about paying rent or putting food on the table. That is why I introduced Senate Bill No. 12 because almost 17 years of inaction is too long. We need to show Pennsylvanians that our priorities include ensuring Pennsylvania's most vulnerable people, its low earners, are included in the prosperity and growth we have seen. Pennsylvania workers deserve better, Madam President. Pennsylvania workers deserve Senate Bill No. 12.
