The PRESIDENT. The Chair recognizes the gentleman from Franklin, Senator Mastriano.

Senator MASTRIANO. Mr. President, I rise in support of Senate Bill No. 683. I would like to thank Senator Brooks for her partnership and leadership in drafting this excellent legislation. Senate Bill No. 683 requires a general acute care hospital treating a person who is receiving a standard 5-panel urine drug screening to include testing for fentanyl and xylazine. Unbeknownst to many doctors, a regular opiate test does not currently require this. According to the studies that we have looked at, only 5 percent of toxicology screens currently test overdose patients for fentanyl. This number is even less for xylazine testing. Fortunately, rapid fentanyl and xylazine testing does exist. There are three low-cost CDC-approved tests that can be used.

Fentanyl is now the number one cause of death for Americans ages 18 to 45 in the United States, and the overdose crisis has affected communities across the Commonwealth. As if that was not bad enough, now our Commonwealth must confront the rising crisis of xylazine, a lethal tranquilizer that is being increasingly mixed with other drugs and leading to even more overdose deaths in our Commonwealth. Most current emergency room drug screens do not capture fentanyl and xylazine use, and some patients are unaware that they are even using it.

Here is an example of how mandatory hospital testing would have saved a life: a 16-year-old male was admitted to the hospital after a presumed drug overdose. He was in a coma for several weeks before being pronounced brain dead. A drug screen on admission was negative, but a fentanyl test never was obtained, and he subsequently, because of this, passed away. Senate Bill No. 683 can help save lives in a number of ways. It can alert the patient or a doctor, provider, or the parents; prompt a prescription of naloxone; make the patients dispose of any counterfeit pills they are using that are laced with xylazine or fentanyl; as well as help us connecting the patient with drug treatment or to affect change in their lives. Additionally, it can help law enforcement in the prosecution of drug dealers. Senate Bill No. 683 will also ensure that our Commonwealth is getting a more accurate account

of statewide fentanyl and xylazine overdoses. Mirror versions of Senate Bill No. 683 have become law in California and Maryland, and I am hopeful that we can accomplish the same thing here in Pennsylvania to save lives. I respectfully ask for an affirmative vote.

Thank you, Mr. President.

Senator MARTIN. Mr. President, I ask my colleagues for an affirmative vote on Senate Bill No. 750. Too many families in Pennsylvania miss out on chances to train for a quality career simply because they do not know what programs or funding packages are available to them or because they think they cannot afford it. Universal FAFSA completion ensures families can make an informed decision about whether to pursue a job training

program, maybe going to a technical or a community college, or even a 4-year college. It is a commonsense way to address workforce needs and boost education empowerment and access, which are among the key priorities and principles shared by my colleagues. When we all know our common knowledge of the fact that Pennsylvania is one of the worst States for average student debt on top of this, these issues combined make this a critical, critical thing to address.

The National College Attainment Network estimates that \$3.75 billion in Federal Pell Grants went unclaimed in 2021 alone. We are leaving way too much money on the table, which means we are leaving way too many opportunities for students on the table. Previous data indicates that 91.5 percent of students who complete the FAFSA enrolled in a postsecondary program by the following November, compared to less than 50 percent enrollment for students who did not complete the FAFSA. As of June 9, 2023, Pennsylvania's FAFSA completion rate is only 53 percent. Nine other States have had success with policies pertaining to completion of the FAFSA. When Louisiana implemented its universal FAFSA policy in 2018, the completion rate jumped by nearly 26 percent.

I would like to note that this legislation and final product is due to a lot of hard work and input from educational institutions and associations from all around the Commonwealth, and through their work, along with the gentlewoman from Allegheny County who helped work with us on an amendment, we feel that this bill is a great solution to do what is right for the future of our children and the Commonwealth. I ask for an affirmative vote on Senate Bill No. 750.

Senator ROBINSON. Mr. President, this bill modernizes the Stuffed Toy Manufacturing Act to allow for the use of recycled materials. When the act was originally passed in 1961, the use of recycled materials was not contemplated. Today, many consumers prefer to purchase items made from recycled materials to lessen their environmental footprint. Manufacturers and retailers that wish to sell or distribute stuffed toys containing recycled material are unable to do so in Pennsylvania under its current law. This issue was brought to my attention by the Toy Association who supports the bill. I also want to thank my colleagues Senator Kane and Senator Haywood for working with me on this bipartisan legislation. I respectfully ask my colleagues to support Senate Bill No. 756.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Haywood.

Senator HAYWOOD. Mr. President, I rise also to encourage my colleagues to support Senate Bill No. 756 but want to share a story that comes from my district office. I was really unaware of these outdated provisions, then a man by the name of Chris Kinka, the owner of The Nesting House, a local toy shop in my district, comes by my district office and shares that he cannot sell toys that have recycled materials in them because of a law in Pennsylvania. I was stunned that we would have such an impediment to small businesses that are only trying to make a living by selling toy products. I was so glad to join Senator Robinson and Senator Kane, who identified the same issue with the same level of astoundment that we would have such restrictions on businesses. It is critical that we in this General Assembly remove outdated legislation and regulations that impede business and entrepreneurship. This is such a piece of legislation, far outdated, came about in the 1960s. So, again, I am glad to be a champion with Senator Robinson and Senator Kane, and Mr. President, I encourage a positive vote on this legislation. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Kane.

Senator KANE. Mr. President, today I rise in support of Senate Bill No. 756, a bill that is near and dear to my heart as a cosponsor. As kids, we all cherished our teddy bears more than anything. We loved hugging them, playing with them, and even talking to them. But have you ever wondered what fills those teddy bears we grew up cherishing? No. Well, neither have I. I do not think any of us have really thought about it. With the passage of Senate Bill No. 756, we can do something good with what fills our teddy bears by allowing for the use of recycled materials in stuffed toys. We can take a step forward in protecting our environment and reducing waste. Teddy bears and stuffed toys have filled generations with happiness and love. Mine happened to be

a monkey that still shares my bed with my wife and I, even though he is disgusting and has been chewed up by half of my dogs, he is still loved. It is time to ensure that what fills our stuffed toys will last as long as that feeling that gives us. Our stuffed toys can now be a symbol of sustainability and environmental responsibility. By enabling manufacturers to create more sustainable products, we can provide consumers with more options that are both good for the environment and good for their hearts. We can move forward and create a snuggly, eco-friendly teddy bear or monkey--friends that will last a long time.

I want to thank my colleagues Chairman Robinson and Senator Haywood for working with me on this bill, and the Department of Labor & Industry and the Pennsylvania Toy Association for their support. Mr. President, I urge us to pass this bill, not only for our environment, but for our good old bear friends, Teddy Ruxpin, Yogi Bear, Winnie-the-Pooh, and Paddington Bear, and the ones who still snuggle kids around the world today. Keeping the teddy bear cycle environmentally friendly is near and dear to my heart.

Every single day, approximately 160,000 motorists, including nearly 13,000 commercial trucks, rely on our vital transportation artery. It keeps our travel, economy, and essential services running smoothly. Through this declaration, we secure the necessary resources to keep the repair work going without any delays. I am pleased to share that that temporary bridge is already in place, allowing traffic to flow. But let us be honest, there is still a lot of work ahead of us. Our constituents, both from Senator Farry's district and my own, continue to feel the impact of this situation. That is why it is vital to extend this emergency declaration, ensuring Pennsylvania maintains access to Federal funds and streamlined procedures. It is the key to swiftly and safely repairing I-95. Governor Shapiro's response, backed by the legislation and our Federal and local partners, shows that we can achieve remarkable things. This resolution is a true testament to that spirit. It is a necessary step toward restoring the full capacity of I-95, and with your support, we will make it happen. I-95 will stand as a monument to what we as Pennsylvanians can achieve when we come together. Now, if we could just figure out how to pass our budget up here in the record time frame that we took to fix I-95, I think we will all be in business. Thank you all for your consideration, and I humbly ask for your affirmative vote.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise because today marks 6,198 days since this Commonwealth's legislature last passed an increase in our minimum wage. In that time, Mr. President, nearly 17 years have passed, but our legislative failure of action has not been seen by our neighbors. Every State that neighbors our Commonwealth has acted at least once, and many multiple times, to pass minimum-wage reform and provide higher wages to all their workers. Everyone knows our minimum wage is \$7.25 an hour, but what they may not realize is our neighbors to the north and to the east, New York and New Jersey, both pay their workers at least \$14.13 per hour. Mr. President, I was not a math major, but that is nearly double what the worker in Pennsylvania earns, often doing the same work.

Recently, a study was conducted by the Keystone Research Center and Pennsylvania Budget and Policy Center to see what the effect of having two drastically different minimum wages is. The results were all doom and gloom, right? Wrong. What did they find? They found that wages increased more in New York and New Jersey, dramatically so in the leisure and hospitality sector, compared to Pennsylvania. They also found that wages increased more in New York and New Jersey. They also found that employment trends differed very little with one exception, leisure and hospitality employment grew significantly more in New York. Mr. President, when workers have more money, they have more disposable income to spend on leisure and hospitality. They also found that Pennsylvania and New York workers, along with northern borders, are behaving quite sensibly. Pennsylvania workers are crossing the border to get a living-wage job. Meanwhile, fewer New Yorkers are likely coming to Pennsylvania to take what would be a poverty-wage job.

Mr. President, across the Pennsylvania border, low-wage employers cannot find workers to fill vacancies because often just miles away workers can cross the border and often double their hourly wage. It makes sense, Mr. President, workers can support their families and support local businesses with increased consumer buying power when wages go up. We have seen time and time again, we are not facing a mass exodus of jobs by raising our minimum wage. What we are seeing is when workers have more money, they participate more fully in our local economy. Mr. President, let us ensure all Pennsylvanians are able to just not survive, but thrive. Let us raise our minimum wage. Let us pass Senate Bill No.12.

Thank you, Mr. President.
