May each Senator, staffer, each person with business here today, be among those who call on You for wisdom, energy, and guidance. May they say "yes" to the compassion in their hearts for the least among us. May their every act be made in service of love for others. Amen.

GUEST OF THE PRESIDENT PRO TEMPORE PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentlewoman from Westmoreland, Senator Kim Ward.

The PRESIDENT pro tempore. Mr. President, today I have the distinct pleasure of introducing a gentleman--yes, and he is a gentleman--who is a shining example of community spirit and community involvement and dedication in Westmoreland County, Chief Thomas Bell of the Greensburg Volunteer Fire Department. Chief Bell's many contributions to our community have no bounds and are worthy of deep gratitude and respect. In August of 2023, Chief Bell was named Fire Chief of the Year by the International Association of Fire Chiefs in partnership with Pierce Manufacturing. He is a good person and a natural leader, and it comes as no surprise that he was selected to receive this honor considering his commitment to serving the public with integrity and a dedication to professional development through innovation with the men and women who serve alongside him. With nearly 50 years of experience, Chief Bell's visionary approach has brought remarkable improvements to the department and our Greensburg community. He has worked his way up the ladder--no pun intended--ascending from a junior firefighter to chief.

His leadership has been a catalyst for positive change. Using skill and kindness, he led the department through a systemic transition, which included bringing in younger leaders with a passion for building a vibrant fire department. Chief Bell's strategic reorganization of leadership positions, implementation of training programs, and emphasis on community engagement have invigorated the department and garnered support from both members of the department and the public. His commitment to fostering a culture of inclusiveness and respect within the department led to the implementation of a mandatory "Dignity Statement" policy, addressing harassment and bullying head-on. Chief Bell is a transformative leader, bringing significant operational improvements to the department, and his initiatives have had a profound impact on the department's response capabilities and overall community betterment. Chief Bell is an amazing individual, and I am glad that he is my hometown fire chief. You know, when you need something in Greensburg, if you have an issue with so many things, even outside the fire department, you can call Chief Bell, and he is a great catalyst for making sure that things are done right. So, congratulations, Chief Bell, on this very well-deserved

honor. The people of Greensburg and Westmoreland County love and respect you.

GUESTS OF SENATOR LISA M. BOSCOLA AND SENATOR DANIEL J. LAUGHLIN PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, I am honored to introduce a group of passionate and engaged young individuals who represent Students for Ballot PA, and they are here with David Thornburgh, president and CEO of the Committee of Seventy. This group, the Students for Ballot PA, is represented by numerous universities across our Commonwealth with students joining us today in the gallery from Bryn Mawr, Carlow, Carnegie Mellon, Gettysburg, Haverford, Kutztown, Pitt, and Swarthmore. The "Swats" are in the Senate--that is what they told me they call themselves, the "Swats," which I thought was really pretty cool. Anyway, I had the pleasure of meeting with these students before the start of Session today. It is incredibly refreshing to witness this group of nonpartisan, volunteer-driven students advocating for a critical change in our electoral system. These students, this group, which is self-organized, meets every Sunday afternoon to talk election law. Now, how many college kids do you know who take the time to give up that kind of time on a Sunday to do something like this and talk election law? I think it is fantastic. Some of them even woke up today at 4:30 in the morning just to get here by 9 o'clock. This is the type of dedication and determination we should celebrate in this Chamber.

It shows that the next generation is paying attention to what we do here. And they care because unaffiliated voters constitute 13 percent of the voting population here in Pennsylvania, which is the fastest-growing segment of registered voters. And, with the recent implementation of the Governor's motor vehicle registration initiative, they have begun to even outpace Democratic

registration. It is incredible. Recent national-level research indicates that 61 percent of 18 to 24-year-olds do not align with any major political party. This disengagement reflects a broader trend, where today's college students, having grown up in a polarized environment, increasingly distance themselves from traditional party affiliations.

These students, they gather here today, the Students for Ballot for PA, they advocate for legislative changes embodied in the measure that I have introduced along with my colleague Senator Dan Laughlin from Erie for Senate Bill No. 400, allowing Independents to vote in the primary. Our bipartisan proposal, and a similar one that may soon be voted in the House--this bill may soon be voted in the House--seeks to allow Independents the right to participate in primary elections aligning with the principles of fairness, accountability, and no taxation without representation. Their cause, my cause, and other cause is endorsed by all five living, former governors and a growing coalition of civic, community, and business organizations. As the inheritors of our democratic system, these students call for the repeal of closed primaries, urging the Senate to move these bills forward, and pave the way for a more inclusive and responsive Pennsylvania democracy. Let us welcome these passionate, caring students as they advocate in the gallery, Students for Ballot PA, who embody the hope of a reformed and improved electoral system in our great Commonwealth. Please join me in welcoming them and giving our usual warm Senate welcome.

Senator LAUGHLIN. Mr. President, today I rise to welcome the group of young individuals who are seated in the gallery from Students for Ballot PA to the Pennsylvania State Capitol. They are here today as Independent voters who have checked "no affiliation" or "none" on their voter registration form, but still want their voices to be heard. In a bipartisan approach, I, along with Senator Boscola, introduced Senate Bill No. 400 that would allow just that. All registered voters deserve to participate in our primary elections, and I thank them for attending today to help defend democracy. So, I ask my colleagues to join me in giving Students for Ballot PA a warm Senate welcome.

Through this terrifying time, she discovered she is BRCA1 positive, although there are no known cases of breast cancer in her family until now. This genetic testing is so valuable, and I am, once again, reminded of the importance of my bill with Senator Kim Ward and Senator Pennycuick that removes out-of-pocket costs for BRCA screenings and MRIs and ultrasounds for women with high-risk factors. Act 1 was signed into law earlier this year, and now, Cara can rest assured knowing that her children have this important access and information about their own health.

Tomorrow, Cara receives the Pennsylvania Breast Cancer Coalition award at their 30th anniversary conference. What an honor to be recognized not only for your strength, but for your outpouring of support and camaraderie to other women who are going through the same diagnosis. Cara uses her journey through her book "Not the Breast Year of My Life" and sharing on-air at WPXI to inspire other women by encouraging them to fight like a mother every day. The Pittsburgh community is extremely proud of you, Cara. Please join me in welcoming 2023 Pennsylvania Breast Cancer Coalition awardee and my constituent, Cara Sapida.

Senator TARTAGLIONE. Madam President, I rise and ask my Senate colleagues to join me in supporting Senate Resolution No. 183 and recognize this month of October 2023 as National Physical Therapy Month here in Pennsylvania. Madam President, physical therapy and therapists play a huge role in ensuring Pennsylvanians and people across the world can improve their quality of life. In addition to relieving present ailments such as arthritis, repetitive stress injuries, posture problems, sports injuries, or back and neck pain, physical therapists can prevent bodily injuries by providing individuals with customized exercise plans. National Physical Therapy Month's theme this year is "Value of PT," which is beyond physical wellness and medical savings, highlights of the emotional rewards and fulfillment felt by undertaking physical therapy. Madam President, it should come to no surprise to the Members of this Chamber that I have had my fair share of experience with physical therapists over the last 2 decades. The passion and drive of these incredible medical professionals have helped keep me going while reducing pain and discomfort. I would also like to recognize that on Saturday, October 21, many of these professionals will be out supporting their communities as part of Global Physical Therapy Day of Service. I ask that my Senate colleagues join me in recognizing the month of October 2023 as National Physical Therapy Month in Pennsylvania.

Senator TARTAGLIONE. Madam President, I rise because today marks 6,308 days since our Commonwealth's legislature last passed an increase in our minimum wage. My home in Philadelphia, Madam President, is often referred to as the City of Brotherly Love, but the city which should be a shining beacon on the hill is sadly plagued by a stark reality. It holds the dubious distinction of being the poorest big city in America. A crisis did not occur by chance, but rather signifies the results of decades of systemic issues and disinvestment in our most vulnerable citizens. Our fellow Pennsylvanians are struggling, living on the fringes of economic disaster, Madam President. The cost of living continues to rise while our Commonwealth's low-wage earners' pay remains the same. But raising the minimum wage in Pennsylvania is not just a policy change, Madam President, it is a lifeline for those trapped in the vicious cycle of poverty. When we increase the minimum wage, we give thousands of hardworking individuals and families the opportunity to afford necessities, a

roof over their heads, food on their table, and access to healthcare. By alleviating these challenges, we can address so many of the hardships that so many of our neighbors face on a daily basis.

But the impact goes beyond individual well-being, Madam President. A higher minimum wage is one of the best catalysts for economic growth. Low-wage earners, when they receive a fair wage, tend to spend more in their communities. This increased spending supports local businesses, creates jobs, and generates economic activity. Raising the minimum wage is not about handouts, Madam President. It is about providing a hand up to those who need, while boosting our Commonwealth's economic strength. That is why I introduced Senate Bill No. 12, Madam President. We need to extend the proverbial hand to the Pennsylvanians who need it most. Madam President, Senate Bill No. 12 would finally put Pennsylvania's low-wage earners on a path to \$15 an hour and boost the pay of tens of thousands of our lowest earners almost immediately while providing an economic safety net to even more. Our Commonwealth's workers deserve better, Madam President. Our Commonwealth's workers deserve Senate Bill No. 12.

Senator ROBINSON. Madam President, I rise today to recognize and honor the 248th anniversary of the United States Navy, which occurred this past Friday, October 13. As a proud veteran of the United States Marine Corps, which is a department of the Navy, I am pleased to commemorate this branch and its sailors responsible for serving on, above, and below the water throughout the world. The central theme of this year's celebration is "248 Years of Power, Presence, and Protection," which highlights the Navy's longstanding commitment to being forward deployed, highly trained, and dedicated to defending American interests at sea.

Beginning with its establishment in Philadelphia in 1775 and continuing to its current modern fleet, the Navy has been on the forefront of defending America. The United States Navy has been the shield of the Republic for nearly two and a half centuries and is a significant element of Pennsylvania's history as they work tirelessly to defend our freedom, preserve economic prosperity, and keep the seas open and free. Please join me in honoring the sailors who have served, and are currently serving, in our distinguished U.S. Navy, and let us wish them a very happy birthday.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Montgomery, Senator Cappelletti.

Senator CAPPELLETTI. Madam President, today I rise to bring awareness to something that is deeply personal to me, Senate Resolution No. 189, recognizing October as Pregnancy and Infancy [Infant] Loss Awareness Month here in Pennsylvania. The road to parenthood is a deeply personal one, not often linear and full of heavy emotions. Since my husband and I began our journey to start a family, we have been very open and honest about our struggles that we have faced, about the fact that we have joined a club that no one wants to be a part of. But in doing so, we have discovered there are more of us than we ever knew. People all across the Commonwealth have connected with me, not only to remind me, but themselves, that we are not alone.

Many of us have this experience, and almost as many went on to start a family, including myself.

According to the Centers for Disease Control [and Prevention], more than a million pregnancies end in miscarriage or still-birth every year. And 1 in 4 women will experience a miscarriage in their lifetime. So based on these statistics, this experience is not uncommon, and you more than likely know someone who has experienced the loss of a pregnancy. Despite October being proclaimed Pregnancy and Infant Loss Awareness Month in 1988, the conversation surrounding pregnancy and infant loss has remained in the shadows. Those of us who experience pregnancy or infant loss may find it difficult to talk about and have trouble navigating the grief.

As a State Senator, I had and have the flexibility to take time away from my work when I need to. But most of my constituents and citizens all across this Commonwealth do not have that luxury. Because of my own experiences, and with others in mind, I introduced the paid leave for pregnancy loss bill. Through this legislation, individuals would be provided 3 days of paid leave if they suffer a pregnancy loss. By providing 3 days of paid leave, we acknowledge the emotional and physical pain and trauma of losing a pregnancy. We give individuals and families at least a little time and space to grieve. There is no linear way to mourn the loss of a pregnancy or an infant, but we can modernize our laws to aid individuals and families in their grieving process. It was about this time 2 years ago, shortly after my second miscarriage, that I first spoke in recognition of Pregnancy and Infancy [Infant] Loss Awareness Month, and the genuine support offered by my colleagues from both sides of the aisle meant the world to me, and it still does. I hope that you all will join me in offering that same genuine support to people struggling to grow their families or start their own families all across this Commonwealth and recognize October as Pregnancy and Infancy [Infant] Loss Awareness Month.
