Senator MASTRIANO. Mr. President, I rise in support of Senate Bill No. 933. This measure would enhance the oversight at our six State veteran homes through their advisory councils. This bill would stipulate that the advisory councils are to advise the Adjutant General of our State on resident care management operations and compliance as well, and most importantly, for the wellbeing of our veterans residing there. Additionally, it would revamp the councils to include 15 members that would also encompass a family member of a current or past resident, something that my colleague Senator Baker worked with me on. Nominations would come from veterans' organizations from around the homes. It would also require the department to provide subject matter expertise to be available at each meeting. Additionally, it would make the meetings open for public review and consideration and require an annual report to be provided to this body. This language was worked on with the Department of Military and Veterans Affairs and is supported by the U.S. Department of Defense-State Liaison Office as well. It is important that we do our utmost to uphold the standard and care for our veterans in our six homes across the State, and this measure would do just that.

Thank you, Mr. President, and I ask for an affirmative vote.

On the question, Shall the bill pass finally? The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Langerholc.

Senator LANGERHOLC. Mr. President, I rise to ask for support for Senate Bill No. 934. Senate Bill No. 934 will amend Act 247 of 1968, which is the Pennsylvania Municipalities Planning Code, to exempt the Pennsylvania Turnpike Commission from local ordinances that are more stringent than the Department of Environmental Protection. What Senate Bill No. 934 will do--it will place the Turnpike Commission under the same exemption as PennDOT, providing uniformity which supersedes local ordinances in the discharge of traffic laws. As mentioned, unlike PennDOT, the Turnpike Commission is not exempt from these local ordinances and must follow stringent regulations to design, permit, and construct stormwater reduction strategies and the like. Without this bill, the commission must continue to address these conflicts and spend upwards of \$25 million. This will save upwards of \$25 million across the board, provide uniformity with the same exemptions that PennDOT is afforded to the Turnpike Commission. I would ask for an affirmative vote to help reduce project delivery costs and provide for uniformity across the Commonwealth's transportation system.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Dauphin, Senator DiSanto.

Senator DiSANTO. Mr. President, I support the legislation and the maker of the bill, but I would also like to point out that local and statewide businesses have to go through this same process every day. And I certainly hope that Governor Shapiro's Administration follows up on their recommendation to eliminate overregulation of businesses in Pennsylvania and try to make us more competitive in the marketplace. Thank you.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Martin.

Senator MARTIN. Mr. President, I rise today to recognize Senate Resolution No. 192, sponsored by Senator Langerholc, Senator Argall, and myself that designates this week of October 16 through 20 as School Bus Safety Week in Pennsylvania. Each year, hundreds of thousands of school buses across our nation travel over 4 billion miles, transporting roughly 25 million students to and from school and school-related activities. Our school bus drivers do this with an impeccable safety record compared to the general public, and for that, we thank them. School Bus Safety Week is recognized in accordance with the National Association for Pupil Transportation, and both PennDOT and the PA School Bus Association have put out reminders to motorists on how they can do their part to ensure safe passage of our children. Each of these organizations include a wealth of information on school bus safety, and I encourage all motorists to review these tips to keep our kids safe. Our school bus drivers are directly responsible for the well-being of our most precious resource when they are traveling on our roads. It is important that we thank them and encourage our fellow motorists to be mindful of all traffic laws and regulations when in their vicinity. Designating this week of October 16 through 20 as School Bus Safety Week helps do just that.

Senator MARTIN. Mr. President, October is recognized as Down Syndrome Awareness Month across this nation, and I am proud to continue to bring attention to the value that nearly 400,000 people living in the United States with Down syndrome have in our communities. Those living with Down syndrome can have different physical and mental characteristics, but the lives they live are truly extraordinary. With early intervention, therapies, quality education, and support from families in our communities, individuals with Down syndrome adapt, and they thrive. They attend school, complete college and job training programs, obtain full-time employment, get married, climb mountains, and achieve things some of us never dare to try. They experience fulfilling lives, and the message we send with this resolution is that

these lives are valued and worthwhile. Our friends and neighbors with Down syndrome bless us every day, and it is my hope that we can continue to honor them by designating October 2023 as Down Syndrome Awareness Month in Pennsylvania.

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Muth.

Senator MUTH. Mr. President, I rise today in support of Senate Resolution No. 83, a resolution that I have introduced along with Senator Lindsey Williams and Senator Pennycuick, which would designate the week of October 15 through October 21 as Military Sexual Trauma Survivor Week in Pennsylvania. The resolution, which was drafted by two veterans who are survivors of military sexual assault, has been previously introduced every year since 2019. Mr. President, this is such a serious issue and troubling issue in our military. And while our military, the Department of Military and Veterans Affairs, and the Department of Defense have started to address this issue, we can, and we must, do so much more; at minimum, at least by acknowledging that this is a persistent problem and has already impacted hundreds of thousands of our own constituents of people that have served in our military serving our country.

According to VA statistics, 1 in 3 women and 1 in 50 men report that they experienced sexual harassment and/or sexual assault during military service when asked by their VA healthcare provider. Anyone in the military can experience military sexual trauma regardless of their age, race, ethnicity, gender, sexual orientation, physical abilities, or branch of service. MST can occur at any time or place during this military service assignment while on or off duty or on or off base. The psychological impact of the assault and resulting trauma can push survivors out of the service and lead to tremendous difficulty readjusting to civilian life. Although MST can be a life-changing experience, sometimes for the worst, obviously, survivors are remarkably resilient. Some recover on their own, but most need additional support and the experience of an MST therapist to help deal with the aftermath of what has happened to them.

In addition to Senate Resolution No. 83, Senator Lindsey Williams and I have also introduced Senate Bill No. 924, which would establish an annual day of recognition and awareness to honor the strength, resolve, perseverance, and acknowledge what happened to many of our armed service members. We need to work urgently to end sexual violence in the military and throughout our entire society and throughout this Commonwealth. And it can start with something as simple as acknowledging and recognizing those who have already been harmed and are victims of military sexual trauma by passing Senate Bill No. 924. Thankfully, the House is taking this issue seriously, and with the leadership of Representative Johanny Cepeda-Freytiz, the House adopted the companion resolution to Senate Resolution No. 83. House Resolution No. 189 passed by a vote of 202 to 1 on Monday. And yes, you did hear that right. There was one "no" vote, and I cannot imagine who would not want to support survivors of military sexual trauma. Mr. President, this is not a partisan issue, and every elected official should stand up to support our survivors all across this country and all across this Commonwealth. I ask my colleagues to support all survivors of military sexual trauma and support this resolution and work with our Caucus to get Senate Bill No. 924 passed and signed by the Governor.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise because today marks 6,310 days since our Commonwealth's legislature last passed an increase in our minimum wage. To put it bluntly, Mr. President, we are failing Pennsylvanians. I am sure that all of my colleagues are familiar with the crisis that is facing down the American workforce, as the number of people in the labor force who are 75 and older grew 53.7 percent from 2010 to 2020 and is projected to continue to grow 96.5 percent between 2020 and 2030. Too many of our seniors and older Pennsylvanians are well behind where they need to be to retire, Mr. President. How can we expect minimum-wage and low-wage workers to save for retirement when they are not even paid enough to ensure their basic needs are taken care of? Raising the minimum wage is not just a matter of economic fairness, it is a crucial step towards ensuring that Pennsylvania seniors can retire with dignity and financial security. The current state of retirement savings in the United States and Pennsylvania paints a grim picture, with a substantial portion of the aging population ill-prepared for their golden years because they are not paid well enough to both meet their current financial needs as well as prepare for their future.

Mr. President, I am sure you know the recommended savings for retirement is 6 times one's current income at the age of 50. For minimum wage earners, achieving this target is nearly impossible, leaving their future financial situation in a perilous place. With no discretionary income and no flexibility in their budgets, low-wage earners are being left behind when it comes to building wealth and saving for their future. Mr. President, raising the minimum wage is a critical step towards addressing one of the leading causes of the retirement crisis facing many seniors and workers of all generations. It not only would help individuals save more effectively, but also promote economic equity. Ensuring older Pennsylvanians can retire comfortably is not just a matter of good economic policy, it is a fundamental aspect of social justice and compassion. Senate Bill No. 12, which I introduced at the beginning of this legislative Session, would raise our minimum wage and help address the underlying issue behind the lack of retirement savings facing far too many seniors across our Commonwealth. Pennsylvania workers need to pass minimum wage reform. Pennsylvania's workers need Senate Bill No. 12.
