# GUESTS OF SENATOR CRIS DUSH PRESENTED TO THE SENATE

Mr. President, as part of its mission statement to share this good news through words and deeds, the Pennsylvania Council of Churches reaches out to our neighbors who travel the interstate highways of Pennsylvania to include those who deliver the food we eat and the products we consume. Through the service of a chaplain, each Truck and Traveler Ministry offers what is appropriate to each situation: a listening ear, emergency assistance, and the good news of Jesus Christ. Today, it is my privilege to welcome another one of God's anointed messengers to the Pennsylvania Senate. Serving my Senate district, the Chaplain of the I-80 Trucker and Traveler Ministry between Exit 60 to 102 is today's guest Chaplain, Rick Youngdahl. After retiring from 48 years as a truck mechanic in January 2014, Rick immediately answered this unique full-time call to traveling ministry. All totaled, there are five travel centers located and affiliated on the I-80 Trucker and Traveler Ministry where Chaplain Rick ministers to truckers, travelers, travel center management and employees, and many other transient folks.

And I would like to, at this point, give an example: a young couple named Tyrone and Tracy that I had the fortune of coming on as their car broke down after they had gotten off of Interstate 80. They were traveling home from New York City to their community in the center of Detroit, and they had not seen anything but woods for a very long time. I pulled up--and at the time, I was working for the Department of Corrections--had a full-face beard and NRA sticker on the back of the car. They were a little concerned. I took Tyrone down to my home, but when I came back, poor Tracy was sitting huddled with her five children in the back. The wheel had literally fallen off the car. She had makeup running down her face. She was so terrified. But Chaplain Bob Bickerstaff, who was Chaplain Rick's predecessor, he and the ministerium--the churches around the area--they got that car fixed. They put them up for a couple of days while they were waiting for the vehicle to be repaired, and although they only had money to pay for the gas to get them the rest of the way there, they were put up in the hotel, they were fed--all five kids. It was a real blessing.

Chaplain Rick and his wife, Dorothy, have been married for 48 years and are longtime members of our local Christian Motorcyclists Association since 2002. With two married sons and one granddaughter, they have also been heavily involved in various youth ministries for over 40 years. Accompanying Rick today is his granddaughter, Rachel. And please, I ask you to please join me in a warm Senate welcome for Chaplain Rick and Rachel. Safe travel and Godspeed as he departs on another soul-winning spiritual journey along the I-80 corridor.

#### BILL OVER IN ORDER

An Act preventing the Commonwealth from dealing with persons associated with the Government of Russia or the Government of Belarus; and imposing duties on the Treasury Department and the Attorney General.

On the question, Shall the bill pass finally?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Schuylkill, Senator Argall.

Senator ARGALL. Madam President, we have all seen the untold horrors of what is happening every day in Ukraine. Since Russia's invasion into that nation, hundreds of thousands have been killed, including over 100,000 Ukrainian citizens. Women and children have been subjected to torture and rape, while captured Ukrainian prisoners of war have been tortured and mutilated. This legislation will ensure that no Pennsylvania State

contract, grant, or tax credit can be awarded to any company that does business with Russia, just as we currently block State business with Iran. According to the United States Census Bureau, because of immigration decisions made more than 100 years ago and the urgent need for coal miners in places like Minersville, Frackville, and Shenandoah, I represent the largest concentration of Ukrainian Americans in the nation. Many of you voted for similar legislation last Session. I am hopeful that you will once again support this legislation so that it can be sent to the House and then to the Governor for his signature.

And the question recurring, Shall the bill pass finally?

An Act amending the act of December 14, 1988 (P.L.1192, No.147), known as the Special Ad Hoc Municipal Police and Firefighter Postretirement Adjustment Act, providing for 2024 special ad hoc municipal police and firefighter postretirement adjustment; in financing of special ad hoc adjustment, further providing for reimbursement by Commonwealth for 2002 special ad hoc adjustment; and, in administrative provisions, further providing for municipal retirement system certification of adjustments paid and of reimbursable amounts and for municipal receipt of reimbursement payment.

# HOUSE CONCURRENT RESOLUTION No. 197, ADOPTED

Senator PITTMAN, without objection, called up from page 5 of the Calendar, **House Concurrent Resolution No. 197**, entitled:

A Concurrent Resolution extending in whole the disaster emergency declared on June 12, 2023, and extended in whole by the General Assembly until November 1, 2023, in response to the collapse of the northbound bridge and severe compromise of the southbound bridge on Interstate 95 in the City of Philadelphia, Philadelphia County.

On the question,
Will the Senate concur in the resolution?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Indiana, Senator Pittman.

Senator PITTMAN. Madam President, I move that the Senate do concur in House Concurrent Resolution No. 197.

On the question, Will the Senate agree to the motion?

Senator DILLON. Madam President, I rise to speak on behalf of House Concurrent Resolution No. 197, sponsored by Representative Pat Gallagher. This resolution provides a much-needed extension to the emergency declaration originally issued on June 11 in response to the collapse of I-95 in my district. The Senate and House successfully passed Senate Concurrent Resolution No. 168 [136] sponsored by myself and my colleague from across the aisle from Bucks County back in June. This resolution is now set to expire on November 1, 2023. Recent updates confirm that repairs are progressing ahead of schedule. PennDOT has estimated that over 90 percent of bridge repair costs will be covered by emergency Federal resources. This extension will continue to provide access to those resources, access to other Federal funds, and continue to accelerate the repair timeline. Passing this resolution will ensure that we do not let this deadline lapse and that the work will continue into March of 2024. This is essential that this resolution passes, Madam President. I-95 is a critical road that will transport millions of fans who will come to Philadelphia to celebrate the Phillies World Series in the next few weeks. I ask for an affirmative vote.

# PETITIONS AND REMONSTRANCES

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Montgomery, Senator Cappelletti.

Senator CAPPELLETTI. Madam President, I rise today to draw attention to an issue near and dear to my heart and one that I have spoken on nearly every month while we have been in Session during my term. Today, I am advocating for a holistic approach to preventing gun violence. Yes, I do want to see this Chamber pass comprehensive, commonsense gun violence prevention legislation, but I am also realistic about the fact that the Majority party does not share this priority. I might be ready to vote for safe storage laws, universal background checks, 72-hour waiting periods, and so many other proven policies that prevent gun violence, as these are the priorities of mine and so many of my constituents and many Pennsylvanians. However, in the absence of movement on those proven policies, I think we might be able to find common ground on other solutions.

Today, I would like to focus my remarks on exploring two keys to aid community safety: clean, healthy communities and strong public schools. First, clean and healthy communities are a key to safe communities. In Philadelphia, researchers found that structural repairs to homes of low-income owners in majority Black neighborhoods were associated with a 21.9 percent reduction in total crime. Another study in Philadelphia found that efforts to transform and clean vacant lots in high-poverty neighborhoods led to a 29 percent reduction in violent crime. However, gun violence and violent crimes are not just a Philadelphia problem. It is a Commonwealth-wide problem, and we can take the lessons that they learn from this research and apply them all across Pennsylvania. Evidence also finds that other improvements to the public realm, such as urban greening and tree canopy programs in urban neighborhoods, reduce violent crime, particularly adolescent gun violence. But creating safe and healthy communities takes more than just ensuring that our outdoor spaces are well kept and cared for. We also need to ensure that our communities have the strong public schools they deserve with the resources they need to provide a quality education to our students.

This year, we saw how different approaches to school funding derailed our entire budget process. And I am glad that the bipartisan Basic Education Funding Commission is collecting testimony on what the path forward should look like when it comes to Pennsylvania's school funding in the wake of the court ruling that addressed how we are currently funded unconstitutionally. I am hopeful that the commission comes away with actionable recommendations that we can focus on and consider and implement those suggestions. It is long past the time that we take bold action when it comes to bolstering Pennsylvania's public schools. I hope that we can all consider strong, quality public schools a top priority and agree that the positive ripple effects of those investments will benefit all of our communities, including to help ensure their safety. When we invest in our communities and the health and well-being of those we represent, Pennsylvania has a much brighter and peaceful future.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Madam President, I rise today and ask my Senate colleagues to join me in supporting Senate Resolution No. 184, which recognizes October 2023 as National Sensory Processing [Disorder] Awareness Month in Pennsylvania. Sensory processing refers to the way the nervous system receives messages from the senses and turns them into appropriate motor and behavioral responses. Sensory processing disorder exists when sensory signals are either not detected or organized into appropriate responses. Although it affects as many as 1 in 20 Americans, many might not be familiar with SPD. In fact, 1 in 6 children struggle daily with sensory processing challenges, and due to low awareness on the subject, it is often difficult for parents to articulate and explain their child's specific needs. Therefore, throughout the month, parents, educators, therapists, and caregivers spread awareness of sensory processing disorders and how they affect many children and adults every day.

The Sensory Processing Disorder Foundation, which is celebrating its 34th anniversary this year, works to educate and raise awareness of processing disorder. Treatment for SPD often involves customized therapy based on specific needs of individuals, and as we take time today to recognize October as National Sensory Processing Awareness Month, I encourage all parents, caregivers, and educators to be aware of the warning signs of SPD and to consult a physician if symptoms persist. Warning signs can be physical signs such as clumsiness, or emotional, such as anxiety and depression. In children, SPD may manifest its behavioral problems: poor performance at school, an extremely high or low tolerance for pain, or difficulty engaging in conversation or play. I ask that my colleagues join me in supporting October as National Sensory Processing [Disorder] Awareness Month throughout Pennsylvania and continue to help bring attention to sensory processing disorders.

The PRESIDENT pro tempore. The Chair recognizes, for a second time, the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Madam President, I rise because today marks 6,315 days since our Commonwealth's legislature last passed an increase in our minimum wage. This inaction, Madam President, stands in stark contrast to the actions being taken by States around our nation, as we see States across all corners of America take proactive steps to raise their minimum wage and provide economic relief to the workers experiencing some of the greatest need. But while States around the nation are taking this needed action, Pennsylvania continues once again to lag behind. With no increase for a staggering 17 years, the economic discrepancy felt by workers in Pennsylvania is not just a matter of its numbers. It is a matter of social equity and economic justice.

Madam President, let us take a moment to consider the recent developments coming out of Oregon and Washington, where their minimum wages are steadily increasing to keep pace with the rising cost of living. Workers in these States are gradually moving towards more livable wages, providing them financial security and a better standard of living. Madam President, these minimum wage raises are a testament to their commitment to ensuring that their workers are not left behind in the face of inflation and economic challenges. Yet, here in Pennsylvania, Madam President, we find ourselves in a starkly different situation. Our minimum wage has remained stagnant for almost two decades, and this stagnation has led to a growing wage gap. This means that full-time workers in Pennsylvania are earning significantly less than their counterparts in other States. It is simply unjust to expect someone to make ends meet on a wage that has lost its purchasing power over time and devalues their work year after year. The consequences of this disparity are far-reaching, Madam President. Our hardworking citizens are struggling to provide for their families, find affordable housing, and access to quality healthcare. It is high time we recognize that our people deserve better. A fair and competitive minimum wage is not only economically sound, but it is one of the truest moral imperatives.
