On June 26, 1989, the revised Public Official and Employee Ethics Law was enacted which re-authorized the State Ethics Commission. The State Ethics Commission is responsible for issuing various types of rulings on matters within its mandated jurisdiction. Pursuant to the law, the Commission is mandated to forward, quarterly, a copy of every Opinion, Advice of Counsel, and Order issued to one law library in each county, one public library in each county, the State Library, the State Senate Library, each authority appointing a Commission member, the Pennsylvania Association of County Commissioners, the Pennsylvania Association of Boroughs, the Pennsylvania State Association of Township Supervisors, the Pennsylvania State Association of Township Commissioners, the Pennsylvania State School Boards Association, and the Pennsylvania League of Cities. Your agency is either specifically identified in the above requirement or has been selected as a library to which this mailing will be made pursuant to the above authority. As such, enclosed please find decisions of the State Ethics Commission from July 1, 2023 to September 30, 2023. Due to budgetary restraints, a CD containing said rulings will replace paper copies that were previously sent.

For your information, the Commission generally issues these types of decisions as follows:

Commission Opinions - Opinions are advisory rulings issued by the State Ethics Commission regarding the duties and responsibilities of public officials and employees under the Public Official and Employee Ethics Law. Opinions are catalogued by year of issuance followed by the sequential number of the opinion during that year. As such, opinions relating to 2023 will begin with the number 23-001 and proceed there from as decisions are rendered.

Advice of Counsel - The Commission's Chief Counsel is authorized to issue similar advisory letters. Such letters are issued generally when there is prior precedent for counsel to rely upon in issuing a decision or when the provisions of the State Ethics Act directly provide the answer to the question posed. Advice of Counsel letters are numbered with the year and a 500 series number that progresses in order therefrom as rulings are issued. If more than 100 such letters are issued, a 600 series number will then be used.

Orders - Commission orders are issued at the end of an investigation and are determinations as to whether or not there has been a violation of the State Ethics Act. Commission orders are categorized numerically from the date of the first order in 1979. That is, the first Order issued was Order No. 1. All orders proceed there from.

It is recommended that Opinions, Advices of Counsel and Orders be maintained separately (in numerical order) so as to afford better retrievability.

The enclosed items are being forwarded for retention, cataloging and for the purpose of being publicly available for review by citizens of the Commonwealth of Pennsylvania who may have an interest therein.

I respectfully and strongly join these students in calling on my colleagues to pass the funding today. Senator J. WARD. Mr. President, I rise today to honor and recognize the life and service of Pennsylvania State Police Trooper Jacques Rougeau, Jr., a man who I am privileged to call a constituent. With me on the floor of the Senate today to remember this fallen hero are his wife, Chloe, his mother, Angela Gervasio, and Pennsylvania State Police Commissioner Colonel Paris, and several members of the front office command staff at PSP headquarters. Trooper Rougeau was tragically killed on June 17, 2023, when a gunman unexpectedly opened fire at the police barracks in Mifflin County where he was stationed. Trooper Rougeau was assigned to Troop G, Lewistown Station. He enlisted in the Pennsylvania State Police in June 2020 as a member of the 160th cadet class. Upon graduation, he was assigned to Troop J in York before transferring to Troop G in Lewistown in March of this year. Although Trooper Rougeau was only 29 years old, his life was tragically cut short, and we are most certain that his impact will endure forever. Trooper Rougeau is the 104th member of the Pennsylvania State Police to make the ultimate sacrifice by giving his life in the line of duty. I join with my Senate colleagues and all Pennsylvanians in expressing deepest heartfelt sympathies to the family of Trooper Rougeau. We hope that our gratitude for the courage displayed by Trooper Rougeau, as he protected the community where he lived and served, will provide great comfort and peace. Today, the Senate of Pennsylvania remembers the vital

role that Trooper Rougeau played in maintaining law and order in our community and expresses appreciation for his heroic actions on June 17, 2023. May we never forget the sacrifice of Trooper Rougeau and his colleagues and may God bless his family and loved ones. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Venango, Senator Hutchinson.

Senator HUTCHINSON. Mr. President, I too rise in honor of Pennsylvania State Trooper Jacques "Jay" Rougeau, Jr., a native of Corry, Pennsylvania, a hero whose life was tragically cut short on June 17. Only 29 years old, Trooper Rougeau chose to protect and serve this Commonwealth and our communities without an ounce of hesitation, placing the safety of others before his own. Trooper Rougeau's selfless dedication to his neighbors, friends, and family members who he served every day will never be forgotten. Today, we are reminded of the sacrifice of Trooper Jay Rougeau that he made while protecting his community. To Jay's family and all his loved ones, may you continue to find strength in the memories, love, and support that surround you all. May God bless Trooper Jacques Rougeau, his family, the Pennsylvania State Police, and all those who have been impacted by this heart-breaking loss to our Commonwealth.

#### GUESTS OF SENATOR DOUGLAS V. MASTRIANO AND SENATOR CAMERA C. BARTOLOTTA PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Franklin, Senator Mastriano.

Senator MASTRIANO. Mr. President, today I am honored to welcome to the Senate floor a true American hero, Walter Joseph Marm, Jr. He was born on November 20, 1941, just a few weeks before the Japanese sneak attack on Pearl Harbor. About 24 years after this devastating attack on our nation, Lieutenant Joseph Marm would perform his own act of conspicuous gallantry, intrepidity, and bravery at the risk of his own life. Marm then was a lieutenant with the United States Army Cavalry and was serving with the 1st Cav in Ia Drang Valley in Vietnam near Cambodia. His unit's actions of that day are commemorated in Mel Gibson's movie, *We Were Soldiers*, to give you a flavor for what sort of action he would have seen and participated in.

As a lieutenant leading a platoon in the 1st Cavalry Division, there were 457 troopers altogether landing on the LZ, the landing zone. They were immediately surrounded by the enemy; 457

Americans surrounded by more than 3,000 enemy soldiers. His own company was B Company, element of which saw an enemy soldier, pursued them, and was then surrounded for the next several days under fire. That platoon--it was Lieutenant Marm's platoon, although not in the pocket, the lost platoon so-called--he was part of the missions to try to bring relief and save those men trapped under enemy fire several times. Under heavy fire at one point, Lieutenant Marm realized that his platoon could not hold very long, and he saw an enemy stronghold not too far from what was called the ant hill. It was a fortified enemy position, and with disregard of his own life and safety, Lieutenant Marm charged that enemy position. First, he engaged it with a light anti-tank weapon, a LAW, and then attacked it with his M-16 and with hand grenades--taking out at least eight enemy soldiers--running across open terrain to engage the enemy so that his unit could advance. He risked his own life to draw fire. His attack inflicted casualties on the enemy but it did not end enemy fire, and he again put his life on the line, again charging across open territory, drawing enemy fire, and reducing the enemy pocket there. During the action. Lieutenant Marm was shot through his face, shattering his left jaw. I know in your speech today, sir, you talked about how you are thankful to God that the entry wound, it was not a little bit lower, or it would have cut your jugular. For his bravery and risking his own life, Lieutenant Marm was presented the Medal of Honor 13 months later by the Army Secretary.

It is a pleasure and honor to see you, sir. It is men like you who make our nation great in the face of overwhelming danger and odds, doing what most people will not, charging into the jaws of death and fire. So, we honor and salute you here. Joe Marm went on to serve his Army with distinction, retiring as a Colonel, and he hails from Washington County and, as such, I am pleased to be joined by Senator Camera Bartolotta in welcoming you to the floor of the Senate.

The PRESIDENT. The Chair recognizes the gentlewoman from Washington, Senator Bartolotta.

Senator BARTOLOTTA. Mr. President, I too am honored to welcome Medal of Honor recipient Colonel Walter J. Marm, U.S. Army, retired, who is joined by his wife, Deborah, to the Senate floor today. I am proud to say that you can trace Colonel Marm's roots to the heart of my Senatorial District in the city of Washington, Washington County. In fact, in June of 2000, there was an interchange at the junction of Route 43 and Route 70 in Washington designated the Colonel Walter J. Marm, Jr., Interchange. And I think I drive through that interchange almost every day. He attended Immaculate Conception parochial school, just a few hundred feet from my district office in Washington where the Irish nuns of the Mercy Order laid the foundation that would define his work ethic moving forward. Colonel Marm's father proudly served as a Pennsylvania State Trooper while his mother stayed at home to raise the family as a very strong foundation.

He was also a dedicated member of the local Boy Scout troop in Washington, earning the rank of Life Scout, and he became a member of the Order of the Arrow. In high school, Colonel Marm was a member of the rifle club, as shooting was a skill he learned from his father, who was an expert pistol marksman competing for the State Police. Colonel Marm has credited participating on the rifle team and Boy Scouts for preparing him well for the military, and they certainly did.

It is of highest esteem to be in the presence of a Medal of Honor recipient. There are only 66 of these heroes walking among us today, and it is with deep pride and respect that I recognize a true homegrown hero. And it was also a delight for me to be at the Steelers game just yesterday when my dear friend Mel Blount took to the field to honor--thumbs up--to honor Colonel Marm and gift him with two Super Bowl tickets--I am very jealous. Colonel Marm, welcome home. Mr. President, please join me in expressing our deep great thanks and gratitude with a Senate welcome to Colonel Walter Joseph Marm and his lovely wife, Deborah.

Thank you, Mr. President.

Colonel Walter Joseph Marm, it would be our honor if you would now address the Senate.

Colonel MARM. It is a distinct honor for me to be here today. I grew up in, as you heard, western Pennsylvania, so I have deep roots in Pennsylvania. And I spent my last 6 years working with the Army Reserves at Willow Grove Naval Air Station before I retired in 1995. So, I still have--my daughter lives in West Chester with her husband and two children, so, we get to come back to this State quite often. But I moved to my wife's hometown of North Carolina, and she spent many years working for a Senator in Washington, DC, then for a congressman, when we retired, when I retired in our home district in North Carolina. So, she knows quite a bit about this type of situation.

But it is an honor. This is a very, very beautiful building, the Capitol. Our county seat of Washington is very special, too. And, I am sorry I do not have any roots left. We sold our home in Pennsylvania, but it has been an honor for me to be a citizen of Pennsylvania. And, I am, and it is very special that my daughter is still there, too. And this is a very--you know, being a couple of days past Veterans Day, and the 14th, and tomorrow is the anniversary of our battle in 1965 when I was seriously wounded and evacuated to the Valley Forge Army Hospital where I recuperated from my war injuries, and then went back into the service again. So, it is just quite an honor for me to be here, and I want to thank you for all you are doing for the great State of Pennsylvania and our great country. God bless you, and God bless America. Thank you.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Fayette, Senator Stefano.

Senator STEFANO. Mr. President, I rise today in support of Senate Resolution No. 200, which would designate the day before Thanksgiving, the Sunday after Christmas, and New Year's Day at 6 p.m., as time to ring the bells throughout the Commonwealth as a sign of thanks, praise, and unity. These occasions are steeped in tradition and carry a deep sense of unity. Throughout history, bells have served as messengers in times of joy and sorrow. They have sounded in celebration of weddings, rung as a call to arms during times of conflict, and tolled solemnly through moments of remembrance. The tradition of bell-ringing has long united communities, transcending political, social, and cultural boundaries. Senate Resolution No. 200 seeks to harness the power of this timeless tradition to unite us as Pennsylvanians. By ringing bells throughout Pennsylvania for just 5 minutes on these days, we send a powerful and symbolic message to our fellow Pennsylvanians, one that transcends political, social, and cultural divides.

First, let us consider the day before Thanksgiving. This is when friends and family gather to express their gratitude for the blessings in their lives. By ringing bells on this day, we symbolize our individual thanks and collective appreciation. It is a moment to celebrate our shared values, embrace our differences, and remember the importance of togetherness, love, and understanding.

The Sunday after Christmas is another memorable moment. It symbolizes the spirit of giving, the bonds of family, and the joy of the holiday season. By ringing bells on this day, we extend the message of peace and goodwill that Christmas brings, spreading happiness and unity in our communities.

New Year's Day marks the beginning of a new full year of promise and potential. As the bells ring out, they symbolize a fresh start, a chance to leave behind the past and embrace a brighter future together. This simple act of unity can inspire hope, motivating us to work collaboratively toward a better Pennsylvania for all.

Bells have the unique power to gather people together physically and emotionally. The Scottdale Area Association of Churches began coordinating to ring bells at a uniform time to give people hope and bring them together and bring comfort. As we enter the holiday season, let us come together as a chorus of unity, gratitude, and praise. Let us show the world that in Pennsylvania, we stand together as one community, bound by our shared values and committed to a future filled with hope and harmony.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise because today marks 6,336 days since our Commonwealth's legislature last passed an increase in our minimum wage. But the sins of this Chamber's inactions are matched, Mr. President, by our Federal

counterparts. Our nation's minimum wage has not moved since 2009, which has meant for more than a decade and a half, workers across America have been subject to starvation-level wages that keep hardworking Pennsylvanians and Americans in the persistent and devastating cycle of poverty. If we would raise our minimum wage, Mr. President--as I have proposed in Senate Bill No. 12, my piece of legislation that would put Pennsylvania's lowwage earners on a path to \$15 an hour--we would help boost tens of thousands of Pennsylvanians out of poverty and provide them with long-needed financial security. But you do not need to take my word for it, Mr. President. In 2021, the Congressional Budget Office released "The Budgetary Effects of the Raise of the minimum Wage Act of 2021 [Raise the Wage Act of 2021]" which studied the Raise the Wage Act of 2021. That study asked a simple question: how would increasing the minimum wage affect family income? And its answers make common sense, Mr. President. They found that, quote, by boosting the income of low-wage workers who have jobs, a higher minimum wage would raise their family's real income, end quote. It is as simple as that, Mr. President. If we raise our minimum wage here in Pennsylvania, or if our Federal counterparts would do the same nationwide, we would see an immediate increase in our constituents' take-home pay. Pennsylvanians deserve to make a livable wage for the work they do. It should not be a novel idea that someone who works 40 hours a week can survive on an income without having to work 2 or 3 jobs just to keep a roof over their head and food on their table. That is why I introduced Senate Bill No. 12, because I am sick and tired of having my neighbors, all of my colleagues' neighbors, and constituents live in a system of State-sanctioned poverty. We can and we must do better, Mr. President. We must pass Senate Bill No. 12. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Robinson.

Senator ROBINSON. Mr. President, this past Friday, the United States Marine Corps celebrated its 248th anniversary of its inception at Tun Tavern, Philadelphia, Pennsylvania, by Captain Samuel Nicholas, our first commandant. The Second Continental Congress passed a resolution on November 10, 1775, to raise two battalions of Marines there. And by January 1776, they set sail at sea to occupy New Providence, Bahamas, 6 months before the Declaration of Independence was signed. The Continental Marines evolved into the United States Marine Corps, where they have performed their duties valiantly throughout the world in every climb and place, in peacetime and in warfare. The Marines work hand in hand with the United States State Department guarding our embassies abroad. And the President's own Marine Corps Band provides the music for State functions at the White House, while Marine One and Marine Two provides helicopter transportation for the President and vice President and is the only branch in our armed services that can be deployed for duties as the President alone may direct, and every President in this nation's history has done so with great success. Storied legendary engagements in Tripoli, Chapultepec, Belleau Wood, Guadalcanal, Tarawa, Guam, Tinian, Saipan, Iwo Jima, Okinawa, Incheon, Chosin, Khe Sanh, Da Nang, Hue City, Beirut, Tora Bora, Nasiriyah, Fallujah, Ramadi, Marjah, and Sangin, just to name a few. We celebrate the legendary exploits of Chesty Puller, John A. Lejeune, Dan Daly, and John Basilone and follow the teachings of James Mattis. We can recognize each other by our

strange haircuts and symbolic tattoos. We have our own language filled with inaudible grunts and a Latin motto, Semper Fi, and our own names for ourselves: jarhead, leatherneck, devil dog, ground pounder, grunts, pigs, and hogs are nothing more than terms of endearment. Our other branches just do not seem to understand the culture, but everyone knows there is no better friend and no worse enemy. And as the Song states: "If the Army and the Navy ever looked on Heaven's scenes, they will find the streets are guarded by United States Marines." Oorah, Mr. President.

Senator CAPPELLETTI. Mr. President, today I rise to recognize this week, November 11 through November 18, as Hunger and Homelessness Awareness Week in Pennsylvania. I have introduced Senate Resolution No. 206 to recognize this week, which serves as a reminder that there are thousands of Pennsylvanians who struggle for the most basic of human needs: shelter and sustenance. Food insecurity remains a critical issue all across our Commonwealth, in addition to the issue of homelessness. Ensuring that every individual can secure a meal and find stable shelter should be a fundamental right. However, the reality is that hunger and homelessness persist as prevalent challenges that demand our immediate attention and concerted efforts.

In Pennsylvania, about 12 percent of the population lives in poverty, with over 15,000 people experiencing homelessness and about 2 million facing food insecurity, with 500,000 of those being children. Additionally, these numbers tend to be statistically higher in marginalized communities, particularly the Black and brown communities of our Commonwealth. In a country as wealthy and as well-resourced as ours, hunger and homelessness are proof of structural and systemic inequities that we have failed to address. By strengthening food assistance programs such as SNAP, WIC, the Pennsylvania Agricultural Surplus System, (PASS), and the Pennsylvania State Food Purchase Program, we can assist a broader population of individuals and families who may not qualify for programs under current income requirements and guidelines. By investing in policies that will improve economic stability, including raising the minimum wage, enforcing rent control, and increasing the income qualifications for property tax and rent rebates, we can combat hunger and homelessness and provide much-needed relief for individuals and families in our communities. Food and housing insecurity impacts all of our communities, and our collective leadership as Senators can make a huge difference in combating those issues that hurt the families we represent, and our Commonwealth's success as a whole.

Let us use this week not only to raise awareness but to make the change. Advocate for those policies that address the root causes of hunger and homelessness. Support your local organizations and shelters that provide crucial assistance to those in need. I hope my colleagues will join me in recognizing November 11 through the 18 as Hunger and Homelessness Awareness Week, because we must work together towards creating a Commonwealth where every individual has access to nutritious food and a safe place to lay their head at night, which requires collaboration and cooperation between government, nonprofits, businesses, and the greater communities that we serve.

Senator REGAN. Mr. President, today, November 13, is recognized as World Kindness Day. So, it is only fitting that I speak today about a constituent of mine from York who turned a random act of kindness into a nonprofit on celebrating Kindness Week and encouraging others to do so by doing kind things for others. On Good Friday of this year, my constituent, Kevin Smith, lost his wallet. We all know that sinking feeling of losing a wallet, the cash, the cards that must be canceled and reissued, the ID cards that could be used to steal our identity. Fortunately for Kevin, a good Samaritan found and returned his wallet completely intact. He was blown away by this woman's kindness and so appreciative, leading to sharing his story with the local news outlets and even on "Inside Edition." But that ignited a fire in Kevin that led to his founding a nonprofit, Kindness Worldwide, focused on celebrating Kindness Week, encouraging good deeds in communities throughout the world, and spreading the joy of kindness to all. It is for this reason that Senator Kristin Phillips-Hill and I have sponsored a resolution recognizing this week as Kindness Week in Pennsylvania and encouraging Pennsylvanians to perform at least one act of kindness each day.
