### GUEST OF SENATOR JUDY SCHWANK PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, today I have the distinct honor of welcoming Robert Fields--we know him as Bob--to the

Pennsylvania Senate. Bob joined the United States Army in 1966 when he was just 18 years old. He was sent, of course, at the time, to Vietnam, where he experienced intense combat from April 1967 to April 1968. While in Vietnam, Bob, who was a sergeant, was wounded twice. His first injury was the result of a bullet that traveled through his steel helmet, slicing open a few inches of his scalp. Bob was put on light duty due to a concussion he sustained as a result. Though painful, this injury did not prevent Bob from rejoining his battalion. Later that month, another bullet struck Bob's helmet, this time above his left ear, causing, again, damage to his scalp before exiting out of the back of his helmet.

After leaving the Army, Bob earned a degree in economics from the University of Pennsylvania. And after their marriage, Bob and his wife, Elizabeth, lived in Florida for 4 years before relocating to Pennsylvania. Despite Bob's heroism in combat, he never sought or received a Purple Heart, recognition that he had earned. That is where Bob's amazing wife, Elizabeth, or Liz, enters the story. Liz, herself a retired captain in the Air Force, started a secret effort to get Bob his due recognition. Her persistence, and the help of Congresswoman Chrissy Houlahan, eventually paid off. Over 50 years since he was injured, in November of this year, Bob finally received his Purple Heart at a veterans' ceremony in Berks County. As you may know, the Purple Heart is the nation's oldest medal, created by George Washington, originally designated as the Badge of Military Merit. Since its creation, the Purple Heart has been awarded to over 1.8 million military personnel.

Mr. President, I have the privilege to call Bob and his wife, Liz, my friends. I have known them for many years, and their service to this country and community is strong. They are very active locally and often open up their home for guests to visit and discuss national and local issues. It is my honor to recognize Bob Fields today for his heroism and service to his country and his long-overdue recognition, receiving the Purple Heart. Unfortunately, Liz could not be here with him today, she did not feel well, but we would certainly honor her as well. But, Mr. President, would you please join me and ask my colleagues to extend a warm Senate welcome to Bob Fields. Thank you.

The PRESIDENT. Would the guest of Senator Schwank please rise and be welcomed by the Senate.

His matriculation at NYU, New York University, and his selection as a Rhodes Scholar, 1 of only 32 students nationwide to receive this distinct honor. I would like to acknowledge him and his mother, Angela Gantt-Dixon, a medical support assistant at the Veterans Administration Medical Center, who are both in the gallery.

A Senate Citation has been prepared to recognize Mr. Dixon. The citation reads [reading]:

Whereas, The Senate of Pennsylvania takes great pleasure in recognizing those citizens who, through dedication and excellence, contribute in a meaningful way to the well-being of their communities and ultimately to all [the] people of this great Commonwealth; and

Whereas, Donovan Dixon is being honored upon his selection as a 2024 Rhodes Scholar by The Rhodes Trust; and

Whereas, The Rhodes Scholarship is a fully funded, full-time postgraduate award that enables talented young people from around the world to study at the University of Oxford in England. A graduate of Central High School and New York University with a bachelor's degree in public policy, Mr. Dixon is one of--only--thirty-two students to be selected by [for] the Rhodes Scholarship across the United States. He plans to study philosophy in comparative social policy at the University of Oxford. To his great credit, Mr. Dixon completed internships at [in] the office of First Lady Jill Biden, [at] the African American Mayors Association and [with] the United States Department of State, where he served the Bureau of Democracy, Human Rights and Labor and the Bureau of Legislative Affairs. While at NYU [New York University], he served as [a] Student Association Representative and held [the] leadership roles of Peer Mentor for Project OutReach and Co-Vice President of Service for the Inter-Residence Hall Council. In addition, Mr. Dixon worked as a community aide for New York City Council members Carlina Rivera and Robert Cornegy, Jr.

Now therefore, the Senate of the Commonwealth of Pennsylvania congratulates Mr. [Donovan] Dixon upon his richly deserved recognition; and offers best wishes for continued success in [all] future endeavors;

Mr. President, my colleague Senator Haywood has also prepared some remarks and would like to welcome Mr. Dixon and extol the virtues of his achievements. Senator Haywood, I yield.

Senator HAYWOOD. Mr. President, thank you Senator Street. I would also like to welcome Donovan Dixon and his mother, Angela Gantt-Dixon, to the Senate this morning. I read a newspaper article in the *Philadelphia Inquirer* highlighting Mr. Dixon's selection as a Rhodes Scholar. I was a Marshall Scholar about 100 years ago, and I know the value of these scholarships for the individual and for their lives. And so, we brought him in, we had a tremendous conversation with him and learned of his desire to be involved in governing this great nation. We then

invited him to a team retreat that we have annually. We had tremendous insights about the direction of our office, the direction of the district, the direction of the city of Philadelphia, as well as the direction and future of the Commonwealth. I was so honored to meet him, and along with Senator Street, we just shared a tremendous lunch with him where he, again, exhibited a tremendous ability to listen and take it in. I want to encourage him, and all of us to encourage him, as this is his first trip to Europe, and it will be a tremendous adventure for him, his friends, and his family. I ask that we give them a warm welcome for an individual who can in the future help govern this nation and be an inspiration to all of us, young and old.

His coursework included business strategies and policy, business management, business law, economics, comparative economics, business statistics, marketing and promotion, information systems management, business sustainability, and environmental economics.

Mr. Az'Zahaier began his internship on November 6, 3 days before my office distributed 4,300 turkeys for Thanksgiving--most of which, I will note, we purchased from Senator Argall. He was immensely helpful during the distribution and continues to serve in my district office by providing constituent services and drafting certificates of recognition, honoring servant leaders across the 3rd Senatorial District. I ask the Senate to welcome Mr. Miles-Dingle, who is working with us and is committed to helping better the Commonwealth.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, assaults on transit workers continue to impact workers, transit agencies, and the traveling public in not just my home of Philadelphia, but also across the Commonwealth and the nation. According to the Transport Workers Union of America, at least one transit worker is assaulted during their shift every day in the United States, and in some localities, the average can be more than five assaults each day. These assaults happen in both rural and urban communities and contribute to productivity shortfalls, workplace absence, and increased levels of stress for assaulted workers, as well as the assaulted workers' colleagues, who are forced to do their jobs in a heightened state of alert. And unfortunately, Mr. President, the data suggests that the problem is only getting worse. The rate of

assaults on transit operators nationwide has nearly quadrupled between 2009 and 2020, according to the Federal Transit Administration. In Pennsylvania, the bus drivers and transit workers who frequently work alone in the service of our communities are also under increasing threat. Assaults on SEPTA operators have dramatically risen from 98 total reports in 2018 to 542 in 2021 and 439 in 2022. Fifty-three of the assaults on SEPTA operators last year resulted in injury, the highest yearly figure ever reported.

At this time, public transportation workers are only protected from the offense of aggravated assault if a person attempts to cause or intentionally, knowingly, or recklessly cause serious bodily injury. Meanwhile, a protected class of public servants has been created under Section 2702(c) of Title 18, a class which, unfortunately, does not include public transportation workers. Our legislation, Bernard's Law, effectively integrates public transport workers into the protections they have long deserved. Under its provisions, interference with an operator causing an injury--not just serious injury--is penalized as a felony 3. And importantly, intimidation of an operator by physical menace is also penalized as a felony 3 under this bill. Those who threaten and cause our operators to fear for their lives cannot continue to be given a free pass. It should not take a serious injury or worse to one of our operators to be in violation of the law.

In closing, I would like to commend my colleague Senator Farry for his diligence and partnership on this bill. And I want to extend my deepest condolences to the family of Bernard Gribbin. I hope with all my heart that my colleagues will join me in voting "yes" on Senate Bill No. 977 so we can do a small part honoring his life, legacy, and service by sending this legislation to the Governor's desk. Our transit workers are essential to this Commonwealth, and we should do everything we can to safeguard them and the traveling public from intimidation and violence. I ask my colleagues for an affirmative vote for Bernard's Law. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Kearney.

Senator KEARNEY. Mr. President, I will be voting for Senate Bill No. 977, but I wanted to rise to note that this legislature cannot pass this bill and think that we can walk away from the need to address safety on public transit. Senate Bill No. 977 echoes the calls from transit workers' unions to increase penalties for interfering or assaulting a transit operator by creating additional new crimes with longer prison times. It will be up to our transit agencies to inform the riders that these new crimes are in place, and it will be enforced. This bill also has added import following the tragic unprovoked October shooting of SEPTA driver Bernard Gribbin, a 12-year SEPTA employee and, by the way, also an Army veteran. I am supporting this bill because the problem is very real across the United States. A recent paper by the Urban Institute notes that between 2008 and 2022, major assaults on transit workers that resulted in fatality or ambulance trips tripled to almost 500 annually, and obviously, that only counts the worst episodes and does not capture the vast majority of assaults. But why are transit drivers subjected to so much anger and violence? The research largely points towards the social climate, inequity, and daily stressors as the biggest influence on rider behavior on transit. You think about it, before disproportionately poor and marginalized riders even arrive at a bus or train stop, they are carrying the stress of their lives with them. Maybe it is multiple jobs, maybe it is unpaid bills, maybe it is housing insecurity, maybe it

is family trauma or domestic violence, and once they arrive, these indignities are also mirrored in the transit experience itself, including long waits at unsheltered bus stops, unexplained delays, or fares they might not be able to afford. When you are not in control of your schedule, of your commute, of your life, it is easy for emotions to boil over. And when your bus does not show up, or it is so late you miss your transfer, or it is so crowded it cannot be taking any more passengers, these incidents can trigger already aggravated people. It is the same psychological causes that caused a surge in road rage shootings. In 2018, there were 70 road rage-motivated shooting deaths in the U.S. and 176 gun injuries. A figure that rose to 141 deaths and 413 injuries in 2022. One of those murders happened within a couple blocks of my district office.

If we want to prevent violence in the first place, we need to do more than enforce stronger criminal laws. We need to diffuse the tension on transit. No, we may not be able to solve poverty and all its indignities in the short term, but we can take action to keep transit vehicles running on time, frequently and reliably. It is absolutely critical that we pair Senate Bill No. 977 with funding to keep our transit systems running on time and without service cuts. As many have heard from leadership at SEPTA, our greatest transportation asset in the State's most productive economy is staring down a \$240 million fiscal cliff. If the State does not step up its financial support, there will have to be 20 percent service cuts. That means fewer buses, fewer trains, higher fares, and many more delays. These cuts and price increases will only trigger greater frustration and violent episodes. If we really want to protect transit workers, then we absolutely must avoid this and include a funding increase. So please, let us keep the conversation going in the coming budget cycle and not have any pretense that we finished our job.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Saval.

Senator SAVAL. Mr. President, I rise today in opposition to Senate Bill No. 977. I am proud to represent, arguably, the most transit-dense district in our Commonwealth. Hundreds of thousands of Philadelphians use our public transit system daily; I am one of them, often with my two young children in tow. Our transit workers are public servants. Their labor powers our communities connecting us with work, school, health care, and commerce, not to mention with friends and loved ones. All of us have been troubled to learn of acts of violence against transit workers, and so many of us were heartbroken when in late October we learned of the death of Bernard Gribbin, a SEPTA bus driver shot and killed while on the job. I share in my colleagues' desire to support and protect these workers from any further harm, and simultaneously, I recognize that the criminal offense this bill creates is in fact already comprehensively covered under Pennsylvania law. Reckless endangerment, simple assault, and aggravated assault are already crimes. Senate Bill No. 977 will inflate our Commonwealth's already enormous Crimes Code, duplicating existing crimes while, I feel, ignoring the root causes and conditions that persistently place transit workers at risk. Our transportation system desperately needs increased funding for staff and for safety infrastructure. We need to foster increased ridership and alleviate the isolated and vulnerable positions in which so many transit workers are routinely placed. As we grieve the death of so many

transit workers and look for ways to honor the life of Bernard Gribbin and others, I humbly ask my colleagues to continue our work for transit that upholds our collective right to freedom of movement by ensuring the true safety of workers and passengers alike. Because I believe Senate Bill No. 977 does not advance this work, I respectfully will be voting "no," and I ask my colleagues to join me. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Mr. President, I rise to support this bill. Rarely do I support increases in enhancements for crimes. However, we have transit workers who go to work knowing that they are putting themselves at risk in the same way that police officers, in the same way schoolteachers and others, in many cases, go to work. We need to send a message that it is not okay to attack them. We need to send a message both to those workers and to the people who are riders. I agree with everything Senator Saval and others have said around the root causes, but we have an immediate group of people who will get up tomorrow and go to work. They will do it faithfully, they come from many of those same communities, and they need to be protected. And so, I do believe it is important that we protect these workers. I think this is narrowly tailored enough, and it is only assaults on them. I have previously opposed legislation that would have changed jurisdictions for prosecutions around all transit stops because that would have affected the prosecutions in much of the city of Philadelphia. And I think the people have elected a district attorney who they believe, in the city of Philadelphia, can respectfully execute the prosecutorial discretion, and people across the Commonwealth have the equal ability to do that. I think that this is a valuable tool. We need to protect our transit workers, and so, I urge a "yes" vote.

The PRESIDENT. The Chair recognizes the gentleman from Bucks, Senator Farry.

Senator FARRY. Mr. President, first of all, I would like to begin by offering my condolences to Mr. Gribbin's family and also providing our thoughts to his coworkers who go to work every day just trying to earn a living and serve our community. I would also like to thank Senator Tartaglione from Philadelphia, who has been a leader on this issue for many, many years, and it is great to work with her on a bipartisan level.

Mr. President, our transit workers just want to be able to go to work and be in a safe working environment. They also want to ensure that those who they are transporting, their passengers, are safe, and we should also want both of those things. They serve a vital role in our community. That role is driving people, or driving a train, to ensure that people can get to work, get to school, but also vital other functions such as make doctor's appointments and shop for necessities. In essence, Mr. President, they are providing a core service to our community. This legislation is supported by transit authorities across this Commonwealth, but it is also supported by the workforces of those transit authorities. I believe some of the men and women who get up every day and staff those transit agencies actually have joined us in the gallery, and I want to thank you for the service you provide every day. Mr. President, it is a very simple bill, as explained by some of the previous speakers. It is an unfortunately necessary bill because of our transit workers being put in harm's way daily. Mr. Speaker, I think it is--or Mr. President, excuse me, reverting back to my previous role for 14 years--Mr. President I think it is very important that

we provide an affirmative vote and send a message to that workforce and those passengers that they will be safe. I ask for an affirmative vote.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise today to urge my colleagues to take up the anti-hate crimes legislation that our colleagues in the House of Representatives sent us back in October. Mr. President, we find ourselves in a tense political moment and are witnessing an unprecedented rise in hate crimes across the board, making all of us less safe. From anti-Semitism to

Islamophobia, to attacks on LGBTQ+ people and beyond, we must take action on hate crimes. The American Defamation League [Anti-Defamation League] has stated that acts of anti-Semitism jumped by 388 percent. The FBI says that it tracked the highest number of crimes towards Jewish people since 1993. CAIR has said that we saw a 172 percent increase in calls to the headquarters about acts of Islamophobia. The FBI said that it has seen a 60 percent jump in hate crimes since the horrific acts of October 7 of this year.

With this information, Mr. President, in mind, and with tensions running high all across Pennsylvania, we must act now. We must act now to strengthen and expand Pennsylvania's high hate-based crime statute. Championed by my colleagues in the House of Representatives, Dan Frankel and Napoleon Nelson, together, these three bills in this package would go a long way in three key areas. First, Mr. President, they would make sure we are tracking hate crime data on our college campuses appropriately, which is an important issue for many folks today. We also would make certain that we are preparing our law enforcement to respond effectively to hate crimes, aligning also our PA protected classes with those at the Federal level, and finally, providing further recourse for victims of hate crimes. These bills that I mentioned, House Bill No. 1024, House Bill No. 1025, and House Bill No. 1027, were passed on a broad bipartisan support in the House, and I urge my colleagues to use this moment to take a strong stance against hate.

It is up to all of us to ensure that our schools, our streets, and our communities are safe for every Pennsylvanian. And in light of the recent events, it is especially important that our institutions of higher learning are prepared, prepared to protect their vulnerable students from harassment and hatred and to ensure that every student has a chance at an excellent education, regardless of their heritage, their faith, their race, their gender, or disability. The time to put our differences aside and pass this package of bills is now. We in this Chamber have the power to move these measures to the Governor's desk over the course of the next several days, and we will be able to protect our friends and neighbors from hate, but only, only if we act now. We have the opportunity to get it done, Mr. President. Let us get it done.

Senator ROBINSON. Mr. President, I am honored to once again join my friend and colleague from Allegheny County, Democratic Leader Jay Costa, to introduce Senate Resolution No. 213, which designates December 16, 2023, as Wreaths Across America Day in Pennsylvania. For more than 3 decades, volunteers throughout America have coordinated wreath laying ceremonies for the graves of their veterans. With each act of laying a wreath on the grave, volunteers speak the veteran's name aloud and thank them for their service and sacrifice and reflect on the veteran's life. Last year, almost 2 million wreaths were laid throughout all 50 States, at sea and abroad. Wreaths Across America's main mission is to "Remember, Honor and Teach." To remember the fallen; to honor those who serve; and to teach the next generation the value of freedom.

The holidays can be a difficult time for those who have lost loved ones, but these wreaths bring comfort to mourning family members, as they know their loved ones are thoughtfully

remembered and appreciated. I encourage all here today to join Senator Costa and myself for our annual Wreaths Across America ceremony at noon tomorrow in the Capitol Rotunda. We will hear from the Adjutant General of the Pennsylvania National Guard, Major General Mark Schindler, as well as students and constituents who are so kind to come out tomorrow to participate in this event. I also encourage anyone who can volunteer to lay down wreaths this Saturday, December 16, at your local cemeteries, and you can find the information at [www.wreathscrossamerica.org](http://www.wreathscrossamerica.org). Let us say their names this holiday season and remember all that they have done so we can be free. I salute you, my fellow veterans.

Senator COSTA. Mr. President, I rise today to join my friend and colleague, to have folks and my colleagues participate with Senator Robinson and myself in the annual Wreaths Across America program happening tomorrow at the Capitol Rotunda, as was indicated, at noontime. As was mentioned, this is a very important program to honor the families of soldiers who never made it home and never made it home for the holidays. I have been honored to participate for many years now in this important program which serves to uphold a very simple mission, a very simple mission statement: Remember, Honor and Teach. And tomorrow we will gather, remember those who did not make it home for the holidays, as I mentioned, and honor their legacies and their sacrifice and teach younger generations about the stories of these brave soldiers. I ask my colleagues to please join us tomorrow at noontime to carry out this wonderful tradition.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise because today marks 6,364 days since our Commonwealth's legislature last passed an increase in our minimum wage. And, Mr. President, not only are we allowing Pennsylvania's lowest earners to be subject to a poverty-level wage over the last more-than-a decade and a half, but we have also done so while our neighbors leave us behind. In a transformative and precedent-setting move, New York State has again shown their willingness to do the work and ensure all workers across the State are able to earn a livable wage for the work they do by more than doubling our minimum wage, leaving us at a critical crossroads. The action taken by our neighbors to the north underscores the urgency for Pennsylvania to reassess and elevate its own minimum wage, not merely as a matter of economic policy, but as a fundamental commitment to the well-being of its residents. Mr. President, as neighboring States make substantial strides in addressing income equality, we increase the risk of us falling behind. The tangible impact of a higher minimum wage extends beyond individual paychecks. It reaches into the very fabric of our communities, fostering economic resilience and reducing dependency on social safety nets. By raising the minimum wage, Pennsylvania can inject vitality into local economies, generating a multiplier effect that stimulates business growth and consumer spending. Our current minimum wage, Mr. President, lags behind the rising cost of living, forcing many individuals and families into a perpetual struggle to make ends meet. Raising the minimum wage is not just an economic

necessity, it is a step towards acknowledging the dignity of labor and recognizing that every Pennsylvanian deserves fair compensation for their hard work, especially when hundreds of thousands of Pennsylvanians live within a reasonable commute of neighboring States, all with a higher minimum wage. Why should anybody be able to leave Pennsylvania? Stay and do the same job for potentially half the pay. Pennsylvania and Pennsylvanians deserve better, Mr. President. That is why I introduced Senate Bill No. 12, because I was sick and tired of allowing our neighbors to continue to fall behind and suffer in the seemingly never-ending cycle of poverty which is perpetuated with our minimum wage. We need to put minimum wage earners on a path to \$15 an hour. Pennsylvanians deserve better. Pennsylvanians deserve Senate Bill No. 12.

Senator VOGEL. Mr. President, I would like to submit my comments to be spread upon the record.

The PRESIDENT. Without objection, the remarks will be spread upon the record.

*(The following prepared remarks were made part of the record at the request of the gentleman from Beaver, Senator VOGEL:)*

Mr. President, I rise today to recognize Cheryl Moon-Sirianni, who has dedicated the last 37 years to PennDOT and assisted residents and officials alike with their transportation needs. She now begins her newest chapter--retirement.

Since February of this year, she has dutifully served as PennDOT's Executive Deputy Secretary, but her PennDOT career did not start there. It began in 1987 with her joining the department as a civil engineer trainee following her graduation from Penn State with a bachelor's degree in civil engineering. From there, she rose through the ranks, creating foundational relationships with department staff, governmental partners, consultants, and contractors along the way.

Cheryl was instrumental in helping develop and construct impactful roadway projects that would benefit our residents and travelers. These included improvements to the Route 28 corridor, Squirrel Hill Tunnel rehabilitation, the Freedom Road improvement project, and the Mae West Bend roadway realignment. I know I had the pleasure of working with Cheryl on a few local road projects when she was the assistant highway district engineer in PennDOT's District 11 back when I served as a township supervisor in New Sewickley. In 2017, she was promoted to, and became the first woman to serve as, District Executive at District 11, which made her responsible for the 8,500 miles of roadway, 1,800 bridges, and 4 tunnels contained within Allegheny, Beaver, and Lawrence Counties. Cheryl served in this capacity until her most recent advancement to Executive Deputy Secretary.

Now, her tremendous work has not gone unnoticed in the eyes of her peers as she has been recognized as the Women's Transportation Seminar Pittsburgh Chapter's Woman of the Year in 2019; received the Engineer of the Year award from the Engineers' Society of Western Pennsylvania in 2015; and was a nominee for the Transportation Ladders of Opportunity national award through the White House Champions of Change in 2014, to name a few.

I would like to personally commend Cheryl on her hard work and dedication to making Pennsylvania a better place, and I ask my colleagues to join me in congratulating her as she now forges a new path in her retirement.
