#### HB 1231 (Pr. No. 1322)

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, in organization of departmental administrative boards and commissions and of advisory boards and commissions, further providing for State Planning Board.

#### HB 1232 (Pr. No. 1323)

An Act amending Title 8 (Boroughs and Incorporated Towns) of the Pennsylvania Consolidated Statutes, in powers and duties of elected officials, further providing for surcharge by auditors; in powers, duties and rights of appointed officers and employees, further providing for borough manager created by ordinance and election, for powers and duties, for other offices not incompatible and for organization of commission; and, in taxation and finance, further providing for preparation of budget.

#### GUESTS OF SENATOR DEVLIN ROBINSON AND SENATOR LINDSEY M. WILLIAMS PRESENTED TO THE SENATE

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Robinson.

Senator ROBINSON. Madam President, I am proud to introduce to the Senate floor today my guest--along with Senator Lindsey Williams--guest Chaplain from Pittsburgh, Chaplain Harry Van Riper, who also offered the prayer at our Wreaths Across America ceremony before Session today. As a teenager, Harry was drafted into the United States Army in October of 1967. Because he was already a mechanic, the Army sent him to track school prior to being deployed to Vietnam with the 1st and 5th Mechanized Infantry. His unit was heavily engaged in the first campaign of the Tet Offensive, and he was involved in the second and third offensives. His infantry division displayed extraordinary heroism in combat operations against Vietnam, who had numerically superior enemy forces. The battle revealed highly specialized ambush missions and counteroffensive actions against a heavily armed enemy.

After hours of a tough battle, Corporal Henry [Harry] Van Riper stayed in place to make sure all of his men were clear. Shortly thereafter, his armored personnel carrier was hit with a rocket-propelled grenade, and shortly after that, the Tet Offensive was declared over. The explosion resulted in Harry losing his left arm and portions of his left leg, as well as a collapsed lung. He spent 8 days in a coma, with doctors claiming he only had a 15 percent chance of survival. Not only did 18-year-old Harry survive his wounds, but he also went on to live an inspirational life full of service. His unit was awarded the Presidential Unit Citation--the highest distinction a military unit can receive--for extraordinary heroism in combat operations by President Richard Nixon. Harry also received the Purple Heart for his wounds, an honor reserved for service members wounded or killed because of enemy action while serving. Just last month he received the 2023 Dr. Charles J. Martoni Veterans Service Award in Allegheny County for veterans who continue to serve their communities following discharge from the military.

After retiring from the military in 1969, he attended college at Duquesne University and became a distinguished professor at the Community College of Allegheny County, teaching science and mathematics for 34 years. He serves as chaplain of the Richland American Legion Post 548 and was named 2018 Pennsylvania American Legion Chaplain of the Year. Continuing with his dedication to lifelong service, Harry spends countless hours helping

and visiting fellow veterans and families of our fallen veterans. Harry also participates in the Honor Guard, which gives military honors to military personnel and their families during funeral services. He and his wife, Susan, who joined with him today, have a daughter, Regina; four grandchildren, and two great-grandchildren. Harry Van Riper is a true American hero, and I am honored to know him and his story. Thank you, Harry, for your sacrifices and continued service to fellow veterans and their families. Please join me in giving Harry and Susan a warm Senate welcome.

#### GUESTS OF SENATOR SHARIF T. STREET AND SENATOR WAYNE LANGERHOLC PRESENTED TO THE SENATE

Senator STREET. Madam President, today I rise to honor Mark Bergstrom, the outgoing executive director of the Pennsylvania Commission on Sentencing. Mark Bergstrom has managed a commission that, under his tenure, has become a national model for both navigating the often difficult and challenging substantive waters of providing fair and reliable data and has championed transparency and data-driven policies for 30 years. Mark has been executive director of the Pennsylvania Commission on Sentencing since April 1998. The commission is an agency of the General Assembly charged with assisting the development, maintenance, and the coordination of effective, humane, and rational sentencing policies, as well as parole and correctional practices in the Commonwealth. As a part of its responsibilities, the commission is required to adopt guidelines for sentencing, resentencing, parole, and recommitment, and to monitor compliance with these and other statutory provisions.

Mr. Bergstrom is an associate teaching professor of sociology and criminology at the Penn State University; and adjunct professor of law at the Duquesne University School of Law; and an adjunct faculty member at the Villanova University School of Law, where he assists with the annual Villanova Sentencing workshop. He has served as a state sentencing and corrections associate with the Vera Institute of Justice, providing technical assistance to jurisdictions on sentencing and correction reforms. He received a bachelor's degree in psychology from Millersville University of Pennsylvania and a master's of public administration degree from Penn State University. He is joined by Matt Kleiman, who has also joined us on the floor, who will serve as the new executive director of our Commission on Sentencing, and who will be filling very big shoes as he has already served the commission faithfully for many years. I would now like to yield to my colleague, Senator Langerholc, who joins me in representing this body on the commission.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Cambria, Senator Langerholc.

Senator LANGERHOLC. Madam President, I rise in conjunction with my colleague Senator Street, who I have the pleasure of serving on the Commission on Sentencing with, to recognize outgoing Executive Director Bergstrom. From the time that I was joining the Commission on Sentencing, it was readily apparent the extreme knowledge that Executive Director Bergstrom has and that he is able to use in such an effective way. He will surely be missed. And in navigating the constantly complex and evolving world of the sentencing guidelines, he was never more than a phone call, an email, or even a text away to share his knowledge and to help to move the commission forward. A Resolution honoring the life and dedication of United States Army Sergeant Richard "Dick" Marvin Sharrow who was killed in action during the Korean War 73 years ago.

On the question, Will the Senate adopt the resolution?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Venango, Senator Hutchinson.

Senator HUTCHINSON. Madam President, I rise today to honor the life of former Marienville resident and United States Army veteran, Sergeant Richard "Dick" Marvin Sharrow, who was killed in action during the Korean War 73 years ago. Sergeant Sharrow faithfully served his country in Company F, 2nd Battalion, of the 5th Cavalry Regiment, 1st Cavalry Division, which was deployed to Pohang and advanced to Yongdong, South Korea, to defend the city against the North Korean People's Army. Since July of 1950, Sergeant Sharrow has been listed as missing in action. Through the work of his family and the United States Department of Defense, Sergeant Dick Sharrow's remains have recently been identified through DNA testing, and this hero was finally returned home. After 73 years, this dedicated Army veteran, who gave his life for our nation, was provided full military honors, as he deserved, and he was properly laid to rest with his family in Marienville, Pennsylvania. May God bless Sergeant Sharrow and the dedicated veterans of our United States Armed Forces and all those who are actively serving and defending our freedoms.

Thank you, Madam President.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Jefferson, Senator Dush.

Senator DUSH. Madam President, on September 22, Senator Hutchinson and I had the privilege of welcoming home one of our precious missing-in-action soldiers who paid that ultimate sacrifice for our freedoms. Seventy-three years after he was killed in the village of Yongdong, Korea, we were both asked to join the family of U.S. Army Sergeant Richard Sharrow as his remains were finally transported home to Pennsylvania. The remains of Sergeant Sharrow, and many of his brothers-in-arms, remained behind North Korean lines until President Trump successfully negotiated the repatriation of their remains. It has taken years to properly identify these men through DNA that family members, such as Sergeant Sharrow's sister and niece, were able to provide.

The patriot riders from all over western Pennsylvania provided two special escorts, one from Pittsburgh International to the funeral home in Summerville, Jefferson County, and another to his final resting place in Marienville, Forest County. As an Air Force veteran and the son-in-law of a Korean War veteran, it was a humbling experience to spend time with his family members on a motor coach during the first part of his final journey. I learned

a lot about Sergeant Sharrow's service and sacrifice by reading some of his letters home, including one mailed just days before he was killed in action. The importance to his great-nieces and nephew, for them to be able to see and learn from a bunch of grizzled, old vets of the importance of never forgetting and honoring our fallen, truly struck me. When I was in Korea, as part of my military duties, I tried to imagine what it would be like trying to take those rocky hills. I came away with an even greater respect for my fellow veterans. All throughout Sergeant Sharrow's final journey, it was truly heartwarming to see the people alongside the road giving him his final and proper welcome home. On the final leg, we saw well over 1,000 people, including one North Korean vet standing by himself saluting as we rolled by--had his Korean veteran hat on. My thanks and deepest gratitude to all who played an important role in bringing Sergeant Sharrow home. Those who were involved with the collection of the remains from North Korea, to identifying the DNA, to identifying his family members, including one great-niece who is serving in the Air Force and escorted his body home from Hawaii. My prayer is that we never forget or leave any of our fallen MIA soldiers behind enemy lines. In closing, Madam President, I ask the Members of the Senate to join with me and Senator Hutchinson in honoring the memory of this selfless soldier with one final moment of silence.

When the widow or widower remarries, they are prohibited from renewing their license and registered to sell their interest in the business. This legislation would remove this outdated remarriage penalty language and allow funeral directors to remarry without giving up their interests in the business. I respectfully ask for an affirmative vote.

Numerous State agencies, including the Department of Labor and Industry, the Department of Education, the Department of Human Services, and the Department of Community and Economic Development, host their own workforce development programs. Recently, Governor Shapiro created a \$400 million workforce training program targeting infrastructure projects. Senate Resolution No. 169 directs the Legislative Budget and Finance Committee to undertake a study evaluating the effectiveness and efficacy of the workforce development programs that are currently in place. Despite the substantial taxpayer investment in workforce development, we continue to hear that employers are unable to fill available positions. To address this apparent disconnect between the programs in place and the needs they are trying to address, the resolution also seeks recommendations from the LBFC to make improvements to Pennsylvania's workforce development programs. As groups continue to seek more taxpayer investment, this resolution will provide an important benchmark on this problem and chart a path forward to make necessary changes to improve our State's skilled workforce shortage. I hope that you will join me in supporting this resolution and vote in favor of its final passage. Thank you.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Madam President, Senate Bill No. 721 will create an advisory board for the Special Supplemental Nutrition Program for Women, Infants and Children--we know it as WIC. This legislation is the cumulative effort of many advocates and providers, the bureau of WIC, the Department of Health, and especially the continued support of Senator Brooks and her staff, who have joined me on countless meetings over the past few years. It is worth noting that this bill had overwhelming support when it passed out of the Senate last Session. I hope two times is the charm.

The federally funded WIC program provides low-income mothers with fresh fruits, vegetables, and formula for their families at no cost to the State. However, it has been suffering from declining participation and has failed to evolve along with the needs of its participants who end up relying on State-funded SNAP benefits. For example, WIC is the largest purchaser of baby formula. When the nation saw a crippling shortage, moms would have to stop at their local WIC office to get their benefit check before they could even start looking for what formula was left. Now, with gas and grocery prices as high as they are, these moms face even more barriers. Many of our programs offer EBT, or electronic, cards for easier access, and some other States even offer this benefit through a downloadable app. There is room for improvement. This advisory board will be tasked to recommend best practices to increase enrollment and to remove barriers to access. The increased participation brings in more Federal funding, which will in turn save State dollars and provide more Pennsylvania families with the healthy start they deserve. This legislature, you, have done great work in terms of maternal health and infant health in the past year or so. And you have done a lot to address the health issues of mothers, infants, and children, and access to healthy foods is just as much part of that health issue as anything. So certainly, I would ask that on behalf of all Pennsylvania mothers and their babies, let us vote "yes" on this once

(b) The task force shall:

- (1) Review and analyze the law, procedures, practices, processes and rules relating to the issues involving stop-and-go establishments.
- (2) Hold public hearings for the taking of testimony and the requesting of documents.
- (3) Through the chair, administer oaths and affirmations to witnesses appearing before the task force.
- (4) Accept and review written comments from individuals and organizations.
- (5) Issue the report under subsection (f) no later than four months after the task force's initial meeting. In addition to any information that the task force deems appropriate, the report shall:
- (i) Define and create a liquor license category for stop-and-go establishments located and operating within a city of the first class.
- (ii) Provide recommendations for regulating stop-and-go establishments that are located and operating within a city of the first class.

- (c) The task force shall consist of the following members who shall be appointed within twenty-five days after the effective date of this subsection:
  - (1) One member appointed by the Governor.
- (2) One member appointed by the President pro tempore of the Sen-
- (3) One member appointed by the Minority Leader of the Senate.
- (4) One member appointed by the Speaker of the House of Repre-
- (5) One member appointed by the Minority Leader of the House of Representatives.
- (6) An ex officio member from the board who shall not have voting
- (d) A chair of the task force shall be elected by a majority vote of the members of the task force.
  - (e) The task force shall conduct business as follows:
- (1) The physical presence of a majority of the members shall constitute a quorum. The ex officio member of the task force shall not be considered for purposes of a quorum.
- (2) Action of the task force must be authorized or ratified by a majority vote of the members.
- (3) A member not physically present may participate by teleconference or video conference.
- (4) The first public meeting of the task force shall be convened within forty-five days of the effective date of this paragraph. Additional public meetings may be called by the chair as necessary.
- (5) The chair shall schedule a meeting upon written request of a two-thirds majority of the members.
  - (6) The task force shall hold public hearings as necessary.
- (7) All meetings and hearings held by the task force shall be subject to 65 Pa.C.S. Ch. 7 (relating to open meetings).
- (8) The board shall provide administrative or other assistance to the task force.
- (9) Members may not receive compensation but shall be reimbursed for reasonable and necessary expenses incurred in service.
- (f) The task force shall compile a report of recommendations under subsection (b) within four months after the task force's initial meeting and deliver the report to each member of the General Assembly who represents residents of a city of the first class, the board, the chairman and minority chairman of the Law and Justice Committee of the Senate and the chairman and minority of the Liquor Control Committee of the House of Representatives.
- (g) The task force shall expire thirty days after delivery of the final report under subsection (f).
  - (h) As used in this section:
- (1) The term "stop-and-go establishment" means establishments that are:
  - (i) legal holders of restaurant or R-licenses; and
- (ii) a convenience store or deli that sells beer and liquor, sometimes in quantities as low as a single shot, that may be consumed on premises or immediately outside the establishment.
- (2) The term "task force" means the Stop-and-Go Legislative Task Force established under this section.

Senator TARTAGLIONE. Madam President, I rise because to-day marks 6,365 days since our Commonwealth's legislature last passed an increase in our minimum wage. This unconscionable failure of governance is not just ensuring our low-wage and minimum-wage earners are stuck in a never-ending cycle of poverty though, Madam President. Our inaction is driving workers out of the Commonwealth to places where they will earn more for doing the same work. A recent study called "When Low-Wage PA Border County Workers Want a Living Wage Job, What Do They Do? Cross Over Into New York or New Jersey." The Keystone Research Center found that while Pennsylvania workers are crossing into New Yorkers are crossing into Pennsylvania. Well, why would they, Madam President? We are having a labor exodus of

our Commonwealth, and there is an easy way to stop the flow of workers.

If we pass Senate Bill No. 12--my bill that would put our Commonwealth's low-wage earners on a path to \$15 an hour-we would prevent the thousands who live in Pennsylvania but take their labor across State borders, as well as those who move entirely to find greener pastures and higher wages for the same work. Madam President, right now, Pennsylvanians living near the borders of our neighboring States are traveling into those States to find work. And who can blame them when they will earn up to \$100 more per week than an in-State job--\$5,000 just for working across State lines? It is a sin, Madam President, that we are falling behind our neighbors and forcing our low-wage and minimum-wage earners to work for pennies on the dollar they could earn elsewhere. Our Commonwealth workers deserve better, Madam President. Our Commonwealth workers deserve Senate Bill No. 12.
