In accordance with Act 31 of 2007, attached is the Triennial Radiation Protection Act.

Act 31 amended the Radiation Protection Act to include a provision that specified a review of PEMA's nuclear power plant (NPP) fees every three years beginning in 2009 with a working group with DEP and NPP representatives. This report is PEMA's work product based on the actual expenditures during the three-year review period of State Fiscal Years (SFY) 2019-2020, 2020-2021, and 2021-2022, with projections through SFY 2029-2030.

Following the review, PEMA recommends increasing NPP fees for RERP from \$275,000 to \$375,000; RERF from \$150,000 to \$200,000, and RTERF from \$2,500 to \$3,000 per individual vehicle shipment and from \$4,500 to \$5,000 per railroad car or river barge shipment. These increases are necessary to meet the requirements established in 35 Pa. C.S. § 7320. The funding increases are due to increases as discussed in 2014. If funding is not increased, PEMA will have a deficit beginning in SFY 2026-2027.

On June 26, 1989, the revised Public Official and Employee Ethics Law was enacted which re-authorized the State Ethics Commission. The

State Ethics Commission is responsible for issuing various types of rulings on matters within its mandated jurisdiction. Pursuant to the law, the Commission is mandated to forward, quarterly, a copy of every Opinion, Advice of Counsel, and Order issued to one law library in each county, one public library in each county, the State Library, the State Senate Library, each authority appointing a Commission member, the Pennsylvania Association of County Commissioners, the Pennsylvania Association of Boroughs, the Pennsylvania State Association of Township Supervisors, the Pennsylvania State Association of Township Commissioners, the Pennsylvania State School Boards Association, and the Pennsylvania League of Cities. Your agency is either specifically identified in the above requirement or has been selected as a library to which this mailing will be made pursuant to the above authority. As such, enclosed please find decisions of the State Ethics Commission from October 1, 2023 to December 31, 2023. Due to budgetary restraints, a CD containing said rulings will replace paper copies that were previously sent.

For your information, the Commission generally issues these types of decisions as follows:

<u>Commission Opinions</u> - Opinions are advisory rulings issued by the State Ethics Commission regarding the duties and responsibilities of public officials and employees under the Public Official and Employee Ethics Law. Opinions are catalogued by year of issuance followed by the sequential number of the opinion during that year. As such, opinions relating to 2023 will begin with the number 23-001 and proceed there from as decisions are rendered.

Advice of Counsel - The Commission's Chief Counsel is authorized to issue similar advisory letters. Such letters are issued generally when there is prior precedent for counsel to rely upon in issuing a decision or when the provisions of the State Ethics Act directly provide the answer to the question posed. Advice of Counsel letters are numbered with the year and a 500 series number that progresses in order therefrom as rulings are issued. If more than 100 such letters are issued, a 600 series number will then be used.

Orders - Commission orders are issued at the end of an investigation and are determinations as to whether or not there has been a violation of the State Ethics Act. Commission orders are categorized numerically from the date of the first order in 1979. That is, the first Order issued was Order No. 1. All orders proceed there from.

It is recommended that Opinions, Advices of Counsel and Orders be maintained separately (in numerical order) so as to afford better retrievability.

The enclosed items are being forwarded for retention, cataloging and for the purpose of being publicly available for review by citizens of the Commonwealth of Pennsylvania who may have an interest therein. SPECIAL ORDER OF BUSINESS LINCOLN DAY ADDRESS

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lancaster, Senator Aument.

Senator AUMENT. Madam President, in 2012, a group of historians decided they wanted to do something different to

recognize the life and legacy of President Abraham Lincoln. They wanted to find a creative way to physically illustrate his importance, and they did so by creating a tower of books that have been written about him. That tower measured 8 feet around and 3 1/2 stories tall. It is estimated that over 15,000 books have been written about Lincoln. I share this to point out that I fully recognize that there is nothing I am going to say today that is original or has not likely already been said and likely been said far better than what I could articulate. However, it is appropriate for us here to pause as we approach the 215th anniversary of President Lincoln's birth, to remember his life and legacy, and thank God that Abraham Lincoln lived.

The speech today has presented me with an opportunity the last few weeks to reflect on that legacy. And I have often found myself thinking about the sad and tragic circumstances of his life. Perhaps, in the midst of it, we can find some hope from the inner strength that Lincoln possessed. Far too often, we attempt to clean up our great historical figures and assign them a life we wish they had lived, or better fits our use today. We make the very mortal, immortal; flawed, flawless; and actually miss some of their greatness when we do so. This does all of us, especially our children, a deep disservice. Poverty, depression, tragedy, abuse, neglect, the circumstances of your birth, your childhood; while it may be your present and important part of your story, does not ultimately have to define who you are or what you become or what you can achieve. We often gloss over this fact of Lincoln's life from beginning to its tragic end. His was a life marked by deep sadness, dissatisfaction, bouts of prolonged depression, and tragedy.

He was born into deep poverty on February 12, 1809, in Kentucky, and raised on the frontier. He lost his mother to milk sickness at the age of 9. Just 10 years later, he lost his beloved sister while she was giving birth to a stillborn son. He had a complicated relationship with his father. He hated the farm labor of his upbringing, possessed very little formal education. Lincoln sunk deep into depression after the loss of a dear friend, perhaps his first real love interest, Ann Rutledge. He had a stormy relationship with his wife. Lincoln and Mary Todd Lincoln had four sons. Two died in childhood, only one survived beyond the age of 18. One son, Willie, died at the age of 11 in the White House, in the midst of the Civil War. He suffered political rebuke, unpopularity, multiple election defeats. Then when he finally reached the pinnacle, election to the White House in 1860, he sees the country literally break apart between his election and inauguration of March 1861, sneaking into Washington in disguise. He presided as a moderate Republican in a deeply fractured party and country. He served as Commander in Chief during a bloody civil war that left 620,000 Americans dead in a country of just 31 million. Brother against brother, countrymen against countrymen, with the promises contained in the Declaration of Independence that all men are created equal hanging in the balance. The very hope that a government of the people, by the people, for the people, might not perish from the Earth. He then became among the final casualties of that war, cut down by an assassin's bullet just days after the surrender at Appomattox. I am only touching the surface of the pain, the tragedy, and the deep sadness Lincoln felt throughout his life. Yet there was a remarkable resilience, strength, and determination. What kept him getting back up when knocked down? What kept him going? This also is worth thinking

about as we celebrate Abraham Lincoln as his 215th birthday approaches.

Lincoln possessed a remarkable drive and an incredible personal ambition. Yes, he was most certainly ambitious for himself and his own personal achievement. He was also incredibly ambitious for his country and ambitious for his fellow Americans, and far more often than not, those ambitions aligned. May the same be said here of us. He was grounded, always grounded by a compass, his true north, and tried to do what was right, even when it was incredibly unpopular and came at a high political and personal cost. As Lincoln concluded his first major eastern address, while preparing to run for President in 1860 at Cooper Union, he said:

Neither let us be slandered from our duty by false accusations against us, nor frightened from it by menaces of destruction to the Government nor of dungeons to ourselves. Let us have faith that right makes might, and in that faith, let us, to the end, dare to do our duty as we understand it.

May it be so with us. Thank you, Madam President. [Applause.]

Senator J. WARD. Mr. President, I rise to give my support for this important legislation and to honor this fallen hero. Lance Corporal Ralph Fabbri was born in Altoona in 1989. He attended Penn Cambria High School and graduated in 2008. It was here that his passion for art and photography began to develop. Corporal Fabbri's love for photography and his desire to serve met when he enlisted in the United States Marine Corps as a combat photographer. He was then assigned to the Headquarters Battalion, 1st Marine Division, at Camp Pendleton, California. Corporal Fabbri was deployed to Afghanistan, participating in Operation Enduring Freedom. On September 28, 2010, he was tragically killed in action in the Helmand Province of Afghanistan, 1 day before his 21st birthday.

Corporal Fabbri was an avid hunter and fisherman and was known to many by his down-to-earth, fun, loving, and considerate persona. On my way to a restaurant where he grew up--it is a favorite restaurant of mine--I often get to see his park. There is a park dedicated to Corporal Ralph Fabbri, and he was a beloved member of the community. But this resolution [bill] and bridge designation help to ensure that no one will forget the blessing he was to those who knew him and that we always remember his selfless sacrifice and his service.

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Martin.

Senator MARTIN. Mr. President, throughout the year, we pause to call attention to cancer in various forms and we honor those fighting it and those we have lost to it. While all forms of cancer are horrible, we can all agree that pediatric cancer is especially heartbreaking. Next week, on February 15, the world will honor International Childhood Cancer Awareness [sic] Day, and I rise today to join them. While it should be celebrated that the 5year survival rate has increased to over 80 percent, I again stand here to remind this body that this figure does not tell the full story. This statistic does not explain that the incidence rate of children diagnosed has increased over the last half-century. It does not show that those who made it past their 5-year mark before passing away, nor does it reflect the struggle these children face for the rest of their lives due to the long-term damage many of our decades-old treatments, harsh treatments, designed for adults, have caused on their young bodies. Today, I rise to call attention to this whole truth, the good, the bad, and the heartbreakingly sad. I want to highlight and thank the medical community for all their work on this terrible disease. I want to tell the parents and families of these children that we, as a body, share grief in all of their losses and, most importantly, to tell these brave little fighters that we stand with them and that we will continue to do so in any way we can support them. I encourage every member of our respective communities to do the same in whatever way they can. I am truly hopeful that as we continue to prioritize this issue, improve access to medications and better treatments, and do what we can do to help, that one day soon we will beat childhood cancer. I ask my colleagues of the Pennsylvania Senate to join me in honoring International Childhood Cancer Awareness [sic] Day in Pennsylvania.

The PRESIDENT. The Chair recognizes, for a second time, the gentleman from Lancaster, Senator Martin.

Senator MARTIN. Mr. President, I rise today to join Senator Langerholc and Senator Dush in recognizing our resolution designating the week of February 12 through 18 as THON Week. The Pennsylvania State University's no sitting, no sleeping, 46hour dance marathon, affectionately known as THON, is the culmination event of a year-round fundraising campaign by what is considered the largest student-run philanthropy in the world. These donations go directly to the Four Diamonds fund, which works with Penn State's Children's Hospital to cover all medical expenses related to pediatric cancer care not covered by insurance and to help fund pediatric cancer research broadly. Over the last 50 years, THON has raised nearly \$220 million for the kids, aiding about 4,800 families. Students engage in an array of fundraising activities, most notably canning weekends, where they visit communities all over our region collecting donations. Approximately 16,500 Penn State students work through various committees to raise these funds and ultimately organize a 46-hour event where over 700 students dance in solidarity with these brave little kids. One of their many mottos is: "One day we will dance in celebration, --but-- until then, we [will] dance for a cure."

I cannot imagine hearing the gut-wrenching words, your child has cancer. But because of the combined efforts of so many, including Penn State students and mini THONs at high schools across Pennsylvania, the very next words these families hear are: we are from the Four Diamonds fund, and we are here to help. For those who have not had the opportunity to witness the event,

it is truly something that cannot be explained in words. You simply must see it for yourself. I encourage everyone listening to this to join the fight against pediatric cancer in whatever way they can, and I ask my colleagues to join me today in recognizing next week, February 12 through 18, as THON Week in Pennsylvania.

Senator TARTAGLIONE. Mr. President, I rise because today marks 6,420 days since our Commonwealth's legislature last passed an increase in our minimum wage. And we are back, Mr. President, this week because our Governor is going to deliver his second budget address tomorrow, which will lay out his plans, hopes, and goals for the coming year. One thing I think we can expect him to call for is raising our embarrassing low povertylevel wage. Governor Shapiro gets it. He knows the current minimum wage just is not cutting it to many hardworking Pennsylvanians. Our low-wage workers are often working two or three jobs and still struggling to make ends meet. We can do better, and it is time to make sure that everyone gets a fair shot. Raising our minimum wage is not just about money, it is about treating people with respect. No Pennsylvanian should be working full-time and have trouble putting food on their table or paying their bills. That is why I introduced Senate Bill No. 12. We cannot continue to allow Pennsylvanians to be caught in this current cycle of economic hardship. Senate Bill No. 12 is a crucial step towards ensuring that every hardworking Pennsylvanian is afforded the dignity they deserve. Mr. President, Senate Bill No. 12 and the calls for an increase in the minimum wage are born out of a basic idea: the idea that a fair wage is not a luxury, it is a basic right. Let us come together and send a clear message to Pennsylvanians that we are prioritizing every worker's right to make a livable wage and not be forced into a cycle of poverty our current starvationlevel wage perpetuates. Let us put Pennsylvania's low-wage earners on a path to \$15 an hour. Let us pass Senate Bill No. 12.

The PRESIDENT. The Chair recognizes, for a second time, the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise today and ask that my Senate colleagues join Senator Baker and me in supporting Senate Resolution No. 228, which recognizes Friday, February 2, 2024, as National Wear Red Day in Pennsylvania. National Wear Red Day urges us all to reflect on the importance of women's heart health and improving the lives of women around the world.

Mr. President, according to the American Heart Association, cardiovascular disease is a leading cause of death among women, causing 1 in 3 deaths each year. While women's heart disease awareness has increased in recent years, Mr. President, a gap in awareness still exists among the demographics of minorities and younger women. By recognizing National [Wear] Red Day in our Commonwealth, we can increase public awareness of cardiovascular disease and the risk it poses to all women. Let us use this day and our clothing as catalysts for change so that we can encourage healthier lifestyles, regular checkups, and promote gender-specific research on health heart. Together, we can ensure women across our Commonwealth and the world have the knowledge and resources to prioritize their cardiovascular wellbeing. Finally, I want to thank my good friend Senator Baker for

joining me in this critical venture, and I encourage my Senate colleagues to wear red this month to bring attention to women's heart health.

The PRESIDENT. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Mr. President, each February, the nation goes red for American Heart Month and Wear Red Day, as millions unite to raise awareness about cardiovascular disease and help to save lives. I am so pleased to join my friend and colleague from Philadelphia, Senator Tartaglione, in sponsoring this Senate Wear Red Day proclamation to recognize these efforts to educate about heart disease and strokes.

As Senator Tartaglione said: cardiovascular disease is the number one killer of women, causing 1 in 3 deaths each year. And although it impacts some women at higher rates than others, most cardiovascular disease can still, can still be prevented with education and healthy lifestyle changes. So, knowing your risk, knowing your risk is critical to prevention. And knowing your risk starts with knowing your numbers. Know your numbers for blood pressure, cholesterol, blood sugar, BMI; your heart depends on it. Tremendous strides have been made educating women especially to the symptoms and dangers of these health concerns. But we need everyone to join us in spreading this message across Pennsylvania to save our hearts and the hearts of those you know and love. Together, we can continue to rock our red and help save more lives. So, in February, let us remember this is national wear red month, and I hope that you will rock your red with us.

The PRESIDENT. The Chair recognizes the gentleman from Jefferson, Senator Dush.

Senator DUSH. Mr. President, I am proud to stand with Senator Martin and Senator Langerholc, and as the State Senator representing the main campus of Penn State University, I am greatly looking forward to attending THON Weekend of 2024, which starts Friday, February 16, and finishes on Sunday, February 18. As anyone who has previously participated is fully aware, THON is the world's largest student-run philanthropy, committed to enhancing the lives of children and families impacted by childhood cancer. Their mission is to provide emotional and financial support, spread awareness, and ensure funding for critical research, all in the pursuit of a cure. This tremendous yearlong effort culminates in a 46-hour dance marathon at the Bryce Jordan Center. Last year's THON was my first. It was an absolute blessing to see thousands of students, along with their organizational teammates, becoming actively involved with young children who have been tragically impacted by cancer. Some of those children and their families were there last year, and their stories about how the student organizations had adopted them and the relationships between the students and these kids was very heartwarming. Time and time again, these inspiring volunteers have basically become part of these kids' families and partners in their care.

Personally speaking, I consider THON to be an excellent example of practicing God's second commandment: to love our neighbors as ourselves. These relationships are truly heartwarming. As always, donations, large or small, make it possible for these pediatric cancer patients and their families not to have to make difficult choices between what is the best treatment and

what their family budget can afford. Much of the money raised annually through THON helps to expand lifesaving cancer research and delivers additional resources to support patients, families, and their caregivers. I fervently believe that all funding generated by THON is essential to developing effective cancer treatments, as well as identifying risk factors and genetic patterns that will accelerate the fight against this terrible disease and ultimately bring an end to childhood cancer. Moving forward, let us always remember the precious loved ones we have lost; let us pray for everyone currently battling childhood cancer; and let us celebrate the courageous survivors who continue to beat this disease. If only one person can make a difference in the fight against childhood cancer, imagine what all of us can do together. We are, Penn State. Thank you for all you do to support THON.

The PRESIDENT. The Chair recognizes the gentlewoman from York, Senator Phillips-Hill.

Senator PHILLIPS-HILL. Mr. President, I rise today, alongside my colleague from Indiana County, to commemorate the observance of Four Chaplains Day. Each February 3, this day of remembrance is celebrated across our nation and our Commonwealth. Rabbi Alexander Goode, a Jewish rabbi; Reverend George Fox, a Methodist minister; Reverend Clark Poling, a Dutch Reformed minister; Father John Washington, a Catholic priest; the Four Chaplains.

These military chaplains sacrificed their own lives to save the lives of their fellow service members during World War II, when the USAT *Dorchester* was attacked in what was known as Torpedo Junction, about 150 miles off the coast of Greenland in the frigid waters of the Atlantic Ocean. As the ship began to sink, the Four Chaplains could be heard together, offering up prayers to God, and in a tribute by 1 of the 230 survivors, it was said that it was the finest thing I have ever seen this side of heaven.

Each year, we gather at the Four Chaplains Memorial of York County's annual breakfast to commemorate and honor the service and the sacrifice of the Four Chaplains. We find strength in the legacy of the Four Chaplains and of Rabbi Alexander David Goode, who left the pulpit at Temple Beth Israel in York to become an Army chaplain. In York, and around the Commonwealth, we continue to remember, to reflect, to commemorate, and to honor the service and the sacrifice of the Four Chaplains. Local leaders who live their lives by the values of the Four Chaplains are recognized, and scholarships are awarded to students from the Alexander D. Goode Elementary School to help them pursue a future in education and to build a strong foundation for a life in which they can give themselves to others for their betterment. Today I thank the Senate of Pennsylvania for the opportunity to remember the Four Chaplains, their service, their sacrifice, and their legacy.

The PRESIDENT. The Chair recognizes the gentleman from Indiana, Senator Pittman.

Senator PITTMAN. Mr. President, I want to rise and echo the comments of my friend and colleague, the gentlelady from York County. For many years now, she and I have worked together to recognize the service and sacrifice of the Four Chaplains. And as we have discussed on this floor over time, my great-uncle Robert Maurice Pittman was a crew member on the USS *Dorchester*. He was not one of those who was fortunate enough to survive, and

to this day remains missing at sea. Obviously, I did not know my great-uncle, but I remember my great-grandmother quite well. And what has always struck me about that sacrifice that she made, was that it was such an ordinary sacrifice in an extraordinary time. And I think it is critically important, as the generations go on and we lose direct contact from the sacrifices that were made during World War II, that we take time to remember how significant those sacrifices were at the time; the sacrifices that the Four Chaplains made; and quite frankly, the standard that it sets for all of us to recognize service above self. And again, the gentlelady from York County, I have always been impressed with what York County does in recognizing and commemorating the sacrifice of the Four Chaplains, and I am thankful that she continues to take the lead on that effort.
