Rep. Ronald Waters, Philadelphia County, is elected a member of the Health and Human Services Committee *vice* Rep. Thomas Petrone resigned.



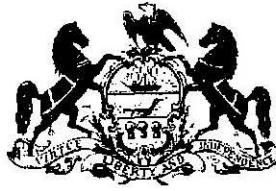
