Re: Support for HB 1393, PN 1714, Medical Marijuana

Dear Representative Oliver:

The Pennsylvania Prison Society supports HB 1393, PN 1714 that provides for the use of marijuana for medical purposes.

HB 1393 will allow people suffering from a number of diseases to legally obtain medication that can reduce some of their discomfort. Patients with AIDS, glaucoma, multiple sclerosis, or even certain chemotherapy regimens, for example, may benefit from a prescription by their physician for marijuana. In these limited circumstances and with the checks and balances included, HB 1393 is a measure whose positive impact far outweighs negative concerns.

Thirteen other states (roughly 25% of the United States) have already approved the use of marijuana for medical purposes. New Jersey may be the next state to support a similar measure.
