Martin Hill - Bedford County - 18 miles of summer trail. Access to the trail is from the parking area located on Route 326 two miles south of Rainsburg.

Potter County - 43 miles of summer trail. A loop trail located south of Denton Hill State Park. Registered Class II ATV's are permitted on this trail that are less than 58" in width and less than 1,200 pounds. Maple Run Tract, Pike County

Summer and Winter Trails

The summer season runs from the Friday before Memorial Day through the last full weekend in September.

The winter season runs from the day following the last day of the regular or extended antlerless deer season as established by the Game Commission through the following April 1.

There are some trails that remain closed until after the late muzzleloader season, please check with the individual forest district to see when the trails will open for the winter season.

Pike County -Burnt Mills and Maple Run ATV Trails reopened for ATV use on Friday, May 23, 2014 and close the last weekend in September. - 7 miles of summer and winter trail. Access is from a parking area on Route 402 one mile south of Porters Lake. Registered Class II ATV's are permitted on this trail that are less than 58" in width and less than 1,200 pounds. Adams & Cumberland Counties - <u>36 miles of summer trail</u>. <u>During the winter season the trail system is expanded to 42 miles by using some dirt roads that are gated during the winter.</u> **Part of the trail system is shared with snowmobiles** when there is sufficient snowfall. The trail is located between Big Flat and Pine Grove Furnace State Park. Access to these are from parking lots located at Big Flat along Shippensburg Road about 1-1/4 miles north of its intersection with Route 233 and on Piney Mountain along Bendersville Road south of Pine Grove Furnace State Park.
