



### H.B. 809 Negatively Impacts a Community's Quality of Life

#### **Student Rental Housing Destabilizes Neighborhoods**

- Out migration families
- Out migration middle and upper income households
- Upends a neighborhood's value system
- Declining property values
- Decline in the aesthetics of residential dwellings due to lack of proper maintenance
