  - Large community mental health center in Uniontown, Fayette County.
  - o Large Outpatient Mental Health Clinic
  - School Based Mental Health Service in all County School Districts and a few outside of Favette County

# Prevalence of Mental Health crisis in children and the impact of the COVID pandemic

- Attached infographic illustration that shows mental health related issues as outlined in the 2019 Pennsylvania Youth Study
- Clearly the isolation, anxiety, stress, fear, and uncertainty of the pandemic has exacerbated this issue
  - CRCSI has seen a 30% increase in our 24/7 Mental Health CRISIS Intervention Service phone calls and interventions.
  - Requests from our clinical staff for the CRISIS Intervention team to follow up or do a wellness check on children has exploded by 500%
  - Increase of 25% for child mental health emergency room visits

#### CRCSI School related Mental Health Services

- o Outpatient Clinic in a school
  - As a licensed Outpatient Clinic the Department of Human Services can license a school as a satellite office adjunct to our main clinic license
    - Positives
      - No cost to Districts professionals
      - Ability to have on-site therapy services (tele-health as well)
      - Less stigma than a formal outpatient clinic
    - Challenges
      - Financial viability difficult to maintain in that only direct therapy services deemed billable to the child's health insurance are reimbursed
      - Therapists caseload and related schedule must be adequate and consistent to be cost effective
      - Child must be diagnosed with a psychiatric disorder
      - Poor and inconsistent payment by health insurance entities

## Mental Health Resource Specialist (MHRS) District contract with CRCSI for a Licensed Social Worker full-time

- o Positives
  - Considerable flexibility in MHRS role as prioritized by District
  - Some direct therapeutic and support services may be billable to health insurance/access

- Opportunity to provide mental health related training and support to District
   Staff
- Student does not always need to be formally diagnosed with a mental health disorder
- Support and consultation from CRCSI clinical professionals, especially, child and adolescent psychiatrist is offered
- o Challenges
  - Financial commitment as part of School District

### Hybrid Mode

 Combines Outpatient Clinic model and MHRS role into the onsite therapists predetermined schedule

## Considerations moving forward

- o Parity in mental health/physical health insurance coverage
- Blended/Braided funding to support mental wellness initiatives and creative support and services
- o Maintain tele-health flexibility as permitted during emergency declaration
- Mental Health First Aid or similar mental health awareness training for all school personnel

38% of our youth have felt depressed or sad MOST days in the past 12 months.



12.9% of our youth have planned suicide



9.7% of our youth have attempted suicide



\*Children presenting in ERs with Mental Health Issues Increased 24% March - October 2019-2020



14.4% of our youth have self-harmed (cutting, scraping, burning)



16.2% of our youth (that is approximately 1 out of every 5) have seriously considered suicide.
