Testimony - Legislative Hearing: Children's Trust Fund April 17, 2024

Good morning. My name is Paul DiLorenzo, and I am the Chairman of the Children's Trust Fund Board. In my full-time role, I serve as the Executive Director of the Salem Health and Wellness Foundation in New Jersey. I began my career in child welfare in 1976 as a caseworker in Philadelphia. I have also served in state government at the Pennsylvania Office of Children, Youth and Families as a Special Assistant and in Philadelphia as the Director of Children's Policy. Prior to those roles, I spent 13 years at Casey Family Programs and in various consulting roles around the country. I live in Montgomery County, PA.

I'm excited to be here, and humbled to be serving as the Chair of a Board that includes a number of very impressive individuals from all over the Commonwealth. Like myself, many of the Board members are very recent appointees and as such we are using this as an opportunity to clarify our "North Star". In a recent meeting that included most of the Board members, we affirmed our commitment to supporting children, their families, and the communities in which they live. The best way to keep kids safe and thriving is to assure that their families have the right balance of parenting information, economic/ healthcare resources, and supportive communities.

I want to use my time today to provide you with an overview of the Children's Trust Fund Board and how it has had an impact in Pennsylvania. Though the enabling legislation is somewhat dated, the Trust Fund's purpose is still relevant and necessary. I'm confident that the new Board members will work to keep kids safe and families strong.

History of Children's Trust Funds

- Michigan Pediatrician Dr. Ray Helfer
- Vision to create a trust fund for the care and safety of our children
- 1980 first CTF established in Kansas
- 1988 PA's CTF established (Act 151)
- 1989 National Alliance of Children's Trust and Prevention Funds established
- Trust funds established in most of the 50 states, D.C., and Puerto
- Funds receive revenue from a variety of sources





CTF Structure - Nationally

State Children's Trust and Prevention Funds take on a variety of structures including:

CTF Revenue - Nationally

- State Children's Trust and Prevention Funds derive revenue from:

- Interest on investments

- State line-item funds
- Federal funds, i.e. CBCAP, MIECHV

- Constant revenue
- \$10.00 surcharge on marriage and divorce applications
- Investment income
- Donation option through state income tax returns
- \$5.00 donation option through the Pennsylvania Department of Transportation online renewal services
- Deposited into a special, non-lapsing state account






Board Member Responsibilities

- Board member position
- Participate in the grant process
- Manage the Children's Trust Fund
- Actively participate in board meetings
- Statement of Financial Interest (Ethics Act)
- Complete the Statement of Financial Interest
- Annually, but prior to May 1st
- Constitutional Oath of Office
- Notarize and file your Constitutional Oath of Office with the Secretary of the Commonwealth

CTF RFA Requirements

- Provide a match to CTF funds
- Primary and secondary prevention
- Work with the whole family
- Provide evidence that the program fits in the community
- Collaborate in the community
- Coordinate with County Children and Youth agencies
- Incorporate the SFPF framework into the work
- Build environments in which families can grow their protective factors





Factors Framework Strengthening Families™ Protective

- SFPF Framework is an approach---not a model
- Aligned with developmental science and research-informed
- Protective and Promotive approach that encourages a changed relationship with parents/caregivers
- Five Protective Factors
- Parental resilience
- Social connections
- Knowledge of parenting and child development
- Concrete support in times of need

CTF Grantees

- Include large and small organizations
- May be housed in community-based non-profits, hospitals, school districts, intermediate units, etc.
- Serve rural, suburban, and urban communities
- Implement nationally recognized evidence-based programs, enhancements to programs, and programs that they have developed
- Partner with families for multi-year or short-term services
- Connect with families through individualized programs or in groupbased formats
