## CONVEYANCE - LAND IN FORMER RIVER BED IN SCHUYKILL COUNTY Act of Apr. 6, 1979, P.L. 3, No. 3 Cl. 85 AN ACT

Authorizing the Department of General Services, with the approval of the Secretary of Environmental Resources, to sell and convey a tract of land formerly within the bed of the West Branch of the Schuylkill River in the Borough of Cressona, Schuylkill County, Pennsylvania, lying within lands now or formerly owned by Aluminum Company of America.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. It is the purpose of this act to encourage the return to operation and productivity of an aluminum extrusion facility and to remove impediments to the financing of the facility. A portion of the West Branch of the Schuylkill River, navigable river, lies within certain lands in the Borough of Cressona, and the Township of North Manheim, Schuylkill County, Pennsylvania, now or formerly owned by Aluminum Company of America. To enable the expansion of the aluminum extrusion facility now or formerly owned and operated in Cressona by Aluminum Company of America, the bed of said river was relocated pursuant to a permit issued on August 11, 1942 by the Water and Power Resources Board of the Department of Forests and Waters of the Commonwealth of Pennsylvania. Pursuant to law, the Commonwealth of Pennsylvania retains fee simple title in and to the tract of land lying within the abandoned riverbed. Therefore, the Commonwealth of Pennsylvania should convey its right, title and interest in the tract of land formerly within the bed of said river, to Aluminum Company of America or such other party as shall own the lands adjacent to said tract on the date of the conveyance.

Section 2. The Department of General Services, acting on behalf of the Commonwealth of Pennsylvania with the approval of the Secretary of Environmental Resources, is hereby authorized to convey, in consideration of \$1, all the right, title and interest of the Commonwealth of Pennsylvania in and to that tract of land, as hereinafter described, in the Borough of Cressona, and the Township of North Manheim, Schuylkill County, Pennsylvania, except for that portion of the land which forms the present bed of the West Branch of the Schuylkill River, resulting from the relocation of said riverbed pursuant to a permit issued on August 11, 1942 by the Water and Power Resources Board of the Department of Forests and Waters of the Commonwealth of Pennsylvania.

The Deed of Conveyance shall name as grantee the owner, as of the date of the conveyance authorized hereby, of certain lands in the Borough of Cressona and the Township of North Manheim, now or formerly owned by Aluminum Company of America, within which lands lies the tract to be conveyed. Said lands are described as follows:

## Tract No. 1

All that certain tract or parcel of land situate in the Borough of Cressona, Schuylkill County, Pennsylvania, bounded and described in accordance with a survey prepared by George H. Steidel, Registered Engineer, under date of October, 1942, as follows:

Beginning at a point on the west side of Park Street 33 feet wide and on the south side of a 16 feet wide alley, said point being 171 feet southwardly from the center of Pottsville Street; thence partly along the west side of Park Street 33 feet wide

and also the west side of Park Street as formerly laid out which is now vacated by Ordinance of Cressona Borough enacted November 2, 1942 (see also Ordinance of November 18, 1946) and partly along the property formerly of the Reading Company south 22 degrees 30 minutes east 1036.15 feet to a point; thence along property formerly of the Reading Company north 87 degrees 56 minutes west 264.0 feet to a point; north 70 degrees 51 minutes west 462.05 feet to a point and north 65 degrees 53 minutes west 297.14 feet to a point, being a corner of this property and properties formerly of the Reading Company and Mine Hill and Schuylkill Haven Railroad Company; thence along the latter property north 4 degrees 36 minutes west 397.47 feet to a point, a corner of this property and property formerly of the Mine Hill and Schuylkill Haven Railroad Company; thence north 4 degrees 34 minutes east 205.34 feet to a point and north 32 degrees 05 minutes east 103.61 feet to a point in center of Pottsville Street; thence along the center of Pottsville Street by a curve to the left, having a radius of 426.6 feet, the chord of which is north 86 degrees 20 minutes east 250.0 feet to a point in the center of said Pottsville Street; thence along the western line of property now or formerly of W. J. Schaller south 13 degrees 24 minutes east 93.4 feet to a point and south 42 degrees 50 minutes east 56 feet to a point, the southwest corner of said Schaller property and the northwest corner of a 16 feet wide alley; thence south 28 degrees 18 minutes east 16 feet crossing the head of said 16 feet alley to a point on the south side of said alley; thence along the south side of said alley north 61 degrees 42 minutes east 244.75 feet to the place of beginning.

Containing 14.57 acres.

## Tract No. 2

All that certain tract or parcel of land situate in the Borough of Cressona, Schuylkill County, Pennsylvania, bounded and described in accordance with a survey prepared by George H. Steidel, Registered Engineer, under date of October, 1942, as follows:

Beginning at an iron pin a corner on the east line of this property and a corner of the property now or formerly of Reading Company and the southwest corner of property now or formerly of Daniel Canfield; thence along said Reading Company property south 22 degrees 33 minutes east 514.77 feet to a point, south 69 degrees 45 minutes west 333.28 feet to a point, south 22 degrees 30 minutes east 200.0 feet to a point, and south 69 degrees 41 minutes west 435.20 feet to a point on the east side of Park Street, as formerly laid out 33 feet wide now vacated by Ordinance of Cressona Borough enacted November 2, 1942 (see also Ordinance of November 18, 1946); thence along the east side of Park Street as formerly laid out 33 feet wide but now vacated as aforesaid north 22 degrees 30 minutes west 659.0 feet to a point on the line between this property and property now or formerly of the Cressona Auto Body Works; thence along the same north 67 degrees 50 minutes east 141.0 feet to a point and north 22 degrees 31 minutes west 112.8 feet to a point on the south line of property now or formerly of Amanda Hein; thence along the same north 66 degrees 37 minutes east 177.65 feet to a point and north 24 degrees 44 minutes west 191.0 feet to a point on the south side of an alley; thence along the same north 44 degrees 03 minutes east 328.52 feet to a point and north 61 degrees 01 minute east 154.36 feet to a point on the south side of said alley and the west side of a private alley; thence along the same which is now or was formerly partly owned by John Trenoski, Gordon D. Reed, Lawrence McKeone, and Daniel

Canfield south 22 degrees 42 minutes east 426.72 feet to the place of beginning.

Containing 15.00 acres.

Together with all the right, title and interest of Seller-Grantor, if any, in and to the bed and surface of Park Street (now vacated) intersecting the premises described above; and

Together with all the right, title and interest of Seller-Grantor, if any, in and to the land lying between the western boundary line of Tract No. 1, as described above in accordance with the aforesaid survey, and the eastern bank of the West Branch of the Schuylkill River, as shown on said survey, together with any and all riparian rights in the said Schuylkill River.

Under and subject to the following:

- 1. Reservation of mineral coal as in Deed Book 6 Page 483.
- 2. To right of others to discharge mine water, culm dirt, slate or refuse matter generally, into the Schuylkill River, without liability, as recited in Deed Book 299 Page 351.
- 3. To easement of sewer and drain pipes extending through premises, as recited in Deed Book 355 Page 173.

Tract No. 3

All that certain tract or parcel of land, situate partly in the Borough of Cressona, and partly in North Manheim Township, Schuylkill County, Pennsylvania, bounded and described as follows, to wit:

Beginning at an iron pin set for a corner where the line dividing lands now or formerly of Daniel Canfield from lands formerly of Reading Company intersects the line of lands formerly of Adam V. C. C. Cresswell; thence along the line dividing lands formerly of said Adam V. C. Cresswell from lands formerly of Reading Company, the three following courses and distances: (1) south 65 degrees 53 minutes east 297.14 feet to a corner; (2) south 70 degrees 51 minutes east 462.05 feet to a corner; and (3) south 87 degrees 56 minutes east 264 feet to a corner; thence partly along said dividing line and partly along the west line of Park Street (33 feet wide) as formerly laid out, but which is now vacated by Ordinance of Cressona Borough enacted November 2, 1942 (see also Ordinance of November 18, 1946); also partly along Park Street as now laid out 33 feet wide, north 22 degrees 30 minutes west a total distance of 1188 feet to its intersection with the south line of Pottsville Street (33 feet wide); thence crossing the bed of Park Street north 43 degrees 47 minutes east 36.44 feet to the east line of said Park Street; thence along the said line of Park Street and also along the east line of Park Street as formerly laid out 33 feet wide, but now vacated as aforesaid, and also along lands formerly of Adam V. C. Cresswell south 22 degrees 30 minutes east 982.10 feet to a corner; thence along the line dividing lands formerly of said Adam V. C. Cresswell from lands formerly of Reading Company the four following courses and distances; (1) north 69 degrees 41 minutes east 435.20 feet to a corner; (2) north 22 degrees 30 minutes west 200 feet to a corner; (3) north 69 degrees 45 minutes east 333.28 feet; and (4) north 22 degrees 33 minutes west 514.77 feet to the point of beginning.

Containing 53.16 acres, more or less.

Also all the estate, right, title and interest whatsoever of it, Seller-Grantor, in and to all land within the lines of any and all streets, avenues, roads, lanes, highways or alleys, wholly or partly bounding the described Tract No. 3 to the extent that the same abut thereon.

All that certain tract or parcel of land, situate in the Borough of Cressona, Schuylkill County, Pennsylvania, bounded and described as follows, to wit:

Beginning at a point in the line dividing lands formerly of Reading Company from lands formerly of the Mine Hill and Schuylkill Haven Railroad Company; thence along said dividing line the two following courses and distances: (1) north 30 degrees 00 minutes west 141.14 feet to a corner; and (2) north 84 degrees 00 minutes east 33 feet to a point on the dividing line between the tract or parcel of land last above described and this tract or parcel of land; thence along said dividing line south 64 degrees 00 minutes east 165.35 feet to a point in a line of the tract or parcel of land last above described; thence along said line south 64 degrees 24 minutes west 122.97 feet to the point of beginning.

Containing 0.23 of an acre, more or less.

Also all the estate, right, title and interest whatsoever of it, Seller-Grantor, in and to all land within the lines of any and all streets, avenues, roads, lanes, highways or alleys, wholly or partly bounding the described Tract No. 4 to the extent that the same abut thereon.

C. Cresswell; thence along the dividing line between lands formerly of said Cresswell and lands formerly of Mine Hill and Schuylkill Haven Railroad Company, south 4 degrees 36 minutes east 397.47 feet to a corner in said lands, said corner being also the northwest corner of lands formerly of Reading Company; thence along the line dividing lands formerly of Reading Company and lands formerly of Mine Hill and Schuylkill Haven Railroad Company, the eight following courses and distances: (1) recrossing the West Branch of Schuylkill River as formerly located south 1 degree 00 minutes west 194.7 feet to a corner; (2) south 75 degrees 00 minutes east 250.8 feet to a point in the bed of said river as formerly located; (3) south 48 degrees 00 minutes east 280.5 feet to a corner; (4) north 67 degrees 00 minutes east 66.0 feet to a point in the bed of said river as formerly located; (5) south 61 degrees 30 feet east 577.5 feet to a point in the bed of said river as formerly located; (6) south 64 degrees 00 minutes east 371.25 feet to a corner; (7) south 84 degrees 00 minutes west 33.0 feet to a corner and (8) south 30 degrees 00 minutes east 141.14 feet to a point; thence by lands now or formerly of Mine Hill and Schuylkill Haven Railroad Company, the six following courses and distances: (1) south 60 degrees 00 minutes west 193.0 feet to a point; (2) south 73 degrees 00 minutes west 132.0 feet to a point; (3) south 76 degrees 00 minutes west 99.45 feet to a point; (4) south 87 degrees 23 minutes west 62.2 feet to a point; (5) north 62 degrees 00 minutes west 72.44 feet to a point and (6) south 85 degrees 30 minutes west 92.4 feet to a point; thence partly by said lands and partly along the dividing line between said lands and lands now or formerly of Schuylkill Navigation Company, south 82 degrees 00 minutes west 202.62 feet to a point; thence by the lands now or formerly of Mine Hill and Schuylkill Haven Railroad Company, the two following courses and distances: (1) north 86 degrees 05 minutes west 170.87 feet to a point and (2) north 83 degrees 31 minutes west 153.02 feet to a point on the aforesaid dividing line between lands formerly of Mine Hill and Schuylkill Haven Railroad Company, and lands of Schuylkill Navigation Company; thence along said dividing line north 79 degrees 45 minutes west 464.6 feet to a point; thence by the lands now or formerly of Mine Hill and Schuylkill Haven Railroad Company, the three following courses and distances: (1) north 61 degrees 34 minutes west 231.0 feet to a point; (2) north 5 degrees 49 minutes east 456.71 feet to a point and (3) north 31 degrees 55 minutes west 148.32 feet to a point on the east line of Sillyman Street; thence on a line radial to the center line of said street north 70 degrees 21 minutes west 16.5 feet to the said center line; thence along the said center line in a southwesterly direction by a curve to the right having a radius of 287.94 feet, a distance of 233.2 feet to a point; the

feet radius a distance of 840.09 feet to a point, the chord of said curve having a course and distance of north 41 degrees 26 minutes west 744.70 feet; thence by lands of the Aluminum Company of America on a line radial to the center line of said river channel north 83 degrees 18 minutes west 54.25 feet to a point; thence north 31 degrees 55 minutes west 205.00 feet to a point, said point being on the center line of Sillyman Street (Pennsylvania Route 183) (33.0 feet wide); thence along said center line by a curve to the right having a radius of 287.94 feet a distance of 39.75 feet, the chord of said curve having a course and distance of south 17 degrees 39 minutes west 39.75 feet to a point; thence on a line radial to the center line of Sillyman Street south 70 degrees 21 minutes east 16.50 feet to the point of beginning.

Beginning at an original tract corner of the Aluminum Company of America located on the center line of State Highway Route 183; thence proceeding along center line of Route 183 the chord course and distance of north 3 degrees 10 minutes east a distance of 72.20 feet to a point; thence along other land of the Aluminum Company of America north 87 degrees 7 minutes east a distance of 231.70 feet to a point in the center line of the West Branch of the Schuylkill River (this line is marked with concrete reference monuments); thence along the center line of the West Branch of the Schuylkill River South 16 degrees 50 minutes west a distance of 169.70 feet to a point; thence further along the same south 13 degrees 23 minutes west a distance of 103.30 feet to a point; thence along land of the Cressona Borough Authority north 83 degrees 18 minutes west a distance of 54.25 feet to a concrete monument; thence further along the same north 31 degrees 55 minutes west a distance of 205 feet to the place of beginning.

Section 3. The Deed of Conveyance shall be approved by the Department of Justice and shall be executed by the Department of General Services, with the concurrence of the Secretary of Environmental Resources, in the name of the Commonwealth of Pennsylvania.

Compiler's Note: The Secretary of Environmental Resources, referred to in this section, was abolished by Act 18 of 1995. The functions of the secretary were transferred to the Secretary of Conservation and Natural Resources and the Secretary of Environmental Protection.

Section 4. This act shall take effect immediately.
