CONVEYANCE - COMMONWEALTH PROPERTY IN BERKS COUNTY Act of Oct. 25, 1979, P.L. 216, No. 72 Cl. 85

AN ACT

Authorizing the Commonwealth of Pennsylvania, acting by and through the Pennsylvania Game Commission, with the approval of the Department of Justice and the Governor, to convey certain Project 70 Lands to the United States of America, acting by and through the United States Army Corps of Engineers, for the Blue Marsh Flood Control Project in Berks County in exchange for certain parcels of land to be used by the Pennsylvania Game Commission in its Blue Marsh Project.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Authorization of transfer.

Pursuant to the requirement of subsection (b) of section 20, act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as the "Project 70 Land Acquisition and Borrowing Act," the General Assembly hereby authorizes the transfer to the United States of America, acting by and through the United States Army Corps of Engineers, 253.97 acres of land located in Bern, Penn, North Heidelberg and Lower Heidelberg Townships for the purpose of the Blue Marsh Flood Control Dam.

Such land shall be free of the restrictions on use and alienation by section 20 of the "Project 70 Land Acquisition and Borrowing Act" upon:

- (1) completion of the exchange transfer to the Commonwealth of Pennsylvania for the use of the Pennsylvania Game Commission of certain parcels of land situate in the Blue Marsh Project; and
- (2) execution and filing of a document of exchange and release, citing such exchange and release of the said lands from the restrictions on use and alienation prescribed by section 20(b) of said act. Subject, however, to all existing easements of record.

Section 2. Description of Project 70 Land to be transferred. The land to be transferred by the Commonwealth of Pennsylvania, acting by and through the Pennsylvania Game Commission to the United States of America, acting by and through the United States Army Corps of Engineers in exchange for other lands now owned by the United States Government is more particularly described as follows:

Commonwealth of Pennsylvania, acting by and through the Pennsylvania Game Commission shall also convey to the United States Government an easement or right-of-way to enable the United States Corps of Engineers to construct Legislative Route 06038, formerly Township Route 550 which will provide access to the Blue Marsh Flood Control Project which traverses a tract identified by Army Corps of Engineers as No. 561E-1 situate in Bern Township, Berks County, described as follows:
