CONVEYANCE - COMMONWEALTH PROPERTY IN PIKE AND MONROE COUNTIES

Act of Mar. 30, 1982, P.L. 206, No. 69 AN ACT Cl. 85

Authorizing the Department of General Services, with the approval of the Department of Environmental Resources and the Governor, to convey to the United States of America, by and through the National Park Service, United States Department of the Interior, 17 tracts of land located in Pike and Monroe Counties, Pennsylvania and to grant and convey to the Township of Delaware in Pike County an easement and right-ofway in and over certain land in George W. Childs State Park in Delaware Township, Pike County, Pennsylvania.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. It is the purpose of this act to effect an improvement in park and recreational use by conveying to the United States of America, by and through the National Park Service, United States Department of the Interior, 17 tracts of land in Monroe and Pike Counties presently held by the Commonwealth for park and recreational use; and to grant and convey to the Township of Delaware an easement and right-of-way in and over land contiguous to the existing right-of-way of Township Road T-344 spanning Dingman Creek to allow and provide for the reconstruction, expansion and maintenance of the bridge and approaches thereto over Dingman Creek. The tracts are within the boundaries of land owned by the United States of America and known as the Delaware Water Gap National Recreational Area. These conveyances will benefit the Commonwealth of Pennsylvania.

Section 2. The Department of General Services, with the approval of the Department of Environmental Resources and the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania, for a consideration of \$1, to grant and convey to the United States of America, by and through the National Park Service, United States Department of the Interior, to be used exclusively for park and recreational purposes, the following tracts of land situate in Pike and Monroe Counties, Pennsylvania, bounded and described as follows:

All those two certain tracts of land situate in Delaware Township, Pike County, Pennsylvania, described as follows:

Tract No. 1 (Parcel One)

Beginning at a stone corner on line of land of Nicholas Depue; thence along said line north 70 degrees west 69 1/4 perches to corner; thence south 40 degrees west 25 1/2 perches to corner in public road; thence along said road south 38 1/2 degrees east 14 perches and 16 links to chestnut corner; thence south 40 degrees west 47 perches to a corner; thence south 51 degrees east 102 perches to a corner; thence along lands of Benjamin B. Brooks north 40 degrees east 56 perches to a corner near a maple tree; thence along said Brooks' land north 39 degrees west 40 perches to a corner in a road; thence by said Brooks' land north 20 degrees east 34 3/4 perches to the place of beginning. Containing 52 acres and 88 perches, more or less.

Excepting and reserving the graveyard on the northerly side of the road leading to Dingman's and adjoining lands of B. B. Brooks, containing 108 perches, as now fenced, together with the road leading from the public road thereto.

Under and subject to certain conditions as set forth in the deed of Emma B. Child to the Commonwealth of Pennsylvania dated May 22, 1912, and recorded in Pike County, Pennsylvania, in Deed Book Volume 66, Page 158; and subject further to an easement and right-of-way contiguous to Township Road T-344 spanning Dingman Creek, granted to the Township of Delaware.

Depue warrants; thence along said warrant line by lands herein described and lands of the Benewater Lodge south 66 degrees 00 minutes east 54.56 rods to a stone corner; thence running through the John Van Campen warrant the following five courses and distances: (1) south 33 degrees 45 minutes west 48.52 rods by lands herein described, lands of Lutz and lands of G. Smale (Y-Buck Hunting Lodge) north 49 degrees 00 minutes west 184.00 rods to stake and stones corner, the place of beginning. Containing 102 acres, 16 perches of land, more or less.

Parcel No. 2 of Tract No. 1 being all that tract of land acquired by the Commonwealth of Pennsylvania in condemnation

proceedings against the estate of Benjamin Brooks and docketed Docket No. 61 of the May 1955 term in the court of common pleas of Pike County.

Parcels 1 and 2 together comprise the area known as George W. Childs State Park.

Section 3. The Department of General Services, with the approval of the Department of Environmental Resources and the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania, for a consideration of \$1 to grant and convey to the Township of Delaware in Pike County an easement and rightof-way, to be used solely to allow and provide for the reconstruction, expansion and maintenance of a bridge and the approaches thereto over Dingman Creek, in certain land situate in the Township of Delaware, Pike County, Pennsylvania, described as follows:

Parcel "A"

Beginning at a point on the northerly edge of the right-ofway of Township Road T-344, said point being located north 12 degrees 34 minutes 39 seconds west 16.5 feet from centerline Station 3+00; thence through lands of the George W. Childs State Park the following seven courses and distances: (1) north 12 degrees 34 minutes 39 seconds west 8.50 feet to a point; (2) south 77 degrees 25 minutes 21 seconds west 75.00 feet to a corner; (3) north 12 degrees 34 minutes 39 seconds west 10.00 feet to a point; (4) south 77 degrees 25 minutes 21 seconds west 50.00 feet to a point; (5) south 12 degrees 34 minutes 39 seconds east 10.00 feet to a point; (6) south 77 degrees 25 minutes 21 seconds west 75.00 feet to a point; and (7) south 12 degrees 34 minutes 39 seconds east 8.50 feet to a corner on the existing edge of the right-of-way of Township Road T-344; thence along the existing edge of the right-of-way of Township Road T-344 the following two courses and distances: (1) north 79 degrees 00 minutes 00 seconds east 99.79 feet to a point; and (2) north 75 degrees 51 minutes 10 seconds east 100.28 feet to a point and place of beginning. Comprising within said boundaries Parcel "A" located on the north side of the existing Township Road T-344 and containing 2,474.7 square feet of land, to be the same more or less.

Parcel "B"

Beginning at a point on the southerly edge of the right-ofway of Township Road T-344, said point being located south 12 degrees 34 minutes 39 seconds east 16.50 feet from the centerline Station 3+00; thence through lands of the George W. Childs State Park the following seven courses and distances: (1) south 12 degrees 34 minutes 39 seconds east 8.50 feet to a point; (2) south 77 degrees 25 minutes 21 seconds west 75.00 feet to a point; (3) south 12 degrees 34 minutes 39 seconds east 10.00 feet to a point; (4) south 77 degrees 25 minutes 21 seconds west 50.00 feet to a point; (5) north 12 degrees 34 minutes 39 seconds west 10.00 feet to a point; (6) south 77 degrees 25 minutes 21 seconds west 75.00 feet to a point; and (7) north 12 degrees 34 minutes 39 seconds west 8.50 feet to a point on the existing edge of the right-of-way of Township Road T-344, thence along the existing edge of the right-of-way of Township Road T-344 the following two courses and distances: (1) north 79 degrees 00 minutes 00 seconds east 9.79 feet to a point; and (2) north 75 degrees 51 minutes 10 seconds east 100.28 feet to the point and place of beginning. Comprising within said boundaries Parcel "B" located on the south side of the existing Township Road T-344 and containing 1,925.29 square feet of land, to be the same more or less. Parcels "A" and "B" together comprise approximately 0.10 acre, located between Stations 3+00 and 5+00 on Township Road T-344.

Section 4. (a) The deed conveying the land from the Department of General Services to the United States of America shall be approved as provided by law.

(b) The deed conveying the interest in the land from the Department of General Services to the Township of Delaware shall be approved as provided by law.

(c) Costs and fees related to the preparation and recordation of the property interest shall be borne by the grantee.

Section 5. This act shall take effect immediately.
