Providing for the capital budget for the fiscal year 2002-2003; and extending certain projects.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Short title and construction.

- (a) Short title.--This act shall be known and may be cited as the Capital Budget Act of 2002-2003.
- (b) Supplements. -- A reference to this act shall be deemed to include a reference to the supplements to this act.
- (c) Capital Facilities Debt Enabling Act.--The provisions and definitions of Chapter 3 of the act of February 9, 1999 (P.L.1, No.1), known as the Capital Facilities Debt Enabling Act, shall apply to this act to the extent they are not inconsistent with this act.

Section 2. Overall limitations on debt to be incurred for capital projects.

The maximum principal amount of additional debt to be incurred during the 2002-2003 fiscal year, and thereafter until the enactment of the 2003-2004 capital budget specifying the maximum debt for the 2003-2004 fiscal year, for capital projects specifically itemized in a capital budget pursuant to section 7(a)(4) of Article VIII of the Constitution of Pennsylvania and the fund to be charged with the repayment of such debt shall, with respect to each category of capital projects, be as follows:

Section 3. Extensions.

Notwithstanding any other provision of law to the contrary, the authorization and appropriation for the projects itemized in sections 3(3) (ii) (B), (iv) (A), (ix) (A), (xii) (A), (4) (ii) (A), (iv) (A), (v) (A), (v) (A), (5) (iii) (B) (i), (iv) (A), (vi) (B), (i) (H) (i), (ii) (A) (iv), (A) (v), (vi), (B) (i), (C) (ii), (6) (i) (B), (C), (xi) (L), (xii) (A), (xiii) (A), (xviii) (A), (7) (viii) (A), (8) (vii) (A), (B), (C), (D), (E), (F), (G), (H), (O), (P), (Q), (R), (10) (viii) (A), (x) (A), (11) (i) (A), (12) (i) (A), (13) (i) (A), (ii) (B), (iv) (B), (vi) (A), (vii) (D), (viii) (B), (x) (A), (xi) (A), (xii) (A), (xii) (B), (xii) (B), (xii) (A), (B), (3) (ii) (I), (8) (vii) (B), (ix) (B), (x) (B), (xi) (A), (C), 5(a) (5) (iv), 6(15) (ii) (A), (17) (iii) (B), (23) (ii) (A), 6(35) (i) (C), (M), (YY), (ZZ), (III), (NNN), (41) (i) (B) and (42) (iv) (A) of the act of October 10, 1997 (P.L.392, No.47), known as the Capital Budget Project Itemization Act for 1996-1997, which were given a one-year

extension to October 10, 2002, are hereby extended for an additional period of two years to October 10, 2004. Section 4. Effective date.

This act shall take effect immediately.
